## Letters To The Editor:

### Scandals and Scams: By Debbie Schum:



Q: What's the difference between the Madoff Ponzi scheme where new investors pay off old investors, and the Social Security Ponzi scheme where new investors pay off old investors?

A: The Madoff scam was voluntary.

It seems there is no end to the scams and scandals. In fact, there are so many of them that most of us aren't even surprised anymore. We know another one is just around the corner, and then another one. And so on.

One of the current outrages today is the credit card rip off. It's nothing new, of course, but is finally being discussed on the news. Not the bail out scam—the other one, where your credit card company suddenly boosts your interest rate as high as 30%. Sometimes it's because of a late payment, or you didn't meet the minimum payment. But sometimes it's for no reason at all, such as happened to my husband recently. A card he's had for years, never late, always paid more than the minimum due, all of a sudden a 27% interest rate, with a multiple choice list of excuses about why from the credit card company.

But here's another credit card company scam many of you may not know about: Merchant Services. I own a small wholesale business, I do international business, and I accept credit cards. When my customers call me with their credit card number (which they could be paying any monthly random interest rate on), I also have to pay. Enter Merchant Card Processing Services. When I signed up for this service, I was told that I would be paying 2.5% plus 20 cents on each transaction, a "small fee" for international transactions, and a penalty if I did not do \$25 per month in transactions. Fine, I don't expect this service to be free. But I do expect to not be defrauded. Those fees are now 3.5% plus 25 cents. When I get my monthly Merchant Services Statement (the statement itself costs me \$7.50 per month), there are 9 different categories of fees, and each of those categories has a host of incomprehensible fees in it. Here are examples from the 8th category, simply entitled "Fees": Annual Compliance Support Fee (\$40. This is supposedly to update my card swiper terminal so it doesn't show credit card numbers, except I don't have a card swiper terminal); US Cross Border Fee; VRU Auth Fee; EDC Capture Fee; International Service Fee; Foreign Handling Fee; Monthly Service Charge; Monthly Statement Fee. That's just some, and only from one category. But the category that is especially scandalous is called "Interchange Charges". Go to your computer and search "credit card interchange fees", and you'll see what I mean. Visa and Mastercard have many lawsuits against them over this. These are fees that are charged to merchants based on the **card holders** credit rating, how long they've had the card, where the card was issued, what kind of card (business cards cost me even more) and the card "rewards system". That's right...store merchants and wholesalers like myself are paying for your frequent flyer miles, hotel discounts, and cash back points. But what is really the zinger in this scam is the fee schedule for these "Interchange Charges". When I called Merchant Services to ask them what percentage rate they were charging me for these fees, I was told by the service agent that she "couldn't tell me". Why--is it a secret (like the charges themselves)? No, it's just that it varies. It could be anywhere from 1 to 4%. What are the variances? Well, the things I listed above, and apparently some other secret things. She told me that if I were to give her a card number and transaction amount, she still couldn't tell me. Which makes it sound like the fee is determined by where a dart hits a dartboard. Now add to this all the taxes, licenses, permits, fines, and fees the government demands on business.

Enjoy the concept of your hotel discount. You'll be making up for it on goods you purchase, because merchants really can't afford the \$100 billion annually in interchange charges (alone) that pay for that "discount".

The Colorado Secretary of State's Office has a "How To Run For Office" document posted on their [website](#).

The Campaign strategy for 2010 has been adjusted to be inline with recent developments. I'm increasing the objective for 2010 to be not less than four Libertarians on every ballot in Colorado.

Definitive plans for a Campaigns Committee are being made. At present, the plan calls for five members who will be called team leader in expectation of there being more than one person involved in each of the five activity areas:

1. Candidate Vetting.
  - This team will be responsible for making recommendations to the Campaigns Director concerning which members are suitable for recruiting for high visibility offices, and specific offices which offices we will decline to recruit candidates for.

2. Candidate Recruiting.
  - This team will be responsible for recruiting as many candidates as is deemed appropriate by the Campaign Director, which shall be based on the information provided by the Candidate Vetting team and subject to Board approval.
