NEW BUSINESS WITH PREVIOUS NOTICE

POTENTIAL LUCHINI CENSURE

WITHOUT OBJECTION, Mr. Lutz moved the following proposed censure of Region 1 Representative Chris Luchini:

WHEREAS..... The obligation of a Regional Representative is to represent the views of the members of the Region to the Libertarian National Committee;

WHEREAS..... Mr. Chris Luchini has on multiple occasions failed to represent the expressed views of the Libertarian Party of Colorado;

WHEREAS.... Mr. Chris Luchini has taken positions on controversial LNC items without consulting the Chair of Colorado or made their objection to his opinion known;

WHEREAS... Mr. Chris Luchini both led the argument against the suspended LNC Secretary at the recent Judicial Committee hearing without consulting the LPCO or the rest of the region, misrepresented the facts in his opening statement about the suspended LNC Secretary's efforts to spur the LNC to action against the COVID regime, and then proceed to vote twice against a reasonable compromise which have been in the best interest of the Party without consulting the LPCO or the rest of the region;

BE IT RESOLVED... The Libertarian Party of Colorado does censure Mr. Chris Luchini the Region 1 Representative for failing to adequately represent the LPCO as a member of his region to the LNC and failing to consult the region on important matters and encourages other Region 1 states to do likewise.

[20211108-04]

The Secretary was instructed to send this to Mr. Luchini, Mr. Flores, and Ken Moellman for publication on the LNC list.

NATIONAL CODE OF CONDUCT CONCERNS

Ms. Harlos warned the Board of the potential for National to be enforcing the affiliates to adopt the national "harassment" policy that exists in the Policy Manual that has never previously been enforced. To the best of her knowledge, Colorado has not signed anything so far that says we agree to this, but an argument can be made that since it is published in the national policy manual that we have implicitly agreed.

Ms. Harlos moved that the Party Chair be directed to proactively and explicitly instruct the LNC that the LPCO will not agree to any adoption of that national policy.

In debate, the Board felt this was premature, and we should wait until an actual enforcement occurs. Ms. Harlos explained her intent was to provoke a motion from the LNC to delete the provision so that no future confrontation is ever necessary.

WITHOUT OBJECTION, Mr. Burroughs moved to postpone this item until the next meeting.

STANDING RULES/SPECIAL RULES OF ORDER AMENDMENTS

Continuity Binders

Ms. Harlos moved the following motion as suggested by Mr. Aitken as follows:

Amend the LPCO Standing Rules and Special Rules of Order to include the following new rule: Candidates for all Board of Directors positions shall be provided a copy of the continuity binder for that position when they notify a Board member that they are interested in filing that position. Copies of the continuity binders shall be made available at the state convention for candidates for all board positions. [20211108-05]

WITHOUT OBJECTION, Mr. Burroughs moved to amend to strike "when they notifyee a board member" and insert "when the Secretary is notified."

The main motion, as amended, **PASSED WITHOUT OBJECTION.** [20211108-05]

Duties

Bylaws Section 3(h)

The Secretary shall maintain a Party calendar of all deadlines required by these Bylaws and the Secretary of State, and shall post these dates within sixty (60) days of their deadlines in accordance with the Party's Standing Rules and Special Rules of Order. The Secretary shall compile, maintain, and make available to the Board a publication listing all Standing Rules and Special Rules of Order adopted by the Board.

Additional Activism Activities:

Attempted to confer with RCV Colorado about the RCV ballot petitioning we were planning for 2022. They needed to wait until the Broomfield measure was done with, which has happened, and passed which is a huge RCV victory.

Email Motions Since Last Report:

Motion #: 20211015-01 Email Ballot

Motion: Move that we adopt the following as our recommendation:

Amendment 78 (Constitution and Statutory)

What it does: Amends the state constitution to require that custodial moneys that get awarded to the state government (like from the CARES Act, transportation funding, grants, gifts, state government lawsuits, etc.) are subject to the same appropriations legislation as all other state revenues. Matching CRS amendments. Creates a custodial fund parallel to the general fund to hold those funds, with earnings on those funds going into the general fund. Exempts the custodial funds from TABOR limits.

Recommendation: NO.

Reason: These custodial funds are currently outside the legislative process and therefore available at the discretion of the executive branch to be spent how they see fit without oversight, which is a recipe for corruption and patronage. However, the parallel custodial funds would be exempt from TABOR, which opens a different door for possible corruption by laundering general revenue funds into custodial fund accounts to get around TABOR requirements. Currently, custodial funds are not exempt from TABOR restrictions, but they aren't subject to legislative oversight, either. The net result of this proposal is a bait-and-switch: the bait is alleged transparency for custodial funds, with the switch being the opening of a major TABOR loophole that nobody is talking about. Given that the loophole is a cure worse than the disease, a NO vote is recommended. At least with the current system, the corruption is limited.

Motion #: 20211015-02 Email Ballot

Motion: Move that we adopt the following as our recommendation:

Proposition 119 (Statutory)

What it does: Increases sales taxes by 5% on cannabis sales to create and fund out-of-school tutoring and enrichment courses. Establishes a new state agency, the "Colorado Learning Authority" to implement it all. Also shifts some funds from existing education funds, including custodial funds, exempt from TABOR limits, equivalent to the same amount transferred to the state public school fund.

Recommendation: NO.

Reason: Increasing sales taxes is never a good idea in the first place, especially on vices like cannabis as they never produce the projected revenues as people cut back due to increased expenses. But this proposition is a hot mess, creating more government and shifting funds away from the current public school funding scheme into these tutoring and enrichment programs. Frankly, if there's a need for tutoring, then why not address that in the schools by addressing why these kids need tutors in the first place—the failure of the schools to educate the kids? As for enrichment programs, that's so broad and vague as to be nonsensical. How this would interact with Amendment 78 if it passes regarding custodial funds is also an unknown. The TABOR exemption already exists on cannabis sales taxes (a different mistake, but it's there). This is a bad solution to a problem. Rather than increase taxes on cannabis, the focus should be on effectively educating the kids.

Motion: Move that we adopt the following as our recommendation:

Proposition 120 (Statutory)

What it does: According to the Blue Book, lowers the property tax assessment rates for multifamily housing and lodging properties only, not residential properties. For multifamily properties, the rate of 7.15% for 2021 would drop to 6.5% for 2022-23, but it was already slated to drop to 6.8% for 2020-23. For lodging properties, the rate of 29% drops to 26.4% for 2022-23, and there was no change slated for 2022-23. Allows for a TABOR exemption if the funds up to \$25M are used to fund existing property tax exemptions such as the homestead property tax exemption. Lodging properties do not include AirBnB arrangements.

HOWEVER, what the actual text of the measure says is different and far simpler. Hence the confusion. The text of the measure says that the tax rate for lodging properties is lowered permanently from 29% to 26.4%, and residential property tax rates are lowered permanently from 7.15% to 6.5%. When in doubt, text of the measure, actual proposed law, trumps Blue Book interpretation.

Recommendation: YES, but an explanation is important.

Reason: SB 21-293 was an attempt to shortcut the original proposition by lowering property tax assessment rates for residential, agricultural, and renewable energy properties for 2022-23, but increases them back to 2021 levels for 2024. The effect of SB21-293 was to lower property tax assessment rates for 2022-23 only, including residential rates from 7.15% to 6.95% for 2022-23, after which they would increase back to 2021 levels as well. This proposition, according to the Blue Book then "picks up the slack" the legislature induced by adding the same permanent tax reductions to the two property classes the legislature created and didn't reduce rates for. At least that's how the Blue Book presents it. If this were actually the case, a YES vote would be recommended for reducing the property taxes on that subset of taxpayers.

The reality is that the proposal does what the text of the measure says it does: lowers property taxes on both residential properties and most commercial properties. For that reason alone, regardless of the confusion, a YES vote is recommended even more so since the scope of tax reduction is even greater.


