## PRINCE WILLIAM TO FIELD TWO CANDIDATES By Philip Hodson

The Prince William LP will run two candidates for office during the 1999 season. Robert McBride will seek the office of Chairman of the County Board of Supervisors, and LP campaign veteran Jim Vencill will run for school board.

McBride intends to use his campaign to further popularize libertarian ideas and to build on recent LP successes in Prince William. He believes that there is a widespread belief among county residents that their money is not being spent wisely, and he intends to offer the voters an alternative to an established government run by long-term incumbents.

Once an active member of the Democratic Party, and former page in the U. S. Senate, McBride became a Libertarian after being forced to sell his Kharmann Ghia convertible to pay his federal taxes in 1986.

The 1997 Vencill campaign generated a great deal of positive press coverage for the LP as it focused on promoting libertarian ideas and building a stronger county party, but in 1999 Vencill expects to win. Vencill has been working with the local civic association during

the past two years since his campaign for delegate, and has established himself as a spokesman for the community. Many residents are angry about overcrowded schools in the county, and have asked him to seek the office. He already has several members of the local civic association actively working for his campaign. The incumbent is an independent, and no Republicrats have yet announced that they will enter the race. If successful, Vencill will become the third Libertarian elected in Prince William County in two years.

An army veteran and a resident of Virginia for the past 17 years, Vencill is the owner of The Technology Group, a systems integration company specializing in computer telephony. He is the father of two children - a daughter, age 14, and a son, age 11.

#### CHESTERFIELD AND POWHATAN



Richmond, VA; April 20th, 1999 -- Tim Belton, (the Libertarian candidate challenging incumbent Republican Delegate Lee Ware in the 65th House of Delegates race) has officially announced his candidacy. The 65th district is comprised of the northwestern portion of Chesterfield County along with the southeastern quarter of Powhatan County

MAIN ISSUES: Tim will work to repeal the State Income Tax: along with the State Fuel Tax (which is currently 17.5 cents on the gallon.) Tim will work to repeal the socalled "Crimes against the public morality", (laws that seek to regulate certain activities between consenting adults, such as sex, gambling, cohabitation, etc.) as he believes such laws have no place in a modern democracy. Tim will work to end the insane "War on Drugs"; and will introduce a bill legalizing the use of Marijuana in Virginia. Tim will introduce a new "Two for One Amendment" to the state constitution: which should reduce the amount of unnecessary legislation passed each year by the General Assembly. It will also purge the books of quite a few outdated laws. Tim will oppose any new legislation that seeks to restrict Virginian's second amendment rights.

Belton notes the lack of any Democratic opposition for Chesterfield and Powhatan counties' Republican Delegates. There are a total of six delegates representing Chesterfield County in whole or in part, (and two of these represent parts of Powhatan County) and all of them are Republicans. John Girardeau (running against Jack Reid in the 72nd district) and Tim Belton (running against Lee Ware in the 65th) are the only challengers to the GOP. It makes one ask, "What happened to the Democrats"? The answer: they appear to be writing off both Chesterfield and Powhatan Counties as unwinnable; leaving only the Libertarian

Party's candidates to challenge the GOP's House of Delegates candidates.

## FAIRFAX COUNTY CAMPAIGNS IN FULL SWING By Paul Gagnon

The campaigns for Chairman of the Board of Supervisors, and northern Virginia Soil and Water Commission in Fairfax County, are heating up for Libertarian candidates Paul E. Gagnon and Johna Good Gagnon. By the end of May several actions will have been completed: 1) petitioning for ballot access, 2) a professional web page <a href="https://www.freefairfax.com">www.freefairfax.com</a> will be operational, 3) magnetic door signs for automobiles will be on the streets, 4) campaign literature will be printed for distribution by the candidates at local subway stations, 5) several press releases will provide background for media exposure, 6) the candidates will have already started speaking tours, especially developed to reach the youth bloc, and 7) the first phase of fundraising activities will be completed.

The race for Chairman of the Board of Supervisors is now between the Democrat incumbent, a Christian Coalition independent Republican, and the Libertarian challenger. The Republican Party refused to endorse Christian Coalition candidate Arthur Purves who advocates prayer in public schools and creationism in science classes. Gagnon sees this as an excellent opportunity to reach out to the 15% of Republicans who identify themselves as libertarian. Democrat Kate Hanley has steadfastly refused to cut taxes even though county revenues are at the highest levels in twenty years. Gagnon believes his proven tax reform proposal to reduce taxes on buildings will become the hottest topic of the election. Gagnon believes his proposal to provide a financial incentive for parents to leave the public school system to relieve overcrowded schools combined with a proposal to rebate tax payers for optioning out of county recreation services will resonate with voters. "I am proposing realistic, responsible, and immediate plans for reducing government at the local level, " said Gagnon.

While the race for Chairman will be aimed at increasing Libertarian Party membership and media exposure, the race for Soil and Water is the means to get a Libertarian elected to a Northern Virginia office. Candidate Johna Good Gagnon is one of four candidates running for three spots on the ballot. Johna believes she has three factors in her favor: 1) she is the only woman running against three men, 2) she is now seen as the only candidate to represent the County's Southside, and 3) most importantly, she has greater name recognition. "I don't just want to win the office, I want to be the one with the highest vote total in the race," said Johna. The Gagnon campaigns can be reached at:

#### **HERNDON**

Libertarian Pete Thomas has announced his intention to run in the 36th Virginia House of Delegates district. He has participated in ballot access drives and campaigns, including serving as treasurer for John Buckley's highly publicized bid for the House of Delegates. Although this is his first bid for elected office, Thomas has served the public as an appointed member of the Fairfax County Arbor Day Commission in the late '80s. As he is both an Engineer and a Unitarian Universalist, Thomas is running on a tri-partite platform: that government should be rational, compassionate, and minimally intrusive. Specific platform planks that he intends to address in door-to-door house visits in the district and campaign literature include:

(1) encouraging projects that demonstrate the advantage of private, charitable, and religious social programs

(2) providing a counterpoint voice to the major parties who answer every political question with "throw more money at it"

(3) sending a message to Richmond that we are goingand growing -- fine without their micro-management

Thomas is seeking two dedicated volunteers to work with him as campaign manager and treasurer--and as many others as can step forward to donate time, money, and ideas. He told activists at a recent Campaign '99 Rally, "I don't *expect* to win this race. Regardless, I'm running to win." To lend your support to this campaign,

#### **LEGISLATIVE NEWS**

I have mixed news on our efforts to create a party petition process in Virginia. House Bill (H.B.) 47, our Party Petition Bill that was carried over from last year's General Assembly session, was intended to create a process for an unrecognized party to qualify ALL its candidates with one petition, rather than each candidate petitioning separately for ballot access as an "independent."

In January, the full House of Delegates passed our bill on a 71-28 vote. It then "crossed over" to the Senate side, where it was assigned to the Senate P&E (Privileges & Elections) Committee. Unfortunately, on Feb. 16, there was a unanimous vote by the Senate P&E Committee to "pass it by for the day." This was their way of killing the bill since there were no more P&E Committee meetings scheduled.

Virginia's General Assembly is on a two-year cycle and no bills may be carried over during an election year. This means we must start from scratch and re-introduce the bill as a new bill next year. However, the fact that H.B. 47 passed the House of Delegates shows promise for an eventual passage of these changes.

Many thanks to all of you who helped in any way to lobby for H.B. 47. It is because of your efforts that we were able to get the bill through the House.

I will soon be preparing for the 2000 session. At this stage, I prefer to introduce the bill on the Senate side and fight for its passage there, on the assumption that if the Senate passes it, the House will be an easier task since they passed it once already. And for election law changes, the Committees are always the keys since the remaining senators and delegates look towards the committee members for guidance.

Therefore, if you live in any Senate P&E member's district, please consider joining our lobbying effort. We need to contact each of these Senators (assuming they file for re-election by the June deadline) and persuade one or more of them to introduce and sponsor the bill, as well as persuading ALL of them to vote to support it.

Also, regardless of where you live, you can help out by contacting civic organizations to which you belong. Ask them to write a letter of support for reducing ballot access restrictions in Virginia, and in particular for creating a party petition process.

#### **PETITIONING NEWS**

We're starting to plan a major petition drive to get two statewide candidates on the ballot in 2000. We need to collect 10,000 valid signatures by early June of 2000 to get a U.S. Senate candidate on the ballot, plus 10,000 more by mid-August for the Presidential ticket. We cannot begin these petition drives until Jan. 1, 2000.

In preparation for next year's effort, I have requested this year's candidates to get as many inexperienced members as possible out to get a couple of hours experience at petitioning. Additionally, new local affiliates are being formed all over the state. Part of the training for new local affiliates is training in petitioning.

If you are not already actively involved in a local affiliate, please consider "joining" yours (you're already a member...just show up and help DO stuff!). If one does not exist in your area, please consider creating one. There are undoubtedly other LP members like you just waiting to be contacted. Training and support will be provided.

Local affiliates will definitely be the key to our success next year at getting our first-ever non-Presidential statewide candidate on the ballot in Virginia. Thanks to your lobbying efforts, the signature requirement for statewide candidate petitions was substantially reduced last year. So join your local and start getting some training for next year's petition drive. WE CAN DO IT!!!

#### **CAMPUS ACTIVITIES**

**University of Virginia:** 

During the spring semester, Students for Individual Liberty (S.I.L.), the largest educationally-oriented group within The Liberty Coalition, sponsored speeches by Mark Brady (Locke Institute) on March 25, and Leri Thomas (Virginians for Property Rights) on April 8. S.I.L. also worked with the Jefferson Leadership Foundation to cosponsor an address on March 2 by Linda Chavez on affirmative action, which has emerged as a hot topic at U.Va. The Chavez talk received media attention throughout the community. As usual, S.I.L. published the S.I.L. Bulletin three times during the semester.

Andy Fitzgerald, a Libertarian activist undergraduate at Wake Forest University, will attend the U.Va. School of Law next fall and wants to become involved in our activities.

#### Other Campuses:

Jeremy Weiland of Mary Washington College is working to build a group at MWC. Todd Pukanecz, who works at Va. Tech, is trying to find students who will organize a group at Tech. He also noted that two Radford students attended the April 13 Libertarian meeting in Blacksburg; the students are interested in building a group.

A major goal for the campus organizing effort during the coming months is to prepare a vigorous outreach effort in late August/early September at the major colleges and universities in the state. Part of this effort will include a tour by the campus coordinator to organize outreach information tables at each institution.

#### JEFFERSON AREA

February: Publication of a newsletter, the J.A.L. News, resumed in February under the editorship of Jim Lark. It will be published in February, April, June, August, October, and December of each year.

March: The JAL conducted a cleanup of a section of Rt. 20 on March 6 as part of our participation in the Adopt-a-Highway program. In mid March, we were informed by the Charlottesville Downtown Foundation that the JAL has been selected to participate as wine vendors and ID checkers at Fridays After Five events on May 7 and July 30. This activity will generate \$300 for the group. On March 27, the JAL cosponsored a protest with the Committee for a Constitutional Foreign Policy at the Federal Court Building against American involvement in the NATO action in the Balkans. Press releases were sent to local media on March 26. As a result, Mr. Lark was interviewed at the event by WINA radio.

April: The major activities consisted of our annual convention on April 3, an outreach table staffed by Mr. Lark and Mr. Westmoreland at the Albemarle Board of Supervisors budget hearing on April 7, and a Tax Day protest on April 15 at the main Charlottesville post office.

On April 12, Mr. Lark mailed information about the JAL to LPVA members and good prospects in the JAL area. We hope the mailing will encourage local LPVA members to become more active in local affairs.

The Tax Day protest was very successful. Mr. Lark sent press releases about the protest to the local media in advance of the protest. Four members (Rick Bukrim, Mr. Cunningham, Mr. Lark, and Mr. Westmoreland) participated in the effort; Mr. Cunningham and Mr. Westmoreland wore the newly produced JAL T-shirts. The JAL distributed a substantial amount of literature (both the Million Dollar Bills and JAL contact information) and gathered the names of some people interested in learning more about us. Also, many people informed us that they were pleased by our effort. Mr. Lark was interviewed at the event by WINA radio.

Throughout the quarter, Mr. Westmoreland has attended the meetings of the Charlottesville City Council to monitor and comment upon their activities.

On Friday, April 30, J.A.L. members Jim Lark, Gerhard Schoenthal, and Gary Westmoreland protested at the Federal Courthouse in Charlottesville against American participation in the NATO conflict in the Balkans. As with the March 27 case, Mr. Lark was interviewed by WINA radio; the story about the April 30 protest ran on WINA on Saturday, May 1.

#### **ASSET FORFEITURE**

"Forfeiture". A word that strikes fear into more and more law-abiding Americans' hearts, year by year. The word itself is rapidly becoming just another curse word; for the abuse of the process by the government's law enforcement agents has now become almost completely systemic and chronic. Law enforcement agents target and seize the property of people who are less likely to fight for their assets back. People who can't afford expensive legal challenges -- and for whom the reward for spending hours, days, weeks, months, and more and more frequently, years, is simply not enough to make even an effort to fight worthwhile. The government's promiscuous use of forfeiture statutes has turned an entire nation of citizens into criminals who haven't been proven guilty yet, rather than free people who are

innocent until proven guilty. It has turned our police forces into lawless highwaymen who are free to rob whomever they wish. There are many people and organizations (including the Libertarian Party) working to change this sorry state of affairs. Tom Gordon is the Washington, DC coordinator for the organization "Forfeiture Endangers American Rights" (FEAR), and spoke to the Richmond Libertarians' "Patrick Henry Supper Club" (PHSC) on April 6th on this very timely topic. FEAR was organized several years ago to help educate the American public on the dangers of the government's broad, sweeping power to seize assets.

The official position of the Libertarian Party on this issue is clear. Look at these excerpts from our 1998 Platform:

#### **VICTIMLESS CRIMES**

"Because only actions that infringe on the rights of others can properly be termed crimes, we favor the repeal of all federal, state, and local laws creating "crimes" without victims...."

#### THE WAR ON DRUGS

"The so-called "War on Drugs" is a grave threat to individual liberty, to domestic order and to peace in the world; furthermore, it has provided a rationale by which the power of the state has been expanded to restrict greatly our right to privacy and to be secure in our homes.

"We call for the repeal of all laws establishing criminal or civil penalties for the use of drugs and of "anti-crime" measures restricting individual rights to be secure in our persons, homes, and property, or limiting our rights to keep and bear arms.

#### SAFEGUARDS FOR THE CRIMINALLY ACCUSED

"Until such time as persons are proved guilty of crimes, they should be accorded full respect for their individual rights. We are thus opposed to reduction of constitutional safeguards of the rights of the criminally accused.

"We oppose labeling cases as "civil" strictly to avoid the due process protections of criminal law and we further oppose governmental civil and criminal pretrial seizure of property for criminal offenses.

"...We support full restitution for all loss suffered by persons arrested, indicted, tried, imprisoned, or otherwise injured in the course of criminal proceedings against them that do not result in their conviction. When they are responsible, government police employees or agents should be liable for this restitution.

## From the Chair

Since the state convention a year ago, the Virginia Libertarian Party has taken great strides forward. Membership has increased to over a thousand; our web page has been greatly improved; *Virginia Liberty* received a facelift; volunteer positions like Communications Director and State Campaign Coordinator have been filled; new affiliates have formed from Abingdon to Norfolk; established affiliates have been revived and reinvigorated; and activists from the other parties who have decided to leave the politics of yesterday and join the Libertarian Party in building a free America today have been welcomed in increasing numbers. Significantly, the LPVA has begun doing what a political party should do – elect officeholders – by winning two Directors of Soil & Water in Prince William County.

Most importantly, the party is focused on the future. There are eight libertarians running for public office. Seats sought vary from Board of Supervisors, Delegate, Soil & Water, and School Board. There are more Libertarians running in Virginia than have ever been fielded in one election previously. Thank you, candidates.

But there is much more to be done. I need your help!

From the experience of my own campaign in '96, I have realized that the issue that differentiated Libertarians from the other parties is ending drug Prohibition. While the other parties may give lip service to tax reduction, social security privatization, and gun rights, they are all running against us on Prohibition. This is unfortunate for them, since public opinion has largely shifted and the Republicrats are asleep at the wheel. The tide has turned. This is amply demonstrated in the many medical marijuana referenda that have passed in recent years.

It is of strategic importance that we now demonstrate to the drug legalization activists that they have only one choice when it comes to party identification – the Libertarian Party – and that it is a credible force with which to be reckoned. This is where I need your help!

On the Fourth of July a rally and march will be held in Washington, D.C. It is important that we Libertarians make a united showing that we are the largest "anti-Prohibition bloc" on the political block. Our plan is to be recognized, not just as protesters, but as Libertarian Party members (LP placards, stickers, hand-outs, etc.).

Quite frankly, the statists occupying the White House and Congress, will not be influenced if 5,000, or 10,000, or even 15,000 protesters show up.
