*Ambitious Data-Gathering Project Can Lead to More Candidates, More Libertarian Officeholders in California*

## LPC LAUNCHES "OPERATION BREAKTHROUGH"

The Libertarian Party of California is launching an aggressive, ambitious project this month that party leaders hope will allow the LPC to reach and

possibly surpass its goal of 200 candidates this year, will make it easier to recruit candidates for local office in future years, and may even lead to some Libertarians taking office without an election being held.

Dubbed "Operation Breakthrough," the plan is the brainchild of LPC Executive Committee member Aaron Starr of Simi Valley, a well-known Libertarian campaign manager who has coordinated the successful campaigns of former Simi Valley City Council member Sandi Webb and current Moreno Valley City Council member Bonnie Flickinger.

Aaron Starr said "This project will be a real breakthrough for us. Knowing every office our members can run for will help us immensely with candidate recruitment."

"The timeline is very tight, but the plan is sound, feasible, and could be a real breakthrough – hence the name – for Libertarian candidates in California," said LPC Executive Director Juan Ros.

Once Operation Breakthrough is completed, Libertarians at the state and local level will have a valuable tool for running more candidates for local office and for reaching out to the over 87,000 registered Libertarian voters in California. The information compiled by Operation Breakthrough will allow us to print out a list of the local offices

up for election in any given year, and the LP members and registered libertarians who are eligible to run for those offices. The possibilities for using this information are endless.

Operation Breakthrough involves a series of steps:

(1) Obtaining precinct data from each of the 58 counties. Specifically, the LPC wants to know which offices are voted on in each county and – just as important – the precinct numbers within each elected office or district. This part of the plan was implemented in early April, and the LPC has already received data from several dozen of the counties.

"It's exactly what we were looking for," added Ros. "Every office – from County Supervisor to City Council to School Board to Mosquito Abatement District – is listed with their corresponding precincts."

(2) Once that data is collated and entered into a database, the precinct information will be used together with the registered libertarian voter file and the LP member database. "The voter file contains each voter's precinct number, and we can cross check the voter file against our membership list," Ros explained. The result will be like having a giant table listing each registered Libertarian voter and the offices for which they are eligible to run.

(3) Next the counties will be requested to provide another key piece of information: a list of the specific offices up for election this year. That data can then be combined with the existing data to produce a list of

the registered Libertarians who live in precincts where a local election is being held.

(4) The final step is to place phone calls and recruit candidates for those offices before the August filing period begins.

### New Party in Mendocino: Symbol Of A Changing Time

**W**e are delighted to announce the new Libertarian Party of Mendocino County! Nine LP members in the county elected officers and adopted bylaws in Willits on March 21.

The members elected Edward Kuwatch as Chair and Emil Rossi as Vice Chair. Kuwatch is one of the leading experts in the nation on laws regarding driving under the influence of alcohol, has written extensively on the subject, and directs a legal group for DUI defendants. He is also the owner of Fast Eddie Publishing. Rossi is currently the LP candidate for Congress, as he was in 1996 and 1998. He owns a hardware store in Boonville.

As befitting an area described in a Doobie Brothers song as "green trees and timberland," the meeting featured a vigorous discussion regarding the nexus of logging and liberty. For example, how does the LPMC promote private property rights for timber companies when clear cutting is a common and, to many, despised practice in the county? Several ideas emerged from discussions of this and other topics concerning outreach to the LPMC's non-Libertarian neighbors.

The county was formerly part of the North Coast LP region, which had been inactive for a number of years. Lake County, with which Mendocino shared the old region, started its own LP organization in June 1999. Mendocino's district attorney is Norman Vroman, a registered Libertarian. The party plans to alternate meetings between Willits and Ukiah. They are also considering the hosting of a Libertarian campout later this year.

To paraphrase the Doobies one last time, "Liberty has found its way...justice is going to stay...in this land, Ukiah!"

### Region 64 Candidates Protest For and Against the Police

**I**n a poignant example of the deeply principled nature of Libertarians, Candidates Mark Selzer (State Assembly District 42) and Jason Heath (U.S. Representative District 30) represented the party at two seemingly divergent protests in the same week. On invitation from the Los Angeles chapter of FACTS (Families to Amend California's Three Strikes), they demonstrated March 15th against the passage of Proposition 21 ("Juvenile Crime. Initiative Statute.") and police brutality and corruption in the LAPD Rampart division. A protest outside the Criminal Courts Building evolved into a well-orchestrated march to a second protest outside police headquarters at Parker Center, where the number of protesters was equaled by the police (many in riot gear). Mark Selzer and Jason Heath distributed literature to passersby.

On March 21st, Mark Selzer and Jason Heath then accompanied Irv Rubin (Libertarian and head of the Jewish Defense League) to the city of Compton to support the free speech rights of four suspended policemen. Four Compton police officers (including a homicide detective) were thrown out of a city council meeting and suspended for improper conduct. Half of the large audience cheered loudly for Mark Selzer's well-taken point that once police officers are denied the right to speak, we mere citizens are doomed.

### From the Chair:

We, as a Party, set two main internal goals this year:

1. Increase our dues-paying membership to 7,000
2. Increase our monthly pledge base to \$6,000 per month

#### Goal 1:

- a. The latest membership figures we have are from March 2000. Thanks to a recent Project Archimedes mailing, we're heading, once again, in the right direction, i.e. growth. The latest number is over 6400, up by more than 200 during the month of March.
- b. Also, I've appointed a Membership Committee consisting of Joe Dehn, Bruce Dovner, and Aaron Starr. They are already exploring new and old ideas of gaining members and keeping them. Stay tuned for more details.
- c. And, I've asked our editor to put the membership graph back into LPC Monthly.

#### Goal 2:

Our most recent fund raising letter is bringing in above-average results. At press time, it had already brought in over \$9,000. And it's added a few new monthly pledgers. Our current pledged total, each month, is \$4,756.15. This is down substantially from two months ago because we had to drop 18 cash pledgers for non-payment. Only 154 people have signed up for our monthly credit card pledge program. Another 67 cash pledgers donate periodically. Most are monthly and a few are semi-annual. I've given Juan Ros a directive to mail six fund-raising letters this year.

#### LPC has endorsed these external goals for 2000:

##### Goal 1:

The LPC Executive Committee has set a goal of 200 candidates in the year 2000. I'm always delighted to discover additional Libertarian candidates who are or have run for office, but we just didn't know about it. It shows there's a great deal of initiative amongst our ranks. By July, we need to recruit an additional 75

non-partisan candidates. See the exciting story about Operation Breakthrough on the front page. Even if we did nothing further, we'd still have more candidates than all other third parties combined. Your support gave us the resources to make that happen. Thank you!

#### Goals 2 and 3

Unfortunately goal 2 (The Repeal of Prop. 10: tobacco tax) and goal 3 (Prop. 23: "None of the Above") failed. The LPC had supported both.

#### Goal 4

Fortunately, the nefarious Prop. 26 failed, thus preserving the two-thirds vote requirement for local bond issues to pass. However, the fight continues because the forces of darkness and evil are already circulating a slightly modified version of Prop. 26 and big money is behind it.

Wouldn't it be great if we were strong enough to lead an effective and visible fight against all new bond issues? That's why we need to focus on membership growth and organizational development, so that one day—and it'll come—we can effectively abort any new tax before it sees the light of day.





### Carole Brow Starts Campaign on Tax Day


Carole held her campaign kick-off at a local street faire on Tax Day (April 15). She sent out a press


There are many books about Libertarian politics, economics and philosophy but few that integrate Libertarian philosophy into everyday life.

“The database work must be completed by late June or early July in order to give us at least one month to make the necessary phone calls,” Ros pointed out. “The schedule is not ideal, but with some effort it can be done.”

There is another factor to Operation Breakthrough that will appeal to Libertarians: many of the smaller elective offices are often filled by appointment rather than election because either no candidate files for that office or the incumbent runs unopposed. Those are the offices the LPC will be paying close attention to – and will be targeting.

“There are literally hundreds of local offices that are filled by appointment. We can use prior election data to determine which offices are most likely to be filled in that manner and then target those offices with Libertarian candidates,” Ros explained. “In some cases it’s possible that a Libertarian candidate can be ‘elected’ to office without an election ever being held!”

For example: in Orange County, out of 33 Special District elections held on November 3, 1998, 19 were filled by appointment in lieu of an election – over

half. In fact, state law requires counties to notify the Secretary of State whenever an appointment is made in lieu of an election, but unfortunately less than half of the counties contacted appeared to be in compliance with this law.

This little-known section of the California Elections Code was the original impetus for Starr to conceive of Operation Breakthrough.

The most exciting aspect is the opportunity for Libertarians to be elected to local office where they can play a positive role in their community as advocates for greater liberty and less government. All politics is local, as the saying goes, and we Libertarians need to live up to that. If Operation Breakthrough is successful, there will be dozens of new Libertarian officeholders all across California promoting our ideals – and that is what being a member of the Libertarian Party is all about!

## ANTI-GERRYMANDERING PETITION NEEDS YOU!




All petitions must be filed by May 22, 2000 so be sure to mail a few days before that date.


### Growth Watch Goal: 7,000 Membership March 31, 2000: 6430\*

#### Cure is Worse than the Disease

Hepatitis C, a viral infection that can lead to liver failure, is surprisingly common in Egypt. Up to 20% of the people there test positive for the chronic illness. Now a study of almost 8,500 Egyptians shows that reused needles spread the disease. Since the 1920s, health authorities employed needles in mass campaigns against schistosomiasis, a common illness caused by a blood-borne parasite. The needles were disinfected with procedures considered sufficient at that time. "Egypt's extensive and dedicated nationwide control program for schistosomiasis was the cause of the current high prevalence of hepatitis C in the country," says G. Thomas Strickland of the U of M School of Medicine in Baltimore.

## *Executive Director Update: Maintains a Hectic Schedule* ON THE MOVE – LITERALLY AND FIGURATIVELY

The LPC is on the move again – both literally and figuratively – thanks to Executive Director Juan Ros.

Ros has been hard at work locating a Los Angeles area office in which to permanently establish the LPC's base of operations. In addition, Ros has located LP contacts in two inactive counties, lectured once again at UCLA, helped launch the LPC's candidate recruitment project, and appeared on numerous radio stations in the past month.

"I haven't stopped moving!" Ros joked, referring to his workload. "And now I am going to physically be moving as well. It's a great step forward for the LPC."

After working out of a home office for the past two years, Ros will be moving into "real" office space. "This is part of the LPC's natural evolution: to centralize operations and establish a permanent home base," Ros said. "It will make handling the party's day-to-day activities more efficient."

The office will serve as a work location for Ros and the LPC's Administrative Assistant. Ros also hopes to recruit a regular group of volunteers and interns to perform important but tedious tasks, and to help implement special projects. "My vision is for the LPC office to be a nonstop beehive of activity! There is a lot of work to be done because there is so much to accomplish," Ros noted.

But office hunting was not the only item on Ros's agenda last month. Ros also helped Northern Vice Chair Rodney Austin locate two Libertarian Party contacts in inactive counties: John Howard in Modoc and Bill Adasiewicz in Sierra. "I am grateful to John and Bill for agreeing to

perform this essential function," Ros declared. "Locating a contact is the first step towards establishing an active, vibrant Libertarian Party county organization, and that's exactly what we plan to do!"

The next step for Modoc and Sierra is a membership recruitment mailing to the registered Libertarians in those counties, followed by an organizational meeting in which party officers will be elected.

"Two down, five to go," Ros pointed out, referring to the five California counties that remain inactive: Colusa, Del Norte, Glenn,

Speaking of activists, Ros worked together with LPC Executive Committee member Aaron Starr last month to launch Operation Breakthrough, the LPC's ambitious project to recruit local candidates up and down the state – and get many of them appointed to office without an election. (See story on front page.)

Ros returned to the UCLA campus on April 10 to lecture another political science class, this time on political activism. "I had the opportunity to discuss everything I do on the job: media relations, press releases, fund-raising, and lobbying the Legislature," Ros recalled.

Ros continued his media efforts with much success last month. Several press releases on gas prices were well received, resulting in a taped interview on Los Angeles news radio station KFVB. Ros also wrote an op-ed article on the same subject; newspapers as far north as Siskiyou County and as far

south as San Diego picked up the article.

A story on "Son of Prop. 26" – the proposed sequel to March's failed Proposition 26 that would lower the threshold for passing local school bonds from the current two-thirds to 55% – resulted in coverage at Fresno's KMJ radio, among others.

Ros also criticized a bill in the Legislature, AB 2574, that would have automatically registered a young man with the Selective Service when he applied for his driver's license. Ros called the bill "a menacing throwback to the days of the draft." Several days before the bill's first Assembly committee hearing, Ros issued an e-mail Action Alert urging Libertarians and others to call committee members and request a "no" vote.

As a result of his efforts against AB 2574, Ros was featured on KFVB and on the "Minyard and Minyard" show, which is currently syndicated on 66 stations nationwide. "The bill allowed me to expand our discussion to the broader subject of whether or not there should even be a Selective Service System, and we took calls from all over the country, many of them supportive of the LP position," Ros remembered. Because of public outcry AB 2574 was revised, making registration with the Selective Service voluntary instead of mandatory.

Ros has been especially busy this month with Operation Breakthrough, his continued media outreach, establishing active county organizations, and setting up a new office! ■
