The meeting was called to order by the Chair, Mark Hinkle.

Chair's Report: Mark Hinkle The State Party membership is at an all-time high. The budget is in the best position ever.

Jack Dean gave an update on the status of various legal pursuits. In regards to membership/fundraising, San Diego, Santa Clara, Region 62 (West L.A.) and Orange County were all praised for their membership numbers.

Bill Evers was elected as the National Platform Committee Representative. Sally Foster is the Alternate.

Karen Huffman was elected the National Credential Committee Representative.

A resolution regarding American Hostages was passed. See Attachment B.

Copies of the previous meeting's minutes were made and the minutes were accepted.

The proposal that San Francisco and Marin be combined into a new

Golden Gate region was tabled until the next Execom meeting to give the Northern Vice Chair an opportunity to investigate the situation.

John Vernon presented a region-building idea they are employing in Region 62, attempting to encourage those who write letters to the editors of local newspapers expressing libertarian ideas. An extension of Bob Lehman's LONG ACTIVE activities, called Live Wood was also discussed.

The motion that 1987 be devoted to improving communication between the regions was passed.

A motion

"That the Secretary send minutes of Executive Committee meetings to all members of the Committee within 4 weeks, regardless of attendance at the meeting.

"That the Treasurer should send a summary of the financial condition of the Party quarterly to each Regional Chair.

"That the Vice Chairs contact each Regional Chair of their constituency at least once every 3 months (ideally following the last Execom meeting, but prior to the next scheduled meeting).

"That the Chair should contact each Regional Representative of the Committee who did not attend the previous meeting.

"All of the expense incurred -- with reasonable scrutiny, generously applied -- should be paid by the Libertarian Party of California.

"The above activities to be included in the Officer's reports to the Execom at the subsequent meeting." passed.

Bud Bates gave a report on the Strategy Committee. The Committee had not been active and he thought the idea of the Committee should be rethought.
