- **Boulder County LP** is busy spreading liberty and acts of voluntarism with continued adoption of a stretch of highway in north Longmont and with a liberty garden that will feed the homeless.
- **Douglas County LP** has offered to assist Elbert County in becoming an affiliate with plans to meet with Elbert Libertarians to discuss. County Chair Wayne Harlos encourages all established affiliates to take their neighboring counties under their wing.

## Update from Region 1

*What an exciting last couple of months it has been in the Libertarian Party!*

Recently many of states have been hosting various Outreach booths, clean-up efforts, and, of course, state conventions. Most of the affiliates in our Region have completed their annual conventions and with that came new leadership and changes in several states.

With changes in leadership and as we transition into the latter half of the year in preparation of the 2020 Election Season, I urge all membership to strive to do what they can for the party in their own way. The Libertarian Party has had the success it has because our volunteers are everywhere and have a wide variety of skill sets, which can be applied to virtually any situation to the benefit of the party. We are a strong and growing group, and it is important to remember

The **Legislative** Committee will be forming in September and interested volunteers should contact Mike Stapleton at [legislativedirector@lpcolorado.org](mailto:legislativedirector@lpcolorado.org). Items on the agenda include the National Popular Vote Compact ballot initiative and protecting the taxpayers' bill of rights. We need to make sure that amendment CC—the last line of defense to protect Colorado from tax increases without consulting the voters—doesn't pass.

**Membership** Director: LPCO currently has 45,386 members. Any Colorado voter who is registered as a Libertarian is automatically considered a member of the LPCO. Of those, we have 521 volunteers.

The **Outreach** Director's seat is vacant. - **Garfield County LP** will be hosting an outreach event on Tuesday, July 23<sup>rd</sup> at Doc Holiday's Saloon in Glenwood Springs to activate their Development Group.
- **Pueblo & Otero Counties LP** – Pueblo County development group held its first meeting in May at which Otero County expressed willingness to have a combined Pueblo and Otero County LP group. In July, the group hosted a speaker on the "Red Flag" gun control law, and in August, the group will feature a speaker on TABOR and the most recent effort to undermine it.

## Take-Make a Seat *Improving mass transit when government drops the ball.*

For people living in metropolitan areas, mass transit is often a crucial means of transportation. People flocking to the cities, instead of being driven away from them, results in a greater number of mass-transit users. This creates a stable means of transportation alleviating poverty through shorter commute times and improving access to local business.

It's been no secret that Metro Colorado's Regional Transportation District (RTD), has one of the highest fares in the country while also struggling to maintain ridership. It's also no secret that when stops lack places for people to sit, riders will resort to whatever is available, even if it's cinder blocks and planks. The average RTD bus shelter costs up to \$10,000.

*What can be done?*

Cities all over the country have seen their communities rise up to provide their own solutions to a lack of bus benches. Rochester, New York has an organization that creates wooden bench "blocks" for riders to use. West Philadelphia has a youth program that engages in public projects such as designing benches for elderly riders. "Thanks" to the bureaucratic nightmare of the city's approval process, only three have been installed. Cleveland Ohio has an organization that solicits sponsorship for the installation and construction of bright blue wooden benches, which can be furnished for as little as \$30 in lumber.

Government has a long and storied history of frequently failing to address the needs of a community, and communities have quickly learned that we can achieve so much more by working with each other instead of waiting for government.

# 2019 LPCO Convention *Highlights from "Retro Liberty"*

I was asked by the Board to help with the convention and I am grateful for the trust and confidence placed in me. This would not have been possible without the assistance of Beatriz Sutton. It was a pleasure to serve to advance liberty with you all. *Caryn Ann Harlos*

We put on our platform shoes and other clothing abominations of the 1970s and kicked off both the convention and party fundraising with a Friday meet-and-greet and dance. Fundraising events continued throughout the entire weekend including auctions of items graciously donated by vendors and party members, a bid to wear the "Only True Libertarian" button (there can be only one!), and opportunities to throw alcohol-infused pies (the infusion included both the pies and the participants) at willing subjects.

About 50 Libertarians came together this Spring to take care of important party business, including the election of new officers and updates to the LPCO governing documents while even more joined us to listen to some amazing guest speakers. Our out-of-town guests were singularly impressed with the organization and enthusiasm level, but of course, this is the birthplace of the Party, we could do nothing less. If you were not able to attend, our new Fundraising Director Angela Plummer is planning already for 2020 to light your liberty fire with a "Focus on Liberty" going into the 2020 presidential election season.

**The Race for Chairman and Vice Chairman** - We had two contested races this year. Candidates for both the chairman and vice-chairman positions participated in community forums and moderated debates.

**Presidential Panel** Nomination hopefuls Adam Kokesh, Vermin Supreme, and Arvin Vohra graciously answered questions from our delegates about their campaign visions. New faces have entered the race for 2020 since that time. **Constitution and Bylaws Committee** The Delegates patiently worked their way through some 20 amendments, including an overhaul of the Board of Director duties and how the Party nominates candidates. The Committee thanks them for their diligence. One major change going forward is the segregation of Bylaws and Platform reform and the nomination of partisan office candidates. Bylaws and Platform reform will be considered on odd years here out. Note that some titles changed to reflect changes in duties previously passed in the Party bylaws. The Records Director is now the Secretary, and the Regions Director is now the Affiliate Development Director.

The 2018 Convention passed Constitution & Bylaws Proposal #16, which contained a Proviso that the 2020 Convention would hear only two proposals to combine the Constitution and Bylaws into one document and to codify the Convention Standing Rules into that combined document. Any other proposals will be addressed by the 2020-21 Committee. *Mike Seebeck*

**Platform Committee Chair** History was made for us when the changes proposed by this committee were passed in one vote (with the exception of the facetious "Conjoined Twins" plank put in to see who actually was reading the report). 
