#### NATIONAL TAX PROTEST DAY

A spirited group of anti-tax demonstrators assembled at Washington's Headquarters in Morristown on Saturday, April 12 to participate in the third annual National Tax Protest Day. NJLP members were joined by representatives of various taxpayers groups from the Federation of New Jersey Taxpayers (FNJT)and by Young Americans for Freedom and other conservative organizations. The protest was specifically concentrated against the proposed NJ state income tax.

After gathering near the flag pole at the Ford Mansion, the demonstrators marched to the square in downtown Morristown chanting "No State Tax" and passing out anti-tax leaflets along the way. About 20 signs carried by the protestors contained slogans such as: "Stop State Income Tax", "Cut Government Spending", "Taxation is Theft", "To Hell With Botter", "Don't Break Our Backs with an Income Tax", "Axe the Tax, Burn Bryne", "I Can't Pay More Taxes", "Taxation Brings Tax Action. They Tax - We Act", "Join the Tax Revolt".

Approximately 400 "Taxation is Theft" leaflets from the Society for Individual Liberty were passed out in addition to FNJT literature urging people to write their state senators and assemblymen to vote against the state income tax.

After passing out literature in the square for about a half hour, the demonstrators marched back to Washington"s Headquarters. Although only 25 people participated in the march, many cheers and words of encouragement were received from passersby and almost everyone seemed interested in the anti-tax literature.

Press releases had been sent to local papers announcing the demonstration, and one reporter spent a lot of time asking us questions about the purpose of the protest.

The following article appeared in the SUNDAY DAILY RECORD, Morristown, April 13, as written by the newspaper reporter Andy Marcus:

#### 'NO MORE TAXES' GOVERNOR TOLD

Fifteen persons from Morris and Essex counties marched through downtown Morristown yesterday afternoon to protest the proposed state income tax and "taxes in general", demonstrating at the Governor Morris Inn, where Gov. Brendan Byrne spoke at a luncheon.

William E. Schetlick, a member of the N.J. Libertarian Party and an organizer of the demonstration, said the group was demonstrating because yesterday was designated National Protest Tax Day by the Society for Individual Liberty, a Pennsylvania-based libertarian organization, and because of the governor's scheduled appearance.

Byrne addressed members of the N.J. League of Women Voters, who were holding their annual convention, which began early in the day.

Representatives of the league informed several protestors at the time the group arrived at the Inn that the governor had already presented his speech and left.

Carrying signs saying "Stop, No Income Tax" and "Tax Revolt" the protestors began their march at about 1 p.m. at the Morris—town National Historical Park (Washington's Headquarters). They marched single file up Madison Street to the town square, shouting their protests amd handing out literature as they went. They returned to the park and rode in cars to the inn.

Several organizations were represented in the demonstration. They were the N.J. Libertarian Party, the Federation of N.J. Taxpayers and the National Taxpayers Union. Schetlick described his party as an "anti-political party" that wants to reduce the power and extent of state and federal government.

About 30 picketers, who had been commemorating National Tax Revolt Day by carrying placards around the Morristown Green, shifted locale to the Governor Morris when they learned of Byrne's appearance.

#### OPERATION PAUL REVERE

The New Jersey Libertarian Party has entered into a loosely-constructed ad-hoc committee for the purpose of defeating any and all of the proposed tax packages in the state. This organization, which boasts of a membership totalling no less than fifteen groups has been very active in the past three weeks following the Governor as he tries to ram an income tax through the legislature. The "operation" has appeared in Trenton, Jersey City, Lyndhurst, Oradell and New Brunswick carrying the taxpayers message to the Assemblymen and State Senators in an effort to encourage them to vote against the tax or face defeat at the polls and a tax strike.

The membership is largely conservative, including the John Birch Society and the Federation of New Jersey Taxpayers. The defunct American Party is well represented, as is MASTO (Majority Against State Takeover) and a Tax Revolt Association. As libertarians, we have been very careful not to let this loose association dominate us in any way, as our beliefs come into direct conflict with many of the conservative convictions. Words like "conservative" have been dropped from the group.

These committees can be extremely helpful to us in our pursuit of freedom. In the near future, we will seek a similiar relationship with some left-like groups in an effort to abolish the draft, and, more immediately, to push the bill in the Assembly to legalize marijuana.

Ed. The NJLP has received word that several key state senators have admitted that the Byrne tax plan was defeated when they decided they would vote against it because of all the recent antitax demonstrations.

Libertarians in New York also participated in NTPD. According to Don Feder (in an writeup for the FLP newsletter), eleven of the Capital District FLP members picketed the IRS regional office in Albany on April 12th. One of their anti-tax signs stated "April 15th - National Rip-off Day".

"The demonstration received excellent coverage on two area television stations." An interview with the group's spokesman, John Deane "made it quite clear that the FLP was calling for the abolition of taxes, rather than tax reform."

According to an FLP news writeup prepared by Howard Katz,
"A dozen stalwart libertarians, primarily members of Sam Konkin's New Libertarian Alliance, demonstrated at the Internal
Revenue Building ... in Manhattan..." on April 15th. "The
group handed out "Tax is Theft" leaflets containing the basic
argument that all taxation is immoral because it is based on
compulsion....The pamphlet advocates: filing W4E forms to stop
withholding, pleading the Fifth Amendment on your tax forms,
resisting tax court (because it is not part of the judiciary)
and joining the tax rebellion." The demonstration received
good press coverage and a long interview with radio station
WBAI.

#### THE BLUFF

You don't bluff in poker to win money. You win money on your good hands. You must bluff occasionally so that your good hands will be raised or at least called. If you don't lose a couple of bluffs in an evening you aren't bluffing enough.

On the other hand, if you allow your opponents to bluff you all evening and never call them, you lose.

Governmental regulatory agencies are getting away with too many bluffs. They continually pass unconstitutional rules, regulations, and guidelines with impunity. These devices seldom have the backing of law; they are not voted on by our elected representatives, but are blindly accepted as law without being tested in court.

Governmental agencies may threaten fines or other use of force if their ultimatums are not complied with, but they may be powerless to levy or collect fines. Our whole legal system is based upon the presumption of innocence. They must prove the defendent guilty before imposing penalties.

When their bluffs are called they may issue dozens of threatening registered letters but may be unable or unwilling (lack of funds, indefensible position, etc.) to pursue the matter and take a citizen to court.

While it may be risky to call the bluff of "city hall", the defense of life, liberty, and property is not without its perils. The alternative, in the long run, is the greater risk. It is called communism.

In the changing fortunes of the political arena, the libertarian philosophy stands alone as the only viable alternative to the mounting rage for statism. This fact has been reiterated time and time again even by those who are not of our persuasion. An article in Newsweek spotlighting the Tuccille For Governor campaign stated that "Libertatians are the only people worth voting for..." This kind of sentiment has done wonders to rekindle the fires of freedom in all of us, perhaps to the extent that we might become lax in our efforts, and giving us a sense of false security. Our recent "victory" against the proposed state income tax, could be just such a lethargic poison. Libertarians all over the state became involved in a myriad of efforts to defeat the tax. We have shown that we can work with other groups in cooperative situations and have all the right in the world to feel pleased with ourselves. However, this achievement, instead of causing complacency should spur us on to even greater heights. Political activism has netted us some impressive publicity, and I have been interviewed by several newspapers, all of them giving us at least some recognition. They expressed surprise at some of our suggestions to cope with social and economic problems, but those who took the time to listen were impressed with the logical consistancy of our postion. Many requested additional information on the party. The point is obviously, that we should continue our steady diatribe against the encroachment of state power through political action. The time has come for libertarians to think seriously about running a campaign to put one of their own into office who will give us a real representative in the state assembly. The coming meeting in June will determine whether or not the libertarians in New Jersey can implement the experience of their activism and are ready to make firm commitments to elect the first real libertarian. Come to the meeting prepared to pledge your support for our five candidates...we'll need all we can get.

#### NO MORE TAXES!

#### NEW JERSEY LIBERTARIANS FIGHT TAXES

On Saturday, April 19 five libertarians were among the opposition which listened to Governor Byrne at Paramus Park while he tried to gain support for his proposed state income tax. According to the Star Ledger (April 20), "Byrne addressed more than 300 persons... most people surveyed said they opposed the tax..."

The Sunday Record (Bergen County) of April 20 reported: "He received a mixed, noisy, and — at times — hostile reception."

'Cut state spending,' 'Byrne resign,' were some of the verbal brickbats hurled at the governor as he stared at placards stating: 'I Can't Pay More Taxes,' 'Lying Greedy Poli-Pigs,' and 'To Hell With Botter.'..."

"Reactions to the tax program ranged from quiet objections to vehement and hostile epithets...."

'Kathy Greene of Parsippany-Troy Hills, a member of the Federation of New Jersey Taxpayers (Ed. and a libertarian) said the income tax would benefit those she termed the governor's rich friends in Short Hills and other posh areas where, she said, wealthy people use tax loopholes to dodge their liabilities."

'R.L.Solyom of Fort Lee, vice-president of the taxpayer federation, (Ed. and NJLP State Committee Representative) said, 'We believe a fictitious gap of \$487-million has been created in the budget to bamboozle the public into thinking an income tax is necessary. It is not necessary. " (Ed. Dick was carrying a "Tax Revolt" sign throughout most of the governor's talk).

When the moderator cut off the questions, the governor left the hall without so much as a goodbye to the audience and was followed by jeers, boos, and hisses. (Ed. It couldn't happen to a nicer guy!).

Part of Kathy Greene's questions were reported on the Channel 4 and Channel 7 newscasts that night and our anti-tax signs also were shown in the background. Silent justice prevailed as Byrne's voice could be heard answering a question while the camera focused on "Lying Greedy Poli-Pigs", etc.

Before and after the Byrne appearance, libertarians met and talked with other interested taxpayers. Kathy McAdam, carrying a "Cut State Spending" sign, collected 33 more signatures on the Taxpayer's Pledge, and she and Ralph Fucetola passed out "Taxation is Theft" leaflets. Kathy Greene and Phil DeBlock had a few interesting discussions with some people who expressed great interest in the work of the Federation of New Jersey Taxpayers. Dick Solyom distributed Federation leaflets urging people to write their legislators and tell them to vote against any new or increased taxes.

Also during April, Bill Schetlick attended a public meeting of pro-income tax groups at Kean College and Dick Solyom went to a similiar meeting at Montclair State. Both of them reported that the majority of people in the audiences at both meetings were opposed to the state income tax and that both meetings disbanded when the speakers realized that they were not receiving support for their tax plans.

(Ed. I staged my own silent tax protest on April 14th. During my lunch hour I left 150 S.I.L. "Taxation is Theft" leaflets under windshield wipers in an underground garage near where I work. After work I left tea bags with National Taxpayers Union "UNTAX US" stamps on the desks of approximately 50 of my coworkers.)

After an organizational meeting in mid April, OPERATION PAUL REVERE (see page 1) began a series of anti-tax demonstrations in Lyndhurst on April 22. The Record (Bergen County) of April 23rd carried an article on page 3 headlined: "Call for 'no' vote from Scardino — PICKETS BOO BYRNE TAX." State Senator Scardino was "reportedly under pressure from other senators to change his

"The protest songs of the demonstators ending "If your damn tax goes through, Bye Byrne,' could be heard outside the Board of Commissioners meeting over which Scardino, as mayor presided."

"Afterward, Scardino said he had made up his mind."

" 'I won't vote for it (the tax,') he said. 'I've never

changed my position.' " The article quoted Dick Solyom and also mentioned the Libertarian Party as one of the groups participating in the demonsta-

The April 23rd Herald-News article headline read: "COALITION LAUNCHES 'REVOLT' AGAINST TAX" and began "Paul Revere rides again."

"Like the colonial rebel who raced through Massachusetts 200 years ago to warn of the oncoming British, a loose coalition of anti-income tax groups swooped down on the Town Hall Tuesday to protest the proposed state income tax..."

"About 45 persons (Ed. we counted closer to 60) ... carried picket signs and chanted "Ax the Tax," 'Vote no' and 'We can't afford any more 'help' from the government.'..."

"Ralph Fucetola, vice president of the N.J. Federation of Taxpayers, said the state should 'tighten its belt' and not launch any spending programs."

'There are two ways of filling deficits,' Fucetola, a North Arlington attorney, said, 'You can increase taxes or cut spending. We say no new taxes.' "

The article also mentioned 'William E. Schetlick, chairman

of the Libertarian Party, which advocates a voluntary society

and the abolition of taxes."

At least eight libertarians participated in the Lyndhurst demonstration including one of our newest NJLP members and one of our former members.

On Saturday, April 26, three NJLP state committee members joined with other anti-tax demonstraters to picket in front of the home of state Senator John Fay who has been one of the supporters of the proposed income tax.

Other anti-tax protests during the last few weeks have been held at Bergen Community College in Paramus, at St. Peters College in Jersey City, and in East Brunswick at the NJ School Boards Association meeting. As this newsletter is going to press, Operation Paul Revere is planning future anti-tax demonstrations around the state.

#### BILL TO LEGALIZE GOLD CASES PENDING IN HOUSE

H.R. 5711, an extremely important bill for all those interested in the gold standard, is now pending in the House of Representatives. It would open the way, now legally barred, for numerous suits concerning the constitutionality of the various measures used by the Roosevelt administration to abrogate the gold standard in 1933-34.

In January of this year the Committee to Establish the Gold Standard brought suit to stop the U.S. Treasury sale of gold on the grounds that it would prejudice the return to the gold standard. Judge Kevin T. Duffy avoided ruling on the merits of CEGS' case by invoking 31 U.S.C. 773b, which states:

"Any consent which the United States may have given to

the assertion against it of any right, privilege, or power whether by way of suit, counterclaim, set-off, recoupment, or other affirmative action or defense in its own name or in the name of any of its officers, agents, agencies or instrumentalities in any proceeding of the nature whatsoever (1) upon any gold-clause securities of the United States or for interest thereon, or (2) upon any coin or currency of the United States, or (3) upon any claim or demand arising out of any surrender, requisition, seizure, or acquisition or any such coin or currency or of any gold or silver and involving the effect or validity of any change in the metallic content of the dollar or other regu-

change in the metallic content of the dollar of other regulation of the value of money, is withdrawn..."

This invokes sovereign immunity (withdrawal of consent to be sued) on all cases involving gold and the basis of our money system. It is a highly discriminatory piece of legislation designed to stop legal cases by gold bugs and no other group.

Congressman Steve Symms has introduced H.R. 5711 which states:

"Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That section 2 of the Gold Clause Act of 1935 (31 U.S.C. 773b) is repealed."

H.R. 5711 would remove this bar to gold cases. Its passage is an extremely important first step in achieving a gold standard as it would open a whole new legal aspect to our attack.

H.R. 5711 has been referred to the House Banking Committee. It is extremely important that all gold bugs write to Henry Reuss, Chairman of the Banking Committee, to urge him to hold hearings on the bill. Without sufficient public support this bill will die in committee. Unless Reuss sees that there is a large segment of opinion supporting it, he will suppress it by simply not scheduling hearings.

We therefore ask all supporters of the gold standard to write to Congressman Reuss to ask him to hold hearings on H.R. 5711. His address is:

Massachusetts LP member Robert Nozick has won the National Book Award in the category of philosophy and religion for his new political theory book, ANARCHY, STATE AND UTOPIA.

According to the March 15 issue of Forbes magazine, Nozick who is a professor of philosophy at Harvard University "stakes out an extreme libertarian position, from which he is tough on 'liberals'. Why is free sex good, he asks, and free enterprise bad? Why divvy up wealth through taxation and not good-looks through free plastic surgery? ... (his book is) nothing less than a challenge to a central feature of the moral landscape: the state as everybody's mother and father."

In the Forbes interview, Nozick stated: "... the central theme of the book was: What activities of the state are legitimate? The two major areas that I really am quite critical about are redistributive activities of the state and paternalistic activities, where people are forbidden activities for their own good; not to help others, but for their own good."

"... I do believe that you should aid people in need. would personally do it, and I would encourage it. But I don't believe the state has a right to force me to do it, or that my fellow citizens, if they're in the majority, have a right to vote to force me to do it."

".. People are entitled to what they have if they got it in a legitimate way....'

(The free-market economists) 'didn't often talk about people's rights, but talked just about capitalism's efficiency. I believe they were right about that, but it wasn't enough. People would say, it may be more efficient but it's not just. One thing I say in the book is that it is just."

"...I would counsel just about immediate lifting of all the paternalistic legislation that there is."

"...most people find the libertarian position threatening, partly because it is saying that people's lives are their own to live. It's not government's job to make you live correctly."

"...The trouble with socialism is that it prohibits capitalistic acts between consenting adults."

The March 31 issue of Newsweek, in a full page article in the IDEAS section, stated that Nozick "argues that any state that pursues egalitarian goals is inherently unjust, however noble its intentions. His book,... is at heart a shrewd defense of <u>laissez</u> faire and a theoretical buttress for the growing libertarian movement."

"An active socialist in his undergraduate days at Columbia University, Nozick has come full circle in his intellectual development to a sophisticated and relentlessly reasoned defense of privilege, private property and the free-market system. Nozick, who is 36, argues that the only just government is the minimal or "night-watchman" state; the only purpose for such a state is the protection of individuals from assault, theft, fraud or breach of contract. The modern state, in Nozick's view, has grossly violated this social contract. As a philosophical libertarian, he is opposed to all paternalistic laws, such as those forbidding drug use, which attempt to coerce bad citizens into becoming good ones. Nozick also opposes taxation as a form of slavery and would abolish all government agencies that regulate--and protect--private business."

"Nozick's underlying point is that any theory of justice that relies on a 'patterned' distribution of goods—each accord ing to his need, effort, marginal productivity or whatevercoerces individuals and violates their fundamental rights...."
...Nozick reasoned his way to libertarianism, a lonely

position he has skillfully defended at Harvard, where he won a

position he has skillfully defended at Harvard, where he won a full professorship at the age of 30."

According to the March-April LP News, articles have also appeared in the Times Literary Supplement (the most important book review journal in Britain), Harpers, and the New York Review of Books. The LP News concluded: "The publication of Nozick's book has moved libertarian political thought into the constructor book has moved libertarian political thought into the spectrum of plausible alternatives in academic circles. Libertarian ideas now have an opportunity to be seriously debated and discussed in scholarly journals. The book's favorable reception in academic circles has already percolated downward, helping to make liber-tarianism something to be considered in popular magazines. Both these effects are important breakthroughs."

#### LAISSEZ FAIRE BOOKS SCHEDULE OF EVENTS

On May 30, Roy Childs Jr. will speak on 'WHY OBJECTIVISM FAILED". UNGRATEFUL

If Congress is expecting a wave of gratitude for the tax refund (April 7), they can forget it. It is like being fawningly grateful when a holdup man gives you bus fare home.

According to the national LP News (March- April), Roger MacBride has thrown his hat in the ring for the LP Presidential nomination. Making the announcement at the annual convention of the California LP, he promised a vigorous campaign if nominated.

'MacBride pointed out that some pessimistic libertarians see the task ahead as hopelessly impossible. But these pessimists are usually thinking about the difficulty of converting 40 million people to a full mastery of libertarian philosophy in all its details and ramifications. 'That indeed would be a mind-boggling task, '..."

"Instead MacBride foresees a 1976 campaign strategy built around persuading the American public of the viability of libertarian solutions. 'Our goal is to convince Americans that we do have the answers. That is a far easier task and one well within our means.'..."

"A prerequisite of the advancement of liberty through the political process is serious political standing in the eyes of

the populace and the news media..."

" 'No reporter for any newspaper, or for any radio or television station will take our ideas seriously if we present the image of a quixotic tiny minority. To avoid that the LP must have ballot status in as many states as our energies permit.' Such ballot status drives will require enormous effort, MacBride said. But with 'a joyous dedication to a cause whose time has come, ' the effort can succeed."

(Ed. We in the NJLP are hoping we will gain experience in this year's assembly campaigns which will be of benefit to us next year for the presidential campaign. Come to the June 1st meeting and contribute to the campaign plans.)

#### SPEAKERS BUREAU

On May 1, Ralph Fucetola spoke about inflation to 200 history students at Bernardsville High School. He reports that the lecture went well, many good intelligent questions were asked, and the audience was very receptive to his remarks. A special thanks to Ralph for filling in with less than 24 hours notice when our scheduled speaker could not make the engagement.

#### PSYCHOLOGY OF SELF ESTEEM

The ballroom of the McAlpin Hotel was filled to capacity. This was the opening lecture (April 18) of a course entitled NEW LECTURES ON THE PSYCHOLOGY OF SELF ESTEEM which was to run for two consecutive weekends, Friday night, and all day Saturday and Sunday. The full course, given by Dr. Nathaniel Branden, was attended by about 100 persons.

Branden began by explaining that the goals of psychology were to understand and explain human behavior and to determine the conditions for change in human experience and behavior. He emphasized that the purpose was change and not control, and that he sought to understand the nature and condition of personal growth and evolution, and what obstructs human growth. Psychotherapists effect change by the communication of values; therapy cannot occur without a communication of values. These values may be communicated in three ways - explicitly, implicitly, and by modeling (the example set by the therapist as a person).

Human behavior is explained as being in response to a value. All action is goal directed, and neurotic behavior also serves its purpose in furthering a goal, the goal often being protection of one's self image or the avoidance of an anxiety producing situation. In order to understand and change neurotic behavior it is more useful to look for the purpose rather than the cause of the behavior. The behavior serves some need of which the individual is usually not aware. He has "disowned" that need and thereby has blocked an avenue of self-awareness. If one is blind to the need, one is also blind to any opportunity to satisfy that need. It is important in therapy to remove the blocks to self awareness. Branden described some of the techniques he used in getting his clients (not patients) to remove these blocks. Often dramatic results have been obtained with his techniques.

Psychological health is defined as having full contact with one's inner world, full contact with the real external world, and knowing the relationship between them. All psychological disorders entail a breach of awareness.

The course was not strictly lecture. There were also lengthy question periods and some workshops. For one workshop the class divided into groups of six persons sitting in a close circle. We were asked to complete, each in turn, a variety of sentences such as "One of the things I don't want to tell you about myself is ..." The answers were both revealing and enjoyable to the participants.

Branden announced that he plans to give a full-day therapy workshop in New York later this year.

The NJLP has again become a very active organization! During the past few months, many of our members have participated in anti-tax demonstrations around the state, five members filed petitions for the state assembly elections, and some members have had Letters to the Editor published in their local newspapers. (We also have 9 new members and 4 new newsletter subscribers.)

The NJLP is planning to work hard on the assembly campaigns,

and we'll attempt to gain good media coverage of our activities. Please be on the look-out in the newspapers for any items about libertarianism, the NJLP, and anti-tax activities, and send them to me for the newsletter and also for the party scrapbook.

This month I give special thanks to Tom Palven for his very generous contribution to the newsletter expenses. Thanks also to Dave Burnett for the Morristown NTPD news article, to Cal Beatty and Tom Palven for the articles about Robert Nozick, and to Ruth Bashlow and Charlie Hofker for the articles about the Lyndhurst demonstration.

#### FEDERATION OF NEW JERSEY TAXPAYERS

At the beginning of April, the FNJT unveiled its taxpayers' proposed budget which called "for a 1¢ reduction in sales tax and a ½ reduction in gasoline tax." NJLP State Committee Representative Richard L. Solyom who is the legislative vice president of the FNJT declared im a press release: "There is no gap - the bud-get CAN be balanced without an income tax!... Our C.P.A. (Ed. NJLP member Robert Steiner) has shown us that new taxes are not needed and existing taxes can be reduced."

"... Amounts spent on relief and welfare have increased beyond all reason during the past few years. The hard-working, productive citizens of this State cannot continue to spend at

this rate without going into bankruptcy!..."

The press release continued: "Calling attention to the Office of Fiscal Affairs' suggested 15% across-the-board reduction, the taxpayers' lobbyist said: 'We believe a 10% reduction is more realistic and we recommend all departments trim spending by this

'When asked if he thought the taxpayers' budget was realis-tic, Mr. Solyom shot back: 'Of course it's realistic; when a family is faced with reduced income the members of the family must cut spending - our State government must do the same...."

The press release was sent to state newspapers and to all 567 NJ mayors. The cover letter to the mayors began as follows: "The drive by those in Trenton to shift taxing authority from municipal level to state level continues unabated. The renewed push for an income tax is evidence that those in Trenton intend to concentrate power IN Trenton." and concluded "... The Legislature, with a State income tax, will take from local officials much of the 'power to tax' thus rendering municipal governing bodies impotent figureheads. Please let your Legislators know your position on this vital issue."

(NJLP members Ruth Bashlow, Cal Beatty, Phil DeBlock, Steve Enterline, Kathy McAdam, Jane Rehmke, and Bill Schetlick collected about 900 of those signatures. I haven't heard from our other members.)

#### RENE BAXTER LETTER

In his fortnightly economic newsletter, Rene Baxter replied as follows to an irate letter-writer who condemned as illegal and ethically immoral his plan to use silver coins to defer capital

"Repeat after me 25 times: 'I am NOT a sacrificial animal.

I am NOT a sacrificial animal. I am NOT.....'. Legally and morally your right to your life, liberty and property is ABSOLUTE.

In a civilized society ALL human relationships are VOLUNTARY. Since I have no right to your life, liberty or property, there is no way I can delegate that right to any government I may create. Government, according to the Constitution, has only those rights

delegated to it by its citizens.

"THERE IS NO WAY THE GOVERNMENT CAN LEGALLY OR MORALLY ARRO-GATE TO ITSELF THE 'RIGHT' TO YOUR OR ANYONE ELSE'S LIFE, LIBERTY OR PROPERTY. In other words, taxation is THEFT, the draft is SLAVERY, and political liquidation is MURDER.

"You have it exactly backward: if you manage to hold on to

part or all of your property, you aren't 'ripping-off' the government. When the government takes your property at gunpoint (or the threat of it), your fellow citizens, under the fiction of government 'legality' are ripping YOU off. You were not put on earth to serve the state. The state was created to serve you and to protect your rights, not to violate them.
"This point of view is neither 'liberal' nor 'conservative'.

It's libertarian, and a direct response to the steadily increasing power of the American Police State. 
