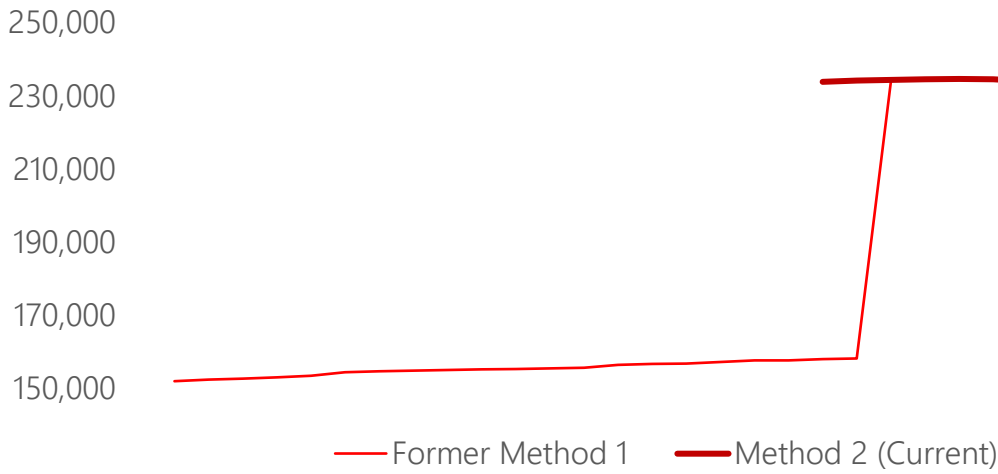

Core membership structure as defined in our Bylaws

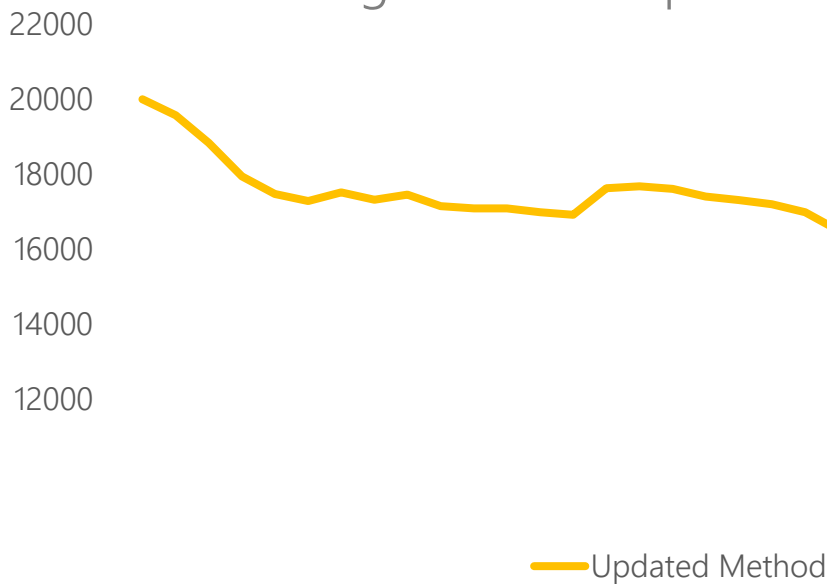

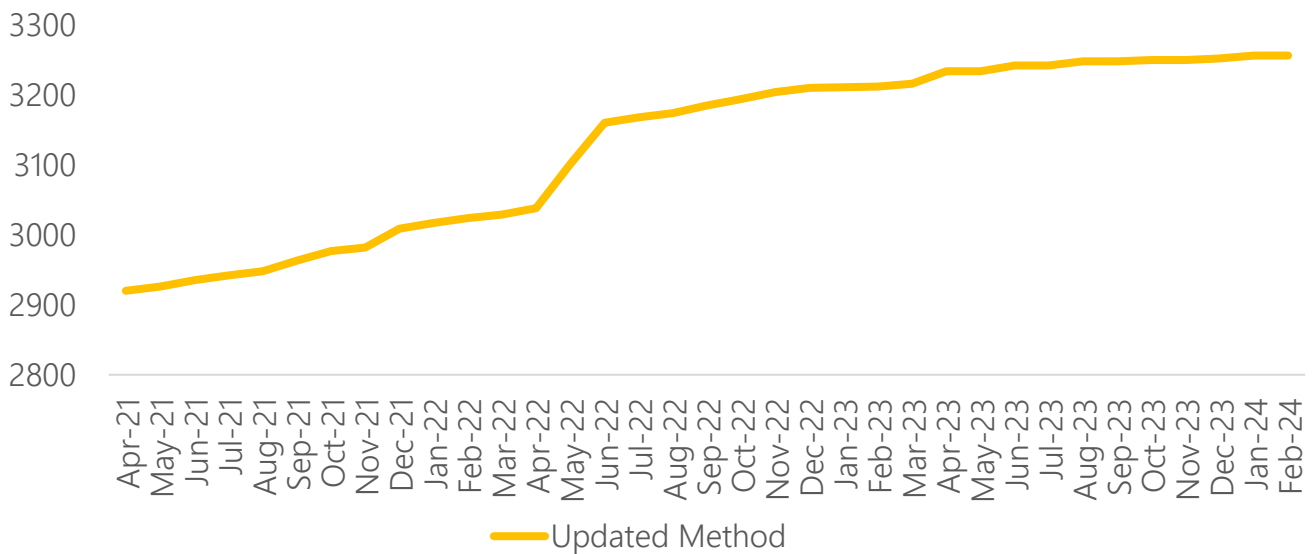
Total Membership through February 2024



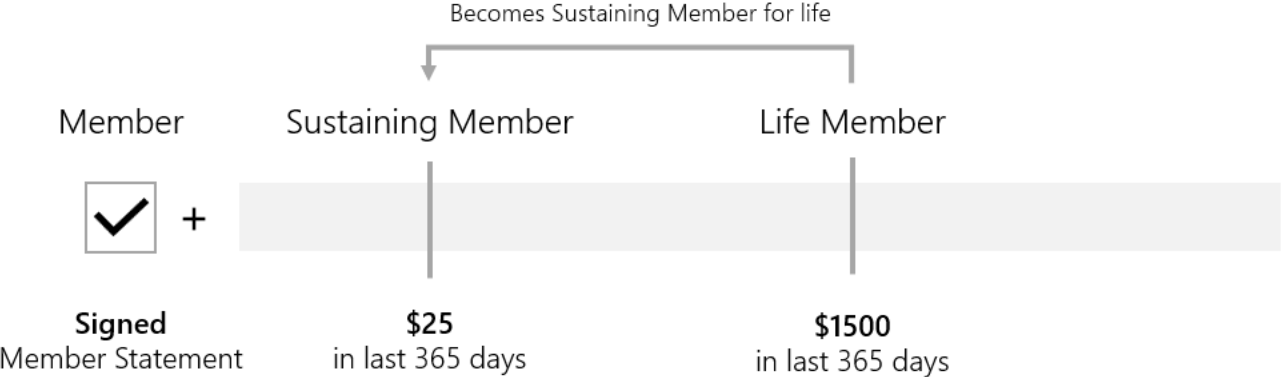
Sustaining Membership through February 2024
