The meeting was called to order at 9:06 p.m. by William Cody Anderson, Chair. Secretary Andrew Kolstee conducted a roll call and determined that a quorum was present.

Motion by Andrew Kolstee to waive reading and approve the minutes of the September 12, 2021 Meeting of the State Committee, the September 13, 2021 Meeting of the Executive Committee, the October 4, 2021 Meeting of the Executive Committee, and the October 27, 2021 Meeting of the Executive Committee was seconded by Pietro Geraci and passed by voice vote.

Empire State Freedom Summit Planning Committee Co-Chair Gabrielle Cordova issued a report. The final financial report is not yet available, but profit is estimated to be around \$6,000. Andrew Kolstee suggested the committee conduct a debrief of the event.

Motion by Paul Grindle to allow the public posting of the recordings of the proceedings for the Empire State Freedom Summit from Friday, November 5, 2021 and Saturday, November 6, 2021 was seconded by Richard Purtell and passed by voice vote.

2022 Statewide Candidates Nominating Convention Planning Committee Co-Chair Andrew Kolstee issued a report in writing (Exhibit 1).

No action was taken regarding a previous motion to constitute a standing Policy Committee.

Motion by Andrew Kolstee to renew the appointment of William Koller as County Contact of Niagara County for a three-month term set to expire on February 23, 2022 was seconded by Duane Whitmer, debated, and passed by voice vote.

Motion by Andrew Kolstee to renew the appointment of Patricia Berthod as County Contact of Oswego County for a three-month term set to expire on February 16, 2022 was seconded by Paul Grindle, debated, and passed by voice vote

Motion by Andrew Kolstee to renew the appointment of Angela Einwachter as County Contact of Steuben County for a three-month term set to expire on February 23, 2022 was seconded by Lora Newell and passed by voice vote.

Motion by Andrew Kolstee to hold a meeting of the full State Committee on Sunday, January 16, 2022 at 7:00 p.m. for the purpose of electing an Elections Oversight Committee, adopting a rubric for the selection of Delegates to the 2022 Libertarian National Convention, and any other business deemed necessary was seconded by Paul Grindle. Motion by Robert Arrigo to postpone the consideration of the question to immediately before adjournment was seconded by Pietro Geraci and passed by voice vote.

Motion by Pietro Geraci to rescind the motion of the October 27, 2021 meeting of the Executive Committee to "hold the Libertarian Party of New York 2022 Statewide Candidates Nominating Convention on the weekend of February 19-20, 2022 in Erie County, New York" was seconded by Lora Newell, debated, and failed to reach the requisite two-thirds to rescind after a roll call vote, with Robert Arrigo, Gabrielle Cordova, Anthony D'Orazio, Pietro Geraci, and Lora Newell voting in favor and Paul Grindle, Andrew Kolstee, Richard Purtell, and Duane Whitmer voting against.

Motion by Pietro Geraci to reimburse Andrew Kolstee \$38.28 for the purchase of stamps for the November 7, 2021 State Committee meeting notice and rules amendments mailer was seconded by Paul Grindle and passed by voice vote.

Motion by Robert Arrigo to call a meeting of the full State Committee to be held within thirty (30) days for the purpose of determining the location of the 2022 Statewide Candidates Nominating Convention was seconded by Paul Grindle and debated. Motion by Andrew Kolstee to amend the motion to read "hold a meeting of the full State Committee on

Sunday, December 5, 2021 at 7:00 p.m." was seconded by Anthony D'Orazio, and passed by voice vote. The original motion to hold a meeting of the full State Committee on Sunday, December 5, 2021 at 7:00 p.m. passed by voice vote.

The postponed motion to hold a meeting of the full State Committee on Sunday, January 16, 2022 at 7:00 p.m. for the purpose of electing an Elections Oversight Committee, adopting a rubric for the selection of Delegates to the 2022 Libertarian National Convention, and any other business deemed necessary was considered and debated. Motion by Andrew Kolstee to amend the motion to read "hold a meeting of the full State Committee on Sunday, January 16, 2022 at 7:00 p.m." was seconded by Robert Arrigo and passed by voice vote. Motion by Andrew Kolstee to amend the motion to read "hold a meeting of the full State Committee on Sunday, January 9, 2022 at 7:00 p.m." was seconded by Paul Grindle and passed by voice vote. Motion by Anthony D'Orazio to postpone the motion to the old business portion of the December 5, 2021 meeting of the full State Committee was seconded by Lora Newell, and passed by voice vote.

Motion by Andrew Kolstee to adjourn was seconded by Lora Newell and passed by voice vote.
