# MINUTES OF THE MEETING OF THE ELECTIONS OVERSIGHT COMMITTEE OF THE LIBERTARIAN PARTY OF NEW YORK HELD ON MONDAY, AUGUST 19, 2024 ON THE ZOOM MEETING APP

The meeting was called to order at 7:15 p.m. by Andrew Kolstee, Chair of the Libertarian Party of New York. It was determined that a quorum was present.

The reading of the minutes of the July 29, 2024 meeting of the Elections Oversight Committee was waived and the minutes were approved without objection.

Judicial District 1 has two (2) seats on the State Committee. New York (Manhattan) held their elections on July 10, 2024 and cast votes for Mark Axinn and Morry Davis. They have subsequently submitted their minutes. Motion by Juan Ayala to certify that Mark Axinn and Morry Davis have been elected to the State Committee representing Judicial District 1 was seconded by Samuel Hordeski and passed without objection.

Judicial District 2 has two (2) seats on the State Committee. Kings (Brooklyn) held their elections on July 17, 2024 and cast votes for Paul Grindle and Gary Popkin. They have subsequently submitted their minutes. Motion by Mark Axinn to certify that Paul Grindle and Gary Popkin have been elected to the State Committee representing Judicial District 2 was seconded by Juan Ayala and passed without objection.

Judicial District 3 has two (2) seats on the State Committee. Ulster County held their elections on July 8, 2024 and cast votes for Justin Carman and Gary Triestman. They have subsequently submitted their minutes. Columbia County held their elections on July 17, 2024 and cast votes for Justin Carman and Evan Lebrecht. They have subsequently submitted their minutes. Schoharie County did not participate in this election. Motion by Mark Axinn to certify that Justin Carman has been elected to the State Committee representing Judicial District 3 was

seconded by Juan Ayala and passed without objection. One vacancy remains in Judicial District 3.

There were no candidates to certify in Judicial District 4. Three vacancies remain in Judicial District 4.

Judicial District 5 has three (3) seats on the State Committee. Onondaga County held their elections on June 26, 2024 and cast votes for Daniel Castello, James Fitch, and Rose Leatherman. They have subsequently submitted their minutes. Oneida County participated in the election, but after the deadline and casted a vote for Amber Nunes. Motion by Mark Axinn to certify that Daniel Castello, James Fitch, and Erinn Rose Leatherman have been elected to the State Committee representing Judicial District 5 was seconded by Robert Schuon, debated, and passed without objection.

There were no further candidates to certify in Judicial District 6.

Judicial District 7 has four (4) seats on the State Committee. Monroe County held their elections on July 11, 2024 and cast votes for Steven Becker, Justin Pelletier, Sean Phelan, and James Ziobro. They have subsequently submitted their minutes. Wayne and Yates Counties did not participate in this election. Motion by James Ziobro to certify that Steven Becker, Justin Pelletier, Sean Phelan, and James Ziobro have been elected to the State Committee representing Judicial District 7 was seconded by Robert Schuon and passed without objection.

Judicial District 8 has five (5) seats on the State Committee. Chautauqua County held their elections on July 15, 2024 and cast votes for Maura Botsford, Andrew Kolstee, Leonard Morlock, Wendi Szabo, and Duane Whitmer. They have subsequently submitted their minutes. Erie County held their elections on July 31, 2024 and cast votes for Maura Botsford, Andrew Kolstee, Leonard Morlock, Wendi Szabo, and Duane Whitmer. They have subsequently submitted their minutes. Motion by Mark Axinn to certify that Maura Botsford, Andrew Kolstee, Leonard Morlock, Duane Whitmer, and Wendi Szabo have been elected to the State Committee representing Judicial District 8 was seconded by Robert Schuon and passed without objection.

There were no further candidates to certify in Judicial District 9.

There were no further candidates to certify in Judicial District 10.

Judicial District 11 has two (2) seats on the State Committee. Queens County held their elections on June 8, 2024 and cast votes for Francisco Olvera and Irwin Mark Weinblatt. They have subsequently submitted their minutes. Motion by Mark Axinn to **certify that Francisco Olvera** 

and Irwin Mark Weinblatt have been elected to the State Committee representing Judicial District 11 was seconded by Robert Schuon and passed without objection.

Motion by Robert Schuon to adopt the Report of the Elections Oversight Committee (Exhibit 1) was seconded by James Ziobro and passed without objection. (Note: The report was amended by Andrew Kolstee to add a notation that State Committee member-elect Leonard Morlock passed away on August 26, 2024).

There were no candidates to certify in Judicial District 12. One vacancy remains in Judicial District 12.

There were no candidates to certify in Judicial District 13. One vacancy remains in Judicial District 13.

Motion by Robert Schuon to **adjourn** was seconded by Juan Ayala and passed without objection.
