As we go to press, OE card reorders and letters are coming in from members saying they like this easy way to spread the LP word. And we've had 5 OE card induced web site hits, one of them with a request for a registration form. But so far we've had no calls for free registration forms.

Psychotherapy As Though Reality Matters

What does it mean to live a good life? A happy and successful life? A virtuous life? A life that we can be proud of?



Don Cormier guarding the First Amendment


