Dear Mr. Detaranto:

We represent the national Libertarian Party and its governing body, the Libertarian National Committee, Inc. This letter is written on their behalf.

We have been advised that you are: (1) holding yourself out to Libertarian Party members, contributors and supporters in the State of Arizona as the Arizona Libertarian Party; (2) using our name "Libertarian Party" as your own verbally, and in fundraising letters and other written publications; (3) soliciting funds for memberships in the national Libertarian Party; and (4) generally attempting to convince government agencies, private institutions and the public that you are the officially designated affiliate of the national Libertarian Party for the State of Arizona.

In fact, the Libertarian Party has not designated you as its affiliate for the State of Arizona, has never licensed the use of its name "Libertarian Party" to you and has not authorized you to solicit and collect funds on its behalf. Your actions constitute misrepresentation, trademark infringement, obtaining money under false pretenses, and theft, and are actionable under numerous federal and state criminal and civil laws.

We demand that you cease these activities immediately. If you do not, the Libertarian Party will have no choice but to take legal action against you.
