Chair Mark Glogowski called the meeting to order at 8:19 p.m. and presented the chair's report. The chair recommended that we convert our filing status with the New York State BOE to a "Type 2" which would (among other things) allow us to function as a PAC. We cannot be a "Type 3" organization as the corporate entity is not a ballot status access party in New York State. We also need to set up a firewall between the corporation and the Libertarian Party of New York Interim State Committee including prohibiting any mutual officers of both organizations.

Treasurer Duane Whitmer reported that a seasonal worker who served as an LPNY petition gatherer filed an unemployment claim and that based upon the rules we should consider contesting it as non meritorious. The matter was deferred pending receipt of additional information.

Secretary William Schmidt called the roll and confirmed that a quorum was in attendance. The minutes of the 5/5/2019 meeting in Rochester are completed and will be distributed shortly.

Chair Mark Glogowski made a motion to reimburse Mr. Whitmer for \$3,002 he expended for a booth for the LPNY at the New York State Fair. Motion carried.

COMMITTEE REPORTS

Conventions: Anthony D'Orazio reported that so far Cattaraugus is the only county to submit a bid for our next convention.

Logo: Fred Cole initiated discussion regarding various options for proposed DBA name changes to the corporate name Free Libertarian Party, Inc. After there was no consensus on a DBA name change, the matter was tabled.

Bylaws: Fred Cole indicated there was nothing new to report on this topic.

PAC Committee: (Vacant) A chair will be appointed.

ISC Liaison: Millie Dordal made a motion to transfer all of our social media accounts and web sites to the LPNY ISC as soon as possible. Motion passed with a request that Chairman Mark Glogowski make arrangements with Jim Rosenbeck to appoint 4 persons from each entity to effect this transfer.

Platform Committee: A motion was passed to dissolve this committee.

Rules Committee: A motion was passed to dissolve this committee.

Outreach Division: A motion was passed to relieve Mark Potwora as chair.

Administrative Division: Mike Dowden as Chairman of IT Committee reported on e-mail security systems in place. He additionally requested volunteers to serve as a Risk Manager for FLP insurance needs

NEW BUSINESS

A motion by Andrew Kolstee was passed to accept the resignations of the following individuals: Jim Rosenbeck as Administrative Director, Rich Purtell as Political Director, Shawn Hannon as Outreach Director, Tony D'Orazio as Youth Outreach Subcommittee Chair, and Brian Waddell as Press Secretary.

A motion was made by Andrew Kolstee to direct Mark Glogowski and Jim Rosenbeck to appoint 4 people (2 from each organization, the FLP and the ISC) to work with the Interim State Committee to prepare for the transfer of all intellectual property from the Free Libertarian Party to the Libertarian Party of New York as recognized by the New York State Board of Election. Motion passed.

A motion was made by Blay Tarnoff to have the FLP approve candidates in counties where there is currently no FLP county committee in existence. The motion was defeated.

The meeting was adjourned at 10:15 p.m.
