Dear All,

Per the notice sent out regarding the hearing to be held on December 19, 2024, the Judicial Committee has compiled a list of questions that would be helpful in disposing of this matter in the most efficient manner. These questions are to both the appellants and respondents, as well as any other interested party that may be able to add clarity.

The questions are as follows:

Regarding the notice sent to the lpca-business@googlegroups.com email list:

- How many individual people receive the emails to this list?
- Is there a list of current recipients, and is there a way to check that against current CA party membership or Neon entries for comparison?
- Is there a way to find out how many people received or read that specific email from that list by October 25th of this year?
- Comparatively, how many members were sent/received the convention announcement email on November 13th?

Concerning precedence (since there seems to be a feeling that the wording of the bylaws lack certain clarity regarding what constitutes notice):

- What has previously been the standard of notice to membership for prior conventions?

- Which method has been used in the past and has it been done before/at the 120 days referenced in the bylaws?

Concerning practicalities:

- Who currently sits on the CA convention committee (as the following questions may be specifically relevant to them)?
- Is there currently a deposit or any kind of financial obligation tying the party to the February 22-23 date - will the Party incur fines or fees for a change?
- Will the hotel/venue be capable of moving it to another date?

We understand that this information might not necessarily be readily available, however it would be helpful to have this information prior to the hearing.
