SENATE BILL 27 provides for \$4,500,000 of your money to be used by the Department of Transportation "for promotion and improvement of transportation facilities and service in order to restrain congestion and enhance mobility for tourists visiting American Bicentennial Historical Sites". The funds will be used, among other things, to distribute brochures and build an aerial cable car across the Schuylkill River at Valley Forge. Wouldn't it be a good occasion to emulate George Washington and take a dinky little boat instead?

SENATE BILL 18 gives the PUC blanket power to regulate Community Antenna Television Systems, while extending to the CATV Company the powers of eminent domain when deemed necessary by the PUC.

HOUSE BILLS 10 & 31, and SENATE BILL 36 create a bureaucracy to establish and maintain a Crime Victims' Compensation Board which would provide compensation not to exceed \$15,000 to innocent victims of crimes, nor to exceed \$20,000 to survivors in the case of the death of the victim. \$200,000 of your money would be appropriated for this act; it hasn't occurred to them yet to make the criminal pay.

ANYONE can get a copy of any bill pending in Harrisburg by writing Legislative Reference Bureau, P. O. Box 1127, Harrisburg 17120. Almost everything under consideration falls under a plank in either the National or State LP platforms. Pending legislation is also a good topic for writing letters-to-the-editor.

#### Miscellany

Govenor Shapp, in his State-of-the-State message to Congress, has announced some impressively bureaucratic goals for 75-76, among which are:

-a drive for a Constitutional amendment to permit a graduated state income tax (establishing a "fairer tax program", of course);

-legislation to establish state control over increasing health care costs by curbing construction or expansion of "unneeded" facilities (and if the law of the State won't solve the problem, we suggest he try the law of supply-and-demand);

-more laws limiting campaign spending(the old get-on-the-band wagon tactic).

The State Executive Committee will be voting this month on a date for the '75 State convention- June 21st has been offered for consideration. Anyone who has a suggestion for a place for said convention should contact State Headquarters with details. The last convention, besides attracting favorable publicity both in and out of the LP, was financially profitable for the host chapter. Highlight of this year's convention will be the election of delegates for the '75 National Convention to be held in New York City in September.

Vivien Kellems, a long-time crusader against unfair taxation, died last month in Santa Monica, California. Ms. Kellens paid only part of her federal income tax from 1967 to 1971 and none for 1972 & 1973. The basis for her refusal was government discrimination by taxing her (a single person) at a higher rate than married individuals. She claimed the government owed her \$83,000 in overpaid taxes and interest accumulating over 20 years "because I couldn't get a husband".

Issue of the Month: ERA RATIFICATION

Only four more state legislatures need to approve the Equal Rights Amendment before it becomes part of the Constitution. Be prepared to take advantage of the occasion with news releases, letters-to-the-editor, and talk show discussions.

Don't hesitate to note the varying degrees of havor the Amendment could cause because of government intervention in a wide range of social activities (e.g., schools, minority hiring regulations, etc.). A good opportunity to discuss individual rights and equality under the law.
