ARTICLES OF INCORPORATION OF LIBERTARIAN NATIONAL COMMITTEE, INC.

To: Department of Consumer and Regulatory Affairs

We, the undersigned natural persons of the age of eighteen years or more, acting as incorporators of a corporation under the District of Columbia Non-Profit Corporation Act [the "Act"] adopt the following Articles of Incorporation for such corporation:

FIRST: Name.

The name of the corporation is the Libertarian National Committee, Inc.

SECOND: Duration.

The period of duration is perpetual.

THIRD: Purposes and Activities.

The purposes for which the corporation is organized are as follows:

- a. The corporation is organized and shall be operated to serve as the operational arm of the Libertarian Party.
- b. In furtherance of this purpose, the corporation shall carry on all functions presently exercised by or hereafter delegated to the Libertarian National Committee by the Libertarian Party and shall have control and management of all the affairs, properties and funds of the Libertarian Party. The operational functions shall include, but not be limited to, the employment of staff, leasing of office space, and contracting with suppliers of goods and services.
- c. The corporation is a political committee defined in 11 C.F.R. section 100.5 (1994) incorporated for the sole purpose of limiting liability pursuant to 11 C.F.R. section 114.12(a)(1994). The corporation shall raise and expend funds to further the policies of the Libertarian Party.

- d. The corporation is organized and operated in accordance with Section 527 of the Internal Revenue Code, as amended, to directly and indirectly accept contributions and make expenditures for the purpose of influencing or attempting to influence the election, nomination, or selection of any individual to any federal, state or local elective public office.
- e. The corporation shall have all other powers to engage in such other activities as may be necessary and proper to accomplish these purposes and the powers now or hereafter granted to non-profit corporations pursuant to the District of Columbia Non-Profit Corporation Act which are not without the scope of this section and Section Four hereof.

FOURTH: Powers.

To further the corporation's purposes, the corporation shall have and shall exercise all powers permitted it by the Act to the fullest extent consistent with all applicable federal, state and local laws. The corporation shall not carry on any other activities not permitted by a corporation whose income is exempt from federal income tax under Section 527 of the Internal Revenue Code, as amended.

FIFTH: Membership.

The corporation shall not have members.

SIXTH: Directors:

The size and manner of election or appointment of the corporation's Board of Directors shall be elected as provided in the Bylaws of the Libertarian Party.

SEVENTH: Corporate Internal Affairs.

Provision for the regulation of the corporation's internal affairs and establishment of its policies shall be provided in its Bylaws.

EIGHTH: Distribution on Dissolution.

Upon dissolution, the Board of Directors, after paying or making provision for the payment of all liabilities, shall arrange for the distribution of all remaining assets to the Libertarian Party.

NINTH: Registered Agent and Office.

The name of the corporation's initial registered agent is the Corporation Service Company and the address of the corporation's initial registered agent in the District of Colombia is 1090 Vermont Avenue, N.W., Suite 910, Washington, D.C. 20005, Telephone 202/371/8090.

TENTH: Applicable Laws. To the extent that any provision in these Articles cites a statute, regulation or other provision of law, it refers to such provisions currently in effect as it may from time to time be amended, replaced or recodified by means of binding legislative or administrative action.

ELEVEN: Initial Directors. The number of Directors constituting the initial Board of Directors is eighteen (18).
