### Brief Biography for Patric R. Brock



I am 58 years old, an only child born in 1951 in Glendale, California to a civil engineer, Robert P. Brock, & a stay-at-home mom, Margaret Rutledge Brock. I grew up in the Orange County town of Seal Beach, but spent the last of my high school days in the southern California desert graduating from Indio High School in Indio, California.

I attended several junior colleges, studying math & drafting at the College of the Desert in Palm Desert & Glendale Junior College. Later I majored electronics at Yavapai College in Prescott, Arizona & Orange Coast College in Costa Mesa, CA.

Living in northern Nevada & northern California I worked in architectural & engineering offices as a draftsman, designing small buildings & plotting surveyor notes as topographic maps.

I moved to Hawaii in 1980, living briefly in Kailua-Kona before moving to Maui. In the early 1980s I installed solar water heating systems & photo-voltaic electrical systems around Maui, later getting a journeyman electrician's license. Utilizing my drafting skills I have drawn the plans for a few Maui houses & later wired the electrical systems.

I have lived in Kihei, Maui for nearly 30 years with the exception of 1987 when I accepted a one-year position with ITT Antarctic Services, a contractor to the National Science Foundation. As Communications Coordinator & electronics repairman I was part of a 9-member team that maintained the United States Antarctic research base, Palmer Station, throughout the austral winter.

In recent years I have combined my plumbing, electrical & electronic experience troubleshooting & repairing swimming pool systems & portable spas on Maui.



I was told that I am direct descendant of Edward Rutledge, signer of the Declaration of Independence, from South Carolina & have considered myself a patriot. During my lifetime I have watched the United States drift away from its fundamental founding principle of empowering & protecting the freedom of the individual. I keep thinking somebody ought to do something about it. My experience has been that things don't get done to my satisfaction unless I do them myself. It now appears that my beloved America may be ruined unless I do something, so I have chosen to run for the United States House of Representatives from the second Hawaii Congressional district.

## Thoughts on Election 2010

With the scant number of Libertarian candidates running this year it is obvious that we still have a ways to go as a political organization. Let's all support Jeff Mallan and Pat Brock in their pursuit of Federal offices and vote for them in our primary. This leaves a lot of races where our choices must be carefully considered. I don't advocate throwing votes around, but I do try to make the best decisions when we have no LP candidate in a race. Sometimes that means not voting on that section of my ballot.

Here are some of my personal opinions.

For the non-partisan Honolulu Mayor's race I will be voting for Panos Prevedouros. This decision I don't make lightly. Both Mr. Caldwell and Mr. Carlisle who also seek this office are well-qualified people whom I perceive to be honest. The bottom line for me is the \$5 billion plus in money that these other two are willing to spend on a train. This is one of the biggest government pork projects anyone of us are ever likely to see. It will drain tax money from our community for generations and provide little real benefits to traffic problems. Although candidate Prevedouros is not a Libertarian he is likely to be the most fiscally responsible choice.

I have been talking to a lot of my friends asking them to please vote for Panos. In the process I have asked about other races. It seems that most my liberal contacts will vote for Abercrombie. The choice between Abercrombie and Hannemann is not one many of us would find desirable. Both men are big spending Democrats. For what it is worth Neil is likely to be more liberal on social issues than Mufi. The LP decided not to put a token into this race, for reasons that involve future considerations that I don't want to go into here. I do think John Carroll who is seeking to beat Duke Aiona in the Republican primary may be the most libertarian person running. At least he has openly pursued our support.

This idea of GOP candidates looking for a libertarian slant to their campaigns has been a much greater feature of 2010 than in any previous election I have been involved in. Obviously it is a positive indicator that the public is finally starting to get it.



# Austrian Economics Camp

Li Zhao Schoolland organized the first China Austrian Economics Camp (CAEC) this summer with Northeastern University (NEU) of Shenyang, China. Teaching about the economics and ethics of free markets were: Tom Palmer of the CATO Institute, Fred Foldvary of Santa Clara University, Cris Lingle of Francisco Marroquin University in Guatemala, Kenli Schoolland of the University of Buckingham in England, Zhu Haijiu of Zhejiang GongShang University in China, Dean Peng of Beijing, and Jeff Crawford & Ken Schoolland of Hawaii Pacific University. Four of these teachers are members of the Mont Pelerin Society, founded after World War II by F.A. Hayek to promote an intellectual resurgence of free market ideas.



Nearly a hundred students signed up for the camp, July 18-25. "This was a remarkable turnout," said Li Schoolland, "considering that the students attended 8 hours of classes and discussions daily during the first week of their summer break! Only a few students missed any classes, and that was only because of conflicts with other summer programs."

NEU provided facilities and accommodations for all students and faculty, Professor Jeff Crawford generously sponsored the travel expenses of most of the faculty, others were sponsored by the International Society for Individual Liberty (ISIL) and the CATO Institute. More than 300 economics books in English and Chinese were donated to the students from various sources: Jim Walsh of Silver Lake Publishing Co., Jim Peron of Laissez Faire Books, and Dick Rowland of the Grassroot Institute of Hawaii (GRIH).

Mark Skousen, author of 20 books translated into Chinese, donated a boxed collection of his books. Each of the hundred students received signed copies of Professor Fred Foldvary's book in English and of Ken Schoolland's book in Chinese. And each student also received the CD "Ideas for a Free Society," a collection of a hundred libertarian classics compiled and produced by Linda Whetstone and the International Policy Network.

The daily program was filled with two large group lectures, two follow-up small group discussion sessions, and four small group lectures with discussions. The students were especially thrilled by the open discussion format, highly unusual in China. Evenings were scheduled with group game contests, debates, documentary films, a talent show, and a closing party celebration. Mornings typically began with swimming at the university pool or Tai Chi in the courtyard. Evenings ended with fabulous dining and exhaustion induced sleep.

From beginning to end, these enthusiastic and brilliant students were eager to practice their English and to engage with their teachers in American-style classes. China is experiencing a stunning market transformation and students are very open to the ideas of Hayek, Mises, and Friedman in contrast to the routine classroom fare of Marx and Keynes. Indeed, these Chinese students seemed to be much more intrigued with free market alternatives than many American students who have taken markets for granted and are too willing to accept central planning.

Two day-time excursions were scheduled to the Forbidden City Summer Palace in Shenyang and museums memorializing the life of General Zhang Xueliang, Li Schoolland's ancestor who was founder and first president of the university. A post camp tour was arranged for faculty to visit the Yalu River bordering on North Korea and the historic regions of Dalian, Weihai, Qingdao, Beijing, and Shanghai. The camp was a spectacular success and every effort is being made to continue it on an annual basis. Many thanks to all who participated and contributed.



## State Special Funds May Hold \$1.4 Billion In Unspent Revenues

Hawaii's taxpayers might be shocked to discover that while numerous voices in and out of the local political establishment are calling for an increase in the General Excise Tax to cover any future budget shortfalls in education or other state services, upwards of \$1.4 billion in unspent excess funds may be sitting in special funds, several of which were tagged by the auditor almost a decade ago for repeal.

According to the Department of Budget and Finance's "Reports on Non-General Fund Information: Fiscal Years 2006-2012," some 186 special funds spread across twenty different departments hold an estimated \$1,412,357,203 in unspent revenues over and above their operational requirements. In plain language, if the estimates provided by the Department are correct, the state has more than just pocket change stuck in its seats.


Until recently, few members of the public were aware of how many special funds existed, what their purpose was or how much money the State of Hawaii was holding in these accounts. For this reason, Grassroot Institute analysts decided to review the Department's worksheets and itemize all the special funds to see just what they contained.
