## **OPENING CEREMONY**

### **CALL TO ORDER**

Chair Wayne Harlos called the meeting to order at 8:00 a.m. The meeting location was the Lily Farm Fresh Event Center in Keenesburg, Colorado.

## **BOARD REPORTS**

Board reports were heard while awaiting the official initial Credentials Report. The only report that was not heard was from the Fundraising Director who was not present until later in the day.

## **INITIAL CREDENTIALS REPORT**

Credentials Chair John Kaufman reported 133 credentialed delegates. The names were displayed on the screen. A motion to approve the Credentials Report **PASSED UPON A SHOW OF HANDS.**

## **ADOPTION OF AGENDA, CONVENTION STANDING RULES, AND INTRODUCTIONS OF CONVENTION OFFICIALS**

The proposed business agenda is attached hereto as **Appendix A.**

Bette Rose Ryan moved to move the Board elections until after the partisan nominations which **FAILED.**

Adam Shuknecht moved to add consideration of a resolution on an official Bylaws interpretation after appointment of convention officials. The resolution was read at this time. This agenda amendment **PASSED UPON A SHOW OF HANDS.**

The agenda, as amended, **PASSED WITHOUT OBJECTION.**

The Convention Oversight Committee and Convention Officials were introduced. Marc Goddard served as the Convention Parliamentarian.

Mike Seebeck presented the proposed convention standing rules (attached hereto as **Appendix B**) which **PASSED WITHOUT OBJECTION.**

## **CONVENTION RESOLUTION**

Adam Shuknecht moved the following Resolution:

**WHEREAS**, the Colorado Bylaws passed last convention which created the Judicial Committee limit its jurisdiction to specifically listed matters including “appeals from Board decisions”;

**WHEREAS**, the Colorado Bylaws further state that all decisions of the Judicial Committee must be in accordance with the Bylaws;

**WHEREAS**, the Colorado Bylaws have adopted Robert’s Rules of Order 12<sup>th</sup> edition as its parliamentary authority;

**WHEREAS**, Robert’s Rules of Order 12<sup>th</sup> edition defines what a decision of the Board is as follows in 1:6;

*The basic principle of decision in a deliberative assembly is that, to become the act or choice of the body, a proposition must be adopted by a majority vote; that is, direct approval—implying assumption of responsibility for the act—must be registered by more than half of the members present and voting on the particular matter, in a regular or properly called meeting of the body.*

**BE IT THEREFORE RESOLVED BY THE ASSEMBLED DELEGATES IN CONVENTION OF THE LIBERTARIAN PARTY OF COLORADO**, that the Judicial Committee has no jurisdiction over matters under the guise of “Board decisions” which were not propositions addressed as main motions that were either temporarily or permanently disposed of by at least a majority vote of the Board in a regularly or properly called meeting of the Board.

The Resolution ***PASSED UPON A SHOW OF HANDS.***

## APPENDIX B – PROPOSED CONVENTION STANDING RULES

### 1. Organization of the Convention

- A. The Party Chair or their appointed designee shall serve as the Convention Chair (“Chair”).
- B. The Chair shall begin the Convention promptly at the time published in the Call to Convention.
- C. The first general orders of business shall be:
  - a. Call to Order
  - b. Introductions of the Convention Chair, Convention Secretary (“Secretary”), Parliamentarian, and Credentials Committee Chair
  - c. Credentials Committee Report (see below)
  - d. Declaration of Quorum
  - e. Approval of Convention Rules
  - f. Approval of Agenda (see below)
- D. Immediately upon Approval of the Agenda, the Chair shall appoint the following Convention Officials:
  - . Timekeeper
  - a. Teller Team
  - b. Sergeant-at-Arms
  - c. Any other Convention Officials as needed.
- E. The Credentials Committee Chair shall report the number and the names of all Delegates registered as present with proper credentials. The list of the names of the Delegates shall be posted or projected in lieu of being read, and the Delegates shall be afforded time to verify the completeness and accuracy of the list, whereupon the report shall be adopted by majority vote. Quorum shall be fixed at the next whole number greater than exactly half of the number of Delegates reported by the Credentials Committee. The Credentials Committee will provide an updated report at times indicated on any approved Convention Agenda. Such update shall only include changes from the initial report.
- F. The Chair shall report on the Agenda, which may be amended by majority vote and shall be adopted by majority vote. After adoption, the Agenda may only be amended by a two-thirds (2/3) vote to suspend the rules and amend the Agenda.

### 2. Conduct Within the Meeting Room

- A. While in the business meeting, Delegates shall be required to display their appropriate credentials issued by the Credentials Committee upon registration.
- B. No person shall disturb materials placed at a Delegate seat without said delegate’s permission.
- C. No person shall speak to the body or to the Chair except upon recognition by the Chair or in accordance with parliamentary procedure.
- D. The Chair shall regulate the proceedings at all times so as not to outpace the Recording Secretary.
- E. No Delegate shall speak in debate more than twice on any debatable motion on the same day, for no more than one (1) minute each time, without permission of the Delegates granted by a majority vote, with said vote to be taken without debate.
- F. The maker of a main motion (including Committee report presenters) shall have the right to speak last for no longer than two (2) minutes even after debate is closed.

### **3. Director Nominations and Balloting**

A. The Chair shall announce which Director positions are open for election in the order in which they appear in the Bylaws (*listed here, see Bylaws Article VI, Section 2, subsection (b), this order of 2-year terms can't be amended is unamendable*). The list of the names of the candidates for Director positions shall be posted or projected in lieu of being read. Director positions to be elected to full terms shall be elected first, followed by Director positions to be elected to complete a term:

- a. Outreach Director (2-year term)
- b. Secretary (2-year term)
- c. Legislative Director (2-year term)
- d. Treasurer (2-year term)
- e. Fundraising Director (2-year term)
- f. Campaigns Director (1-year term)
- g. Communications Director (1-year term)

B. Nominations and/or declarations, nominating speeches, and elections shall take place in the order outlined above. "None of the Above" is always a voting choice but is not considered to be a candidate. A nominating speech for "None of the Above" (NOTA) may be offered for any Director position. The total duration of candidate and nominating speeches for each candidate (and also for NOTA) shall be no longer than five (5) minutes. Speech order between candidates for a position shall be determined by random draw.

C. Voting for Director positions shall be conducted via the following method:

- . For each ballot for a Director position, each Delegate shall vote for either one (1) candidate or for NOTA. Voting for both one (1) candidate and for NOTA, or for more than one (>1) candidate, shall disqualify the ballot.
  - a. Upon tallying the ballots, if one (1) candidate or NOTA does not earn a majority of the votes cast, the lowest vote-earner (excluding NOTA) shall be dropped from the next ballot. Candidates so dropped shall have, if they desire, one (1) minute to speak. Balloting will continue in this manner until one (1) candidate or NOTA earns a majority. If one (1) candidate earns a majority, they are elected to that Director position.
  - b. If NOTA earns a majority, then the Director position shall be reopened to new nominations, except that the candidates previously running shall be ineligible. If no candidate wins a majority on this second round of voting, the position shall remain vacant and be filled by the Board in accordance with the Bylaws.
  - c. NOTA will always be included as an option, but is not considered to be a candidate.

D. Should a written ballot be required, the candidates (or NOTA) that the Delegates choose to vote for shall be written in by the Delegates on the ballots they receive. Delegates shall legibly print their name and choices and sign each of their ballots. Any ballot with an illegibly-printed names or choices shall be disqualified.

### **4. Partisan Public Office Nominations and Balloting**

A. The Campaigns Director shall include in his report-and announce a list of partisan public offices open for election in the order listed on the Agenda. Nonpartisan offices shall not be included.

- B. The Secretary shall cause to be projected the offices in the order as they appear in the Agenda.
- C. Nominations and/or declarations, nominating speeches, and elections shall take place in the order outlined in the Agenda. The total duration of candidate and nominating speeches and questions for each candidate shall be no longer than four (4) minutes. A nominating speech for NOTA may be offered for any public office.
- D. Voting for partisan public office positions shall be conducted via the following method:
- a. For each ballot for a nomination for a partisan public office, each Delegate shall vote for as many candidates as they wish, or for NOTA, using approval voting. Voting both for candidate(s) and for NOTA shall disqualify the ballot.
- b. Upon tallying the ballots, if no candidates earn at least 30% of the votes cast, the lowest vote-earner (excluding NOTA) shall be dropped from the next round of voting. Candidates so dropped shall have, if they desire, one (1) minute to speak. Balloting will continue in this manner until at least two ( $\geq 2$ ) candidates earn at least 30% of the vote, or if only one (1) candidate or NOTA earns a majority. If at least two ( $\geq 2$ ) candidates earn at least 30% of the vote, they shall be designated for primary election (*required per CRS 1-4-1304(b)(II) and (c)*). If only one (1) candidate earns a majority, they shall be the nominee for the general election.
- c. If NOTA earns a majority, then the partisan office shall be reopened to new nominations for one (1) additional round of voting, except that all candidates previously running shall be ineligible. If NOTA earns a plurality, then there will be no candidate for that race for the general election (*unamendable, see Bylaws Article IX, Section 3, subsection (g)*). If at least two ( $\geq 2$ ) candidates earn at least 30% of the vote, they shall be designated for primary election (*required per CRS 1-4-1304(b)(II) and (c)*). If only one (1) candidate earns votes greater than 30% and greater than NOTA, they shall be the nominee for the general election.
- d. NOTA will always be included as an option, but is not considered to be a candidate.
- E. Should a written ballot be required, the candidate(s) (or NOTA) that the Delegates choose to vote for shall be written in (if necessary or not pre-printed) by the Delegates on the ballots they receive, using the approval voting process (*this approval voting process is unamendable or suspendable as it is in the Bylaws, see Article IX, Section 3, subsection (e)(1)*). Delegates shall legibly print their name and choices (if necessary) and sign each of their ballots. Any ballot with an illegibly-printed names or choices shall be disqualified.
- F. For each ballot for a nomination, each Delegate shall vote for as many candidates as they wish using approval voting, or for NOTA, but not both. Voting for both candidate(s) and for NOTA shall disqualify the ballot.

## **5. Nomination and Election of National Convention Delegates and Alternates**

- A. Delegates and Alternates to the National Convention shall be elected in the manner outlined in the Bylaws.
- B. The Party Chair shall announce the number of National Convention Delegates (up to 35) and Alternates (up to 50) to be elected by the state Convention Delegates. (*unamendable, this is Article IX, Section 4, subsection (c)*).
- C. Nominations for National Convention Delegates shall be received from the floor with no seconding required. Members may nominate themselves. Each state Convention Delegate in attendance at the state Convention shall cast a single a single vote for each National Convention Delegate candidate of their choice by submitting a signed ballot prepared by the Board for this purpose. The total votes cast on a ballot by each state Convention Delegate shall not exceed the number of National Convention Delegates to be elected. . National Convention Delegates shall be elected by a majority of the state Convention Delegates voting. Subsequent



ballots shall be taken as necessary to fill any remaining National Convention Delegate slots. In the event that there are more candidates receiving a majority vote than there are National Convention Delegate slots to be filled, those candidates receiving the highest vote totals shall be elected. No elections by slate shall be permitted. *(unamendable, this is Bylaws Article IX, Section 4, subsection (d)).*

D. After the National Convention Delegates are elected, National Convention Alternates shall be selected using the same procedure as used for selecting National Convention Delegates. *(unamendable, this is Bylaws Article IX, Section 4, subsection (e)).* Nominees for National Convention Delegates that did not get elected as National Convention Delegates shall be automatically nominated to be National Convention Alternates. Additional nominations may also be made.

E. A ballot shall be disqualified if the total votes cast on a ballot exceeds the number of National Convention Delegates (35) or Alternates (50) to be elected.

F. Delegates shall legibly print their name and choices (if necessary or not pre-printed) and sign each of their ballots. Any ballot with an illegibly-printed names or choices shall be disqualified.

## **6. Reports**

A. All reports and other material for the permanent record or printed proceedings shall be in an acceptable commonly-used electronic format and shall be sent to the Recording Secretary prior to presentation.

B. Board reports, including questions from the Delegates, shall be limited to four (4) minutes for each Director.

## **7. Notices for Announcements**

Notices for announcement to the Convention shall be in an acceptable electronic format or legibly printed and signed by the person (or a proper representative of the persons) under whose authority the announcement is issued and shall be sent to the desk of the Recording Secretary.

## **8. Minutes**

Draft minutes will be posted to the Party website within sixty (60) days of adjournment sine die of the Business Session of the Convention for Member comment. Convention minutes shall be approved by the Board within ninety (90) days of adjournment sine die of the Business Session of the Convention.

## DELEGATE VOTING SHEET INSTRUCTIONS AND TIPS

This election is conducted via Approval Voting. This means that you can select as many people as you approve of **UP TO 35**. Please pay careful attention to that number. You can choose less if you wish but if you pick more **your ballot will be invalidated**. So before turning in the ballot please double check that you picked no more than 35 candidates. If you choose NOTA (which will always remain on the ballot) you **cannot choose any other candidates and if you do, you will invalidate your ballot**.

Also, it is required that the ballot have your handwritten legible name and signature. If the name is not legible, this may disqualify your ballot.

If you have any questions at all, please ask a member of the Teller team or the Convention Secretary Caryn Ann Harlos before turning in your ballot at the designated time or station. Do NOT fold your ballot in with anyone else's ballot.

It takes a majority vote for any candidate to be eligible for a seat. If more than 35 delegates get a majority, the ones with the most votes will fill the seats until all 35 are filled. Those who have a majority but are not in the top 35 **are not automatically** alternates. There is a separate ballot for alternates. Everyone who does not win a primary seat is automatically on the alternate ballot unless they ask to be excluded. Additional names can be nominated for the alternate ballot.

Write-ins are also always allowed.

If we do not fill our delegation, and there are not enough available alternates at convention, the Colorado delegation can vote to seat people who show up at the convention that are otherwise qualified unless they already were voted on at delegation and did not get a majority in either the primary or alternate ballot. At the national convention, alternates are seated in order of rank with rank being determined by the number of votes. Ties are broken randomly.

## ALTERNATE DELEGATE VOTING SHEET INSTRUCTIONS AND TIPS

This election is conducted via Approval Voting. This means that you can select as many people as you approve of **UP TO 50**. Please pay careful attention to that number. You can choose less if you wish but if you pick more **your ballot will be invalidated**. So before turning in the ballot please double check that you picked no more than 50 candidates. If you choose NOTA (which will always remain on the ballot) you **cannot choose any other candidates and if you do, you will invalidate your ballot**.

Also, it is required that the ballot have your handwritten legible name and signature. If the name is not legible, this may disqualify your ballot.

If you have any questions at all, please ask a member of the Teller team or the Convention Secretary Caryn Ann Harlos before turning in your ballot at the designated time or station. Do NOT fold your ballot in with anyone else's ballot.

It takes a majority vote for any candidate to be eligible for a seat. If more than 50 delegates get a majority, the ones with the most votes will fill the seats until all 50 alternate seats are filled. All persons who were not selected in the primary delegate round are automatically included on the alternate ballot and additional nominations are permitted. Write-ins are also always allowed.

If we do not fill our delegation, and there are not enough available alternates at convention, the Colorado delegation can vote to seat people who show up at the convention that are otherwise qualified unless they already were voted on at delegation and did not get a majority in either the primary or alternate ballot. At the national convention, alternates are seated in order of rank with rank being determined by the number of votes. Ties are broken randomly.
