The meeting was called to order at 10:24 p.m. by William Cody Anderson, Chair. The Credentials and Nominations Report (Exhibit 1) indicated that there were 57 voting members at the time the meeting was called to order. Resignations since the previous meeting were recognized: Sean Stevens on April 13, 2021 as a member from Judicial District 5 (Exhibit 2), Andrew Hollister on May 2, 2021 as a member from Judicial District 7 (Exhibit 3), Ilya Schwartzburg on June 18, 2021 as a member from Judicial District 1 (Exhibit 4), and Kari Bittner on July 2, 2021 as a member from Judicial District 5 (Exhibit 5). A roll call of voting members was conducted by Andrew Kolstee, Secretary.

43 of 57 Members of the State Committee were present at the time of roll call, with 34 attending in-person and 9 attending remotely via the Zoom Meeting App. Gary Popkin later entered the meeting.

The Chair issued welcoming remarks.

Fundraising Committee Co-Chair Gabrielle Cordova issued a report. Over \$5,000 was raised for the cocktail fundraiser held on Saturday, July 18, 2021. The Fundraising Committee is preparing for fundraising activities for the State Committee meeting that will be held the weekend of November 5-7, 2021 in Syracuse. The LPNY Store is also up and running. For the month of June 2021, a total of \$2,809 was raised.

Local Affiliate Development Committee Chair Robert Arrigo issued a report. The committee's focus in recent months has been to work on maintaining and growing stronger county affiliates. The party resources page has been developed with resources for local leaders. Monthly trainings have been held for county leaders and county contacts.

Legislative Affairs Committee Chair Richard Purtell issued a report. The committee has been focusing on issues regarding the government response to COVID-19. The committee is also in need of a Second Amendment activist.

IT Committee Chair Andrew Kolstee issued a report. The website continues to be updated with a recent call for updates from county affiliate leaders. The LPNY Discord Server was displayed to the meeting and will become the official collaboration and messaging platform for the Libertarian party of New York on August 1, 2021.

Public Engagement Committee Chair Anthony D'Orazio issued a report. The committee continues to distribute press releases. Recently there has been more focus with social media outreach on Facebook, with new people brought in to help. The Twitter account is more active, with Lisa Gansky recently promoted to help manage the account. Maura Botsford continues to manage the Instagram account. Recently, the Libertarian Party of New York began a presence on Clubhouse, and the meeting is also being broadcast there and YouTube. Maura Botsford will be working on the Young Engagement Subcommittee. In November 2021, Spike Cohen will headline a tour of New York colleges.

Special Rules of Order of the Libertarian Party of New York for the State Committee Meeting of July 18, 2021

As adopted by the State Committee on July 18, 2021.

Rule 1. **CREDENTIALS.** The Secretary, directly after the opening ceremonies of the business meeting, shall call the roll of the elected members of the State Committee.

Rule 2. **IDENTIFICATION OF VOTING MEMBERS.** To facilitate identification, seating, and voting, members and others shall be required to retain and display upon request the wristbands, voting cards, or other indicia issued by the organizers of the meeting upon registration. Division votes, whether simple or counted, shall be taken by members' standing and display of such voting member indicia. For meetings held by teleconference, voting members shall be identified within the platform or platforms used to conduct the meeting.

Rule 3. **DEBATE.**

- Rule 3.1. No member shall speak in debate on the same question a second time until every other member who wishes to speak had the opportunity to do so.
- Rule 3.2. No member shall speak in debate on the same question more than twice or longer than three (3) minutes in total without permission of the State Committee granted by a two-thirds vote without debate.
- Rule 4. **FILLING OF VACANCIES.** Vacancies on the State Committee shall be done in a manner as described in this Rule and in accordance with the Rules of the Libertarian Party.
- Rule 4.1. Nominations for vacancies on the State Committee may be submitted by any member of the State Committee. If such nominations are received by the Secretary at least seven (7) days in advance of the meeting, the Secretary shall distribute the names of the nominees and any statement regarding their candidacy to all members of the State Committee at least five (5) days in advance of the meeting in which vacancies are to be voted upon. Once the filling of vacancies begins, the Secretary shall present the nominations they received and all such qualified candidates that accepted the nomination shall be entered into nomination. Subsequent nominations may be made on the floor prior to the election to fill such vacancies. The Chair shall request that each nominee confirm that they are qualified to fill the vacancy and accept the nomination in order to be entered into nomination to fill the vacancy they seek.
- Rule 4.2. For each district, the ballot shall contain all the names of the eligible nominees and identify the number of vacancies in the district. Each ballot shall contain NOTA as a candidate.
- Rule 4.3. The election shall be held with approval voting and candidates with the most votes shall be elected to fill the vacancy or vacancies as long as they have received a majority of the vote of the voting members. If there is a tie in which two or more candidates have received a majority of the vote of the voting members and at least one vacancy still exists, an instant run-off vote shall occur. If NOTA receives a majority of the votes, there will be a new round of nominations and a new election, in which all of the nominated candidates who were outpolled by NOTA are ineligible.

Rule 4.4. Members of the Libertarian Party chosen to fill vacancies on the State Committee shall not be allowed to participate in the meeting until acceptance of the quorum report of the Secretary by the State Committee, scheduled to occur after the filling of vacancies; and in particular may not nominate, speak, or vote in any contested election for filling additional vacancies.

Rule 4.5. If there is no candidate to fill a vacancy for a particular district, the Chair may move to the next district or item on the agenda.

Rule 5. ADOPTION AND AMENDMENT OF PARTY RULES.

Rule 5.1. All proposed amendments of the Party Rules must be submitted in accordance with the Rules of the Libertarian Party.

Rule 5.2. The Rules Committee may, prior to the consideration of any other amendment, present a report that includes any recommended amendments to the Party Rules, including those submitted to the Secretary. This report may include any motion to adopt amendments recommended by the Rules Committee as a whole, as long as such amendments were distributed to the State Committee in accordance with the Rules of the Libertarian Party. Any motion to divide such motion shall be in order.

Rule 5.3. Subsequent amendments not recommended by the Rules Committee shall be presented by the Secretary as long as such amendments were received by the Secretary and distributed to the State Committee in accordance with the Rules of the Libertarian Party. The Secretary shall present such amendments in the order they were received, alternating between different authors, if such authors are proposing multiple amendments, in the order that the Secretary received them.

Rule 5.4. If discussion on an amendment has begun, any recognized speaker may also discuss alternative proposed amendments that deal with the same issues and may use that text to propose a substitution to the current amendment.

Rule 5.5. If a member of the State Committee proposes more than one amendment, their subsequent proposals shall be taken up only after every other member's first proposed amendment has been considered.

Rule 5.6. Debate on each amendment shall be limited to ten (10) minutes. Each speaker is limited to one (1) minute at a time. The Chair shall alternately recognize those speakers in favor of and opposed to the amendment.

Rule 6. ELECTIONS.

Rule 6.1. **GENERAL.** Elections of party offices shall be conducted by election in accordance with this rule. Such offices shall include the officers (Chair, 1st Vice-Chair, 2nd Vice-Chair, Secretary, and Treasurer), Members-At-Large of the Executive Committee, and the filling of vacancies of any of those offices, including members of the State Committee.

- Rule 6.2. **NOMINATIONS TO FILL VACANCIES.** Nominations to fill any vacancy in any party office may be submitted by any member of the State Committee to the Secretary in advance of the meeting or on the floor at the meeting.
- Rule 6.2.1. **SUBMISSION OF NOMINATIONS IN ADVANCE.** If such nominations are submitted to the Secretary at least seven (7) days in advance of the meeting, the Secretary shall distribute the names of the nominees and any statement regarding their candidacy to all members of the State Committee at least five (5) days in advance of the meeting in which vacancies are to be voted upon. Once the filling of vacancies begins, the Secretary shall present the nominations they received and all such qualified candidates that accepted the nomination shall be entered into nomination.
- Rule 6.2.2. **SUBMISSION OF NOMINATIONS FROM THE FLOOR.** Subsequent nominations may be made from the floor prior to the election to fill any vacancy. The Chair shall request that each nominee confirm that they are qualified to fill the vacancy and accept the nomination in order to be entered into nomination to fill the vacancy they seek.
- Rule 6.3. ELECTION PROCEDURES.
- Rule 6.3.1. **ELECTIONS BY ELECTRONIC MEANS.** All elections of the Executive Committee shall be conducted as a secret ballot using an electronic system that batches the ballots of in-person and teleconferencing participants together.
- Rule 6.3.2. **BALLOTS.** For each office, the ballot shall contain all the names of the eligible nominees and identify the number of positions to be filled in that office.
- Rule 6.3.3. **NONE OF THE ABOVE ("NOTA") AS A CANDIDATE.** All ballots in all elections shall have "None of the Above" ("NOTA") as an option. This option is to be explicitly mentioned as valid when listing the candidates for the election. If NOTA receives a majority of the votes in any given election, there will be a new round of nominations and a new election, in which all of the nominated candidates who were outpolled by NOTA are ineligible.
- Rule 6.3.4. **ORDER OF ELECTIONS.** Elections of each party office shall be held individually in the following order, if such election is required by the agenda: Members of the State Committee, Chair, 1st Vice-Chair, 2nd Vice-Chair, Secretary, Treasurer, and Members-At-Large of the Executive Committee.
- Rule 6.3.5. **MANNER OF ELECTION.** All elections shall be held with approval voting and the candidate or candidates with the most votes shall be elected to fill the party office or offices as long as they have received a majority of the vote of the voting members. If an insufficient number of candidates receive a number of votes equal to or greater than a majority of the number of ballots cast, another round of voting shall immediately occur.
- Rule 6.3.5.1. **SUBSEQUENT ROUNDS OF VOTING.** In the subsequent round of voting, the candidate that received the lowest number of votes in the previous round shall be removed from the ballot. If there

was a tie for the smallest number of votes, no candidate shall be removed from the ballot. Subsequent rounds of voting shall be conducted until the party office is filled.

Rule 6.3.5.2. **ELECTION OF MEMBERS-AT-LARGE OF THE EXECUTIVE COMMITTEE.** In any election for Members-At-Large of the Executive Committee, only the candidate with the highest number of votes from a Judicial District shall be elected. There shall be no more than one Member-At-Large elected from a Judicial District. Once a candidate is elected as a Member-At-Large of the Executive Committee, any other candidate residing in that Judicial District shall be disqualified and removed from any subsequent ballot.

Rule 6.3.6. **TIES.** If there is a tie in which two or more candidates have received the same number of votes of the voting members in which there is a majority and at least one party office remains to be filled, an instant run-off election shall occur, in which the candidates who tied shall be the only candidates on the ballot. If votes gained by candidates remain unchanged in two successive rounds of voting, then all those candidates shall be dropped from the ballot.

Rule 6.4. **SEATING OF NEW MEMBERS ON THE STATE COMMITTEE.** Members of the Libertarian Party chosen to fill vacancies on the State Committee shall not be allowed to participate in the meeting until acceptance of the quorum report of the Secretary by the State Committee and in particular may not nominate, speak, or vote in any contested election for filling additional vacancies.

Rule 7. CANDIDATE SPEECHES.

Rule 7.1. Candidates for Chair shall each be allowed five minutes to speak; candidates for all other Party offices shall each be allowed three (3) minutes to speak. Candidates to fill vacancies on the State Committee shall be allowed one minute to speak. Candidates may cede their time only to other members of the State Committee to speak on their behalf during their allotted time. Speeches will not be allowed for uncontested positions, in which candidates are only running against NOTA.

Rule 7.2. Candidates seeking endorsement for the highest public office shall each be allowed five minutes to speak; candidates seeking endorsement for all other public offices shall each be allowed three minutes to speak; candidates seeking endorsement for any public office shall also each be allowed one nominating speech and one seconding speech of one minute each.

Rule 8. **ENDORSEMENTS OF CANDIDATES.** Endorsements of candidates for public office shall be made in the same manner as elections for Party office, except that endorsements shall require a two-thirds (2/3) majority. Each office shall be filled with one election, even if that office has more than a single position to be filled. Each election shall consist of a series of ballots. In each ballot, voters may vote for as many candidates as there are positions for the office still open or "None of the Above". If None of the Above achieves a majority, a new election shall be held for the open positions still remaining and the candidates who were outpolled by None of the Above shall be ineligible; otherwise, those who achieve the requisite majority shall be recognized as elected, in order of their vote totals and in order of the length of term. The candidate receiving the fewest votes shall be eliminated from succeeding ballots. Ties shall be resolved by a separate ballot.

Rule 9. **PLATFORM.** When discussing the Platform, the previously adopted Platform shall be the base on which amendments, additions, or deletions shall be offered. Such changes to the Platform shall require a vote in accordance with the Rules of the Libertarian Party.

Rule 10. RESOLUTIONS.

Rule 10.1. A resolution offered by an individual member shall be submitted by the maker and the seconder – each of whom shall be a member of the State Committee – and shall be sent by email directly to the Secretary.

Rule 10.2. The Resolutions Subcommittee may convene during the main meeting to consider resolutions. Each member who offers a resolution shall be given an opportunity to explain it to the Resolutions Subcommittee if he so requests.

Rule 10.3. The Resolutions Subcommittee shall review all resolutions in the order they were submitted, and shall amend the text of each resolution to the satisfaction of the member that submitted the resolution, while satisfying formatting requirements, grammar, clarity, etc. The Resolutions Subcommittee shall present a report to the State Committee of all resolutions in the order they deem appropriate.

Rule 11. **PERMANENT RECORD.** All reports and other material for the permanent record or printed proceedings shall be typewritten and, immediately on presentation, shall be sent to the Recording Secretary in electronic form.

Rule 12. **ANNOUNCEMENTS.** Notices for announcement to the convention shall be in writing, signed by the person (or a proper representative of the persons) under whose authority the announcement is issued, and shall be sent to the desk of the Recording Secretary.

Rule 13. SUSPENSION OF SPECIAL RULES OF ORDER. These Special Rules of Order may only be suspended by a two-thirds (2/3) vote.

REPORT OF THE RULES COMMITTEE OF THE LIBERTARIAN PARTY OF NEW YORK FOR THE STATE COMMITTEE MEETING OF SUNDAY, JULY 18, 2021

The following proposals have been recommended by the Rules Committee for adoption by the full State Committee for the meeting of Sunday, July 18, 2021. This report includes all or part of each rule and the proposed amendments, either striking (indicating strikeout in red) or inserting (indicated in green). [...] indicates omitted text within the articles in which no amendments are proposed.

PROPOSAL 1 (BO). Simplify article to only include objective, with reference to support of Party Platform.

Article 4. Principles and Objectives

- 4.1. The Libertarian Party is a political party which has as its whose primary objective is the extension of individual liberty to its furthest limits. To that end the party affirms the following principles as embodied in the party platform. election to public office of enrolled members of the Libertarian Party who support its principles and objectives as expressed in the Party Platform.
- 4.1.1. Each individual possesses the inalienable right to life, liberty and justly acquired property.
 4.1.2. No person or institution, public or private has the right to initiate the use of force or fraud against another.
- 4.1.3. Individuals are entitled to choose their own lifestyles so long as they do not forcibly interfere with the lives of others.
- 4.1.4. The only moral purpose of government is the preservation of individual rights.
- 4.1.5. The voluntary exchange of goods and services is essential for a free and prosperous society of diverse beliefs.
- 4.2. In recognition of the fact that the initiation of force by government has been the chief instrument for the expropriation of individual rights and freedom, the Libertarian Party enters the political arena for the avowed purpose of eliminating the intervention of government in moral, social and economic affairs by functioning as a libertarian political entity separate and distinct from all other political parties or movements and moving public policy in a libertarian direction as a political party that elects Libertarians to office.

On ballots with the ability to vote for two or more candidates, where one or more candidates are supported, the designation of NOTA on the ballot will be ignored.

- 9.2.2. **SUBMISSION OF NOMINATIONS FROM THE FLOOR.** Subsequent nominations may be made from the floor prior to the election to fill any vacancy. The Chair shall request that each nominee confirm that they are qualified to fill the vacancy and accept the nomination in order to be entered into nomination to fill the vacancy they seek.

9.3. ELECTION PROCEDURES.

- 9.3.1. **ELECTIONS BY ELECTRONIC MEANS.** All elections of the Executive Committee shall be conducted as a secret ballot using an electronic system that batches the ballots of inperson and teleconferencing participants together.
- 9.3.2. **BALLOTS.** For each office, the ballot shall contain all the names of the eligible nominees and identify the number of positions to be filled in that office.
- 9.3.3. **NONE OF THE ABOVE ("NOTA") AS A CANDIDATE.** All ballots in all elections shall have "None of the Above" ("NOTA") as an option. This option is to be explicitly mentioned as valid when listing the candidates for the election. If NOTA receives a majority of the votes in any given election, there will be a new round of nominations and a new election, in which all of the nominated candidates who were outpolled by NOTA are ineligible.
- 9.3.4. **ORDER OF ELECTIONS.** Elections of each party office shall be held individually in the following order, if such election is required by the agenda: Members of the State Committee, Chair, 1st Vice-Chair, 2nd Vice-Chair, Secretary, Treasurer, and Members-At-Large of the Executive Committee.
- 9.3.5. **MANNER OF ELECTION.** All elections shall be held with approval voting and the candidate or candidates with the most votes shall be elected to fill the party office or offices as long as they have received a majority of the vote of the voting members. If an insufficient number of candidates receive a number of votes equal to or greater than a majority of the number of ballots cast, another round of voting shall immediately occur.

All County Organizations affiliated and certified prior to March 31, 2021 in accordance with Article 9.2.3 of these Rules shall continue to be affiliated with the Libertarian Party, provided that no revocation of such affiliation is authorized by the State Committee in accordance with Article 11 until March 31, 2022, in which they. All County Organizations shall adopt or amend Rules that meet the requirements set forth in Article 9.3. A quorum of the Executive Committee shall certify by a majority vote that such requirements have been met, otherwise they shall have their affiliation automatically revoked on March 31, 2022.

PROPOSAL 17 (AK). Readd language that was unintentionally removed.

9.4.5. **ELECTION DISTRICT DELEGATES.** The County Organization shall appoint no more than two (2) enrolled members of the Libertarian Party to represent each Election District in their county. [...]

PROPOSAL 18 (V). Simplify by merging sections into one paragraph.

9.5. **CONSTITUTED COUNTY COMMITTEES.** 9.5.1. When the number of Election District delegates elected at primary is sufficient to meet Election Law requirements, and an organizational meeting is held, the County Affiliate shall be referred to as a Libertarian County Committee. No County Committee shall be recognized unless elected, organized, and constituted in accordance with the Election Law. 9.5.2. County Committee Rules. County Committees shall adopt rules that are consistent with these Rules and Election Law.

Article 10. Judicial Committee

[Entire text deleted July 18, 2021. This Article Number is reserved for future use, providing for investigation and resolution of internal disputes between Party Members]

10.1. **ORGANIZATION.** The purpose of the Judicial Committee is to adjudicate disputes within the Libertarian Party and hear appeals of disciplinary decisions.

10.1.1. **COMPOSITION.** The Judicial Committee shall be composed of nine (9) members elected by the State Committee at the first meeting of the full State Committee following the organization meeting for a term of two (2) years. Each member must receive at least two-thirds (2/3) of the vote to be elected.

10.1.2. **ELIGIBILITY.** Members of the Judicial Committee must be enrolled Libertarians who are not members of the Executive Committee.

10.1.3. **OFFICERS.** The members of the Judicial Committee present at the first meeting of the State Committee subsequent to its election shall meet to elect a Chair, a Vice-Chair, and a Secretary.

10.2. MEETINGS.

10.2.1. Meetings may be called by the State Committee for the purpose of conducting a hearing as described in Article 12.

10.2.2. Meetings may also be called for the purpose of issuing an opinion on a matter in dispute, by the Executive Committee or by a petition declaring the issue in dispute signed by at least twenty-five percent (25%) of the State Committee submitted to the Secretary or Chair of the Judicial Committee; the Chair of the Judicial Committee shall set the hour and location of any such meeting, which shall be held within thirty (30) days and may be held by teleconference, and the Secretary shall issue to the members the call of the meeting at least five (5) days in advance. 10.3. **QUORUM**, Quorum shall consist of five (5) members.

10.4. **VOTING.** The votes of the members of the Judicial Committee shall count equally. Opinions, dissents and concurrences issued by the Judicial Committee shall be signed by the members who support them.

10.5. VACANCIES. Vacancies on the Judicial Committee shall be filled by the State Committee. In the event that the Chair is not present or otherwise relinquishes the chair at a meeting, the Vice-Chair of the Judicial Committee shall preside. If neither the Chair nor the Vice-Chair is available, the Secretary shall preside. If neither the Chair nor the Vice-Chair nor the Secretary is available, the members present shall select a chair pro tem to preside.

10.6. REMOVAL OF MEMBERS. Members of the Judicial Committee may be removed as outlined in the provisions of Article 12 by the full State Committee.

All complaints must include a claim that the accused violated state law, electoral law, Rules of the Libertarian Party of New York, or Rules of a County Affiliate, and/or that the actions caused harm to the party, its members or it's governing structure.
- 10.2.2. **NOTIFICATION.** All parties involved in complaint shall be notified via certified mail or other reasonable and effective method of communication.
- 10.2.3. **INVESTIGATION.** The Judicial Committee, or a panel of three members appointed by the Judicial Chair conduct an investigation into the complaint collecting relevant evidence and testimony.

Investigation should take no longer than 30 days but may be extended by majority vote if it is deemed necessary. Upon completion of the Investigation a report on the findings and recommendation of actions shall be prepared and approved by the majority of quorum of the Judicial committee.

10.3. **APPEAL OF STATE COMMITTEE DECISION.** Within 10 days of notification of the State Committee decision, any party may file, in writing via electronic or physical methods, for reconsideration of the decision to the Judicial Committee. Upon a Majority vote of the Judicial committee a new report and investigation mayis to be completed within 20 days following procedure as outlined in 10.2.3 if reconsideration is deemed necessary by the Judicial Committee.

10.3.1. **DISMISSAL OF RECONSIDERATION.** The Judicial committee shall not take up reconsideration unless: Important and relevant information has surfaced which was not readily available during the initial investigation and reporting period prior to the State Committee decision; Clear evidence of undue influence or bias amongst the members of the State Committee; and/or Parties involved in the complaint were not properly and diligently informed of the investigation.

10.4. MEDIATION AND ADJUDICATION PROCEDURE.

PROPOSED PLATFORM AMENDMENTS

The Platform Committee proposes the following language to append to the Platform of the Libertarian Party of New York.

Proposal #1. New Platform Plank Proposal A

Motion to adopt the following platform plank:

The Right to Decide - Individuals and families have a right to decide for themselves all issues regarding their health, wealth, and safety.

Proposal #2. New Platform Plank Proposal B

Motion to amend the following platform plank and move to the end of the Platform:

While we defer to the national party on issues of national interest, and we defer to our candidates to offer specific policy proposals, we do so only so far as they do not conflict with the following principles:

We support the Platform of the National Libertarian Party, in addition to the following planks specific to New York State:

Proposal #3. New Platform Plank Proposal C

Motion to adopt the following platform plank:

Eliminate taxation and regulation of cannabis for adults. We support the full legalization of cannabis and hemp products, including cultivation, processing, distribution, sales, possession, and transportation, without introducing any new taxes or licensing requirements.

Proposal #4. New Platform Plank Proposal D

Motion to adopt the following platform plank:

Require that the legal age for any adult activity regulated by the state not exceed 18. Once individuals are considered to have adequate judgment to vote and to serve on a jury or in the military, they should be considered to have sufficient judgment to decide their own purchase and use of alcohol, tobacco, firearms, and other potentially risky activities.

Proposal #5. New Platform Plank Proposal E

Motion to adopt the following platform plank:

Maintain the greatest possible degree of local autonomy during emergencies. Government responses to extended emergencies, including pandemics, should be as localized as possible. One-size-fits-all solutions have little benefit for sparsely populated regions in much of the state.

Proposal #6. New Platform Plank Proposal F

Motion to adopt the following platform plank:

Maintain due process during extended emergencies. Any response to an emergency at the state level must be enacted by the Legislature following extensive committee hearings, not by Executive Orders, and should expire when the emergency declaration expires. The State should be held liable for damages to persons or businesses, that are caused by emergency rules that have not been subject to a deliberative legislative process.

Proposal #7. New Platform Plank Proposal G

Motion to adopt the following platform plank:

Protect personal freedoms during emergencies. We oppose the violation of First Amendment rights of free association and human interaction associated with lockdowns and stay-at-home orders during government-declared emergencies. We respect the diversity of values; people who wish to engage in commerce, worship, and social interaction should be free to individually assume the associated risks of such action. We believe government decrees intended to enforce healthy behavior erase personal responsibility. The continued use of emergency powers to make and enforce such decrees habituates society away from personal responsibility, which will gradually erode our liberties.

Proposal #8. New Platform Plank Proposal H

Motion to adopt the following platform plank:

Increase choices and eliminate barriers in education. We support parents' rights to send their children to any school of their choosing, whether public, private, or charter. We furthermore support eliminating barriers to alternative educational options, such as vocational training and homeschooling.

PETITION TO THE NEW YORK STATE SENATE AND ASSEMBLY PLEA TO CHANGE THE STATUTE CONTROLLING POLITICAL PARTY OFFICIAL RECOGNITION

The election law statutes deliberately create an unfair disadvantage to fledgling independent political parties. The criteria Independent Parties must meet are not only unconstitutional on the surface, but are also illogical. 150,000 votes or more must be cast for an 'independent' gubernatorial candidate on the independent party's ballot line. There is no requirement for the party to have any enrolled members, nor to have any kind of structure, nor to have ever held a meeting, nor to have the purpose, principles, or object of the party defined by any document. Effectively, the statute has allowed the formation of sham shadow parties, created with no political substance, and no membership. This happened in two cases in the 2014 election where the two large parties formation if two sham parties represents a blatant abuse of power by the two major parties.

Therefore, whereas the current statute requires 1) an independent political party to receive 150,000 votes or more for their gubernatorial candidate before it will be recognized as an official political party in New York State, and 2) the independent party's gubernatorial candidate does not have to be affiliated with the independent party, and 3) the independent party is not required to have any members enrolled in the party, and 4) these conditions often result in the cross endorsement of the large political party's candidate, thereby eliminating the need for any third party to have a political organizational structure, and

Whereas, the independent party (independent nominating body) must collect not 3 times, but 9 times the number of signatures, or more, on a nominating petition required on the corresponding petition filed by an officially recognized political party, and

Whereas, the time period for collecting an independent party's petition signatures commences after the recognized parties have finished collecting their signatures and have started campaigning, and

Whereas, the two large parties willingly abused the system in 2014, creating two shadow parties comprising just 11 and 12 members each, and where those parties have no bylaws posted, and their practice is to just 'cross endorse' candidates of the major parties,

Therefore, be it resolved that because the current Election Law statues are no longer acceptable to the undersigned citizens of NYS.

We, the undersigned, hereby petition the Legislature of New York State to change the statute concerning how an independent political party is formally recognized by the Board of Elections, and request the following criteria be adopted:

- 1) The present criteria concerning the official recognition of a state level political party be abandoned.
- State and County Board of Elections accurately record the enrollment of voters in the political entity of their choice, no matter how small.
- 3) It be a requirement that any political entity desiring to be recognized as an official state wide Political Party in New York State submit to the Board of Elections a set of Rules approved at an annual or inaugural convention of the members of the political entity, and which such Rules define at a minimum the a) purpose of the party, b) the political principles that the party embraces that make the party different from an existing party, c) the offices of the party, and d) the requirement the members to be members of that political party only.
- 4) The Rules of the party are to be made publicly available.
- 5) After filing said Rules , when the political entity has no less than 15,000 registered voters enrolled in their party and registered at the Board of Elections for a period of more than one year, the entity become automatically an officially recognized political party. (Thus, removing the requirement that a gubernatorial or presidential candidate be run.)
