I. Open Discussion & Guest Speaker (Social)

V. Approval of the Minutes (Summary)

- The members voted unanimously to approve the March minutes as amended, with corrections to the expenses approved during the February meeting of \$231.55.
- The members agreed to table the approval of the January minutes to allow time for review of some non-included modifications.

VI. Officer Reports

- The Chair reported on taking out a Facebook ad to promote our guest speaker, and paying for it out of his own pocket. The Chair also wished to acknowledge the efforts of Michael Lema from Alameda County Libertarian Party, who gathered data on Contra Costa County elected officers for us. Thanks Mike!
- Treasurer's report: \$2,031.42 balance in our account. No drawn from expenses this month.
- The Vice-Chair made mention of pairing up with the Alameda County Libertarian Party for the [National Libertarian Day of Service](#) (more on that to come in a separate email as details become known). The Vice-Chair also made mention of attending the Contra Costa County Elections Community Engagement Committee quarterly meeting. He reported that the Committee fully expects the recall of Governor Gavin Newsom to take place, once tens of thousands of petition signatures are verified in this county alone. More recall and election updates are expected in subsequent Committee meetings which the Vice-Chair expects to attend.
- No reports from the Secretary.

VII. Activism Meeting and Updates

- Updates were given out about the March 27th activism meeting, where a discussion was had about creating opportunities for local voters to take action, and make a difference in our community.

 - Asked everyone present to think of at least 5 businesses each, that may be receptive to a reach out about how the lockdowns have impacted their lives, as well as the possibility of creating a coalition to resist government tyranny.

 - Has a list of guest speakers lined up for our June and August meetings (more on that to come).

- We discussed the mechanism for changing our Bylaws, the outstanding changes we might want to make, including rewriting, or even terminating the Bylaws. The Vice-Chair volunteered to rewrite the Bylaws, and present them via email prior to the next meeting for feedback or even a possible vote, as suggested by Kurt Schultz. Kurt also offered to assist with any potential Bylaws discussions or proposals as needed.
- Everything regarding Bylaws discussions was tabled until further notice by a vote of 6 'ayes' (Sandra, Kurt, Den, Brandon, Roberto, Justin) to 3 'abstains' (Kevin, Adrian, Jessica).
