CONVENTION REPORT

Alabama Libertarians, convening in Birmingham, strongly condemned draft registration and mandatory seat-belt laws. They also voiced support for a Decatur, Ala., couple who were jailed earlier this year for refusing to send their children to public school.

Resolutions on these items, plus one urging support for a bill pending in Congress to make ballot-access easier for third parties, passed unanimosly.

The june convention was judged thy several attendees to be the best in many years. It was held at the Birmingham Press Club and featured guest speakers Paul Jacob of Arkansas and Jimmy Harris of Georgia.

Jacob is a young man who was indicted for refusing to register for the draft. His case went to trial three weeks after the ALP convention (he was found guilty).

Harris kept the group laughing with his description of the Georgia General Assembly, the stupid laws they are always thinking up, and the Crakpot Awards with which the Georgia LP recognizes the legislators' often astonding efforts to promote the general welfare on that side of the Chattahoochee.

In convention business, Bobby Chapuis was elected party chairman. Chapuis was active in the Tennessee LP before moving to Alabama a few years ago. He previously served the Alabama party as vice chairman. (continued page two)

PAUL JACOB GOES TO JAIL

Paul Jacob went to trial for failure to register for the draft on July 1st. On the first day of the trial the jury heard extended testimony from 1980 Libertarian Presidential candidate, Ed Clark. On the second day of the trial former Congressman Ron Paul from Texas came to Little Rock Arkansas to testify on Paul's behalf. The jury then went into extended deliberation only to find Paul quilty. The jury followed their instructions to come to a decision based on the law even though members of the jury, including the foreman felt the law was unconstitutional.

CONVENTION REPORT

PAUL JACOB GOES TO JAIL

Paul Jacob went to trial for failure to register for the draft on July 1st. On the first day of the trial the jury heard extended testimony from 1980 Libertarian Presidential candidate, Ed Clark. On the second day of the trial former Congressman Ron Paul from Texas came to Little Rock Arkansas to testify on Paul's behalf. The jury them went into extended deliberation only to find Paul quilty. The jury followed their instructions to come to a decision based on the law even though members of the jury, including the foreman felt the law was unconstitutional.

Paul was sentenced to 5 years with four and a half years suspended to be served on probation. He was also sentenced to 2 years of community service upon release from federal prison.

The judge denied bond for Paul at the conclusion of the trial. An emergency appeal for bond was also denied by an appeals judge.

Prior to the trial Paul traveled the country in opposition to the draft and the support of freedom. He made two stops in Alabama. He addressed a group of students at Auburn University in the spring and resently spoke at Alabama Libertarian Party' state convention. (continued page two)

Convention goers agreed to give top prioity to these projects for the remainder of 1985:

- l. Writing letters and doing other lobbying to gain passage of H.R. 2320 in the U.S. House of Representatives. This bill would make ballot access for third parties much easier across the country.
- 2. Collecting petition signatures to put the LP on the Alabama ballot for the 1986 general election.
- 3. Running and promoting a "Taxpayer's Slate" of candidates in the non-partisan Birmingham city council election this fall.
- 4. Turning in petitions to Gov. George Wallace calling for freeing the Pangelinans (the couple who got in trouble for homeschooling their youngsters).
- 5. Strengthening outreach, internal education, membership and finance efforts.

On a suggestion by Bobby Chapuis, the convention voted to name the entire state executive committee as delegates to the national convention in Phoenix, with all other party members as alternates.

Congressman John Conyers of Michigan has introduced a ballot access bill (H.R. 2320) which will permit much easier ballot access for third party and independent candidates for federal office. Only one-tenth of one percent of registered voters would have to sign a petition. This would cut our requirement by half in Alabama and save the LP millions of dollars nationwide!

- All Libertarian supporters must take advantage of this golden opportunity! At least two letters should be written.
- 1. To your own congressperson asking him to co-sponsor the bill.
- 2. To congressman AL Swift, Chair of the Subcommittee on Elections, Asking him to hold hearings on the bill this fall.

IT'S A FREE COUNTRY, ISN'T IT? By Alan Burris

The supreme power...covers the surface of society with a network of small complicated rules, minute and uniform, through which the most original minds and the most energetic characters cannot penetrate to rise above the crowd. The will of man is not shattered but softened, bent and guided; men are seldom forced by it to act, but they are constantly restrained from acting. Such a power does not destroy, but it prevents existence; it does not tyrannize, but it compresses, enervates, extinguishes, and stupefies a people, till each nation is reduced to nothing better than a flock of timid and industrial animals, of which government is the shepherd--I have always thought that servitude of the regular, quiet and gentle kind which I have just described might be combined more easily than is commonly believed with some of the outward forms of freedom and that it might even establish itself under the wing of the sovereignty of the people.

It Isn't

We are not as free as many would have us believe. Because we are accustomed to the restraints on our liberty (and the restraints are often invisible) we may not sense the violations of our natural rights. But while we do not see our cage, or feel the weight and hear the clanking of our heavy chains, our bondage is no less real.

A good way to evaluate the loss of our liberty is to prepare two lists, one of the liberty we still enjoy, and the other of rights we are denied by threat of force. The liberty list should include only those things we are free to do without government permission or regulation, and without our right being limited by taxation.

Remember that even as we sleep, we probably rest on a mattress manufactured according to government specifications by a licensed manufacturer, sold to us by a licensed bedding dealer, and its cost more than doubled by direct and indirect taxation. And that's just the mattress!

The wood for the bed frame may have come from a government-owned forest. The bed linen and blanket also had to meet government-imposed standards and were not only taxed, but the price we paid was substantially increased by government tariffs and quotas on low cost foreign textiles. If thinking of all of this keeps you from sleeping, a government-licensed sleeping pill may help.

If carefully thought out, it will be found

that the liberty list is incredibly short and the liberty lost list is infinitely long. The hard fact is that we have the "liberty" to do as our masters wish and approve, and very little else.
