The meeting was called to order at 9:03 p.m. by William Cody Anderson, Chair.

William Cody Anderson issued welcoming remarks and welcomed the observers to the meeting. Andrew Kolstee conducted a roll call and quorum was established.

Motion by Andrew Kolstee to waive reading and approve the minutes of the February 23, 2021 Meeting of the Executive Committee was seconded by Pietro Geraci and passed unanimously without debate.

Motion by Lora Newell to reimburse the Law Office of Michael Kuzma for \$1,515.52 for the purchase of copies of transcripts was seconded Richard Purtell, debated, and passed unanimously.

Andrew Kolstee issued a report on the status of the certification of County Affiliates in accordance with Article 9.2.3. of the Rules of the Libertarian Party of New York (Exhibit 1).

Motion by Andrew Kolstee to certify that the County Organizations in Chemung, Kings, Queens, and Tioga Counties have met the criteria required in Article 9.2.3. of the Rules of the Libertarian Party of New York was seconded by Gabrielle Cordova and passed unanimously without debate.

Andrew Kolstee issued a report (**Exhibit 2**) concerning the attendance members of the State Committee that have missed two consecutive meetings and may be eligible for a hearing for removal. The resignations of two members of the State Committee were recognized: Nathan Dunn on March 3, 2021 as a member from Judicial District 4 (**Exhibit 3**) and Aaron Commey on February 24, 2021 as a member from Judicial District 12 (**Exhibit 4**).

Motion by Andrew Kolstee to request a hearing to be held by the State Committee for the purpose of removing Tara Scrivano from the State Committee as representative from Judicial District 8, and removing Carmen Horan, Satinder Kaur, and Mahavir Singh from the State Committee as representatives from Judicial District 10 due to abandonment of position per Article 11.4 of the Rules of the Libertarian Party was seconded by Paul Grindle, debated, and passed unanimously.

The meeting stood at ease from 9:20 p.m. to 9:24 p.m.

Ilya Schwartzburg issued a report on the status of the ballot access lawsuit.

Motion by Paul Grindle to enter Executive Session for the purpose of discussing active litigation was seconded by Lora Newell and passed without objection.

The meeting entered into Executive Session at 9:36 p.m.

Executive Session was adjourned at 9:53 p.m.

Motion by Duane Whitmer **to adjourn** was seconded by Lora Newell and passed without objection.

The meeting was adjourned at 9:54 p.m.

REPORT OF THE SECRETARY OF THE LIBERTARIAN PARTY OF NEW YORK IN REGARD TO CERTIFICATION OF COUNTY AFFILIATES MARCH 4, 2021

On May 24, 2020, the Interim State Committee of the Libertarian Party of New York amended the Rules of the Libertarian Party that prevented Interim County Organizations from ceasing to exist on May 31, 2020. Instead, Interim County Organizations became County Organizations on June 23, 2020. This was part of the Rules of the Libertarian Party of New York adopted by the State Committee on September 26, 2020.

Because the amended Rules of the Libertarian Party required that counties hold regular meetings at least quarterly and that their rules provide for the election of officers, several counties were required to update their rules to comply with the new requirements. As a result, all counties are given a deadline of March 31, 2021 (previously March 1, 2021) to meeting the following criteria:

- 1) a provision in the rules for at least quarterly meetings (Article 9.2.3.2)
- 2) a provision in the rules for the election of officers (Article 9.2.3.1)
- 3) an election of officers held between June 23, 2020 and March 31, 2021 (Article 9.2.3)

Later in this report, there is a list of documents that are missing on file with the Secretary. If you have any of these documents, please provide them.

A. STATUS OF CERTIFICATION

In order for the Executive Committee to consider the certification of County Affiliates, the following documents must be submitted to the Secretary:

- A copy of the County Organization's latest rules.
- Minutes from the county's meeting in which officer elections were held since June 23, 2020.
- 1. CERTIFIED COUNTIES. Only 10 out of 31 County Affiliates have been officially certified (Chautauqua, Columbia, Fulton, Nassau, New York, Orange, Orleans, Richmond, Saratoga, and Wayne). The remaining 21 County Affiliates are not yet certified.
- 2. MEETINGS PROVISION. 14 out of the 21 remaining counties (Albany, Broome, Chemung, Monroe, Kings/Brooklyn, Onondaga, Ontario, Rensselaer, Queens, Schoharie, Suffolk, Tioga, Ulster, and Westchester) have a provision in their rules for holding at least quarterly meetings of either the County Committee or the Executive Committee.
 - 1 county (Bronx) has a provision for "4 meetings per year," but that does not meet the "quarterly" criteria required in the State Party Rules.
 - 4 counties (Cattaraugus, Chenango, Madison, and Otsego) do not have a provision for holding regular meetings. 2 counties (Chenango and Madison) are working on amendments.
 - 1 county (Erie) only has a provision for holding annual meetings and is working on amendments.
 - 1 county (Genesee) has not provided a copy of their rules.



- 3. OFFICER ELECTIONS PROVISION. Only 9 out of the 21 remaining counties (Broome, Chemung, Erie, Kings/Brooklyn, Madison, Queens, Suffolk, Tioga, and Ulster) have met the criteria for having a provision in their rules for electing officers. Other counties will need to amend their rules to comply with this requirement:
 - 9 counties (Albany, Bronx, Cattaraugus, Monroe, Onondaga, Ontario, Rensselaer, Schoharie, and Westchester) have a provision for an election of officers, but only at an organizing meeting, which is to be held within 20 days after the primary and elected by the elected County Committee, which is not possible for a County Organization, as they were not elected at a primary. All 11 of these counties use the Monroe Template, which is only useful if the counties are a constituted County Committee.
 - 2 counties (Chenango and Otsego) do not have a provision for holding officer elections when not a constituted county committee but do not use the Monroe Template.
 - The rules of the remaining County Affiliate (Genesee) are not on file with the Secretary, so I do not know whether or not they are in compliance with the State Party rules. I do have a draft copy of their rules, but not the copy of the rules that were adopted.
- 4. ELECTION OF OFFICERS. Since June 23, 2020, 14 of the remaining 21 County Affiliates have held an election of officers: Broome, Cattaraugus, Chemung, Chenango, Erie, Kings/Brooklyn, Madison, Monroe, Onondaga, Otsego, Queens, Rensselaer, Tioga, and Ulster. The following counties must hold an election of officers between June 23, 2020 and March 31, 2021:
 - **Broome** County held their election of officers, but it is incomplete.
 - 5 counties (Albany, Schoharie, Suffolk, and Westchester) have their conventions scheduled between now and March 31, 2021.
 - No additional County Affiliates have informed me that they expect to hold their convention before the March 31, 2021 deadline.
 - The status of an election of officers of the remaining 3 counties is unknown. I have no record of any of these counties holding an election of officers since June 23, 2020 or no record of any indication of a convention to be held before the March 31, 2021 deadline: **Bronx, Genesee, and Ontario.**

B. SUMMARY. A total of 5 of the 21 remaining County Affiliates have met the criteria to be certified per Article 9.2.3. (Chemung, Kings, Queens, Tioga, and Ulster). Only 4 counties (Chemung, Kings, Queens, and Tioga) have provided proper documentation and are eligible to be certified. The remaining 19 counties must ensure that their rules are in compliance and they hold an election of officers by March 31, 2021 if they have not done so already.

D. ADDITIONAL PROVISIONS FOR 2022. On January 23, 2021, the State Committee voted to approve amendments to the Rules of the Libertarian Party that created a new certification process for counties to ensure their compliance with Election Law and readiness for the future. This certification process deadline is due on March 31, 2022, and counties will be required to do the following, in addition to what is outlined in this report. See Article 9.2.4 for details.

- Have a provision in the rules for the election of officers. (see Article 9.3.2.1)
- Have a provision in the rules for holding at least quarterly meetings of the County Committee.
 Previously, counties were only required to have a provision for quarterly meetings of either the County Committee or the Executive Committee. (see Article 9.3.2.2)
- Have provisions in the rules that are compliance with Article 9.4 of the Rules (see Article 9.3.2.3) which is to define voting members as those who are 1) enrolled Libertarians and 2) elected or appointed election district delegates.

ATTENDENCE REPORT OF THE LIBERTARIAN PARTY OF NEW YORK OF THE STATE COMMITTEE MEETINGS MARCH 4, 2021

There have been concerns in regard to the inactivity of members of the State Committee, which led to a lack of quorum on February 21, 2021, in which about 30 members of the State Committee had to wait for quorum to be reached. The scheduled start time of the meeting was 1:00 p.m., but we were not able to begin until 1:07 p.m. At the September 26-27, 2020 organization meeting, 61 out of 66 members (92%) of the State Committee attended one or both sessions. At the January 23 and 31, 2021 meeting of the State Committee, 51 out of 67 members (76%) of the State Committee attended one or both sessions. At the February 21, 2021 meeting of the State Committee, 43 out of 63 members (70%) of the State Committee attended the meeting.

Article 11.4 of the Rules of the Libertarian Party of New York is as follows:

11.4. **ABANDONMENT OF POSITION.** Any member of the State Committee who has previously failed to attend or participate in two (2) consecutive properly called meetings and has evinced no other intent to continue in office may be removed following a hearing by the State Committee for having abandoned the position; for this vote, the member or members in question need not be counted for quorum purposes.

Due to quorum and commitment concerns, all members of the State Committee that met the above criteria (missed two consecutive meetings) were the following members contacted by the Chair and/or Secretary and asked whether or not they wished to continue as a member:
