## 2020 March LP Board Minutes

### Public Comment

**Frank Atwood** - Liaison to Center Right Coalition. He had some information on crowdfunding for freedom and other techniques. Also Casper has written a book.

### Affiliate Representatives

**Judy Darcy** - Representing **Arapahoe** County - They will have a speaker addressing low level marijuana charges and another speaker on the status of the homeless in Denver.

**John Hjersman** - Representing **El Paso** County - They will participate in the St. Patrick's Day parade. They will be soliciting candidates at their next meeting on the third Thursday.

**Kyle Furey** - Representing **Denver** County - The next meeting is March 17th with a speaker working to decriminalize sex work. They are also a full affiliate so they need to have their money returned.

**Ross Klopff** - Representing **Jefferson** County - The last meeting featuring approval voting was quite successful. They have openings for officers. Elections will be Thursday March 19th.

**John Pickerill** - Representing **Pueblo** County - They will be having a St. Patrick's Day event instead of their regular meeting. In April Michael Stapleton will speak at their meeting.

#### Director's Reports

**Chair** - Victoria Reynolds - In addition to her report she attended the Delta County meeting. They are looking for new board members. She testified against the flavor ban in the House. She is running for Douglas County County Commissioner.

**Vice Chair** - Eric Mulder - He added the State Convention candidate search to his report.

**Treasurer** - John Hjersman - He has 2 earmarked contributions: buttons and postcards.

**Fundraising** - Angela Plummer - She added the counting mechanism to the national delegate voting process.

**Campaigns** - Matt DiGiallonardo - The Campaigns Committee is organized with several participants. They are soliciting candidates. He believes that they have filled the Federal races. The Campaigns Committee Chair, Kevin Gulbranson noted that they are building a database infrastructure that will make the next 5 years much easier to run. Matt wants the candidates to enter their own data on TRACER. He moved to appropriate \$170 for a Campaigns outreach event and fundraising on the 21st. This passed without opposition.

**Outreach** - Alexis Buschmann - At the Colorado Springs Tanner Gun show they collected 20 sign ups and \$27. They need volunteers for their St. Patrick's Day parade float. She requested up to \$1000 for Denver Gun Show, Pueblo Gun Show, Rifle Rendevous, Denver Pridefest and Cinco De Mayo and for buttons, t-shirts and bumper stickers. This passed without objection.

**Affiliate Development** - Steve Gallant - nothing to add to his report

**Legislative** - Michael Stapleton - He warned that the committee will be voting on the flavor ban tomorrow. The Death Penalty Repeal passed. Thursday is the committee

hearings for the Red Flag repeal bill. So far there have been 350 bills in the House and 251 in the Senate.

**Membership** - John Pickerill - He apologized that he did not submit a report. The number of registered Libertarians increased by 2,000. He thanked Marc Montoni for contacting the new members. He is applying Libertarian principles during his term on a board of directors. Reynolds re-appointed Montoni as Welcome Committee Chair.

**Communications** - Stacy Petty - nothing to add to her report.

**Secretary** - Ross Klopf - noting to add to the report.

#### Committees

**Technology** - Mike Quinlan - nothing to add to his report.

**Database** - David Aitken - he mentioned that he has uploaded the latest set of voter registration data from the Secretary of State.

**Legislative** - Michael Stapleton - there are several folks monitoring legislation

**Campaigns** - Kevin Gulbranson - covered earlier

#### New Business

**Welcome Postcard** - David Aitken - He suggested that the affiliates fund a postcard to give new registrants links to information and an inducement to donate. Reynolds noted that the state would have to cover the ones that aren't within established affiliates. Eric Mulder moved that the affiliates interested should pay for the postcards to their areas. This passed without objection. Eric Mulder moved that the state pay \$150 to cover the remaining postcards. This passed without objection. Victoria Reynolds moved that Eric Mulder design the postcards. This passed without objection.
