Court returns Libertarian city council candidate to Ohio's November ballot

The Franklin County Board of Elections returned a Libertarian candidate for Reynoldsburg City Council to the November ballot on Tuesday, about a week after being ordered to do so by the Ohio Supreme Court.



Robert Bender had filed suit seeking reinstatement in the race for the Ward 3 council seat after elections officials invalidated several

petition signatures he had submitted, leaving him short of the number needed to appear on the ballot.

According to court documents, Bender submitted his candidacy declaration in early February, and elections officials determined that he had the requisite number of valid petition signatures to qualify for the ballot.

Jake Porter of Council Bluffs, last year's Libertarian candidate for governor, said it will likely reduce the number of third party candidates who run for office.
