Our **August** Amazon bill for CRM email services was **\$7.09** for just over **70,000** emails. This cost is recorded as an In-Kind donation by the Database Manager.

Our credit with MailChimp for email services has expired and we are no longer maintaining that account. Our free data storage with Amazon will terminate at the end of 2023. Our domains managed by Google will be moved to Squarespace sometime soon.
