#### Campus Libertarian Groups Activities

University Libertarians have been invited to participate in a debate (to include Democrats and Republicans (and perhaps Greens)) on Nov. 3 at U.Va.

I was quoted (actually, slightly misquoted) in The Financial Times of London on Sept. 9 in an article about the climate for business in Virginia. My comment concerning a tradition of (relative) fiscal conservatism at the state level, which tends to serve as something of a rake on the more enthusiastic proponents of using the state to do good.

I am serving as a faculty member for the "Success '97" seminars, sponsored around the country by the Libertarian Party. I give lectures and workshops on campus organizing, and discuss effective public speaking on campus. Students for Individual Liberty (S.I.L.), the largest educationally-oriented group within The Liberty Coalition, remains the most active organization. S.I.L. sponsored a major advertising campaign (including information tables at activities fairs) prior to the semester, which generated substantial interest in our activities. So far, S.I.L. has sponsored addresses by Jacob Hornberger, president of the Future of Freedom Foundation (Sept. 3), and David Borden, president of the Drug Reform Coordination Network (Sept. 18). Both events drew 25-30 people; in both cases, the audience included 9-10 nonlibertarians who wished to learn more about the libertarian perspective.

In coming weeks, S.I.L. will sponsor addresses by Robert Holland (op-ed page editor of the Richmond Times-Dispatch), Ronald Bailey (author of coScam and editor of The True State of the Planet), and John Taylor (president of the Virginia Institute for Public Policy). In addition, S.I.L. will cosponsor (or, at the least, assist) addresses by Charles Murray and David Boaz; the Jefferson Society will pay the expenses for the Murray and Boaz events. We are pleased to announce that we have arranged to have videotapes of the S.I.L. speaker series shown on Adelphia Cable. Bill Martin, president of S.I.L., is attempting to organize regular discussion sessions among libertarians; the first session will take place later this month. Jamie Plummer, president of the

Classical Liberal Roundtable, continues to write a weekly column for The Cavalier Daily. Law Students for Individual Liberty has been reinvigorated by Scott Matthews, a first-year law student who until recently worked for the Institute for Humane Studies. Mr. Matthews and his colleagues are planning a couple of outreach events during the fall semester; they intend to mount a major outreach effort during the spring semester.

Unfortunately, Students for the Second Amendment (SFSA) and Law Students for the Second Amendment are inactive for now. Austin Jamison, who became president of SFSA in January, has transferred to the University of Maryland. University Libertarians (UL) are planning to assist the Jefferson Area Libertarians in their effort to fight a proposed meals tax for Albemarle County. A referendum on the tax will take place on Election Day in November. Some of the members may assist L.P.Va. candidates in Northern Virginia.

## **Ballot Access Committee (BAC) News**

Three draft bills are being submitted for us in the State House by Delegate Vincent Callahan. If passed they would: 1) change the number of signatures required for statewide offices from 0.5% of registered voters to a flat 5,000 (500 for U.S. House). 2) Reduce the retention amount (percentage of statewide vote required to be a recognized party) from 10% to 5%. 3) In addition to meeting the retention amount to qualify as a recognized party, add a provision to qualify by filing a party petition of 10,000 sigs. We are still seeking a State Senator who will introduce the bills on the Senate side of the General Assembly.

I have created a lobbying information packet. I am busily mailing it out to volunteers who have indicated their willingness to contact their state representatives and ask them to support our bills. We have a wonderful opportunity here regarding the first bill. The number of registered voters is on the rise due to the "Motor Voter" law. Delegates on the Privileges and Elections Committee have expressed a concern over the situation plus an interest in changing the sig requirement from a percentage to a flat number. Please join our lobbying effort! I feel it is really important to ask EVERY state rep to support fairer ballot access laws in Virginia. Just because they sought public office via a major party ticket, doesn't mean they support that party 100%. It is up to us to seek out those in the General Assembly for whom fairness is more important than party politics.

There are 100 delegate districts and 40 senate districts in the state. Since Delegate Callahan is already sponsoring our bills, I am seeking a minimum of 99 other LPVA members to contact their delegate and senator. With our membership spread as thin as it is, it is possible that YOU are the only Libertarian in your delegate district! PLEASE contact me, and I'll mail you a lobbying info packet to get you started. We need to lobby NOW. Once the General Assembly begins in January, things move very quickly, and it is too late to begin this ind of discussion. ## LETTERS TO THE EDITOR

I came to my libertarian beliefs through my "New Age" spiritual beliefs. My friends in both camps tell me the belief systems of libertarians and New Agers are incompatible, perhaps even contradictory. Well I'm here to tell you, it ain't so. I'm both. The only political philosophy I know of that espouses maximum personal and economic freedom is libertarian. Choice is the key word. In my spiritual life, too. The only way I'm going to achieve true enlightenment on my spiritual path is by choosing it through my own volition.

The New Age culture, like the rest of America, includes a wide variety of beliefs and religious practices. Some seem far out to many people. In their political lives, some sound like authoritarian socialist Democrats while others sound like authoritarian rightist Republicans.

All those I've encountered, however, believe at their center in a climate where choice is honored above coercion; indeed, where all nonaggressive choices are honored. That's also the center of liberty as I understand it. For me, the two worlds mix beautifully.

I believe that I am a spiritual being at my core, and that my purpose on earth is personal and spiritual growth—my path to enlightenment. Such a path requires freedom to choose. That's where my political side kicks in. I may stumble and make some bad choices along that path, but I'll accept responsibility for them; they're my choices, after all. And I'll experience their consequences as part of my growth. If someone buffers me from such consequences, I can't grow. As long as I do no harm to another's person or property, I expect no interference in my choices, in my growth.

When my wife and I first heard a libertarian explain his principles, we were delighted. Some very bright and very principled people had translated our spiritual philosophy into the social and economic world. A practical example: Since we believe that essentially we are all one, it follows that being in service to others actually serves ourselves. (Sounds a bit Objectivist to me.) One way I choose to be in service is to contribute to charities. My government, however, limits how much I can give to charity by taking almost half of my earnings and then wasting large chunks in counterproductive and misguided efforts

to distribute wealth. Shame on them! I can't truly learn goodness and mercy unless I practice freely. No one should coerce me into such practices; it's by my own choices I'll be judged.

My faith honors free will in all matters pertaining to my spiritual growth. My politics says: I'm pro-choice on everything. Both are saying it's up to me to choose how to conduct my affairs, whom to associate with, what to read or watch. I decide what I eat, drink, or smoke. I may seek counsel in deciding these choices, but ultimately I am self-governing. If I am to fully experience the God-presence at my center, I must be at choice. I'm grateful to both my religion and my party for supporting me. As I see it, both of these pillars of my life are based on the underlying truths of both my inner and outer self: liberty and choice.

## THE LPVA LIST SERVERS

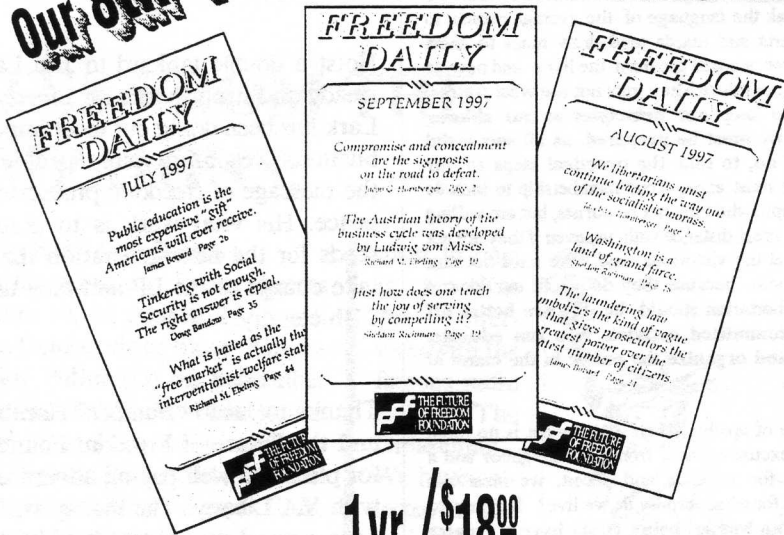

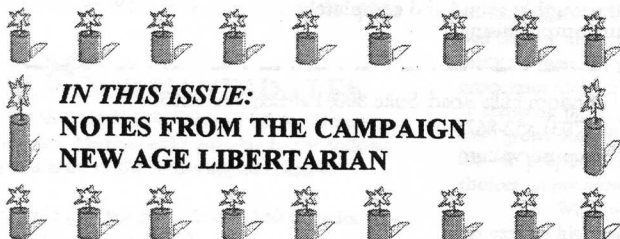
