That was the vision of the Founding Fathers, so in a sense this is a restoration of strictly limited Constitutional government. However, there were some obvious flaws in that vision. Our movement intends to improve on that vision so that freedom comes to all people, not just white Anglo-Saxon protestant males.

The LP is growing every year. We just elected four state representatives in New Hampshire as Libertarians. There are hundreds of Libertarians throughout the country elected to local positions such as city council and school boards. LPI member Paul Salander is an elected township supervisor in LaSalle County here in Illinois.

In November, our US senatorial candidates received more votes than any third party has done since 1914—1.1 million. Over three million people voted for a Libertarian in the past election. We are the largest "third" party in the country, the most organized, and the one destined to deliver the concept and realization of individual freedom to citizens of the 21st century.

An Evaluation and a Plea

As the Spiegel for Senate campaign manager, I would like to take this time to assess the campaign—what we did well, what we didn't do well, what succeeded, and what failed. And to make a plea.

First, though, I would like to thank all volunteers who helped with the campaign to make it a success. I especially would like to thank Pat Pepin Franke who agreed to answer the phone for us at LPI headquarters (which is also her and her husband Frank's business), and to mail out literature to inquiries and volunteers. The Frankes' help was indispensable. Jeanette Muench also helped in this regard when Pat and Bob were out of town on business. Pat, Bob, and Jeanette—thank you! I would also like to thank Ralph Miron for first suggesting, and then helping recruit Andrew Spiegel to run for Senate. o a great thanks to Jeanette Clinkunbroomer, data base coordinator, who kept us supplied promptly with names, phone numbers and mailing labels. She also wrote one of the position pa-

Obviously, the vote total of 34,500 was a disappointment. But we did a lot of good things that will make that vote total go up geometrically next time.

First, one of the main accomplishments we made this year was in recruiting a truly great candidate. Andrew Spiegel not only articulated the issues very well, but did so in a prolific manner. Andy was a very hard worker, and it paid off in a number of ways.

We now have county contacts in a number of areas in Illinois that we never had before. Budding activism is developing in Centralia, Belleville, Vandalia, Bloomington, Champaign-Urbana, Decatur, the Quad cities area, Rockford, Oregon, Northwestern Law School, Harper College, and Elgin. Peoria Libertarians are continuing their activism at a fever pitch. With Andy's help, Paul Salander has definitely made libertarianism a household word in the LaSalle County area.

Building a political party at the grass roots level as we are doing will make the Libertarian Party a major player in Illinois politics.

During the campaign, we increased our data base by 100% to over 4,000 names. Membership is growing.

We sent out media kits to over 120 news organizations. These organizations include every daily newspaper in the state. I'm sure more than a few found out about the Libertarian Party for the first time. Press coverage was very good in the medium and smaller markets. And we got page-one coverage in the Daily Herald, the fastest growing daily newspaper in Illinois. Persistence paid off and we managed to get Andy on channel 11—WTTW, where he outshone all other senatorial candidates by far. He received excellent coverage by WCIA TV in Champaign, the most watched television station outside the Chicago area.

We ran radio ads through Treasurer Helen Heyden's efforts, continuously throughout October in Chicago—WGN and WLS, Rockford—WROK, Ottawa—WCMY, Champaign—WDWS, Salem—WJBD, Spring-field—WTAX, and Marion—WDDD. Also one man contributed 50 radio spots on an easy-listening-to radio station in Peoria. And other Peoria activists put in quite a bit of their own money and produced their own ad for the Libertarian Party.

Andy attended candidate forums throughout the state, helping to make libertarianism a household word. Andy also testified against the Berman Amendment, which went down to defeat saving Illinois taxpayers billions of dollars.

Andy and I also made contact with some politicians who might be able to help us with ballot access legisla-

So when we look at the campaign as a whole, and not just the vote totals (there were eight candidates on the ballot for U.S. Senate), it was definitely a success.

There are things we should do better next time. The first thing is planning. We got the campaign started and recruited our candidate with no planning at all and with no money to start with. Until August 3, we had to concentrate on ballot access. Because of the lack of planning, as cattifician manager I had to personally take the jobs of fund raising, press relations which included putting together 120 media kits that had 10 position papers, typesetting, scheduling, pinch hitting for Andy, coordinating volumters, and event planning. Because of this, the fund raising effort of the campaign fell short. We raised only \$10,000 and have a current debt of over \$2,000.

The debt breakdown includes a \$300 loan from volunteer treasurer and radio advertising manager Helen Heyden. Andy Spiegel has over \$500 coming in expense reimbursements. We owe our printer about \$700. And the campaign owes me over \$500 do to reimbursements and a less-than-minimum-wage commission.

Helen, Andy, and I worked full time for this campaign. We think we succeeded in many aspects. Now we ask you to help us out this one more time and eliminate this campaign debt. A return form is provided below, and a return envelope is included in this newsletter. Please make checks payable to Spiegel for Senate. The address is P.O. Box 396, Wheaton, IL 60187.

Any money we receive beyond our debt will go into a Libertarian Party Campaign Development Fund, so that the next campaign doesn't start behind the eight ball the way we did.

Please help us get in the black, and put Campaign-94 on the right track.

Election '92: A Candidate's Perspective

Now that Election '92 is over, it is time for Libertarians to accentuate the positive and eliminate the negative.

As human beings, we each have the choice to view the glass as half full or half empty. Since 95% of the struggle for success consists of maintaining a positive mental attitude, I suggest we all view the glass as half full

Let's look at the presidential race first. Clinton did not win by any landslide. When you consider the fact that only 55% of the electorate actually voted in the '92 Election, Clinton actually received only 23.65% of the possible popular vote.

Another interesting fact is, excepting Woodrow Wilson in 1912, Clinton won with the lowest popular vote (43%) since 1860. The historians among us will recall Michael Dukakis received 45.9% of the vote in 1988; Clinton received only 43%, the same percentage

kansas and in Washington D.C. There were anti-Clinton majorities in 49 of the 50 states. His election confirms that the Democratic Party is a minority party.

Next, let's look at the third party/independent vote. Ross Perot received 19%, which was better than any other independent candidate since the 27% polled by Teddy Roosevelt as the Bull Moose Party presidential candidate in 1912. Perot's vote totals showed the amount of discontent among voters with the Republicrats.

As we all are painfully aware, Andre Marrou as well as other third-party and independent candidates received hardly any news media attention compared to Perot. Andre came in first among the remaining third-party candidates. Vote totals as of November 9, 1992, according to the Associated Press were as follows:

These compromises will be the type that only dedicated statists can achieve: subsidies for big-business in exchange for subsidies for the social services racket; gun control in exchange for warrantless searches; new regulations on business in exchange for new restrictions on civil liberties; new war toys in exchange for useless military bases kept open, etc. etc. All of this will be paid for by increased taxes, increased deficits, and a rising National Debt.

The good news is that the Liberals may get enough of what they want to ruin things fast and bring the majority of the American people to their senses. Many new Liberal Democrat Senators and Congresspersons were elected also. The current feeble recovery will continue for a short time but will sputter out as the government takes a larger and larger share of the nation's income and resources and new laws and regulations put small companies out of business.

The Communist Manifesto Of 1848 As Practiced Today

During the 1992 presidential campaign, Libertarian candidate Andre Marrou shocked and offended many interviewers by stating that 70% of the Communist Manifesto had been enacted in America. This statement was met with disbelief because many journalists and reporters, as well as the public they try to inform, do not know the source of many of the most common political, social and economic principles being promoted today.

It is not the intention of this article to accuse any politicians or holders of public office of being Communists. The purpose of this article is to expose the source of many of the ideas and principles held by many politicians, journalists, and educators who may well not be aware of the source of their beliefs. Democrat, Republican and Independent politicians have all adopted planks. These ideas have found their way into school text books, and are taught without any awareness of their source or purpose.

This also demonstrates that a small political movement that never gains electoral success can still have profound influence on events.

The following bold print items are the ten points recommended by Karl Marx: "to wrest, by degrees, all capital from the bourseois, to centralize all instru-

the proletariat organized as the ruling class." The ac-

and blireaucrats the ruling class.

 Abolition of property in land and application of all rents of land to public purposes.

Property tax, and the seizure of land for non-payment of property tax have accomplished the same effect while maintaining the pretense of private ownership. Not only are you required to pay rent on the land you "own", but zoning, licensing, agricultural and environmental laws and regulations control exactly what you may be allowed to build, grow, or do on "your" land.

2. A heavy progressive or graduated income tax.

The intent of the progressive income tax is to pull everyone down to the lowest level regardless of their earnings rather than improve the prospects of the work-

3. Abolition of all right of inheritance.

Confiscatory estate tax rates.

 Confiscation of the property of all emigrants and rebels.

Emigration and rebellion have not become problems for the government here, yet T MA M JIW

Centralization of credit in the hands of the state, by means of a national bank with state capital and an exclusive monopoly.

The Federal Reserve Bank

6. Centralization of the means of communication and transport in the hands of the state.

The Federal Communications Commission and the Interstate Commerce Commission have given the government almost total control of these while permitting the illusion of private ownership.

7. Extension of factories and instruments of production owned by the state; the bringing into cultivation of waste lands, and the improvement of the soil generally in accordance with a common plan.

See the TVA and the U.S. government's agriculture policy for examples of this.

8. Equal obligation of all to work. Establishment of industrial armies, especially for agriculture.

How about a National Industrial Policy?

 Free education for all children in public schools. Abolition of child factory labor in its present form. Combination of education with industrial production, etc.

Why public (i.e. government) schools instead of private? To control the children's political and social indoctrination. It's working.

Abolition of child factory labor was probably the only good idea in the whole mess. Also probably the least necessary, as rising factory wages for adults would have eliminated the need for families to send their kids to work in sweatshops in a free market.

Planks number 4 and 9 seem more applicable to Europe, where the manifesto was written. The rest are well under way here in the United States today.

Then Callet #2 vowed to "pink-slip" his twelve employees and go back to operating his business all by himself.

I cherish this kind of Atlas Shrugged talk. There must be some way to get some literature to these fine, upstanding, patriotic Americans.

A campaign hangover feels like disappointment/despair/anger/bitterness/contempt/emptiness/mean-spirited hatred, and it's always worse than I think it could possibly be I mean, what did I expect? Still, there's no outlet for this dreadful grief except maybe to slap around a postal worker, and that's against my principles.

What has happened over the course of several election years is that all these nebulous negativities have hardened into a resolve that's beginning to frighten me.

No way. I'm not giving up. They (the establishment in general) isn't taking my commitment to liberty away from me, although they may end up with just about everything else. And isn't it about time we get started on the 1994 campaigns, instead of sitting around here whining?

The steady and rapid growth of the Libertarian Party continued despite both Ross Perot's media sideshow and active campaigns by more alternative parties than ever before.

Andre Marrou received 300,000 votes. While we were disappointed with this, we always knew we were not going to win the Presidential election. That is why most of our work and money concentrated on state and local elections. In one state-wide race, Libertarian candidate Richard Draheim received over 400,000 votes in his campaign for Texas Railroad Commissioner.

Seven other Libertarian candidates were elected including four State Legislators in New Hampshire, and many county and city officers.

Major Party ballot qualification was won or retained in 18 states, which will greatly reduce our petitioning requirements in future elections and allow us to spend more time, money and energy on our campaigns, and

Nillions of voters split their fickets to vote for at least some Libertarians, many for the first time. Libertarian candidates for local and state offices in every state received double-digit percentages and totaled over 3 million votes.

The cracks in the foundation of the status-quo have become too big to hide. More people than ever agree that big government doesn't work, and are ready to vote for less government.

It is important and useful to let our members and supporters know about these results. It is even more important to let the public know there is an alternative while there is something left of our country to save. We know by now that we can't count on the news media to understand or report the importance of our progress. We are going to have to publicize these results ourselves.

20% of the American people are fed up with the Republicans and the Democrats. When you factor in the 45% of the electorate who did not even bother to vote, we are talking about 65% of the electorate being fed up with the system! This represents an untapped gold mine for the Libertarian Party.

Turning to the U.S. Senate races, for those of you who don't know, my final vote total was 34,527, which represented .7% of total votes cast. However, nation-wide, our Libertarian U.S. Senate candidates received over 1,243,279 votes! We had an 8-way race in Illinois. The final vote totals were in direct proportion to the news media attention (or inattention, as the case may be.)

In the U.S. House races, Libertarian candidates received over 803,000 votes. Perhaps even more importantly, there was a 100% victory for term limitations referenda in 14 out of 14 states on which that question appeared on the ballots. And of course we defeated the dreaded Berman Amendment here in Illinois, which would have increased taxes by billions of dollars and taken what local control is left in the government school system.

During the campaign, it became apparent there are even closet libertarians among the Republicans and Democrats. These people represent another untapped mine for the Libertarian Party to work.

Election '92 was a building process. Now, we must continue to build on our achievements. We have identified people around the state willing to act as county coordinators. We must continue to identify friends of liberty and remain eternally vigilant in our struggle to restore the Constitution.

One Strategy that Worked

It had been my number one goal this year for the '92 campaign to be able to vote for a Libertarian candidate from president on down to state representative. I succeeded in that goal and in the process Ken McCracken running for state representative in my 39th district received permanent ballot status by getting 12% of the vote in a two-way race.

The work I put in getting us permanent ballot status really wasn't that extensive because it only amounted to recruiting candidates.

Upon Ralph Miron's recommendation, Ralph, Helen Heyden, and I recruited Andrew Spiegel for U.S. Senate. Then, I made a pact with Ralph. If he would run for Congress, I would run for State Senate. He agreed. The only position left was state representative. I asked Ken McCracken if he would run at least a paper candidacy for state representative in the 39th district. He agreed. Ken is in the process of developing a new career as a trader, and so did not really devote much time to the campaign. But he did answer some questionnaires and it turns out that he ran in a two-way race, virtually guaranteeing future permanent ballot status if he got on the ballot.

It is important to note that neither Ralph, Ken-McCracken nor I got sufficient signatures to qualify for ballot status. But only Ralph got challenged. So Ken and I were on the ballot and Ralph was on as a write-in candidate. I fulfilled my goal to vote for a Libertarian candidate from president on down to state representative.

So my first point I would like to emphasize to all activists is that there really wasn't that much work required to do the minimum to get Libertarians on the

ballot, to be able to vote for them and to actually get permanent ballot status for one district. So I urge everyone in the next election to try to do at least this minimum amount. Our party will grow in leaps and bounds in proportion to this minimal work.

Now, granted I actually did do a lot more. Since I wanted to assure ballot status, I helped Ralph Miron get signatures to be on the ballot, and also got some for Ken McCracken and myself. In the process I gathered 3500 signatures (1500 paid for by LIFBAC for our state slate) from president on down. If we had 100 activists pursuing the same strategy throughout the state, I am convinced that the Libertarian Party would become a household word in Illinois. Ballot status would be easily obtained for our Gubernatorial race. And we would probably get permanent ballot status in a minimum of twenty five districts. It also seems reasonable to assume that as more Libertarian candidates are on the ballot in Illinois, that will help increase our vote totals in a geometric fashion. We will be perceived as a serious party with numerous people on the ballot. State party ballot status would be a realistic possibility.

Andre Marrou received three and a nair diffiel as many votes in my precinct (on a percentage basis) as be did in all of DuPage of the state for that matter. I believe that was due to having Libertarians to vote for in other races besides president, and also because of literature distribution in my precinct.

"All politics is local," is a familiar phrase and very true. We need to get involved locally—not only politically but in social organizations; letters to the editor, and in the-neighborhood. To the extent we develop local contacts and run for office locally, district-wide, or county-wide is to the extent the Libertarian Party will become a serious party country-wide.

them. We do well at communicating our principles to urban and suburban educated white collar workers and intellectuals. We have failed to explain our ideas to these people.

Size We need to develop our explanations of free-market economics, free-trade, non-intervention, and tolerance of other lifestyles so that these people will understand that we mean these terms in their true sense, not the warped, distorted way the major parties use them and that these ideas are no threat to decent working people.

When they hear us say free trade, they probably think we mean free trade for the government subsidized monopolies like the Republicans mean. When they hear us say tolerance, they must think we mean to support the irresponsible like the Democrats mean.

If the Libertarian Party fails, it will be because we failed to attract working people like these who will get off their couch and get out and campaign for what they believe in

Future elections should get more interesting as more people get disgusted with the two larger parties, and more new political parties and independent campaigns are started by both people with a vision and by ambitious opportunists.

PEROT SAVES THE STATUS-QUO... for a few years.

Early in this campaign, Andre Marrou released his campaign plan. One item in his plan was an acknowledgement that "there will always be an Anderson." This was a reference to the 1980 campaign, when Libertarians hoped the media would cover Ed Clark as the outsider candidate only to have the media focus on John Anderson, a Republican sore loser. The media repeatedly and erroneously referred to Anderson as a "third party" candidate.

Andre's prediction came true with a verigeance.
This year the news media chose government-contract.
Billionaire and long time political activist and contributor Henry R. Perot as their featured "outsider."
Again, they referred to Perot as a third party.

It must have been frightening for them before Perfot entered the race. Voilers had already rejected second-generation career politicism serry Brown and long-time political Columnist and Nixon speech. Writer Pat Buchanan in their bids to be this year's official "outsider."

The Libertarian Party expected to make recordsetting progress this year, and have an unprecedented opportunity to get our message before the public.

When Perot made his initial announcement of "willingness to serve" on the Larry King show, our phones almost stopped ringing. Many Americans who were unhappy with the status-quo jumped at the chance to support an "outsider" candidate who actually had a chance at winning the election.

The fact that Perot wouldn't say what he would do about the issues didn't prevent him from rocketing up in the polls, as Americans who were desperate for change grasped at this straw. At his peak, some polls showed Perot beating both President Bush and Democrat challenger Bill Clinton.

Many of Perot's objections to the present system were valid. Few of his supporters seemed to notice the irony of a man who has had both hands in the taxpayers' pockets since the 1950s suddenly discovering that the government is spending too much.

When Perot started talking about what he would do about the problems facing the United States, it became clear to most that this was not the thinking of an outsider they were hearing. Perot had a big-government solution in mind for any problem anybody could think of. He seemed to believe that his election would cause reform in Congress and the bureaucracy. He also seemed to believe that the same sort of programs that turn into hopeless boondoggles under anyone else would work just fine if he were in charge. What would happen after he left office was never considered.

In July, when Ross the Boss announced that he would not become a candidate, many Libertarians thought there might be a great opportunity to win over

these people. Some of those who supported Perot just because he might hurt the two-party system did come over. But most of us who tried to contact the hard core Perot organizers were disappointed to find that most of them want the government to do even more than it is doing now.

Apparently, many of Perot's supporters believe the media stories and Democrat myths that the government hasn't been doing anything for the last twelve years.

Hard core Perot fans seem to think that more efficient government intervention in the economy and in world trade will solve the problems caused by government intervention in the economy and trade. They believe more efficient tax collection will solve the problems caused by taxes being too high in the first place. All Perot and his fans have to offer is more of the same kind of thinking that got us into this mess in the first place.

For an example of the efficiency we might have enjoyed under a Perot Administration, consider this. The Libertarian Party spent less than \$500,000 to get on the ballot in all 50 states. Mr. Super Efficient Capitalist Businessman Henry R. Perot and his grass roots younteen spent over the ballot in all 50 states. But the kinds of performance, we have come to expect from government contractors.

In the end, Perot cost the Libertarian Party in two ways. He received many votes from malcontent voters who might have voted for an alternative party because "none of the above" was not on the ballot. More importantly, he took enough of the anti-Bush vote away from Clinton to make the race between Bush and Clinton closer than it would have been. This caused many people to vote for either Bush or Clinton who would have voted for Andre Marrou if Clinton had been a sure winner.

Perot delayed the inevitable collapse of big government in the United States, but nothing can save a system that doesn't work. We did make good progress in state and local elections despite our disappointment with the results of the presidential election.

Perot or somebody like Perot will probably become a regular feature in presidential elections. We will concentrate on progress in the Congressional and state office elections held between the presidential elections when there will be no such distractions. The 1994 campaign started on November 4th.

Mission: To educate Illinois citizens on their already existing right and power to judge not only the facts of the case but the law itself while sitting on juries and grand juries.

What are Fully Informed Juries?

The heritage of fully informed juries or the right to jury nullification as it is sometimes called, dates all the way back to the Magna Carta. It is our common law heritage that juries are the last arbiter of the law itself. Our founding fathers understood this and thus assured that right through the sixth and seventh amendments to the US Constitution.

Thomas Jefferson said it this way, "I consider trial by jury as the only anchor yet imagined by man by which a government can be held to the principles of its constitution." And John Adams, "It is not only his right, but his duty . . . to find the verdict according to his own best understanding, judgment, and conscience, though in direct opposition to the direction of the court."

First US Supreme Court Chief Justice and author of the Federalist Papers, John Jay, charged the jury in the first jury trial in front of the US Supreme Court, "It may not be amiss, here gentlemen, to remind you of the good old rule, that on questions of fact, it is the province of the jury, on questions of law it is the province of the court to decide. But it must be observed that by the same law, which recognizes this reasonable distribution of jurisdiction, you have nevertheless a right to take upon yourselves to judge of both and to determine the law as well as the fact in controversy both objects are lawfully within your power of decision."

The Court unfortunately ruled that jurors need not to be told of this power.

What LIFBAC Does for You as an LPI Member

You aren't a friend of the IRS—that seems obvious, or you wouldn't be reading this newsletter. You also are a supporter of the Libertarian Party of Illinois with your hard-earned money and leisure time.

Consider this: Would you want the LPI—always short of hands to do its political tasks—to have to find people to prepare tax returns and the money to pay income taxes each year?

How about reports every three months to the State Board of Elections? And how about providing many levels of bureaucrats with complete reports on every financial detail of party operations?

Or how about this: If a paid ballot petitioner turns in a batch of falsified signatures, is miffed at not being paid, and files a lawsuit, would you want to be partly liable for paying for lawyers to defend the party, since you are an LPI member?

LIFBAC Insulates the Party

Don't worry, though. You ought to be insulated from these burdens in being a member of LPI—and to a large entage, you already as the second isted since 1976 that helps take care of these concerns,

for ballot status in Illinois.

That organization is a political action committee (PAC) called the Libertarian Fair Ballot Access Committee, or LIFBAC. You've seen many references to LIFBAC in fundraising letters, at our state conventions, and in this newsletter. You deserve to know in some detail about this organization.

LIFBAC helped the LPI's candidates gain statewide ballot status in 1992 at a cost of about 60 cents per signature. That is down from a cost of \$1.00 per signature in 1988—and a savings of \$13,000. Many LPI and LIFBAC activists have gained expertise that is saving the libertarian movement a great deal of money.

Why have a separate entity for this? Why have some other non-LPI group that takes our checks? Because LIFBAC is in a position under Illinois and Federal law to take many different burdens off the back of the LPI. It frees us as LPI members to get the word out about our philosophy and our programs.

What LPI Would Have to Do Without LIFBAC

Political parties that don't have permanent ballot status have a vague and fuzzy status under Illinois law. (As well as in what most of them stand for . . . but you knew that.) In the law's phrase, they are "miscellaneous other organizations" that don't have to file State Board of Elections reports.

Can such parties legally donate to their candidates' campaigns? It's a murky subject that still needs to be litigated. What about general efforts to comply with the law, such as petitioning to get ballot status? The LPI could do this itself. But unless we did it entirely with volunteer labor and donations in kind of material—and

you know how hard that would be-LPI would have a truckload of restrictions and rules dumped on it:

- All individual contributions and all expense payments over \$150 in a year would have to be reported to the State Board of Elections, and an individual would be limited to \$1000 of donations per year.
- For federal campaigns, several completely different—and confusing—limitations and reporting requirements apply.
- The party would have to file its very own type of tax return, called Form 1120 POL, and any petitioner (or other person) earning over \$600 from the LPI would have to be given a Form 1099 to allow a report to Uacle on April 15.
- And let's not forget a large stack of quarterly, semi-annual, or annual reports that would have to go to the State Board, the Federal Election Commission, and other agencies.

Nice, eh? Wouldn't you rather have our LPI officers spending their time and your dues on a better news letter, on educational literature, on supporting local clubs and campus reps, on funding street-fair booths?

Many of the past LPI officers thought so.

LIFBAC Takes On the Burdens

tition drive every other year with far fewer burdens than the LPI would have. LIFBAC is registered as a PAC with the Illinois and Federal governments. It can, as it has told the State Board, "organize and finance petition collection for Libertarian Party candidates" and "lobby for changes in Illinois ballot access laws."

LIFBAC does have to handle paperwork for all of this—but only for matters of ballot access. If the Illinois party took this on, all LPI business would become part of public records that anyone could look at! LIF-BAC keeps the bureaucrats' prying to a minimum under the law, and insulates the LPI and its members from giving up more of their privacy.

We could also, legally, make use of LIFBAC to organize and finance campaigns for individual candidates. But because of other requirements, it's better to have a separate, formally organized campaign committee if a candidate actively seeks outside donors.

(LIFBAC provided some money before the 1992 LPI State Convention to assist with paperwork and setup costs for the Grenke for Congress campaign and for some local costs of the Marrou/Lord presidential campaign. This money, about \$900, made use of the residue from the 1990 ballot drive. It also required LIFBAC to file a sheaf of paperwork with the FEC! Since LIFBAC isn't legally well suited to providing campaign support, it no longer will be doing so, even indirectly. All money raised in 1992—and then some—was used solely for ballot access. See the table that accompanies this article.)

Illinois Libertarians also have a ready-made conduit, with LIFBAC, for help from the National LP Baltot Access Committee. They helped our 1992 petition drive with over \$6,000 in direct cash and by paying thousands of dollars in other expenses for several groups of traveling paid petitioners. With such money being sent through LIFBAC, the LP donors elsewhere are given more assurance that the money they give to the National BAC will go directly to help Illinois get on the ballot—and thus indirectly help the 50-state effort in presidential years.

Finally, LIFBAC provides a partial shield for LPI against claims of liability in carrying out petition drives. The party is not, and cannot be, a corporation. All members could potentially be jointly liable for its actions. The LPI was sued once, several years ago, in a matter arising from a member being charged with violating the membership pledge. Even though LPI won its case; it was pretty expensive for the officers that other named members in the suit, who took on the expenses involved.

Paid petition drives are the times when we deal most with people not affiliated with the LPI. They have their own potential pitfalls, such as disputes over configuration or independent contractor status for petitioners. LIFBAC helps shield the LPI from all of these concerns.

A Long Cooperative Bifort

LIFBAC is legally independent of the LPI—but the two have nonetheless had a long and close association. LIFBAC had used the party's post office box and mailing permit for many years (until recently, when logistics made separate arrangements easier to handle). The past chairs of the LPI have traditionally taken up positions as officers of LIFBAC, including yours truly and Sue Walton, the current LIFBAC chair.

LIFBAC has several LPI members on its board, assisting with that paperwork that LPI shouldn't have to worry about. If you want to get involved, you are more than welcome to express your interest and participate—no secrets are involved, as some have mistakenly felt about LIFBAC recently. LIFBAC does appoint its own board members as an ongoing committee, but any interested LPI member is welcome to seek membership or attend meetings.

Our LIFBAC work has come to its alternate-year hiatus, now that the state and national LP candidates have been listed on the 1992 ballot. If LIFBAC had any notable money left over, it would be kept to earn interest for the 1994 ballot drive—or would be available to make mailings possible to urge LPI members to lobby for support of beneficial ballot access bills (as we have heard some state legislators are thinking about introducing). But we gauged our expenses carefully this year, and only a small amount is left to keep our bank account open.

Those of us involved in LIFBAC look forward to being able to help the Libertarian ballot access cause again in 1994. It'll take us that long to get rested up!

LIFBAC Income and Expenses for the 1992 Ballot Drive:

A Summary for LPI Members

During this ballot drive season, the amount of funds raised from the generosity of Illinois libertarians almost equaled the amount paid in cash to well over 50 petitioners.

The donation that LIFBAC received from the LP National Ballot Access Committee thus paid—almost—for the additional expenses of printing petitions, making fundraising mailings, keeping everyone involved in touch by phone, printing some material for parade petitioning, paying for some petitioners' motel rooms and plane tickets ... and a few dollars to feed the late-night crews that assembled and notarized the petitions.

(National's cash donation to LIFBAC was in addition to another huge amount of petitioner expenses—food, transportation, and shelter, mostly—that National carranged and pasts for directly. We estimate those costs to be at least another \$6,000 to \$7,000.)

You can see some of the summarized details of this year's huge effort in the figures below and in the two bar graphs.



Ballot obstacles

To the Editor:

Republican Central Committee member Fred Pehrkon's letter to *The Star* Sept. 13, lamenting the perennial low voter turnout, questioning voter apathy and exhorting people to register and vote, displays a familiar theme in the media as the November election approaches. While few would argue with the validity of the points that the letter raises, nevertheless one important contributing factor to voter apathy is omitted: ballat access laws.

Ballot access laws, not required by the U.S. Constitution but passed at the behest of the two major political parties, make it very difficult for independent and third-party candidates to get on the ballot. These candidates must obtain enough valid petition signatures within a short period of time that will satisfy the election commissioners' requirement (for example, 25,000 for a statewide office) and a margin of signatures beyond the minimum requirement so that the petition can survive any challenges by contenders. Even if ballot status is achieved by this grueling process, the

non-major party candidates then find that they have little resources remaining with which to mount an effective campaign. As a result, few candidates outside the two major parties gain ballot status.

While many voters are content to be limited to major-party sanctioned candidates, an increasing number of voters resent the limited choice, see no point in voting, and drop out of participating in the political process. This year's Perot phenomenon shows that this voting block may be very substantial indeed.

Abolishing ballot access laws and restoring competition to the polling place will do more to increase voter turnout than periodic articles and letters on voter apathy.


