The Statewide Races

With the general election just a few weeks away, the various campaigns are going into high gear, with LPC candidates appearing on radio, TV, before groups—even in schoolrooms.

It's crucial to our future as a political party that we do well in November. To stay on the ballot it's necessary for one of the state-wide candidates to get at least 2% of the vote. That could well be Ray Cullen or Norma Jean Almodovar—but nothing is sure in this game till the last ballot is tallied.

To insure a good vote total, our candidates must get the message out—and to do this they need speaking engagements and the wherewithal to travel or print and mail literature. Since no candidate can ever have too many speaking engagements or too much money, special requests by the candidates for these prime commodities are included in some of the campaign overviews.

Joe Fuhrig: The gubernatorial campaign has kept Joe busier than he had expected. As a professor of economics, he has the heaviest teaching load of his career—seven classes per semester—yet that hasn't discouraged him from traveling up and down the state. He's visited high schools and has been on radio and TV, such as a one-hour call-in talk show on KGO, San Francisco. He's also invited to be on KCBS, but the date hasn't been set.

Norma Jean Almodovar: The lieutenant governor candidate has received a great deal of publicity, with articles about her appearing even in the international press. Wherever she goes, she carries the libertarian message of individual liberty.

Although she has a number of speaking engagements lined up, she'd like more in the northern part of the state, particularly for October 20-24.

It's an active campaign with a lot being done, so every Wednesday evening a work-party is held at Campaign '86 headquarters, 7250 Franklin, Los Angeles (near La Brea). Everyone's invited to come and help.

Richard Winger: An editorial in the Escondido *Times-Advocate* (San Diego County) pointed out that the state constitutional offices can be some of the best political battles, with that of the secretary of state providing a chance to "shine the spotlight on how elections are administered." The *Times-*

Advocate observed: "There is an interesting candidate in this race from the Libertarian Party, Richard Winger of San Francisco, who has spent most of his life studying the esoteric provisions of California election laws. If nothing else, maybe he can shine some light on those grisly details." Which is exactly what Richard's been doing, and he's picked up some supporters along the way.

He's earned the endorsement of John B. Anderson, former Congressman and independent presidential candidate. Also, 15% of MAPA (Mexican-American Political Association) delegates to the statewide endorsement convention on Aug. 23 in Sacramento voted for a MAPA endorsement of Richard, after hearing him speak about the bad effect the California election code has on Mexican-American political representation.

Richard has pledged to go anywhere in the state to speak out against California's election laws, the worst in the U.S.A.

Carol Newman: "Pleasant as Carol Newman is to talk with, she's very tough minded and hits you gently with hard ideas. I mean, a debate with her is a debate, not a recital of empty rhetoric or a shouting match." That's how attorney Art Bell, writing in *The Compendium*, a legal newsletter published in Woodland Hills, describes the LPC candidate for attorney general, while reminding readers that John Van de Kamp isn't the only one running for that office.

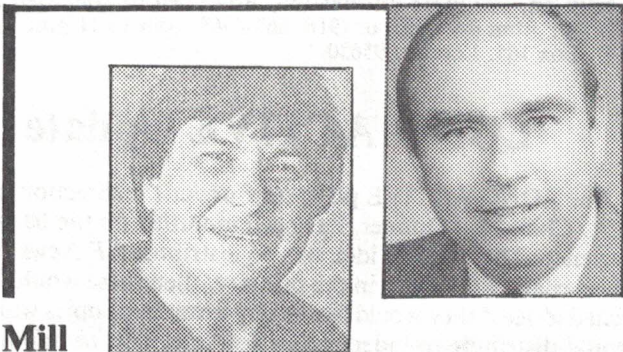

Meet the Candidates



Betsy Mill **38th State Senate District** **(San Diego County:** **Oceanside, Escondido, Mira Mesa)**

Because no Democrat waged a write-in campaign to get on the November ballot, Republican incumbent William Craven's only opponent will be Betsy Mill, 48, a member of the Libertarian Party.

Candidate Mill, of San Diego, directs sales and marketing for a small publishing company and also helps run the family upholstery business. She has run unsuccessfully for the San Diego Unified School District Board of Education and the San Diego County Board of Education.

As a Libertarian, she favors abolishing the state income tax and also favors repealing laws she contends interfere with people's lives.

A recent example, Mill said, is the state's new mandatory seat-belt law. "I put seat belts in my car when you had to go to a special shop to have them installed," she said, "but I object to the government being a wet-nurse nanny and telling us we have to wear them."

Mill also contends that drug laws do little more than foster crime. "We are putting people in prison for small amounts of marijuana, but we are letting people who do violence to other people go," she said.

Carol is looking for more speaking engagements and would like to do a swing through Northern California. She's tentatively scheduled to speak in San Francisco before Libertarians for Gay and Lesbian Concerns the week-end of October 17-18, so sometime around that date would be fine.

Also, she wants to do a direct mailing of her campaign brochure (it was included in last month's *CLNews*) to 20,000 Californians in selected precincts and areas, and this will cost about \$2,000. Donations should be made out to Carol Newman for Attorney General, 7150 Carlson Circle, #19, Canoga Park, CA 91303.

Ray Cullen: The race for treasurer is virtually uncontested, with no Republican challenger facing incumbent Jesse Unruh. But *Political Pulse*, a bi-monthly publication from Sacramento, took note of the fact that there is, nonetheless, another candidate, Costa Mesa CPA Ray Cullen. Ray was interviewed for the August 22 edition. He pointed out that the office itself is essentially a figurehead position, with no real role, and that if elected he would try to have it combined with that of controller. He hopes to garner votes from those voters who are fed up with extraneous state offices.

John Murphy **75th Assembly District** **(San Diego County:** **Solano Beach to Imperial Beach)**

While Democratic write-in candidate Michael I. Lasky, 44, favors greater governmental control to handle key problems, Libertarian Party candidate John Murphy, 45, would be happiest if government control could be removed from practically all societal aspects.

Financing education concerns Murphy in a different fashion from Lasky. "I would like to get government out of the schools," said the father of two, who also would like to see mandatory school attendance abolished. Although ultimately he favors a fee system under which everybody pays according to usage, he proposes for the short term, a system under which each student would receive a voucher in the amount of money the state spends on education per child.

Getting government out of just about every program, including welfare and medicine, is Murphy's ultimate goal. "What a man earns, he should keep," said the marketing executive of a major bank and former Navy Supply Corps officer. "Philosophically it is right and pragmatically it is correct." The state is a "massive bureaucracy" whose only legitimate functions are defense and security matters—but not to include Border Control. On the contrary, "I favor a five-word amendment to the Constitution: There shall be open borders," said Murphy, whose mother, and the family of his wife, immigrated to the United States from Italy.

Where the Votes Are

Going for the Gold

Did you know it is estimated a full 1/3 of registered Republican voters are personal libertarians? WOW! That's like knowing where the mother lode is located, and all that is needed is a shovel to did the gold.

Consider this: Every registered Re-publican's name, age, and address is a matter of public record. Additionally, occupation and telephone number is usually included. How easy it would be to target a particular type of Republican voter in a specific precinct. Each precinct has a voter population of about 300 people, and about half of them are Republican's. These are very manageable numbers.

A carefully designed letter (or small series of letters) targeting a specific type of voter by age or occupation could be tested in different precincts until one is developed that yields a good return of new registered Libertarians and activists. The success of each type of mailing can be easily measured and quantified by including an LP membership application and a voter registration card. Once an effective mailer is developed, a statewide mailing strategy can be implemented from each county or region that is interested.

Are you, or do you know, a word-smith or letter designer who would be interested in developing the prototypes? I would be glad to send copies to all of the county and regional chairs so that they may be tested in the field throughout the state to find which works best. I will also correlate the results and share them with all of the chairs and candidates. Let me know if you are interested.

LONG ACTIVE Update

The LONG ACTIVE plan, now under the direction of West L.A. Chair Neil Donner, has been modified on the basis of experience. The original idea was to distribute *LP News* to those libertarians who voted in the primary, then these would be contacted to see if they would like to buy a hundred copies which they would distribute to independent voters in their neighborhoods.

But people like to have choices and were more eager to participate if they could give, say, only money or only time. So now there's three choices: contacts are asked if they'd like to contribute money, distribute *LP News*, or both.

The results so far have been very good, with a response rate of around 30%. \$700 has been pledged towards the purchase of the *LP News*, and there are now 68 area captains. The record for distribution so far goes to Cullene Lang, chair of region 66, who has distributed *LP News* to 100 homes. Several dozen new activists have been discovered; and one of these, Herbert Blinn, agreed to distribute 200 *LP News*!

As Neil points out, "The important result of all this will be that sizeable numbers of philosophical libertarians will have begun to work for the party organization for the first time."

The Sounding Board

Abandon Ship!

That's the call going out to LP members from some people within our organization. Some LP members want us to become an active sub-group of the Republican Party. They apparently feel that the Libertarian Party is not in a position to get anyone elected to a partisan office in our present role as a "third party" in the two-party system. Dick Randolph, a formerly elected state representative in Alaska, is one of these. He ran for governor in that state in the last election as a Libertarian *and lost*. In the past Alaska primary election he ran for governor as a Republican, apparently making a decision that he had a better chance of winning under that heading instead of Libertarian. *He lost again*. Before the primary, he made a statement to Libertarians throughout the country that if elected he would maintain his libertarian beliefs even though he ran as a Republican, and asked for Libertarian support. I don't know how much he got, but I *do* know he received none from me.

Why didn't I support Dick? Well, it's not that I didn't want him to win. I'm sure he would have maintained some libertarian policies if he had won the Republican primary and gone on to win the general election. But maintaining *some* libertarian policies is not what I'm after. I didn't support him because he was willing to compromise his beliefs *before* the election and call himself a Republican in order to win. I felt he would probably compromise his beliefs *after* the election when he had won, and more libertarian policies would have gone by the side of the road.

Another reason for us to keep the Libertarian Party, instead of trying to "invade" the Republican Party (which is a sugges-

tion of some of the "get elected at any cost" libertarians), is highlighted by the problems the LaRouche candidates are having with the Democratic Party. The LaRouche organization made a decision to infiltrate the Democratic Party and take it over so they would have an established political party as a mouthpiece for their Neo-Nazi point of view. They wanted credibility and they were going to use the Democratic Party name to attain it (even though we already know it's not a source of credibility). They are now having problems getting the Democratic Party to give them names and addresses of registered Democrats so they can be solicited for votes. In other words, one section of the party is refusing to cooperate with another section of the party.

It's my view that the Republicans would do the same thing to us as Libertarians. Sure, we could become part of the Republican Party to try and gain some "credibility" and get people elected, but what would keep them from cutting us out just like the LaRouche organization has been cut out. Besides, we can get people elected on our own. Alaska is proof of that, along with many non-partisan offices. We have already attained some credibility with the news media and registered voters. We would be compromising our beliefs, which is what makes us different from other political parties. We have a message. We can get it out on our own. We don't want to lie to the public—that's the reason we're operating our own organization in the first place. Other parties don't tell the truth.

So, when the question comes up, keep this editorial in mind: *stay Libertarian*.

The Nipton Connection

October 4-5 is the weekend for the Save Our Land Benefit and Rally to fight S-2061. This is the bill, introduced by Alan Cranston, which would create a 9.5 million acre East Mojave National Park. Those most affected by it—the ranchers, miners and property owners who will lose their land—are joining together to form a coalition of opposition.

Rally organizer Gerald Freeman told *CLNews* he would like to see the town of Nipton, where he lives, become "a libertarian showcase community" and he's working toward that goal. He reports "a lot of sympathy out here" for libertarian ideas and predicts that "if we can start in a small community, we can hit a note that will vibrate in ever-widening circles." Freeman puts out a newsletter (four times a year) advocating, among other things, hard money and a return to the gold standard.
