From The Folks Who Brought You The Cypress Freeway Infrastructure... by Kate O'Brien

There is an absolutely horrendous Constitutional Amendment which will be on the <u>June 1998 ballot</u> (unless the Governor calls a special election beforehand). It was put there by the *Professional Engineers in California Government* (PECG - a state employees union), and is called (in a rare touch of irony) *The Government Cost Savings and Taxpayers Protection Amendment.*

Currently, in order to get projects built on time, safely, and under budget, various levels of government are allowed to contract with private firms on a competitive bases for public projects. The PECG amendment would change the formula by which project costs are determined, stacking the deck against private A/E firms, and for the State Bureaucracy.

The proposed new formula would: (1) Set the cost of using state employees at zero. It specifically prohibits factoring in salaries, benefits, office rental and other overhead costs. (2) Require those same costs to be factored into any estimate submitted by a private firm (the way those of use who like to eat usually do business anyway).

As a result, no private firm would ever win a government contract, because the state employees are treated as free labor.

Furthermore, there is nothing in this initiative about the State delivering projects on time, under budget, or safely. And this initiative specifically states that if a private firm did get a small part of the project, they would be required to insure the entire project for the State's negligence.

Even with all the stumbling blocks in our way now, private firms consistently outperform state government. For example the Santa Clara County Traffic Authority used private firms for its entire transportation project. These firms completed the job seven years faster than the time estimated for the State to do the job.



Libertarians Must Address the Environment by Bernie Jackson

In the San Francisco Bay Area, stronghold of political correctness, the most common objection I hear to free market principles is, "what about the environment?" People seem to understand such basic economic principles as competition, supply, demand, and price, so they are somewhat amenable to the general arguments for economic freedom.





To silence this terrible mooing, we must do two things: (1) prepare a simple formulation of free-market environmentalism, and (2) make it clear to our Bay Area friends that we do not treat the environment as a pesky afterthought.

Unfortunately, the environment usually does appear as an afterthought in any discussion of economic freedom. This happens because we tend to focus on economic quantities (price, product quality, employment, etc.). When our brains are in "economics" mode, we usually do not have "environment" on the tips of our tongues. I think this creates the impression that we libertarians care more about low prices than whether or not our "fragile" planet survives, and it encourages our Bay Area friends to write us off as greedy fools.

To make matters worse, it can be particularly difficult to explain the relationship between private property rights and a clean environment.

While the fundamentals of supply, demand, and competition are fairly commonly known, the notion that private property rights *improve* the environment is alien to the average person. In this area, we have to start from scratch with each new listener.

I have found that a good starting point is the following question: "If you needed to dump garbage on a regular basis, would you dump it in your own yard, your neighbor's yard, or some land that nobody owns?" Another good one is, "Have you ever washed a rental car? Why not?" Choose an engaging question that will encourage the environmentally correct to start thinking about private property, and read up on free market environmentalism so you can help your green friends puzzle through it.

By focusing on these concerns, we may yet make mincemeat of the statists' final sacred cow.
