## Libertarian slate nominated for November Orange County LP Turnout is 28 percent

To no one's surprise, the entire slate of Orange County LP candidates won nomination to the party ticket for November by overwhelming majorities.

The nominees are **Scott Bieser** (Assembly Dist. 70), **Geoff Braun** (Assembly Dist. 72), **Gary Copeland** (U.S. Rep. Dist. 45), **David Keller** (Assembly Dist. 69), **Doyle Guhy** (Senate Dist. 33), **Richard Newhouse** (U.S. Rep. Dist. 46), **Eric Sprik** (Senate Dist. 35), **Brian Schar** (Assembly Dist. 67). **Richard Boddie** of Huntington Beach is the nominee for the "short" U.S. Senate seat held by John Seymour. **Paul H. King** of Oceanside is the nominee for Assembly Dist.

According to a "Semi-Official Election Sum-

mary" distributed by the Voter Registrar's office, LP Presidential nominee **Andre Marrou** received 1,297 notably less than Boddie's total of 1,463 and **June Genis's** total of 1,470 for the other U.S. Senate seat.

Boddie is running a serious, full-time campaign to win the two-year Senate Seat, noting that in a three-way race he only needs 34 percent of the vote to win and discontent with the major parties is at an all-time high.

The OCLP candidates are running a "no pain" campaign, asking for no countributions and chipping in for a special Media Guide sent to 50 area media outlets. They are all running as "citizenactivists" who have jobs in the real world.

# Libertarian petition calls for medical marijuana State AMA support cited, volunteers needed

An advisory petition calling to allow medical uses of marijuana in California is being circulated by Orange County Libertarians. David Keller is heading the local effort.

The petition notes a recent ruling of the California Medical Association that "theraputic use of cannabinoids under the direction of a physician may be appropriate for certain conditions." The LP of California is also mentioned in the wording, but signers "indicate nothing about their political affiliation by signing the petition."

The advisory petition is different from a citizen's inititiative petition in that it is not binding on the state government. It is only a demonstration of popular opinion. This sort of activity is useful to the

party because it gets activists out into the public, spreading libertarian ideas and the party's name.

"The first person to sign the revised petition was the photocopy machine operator who ran off the initial batch," Keller said.

Keller is asking Orange County activists for time and monetary donations in this effort. "Grassroots activity is relatively inexpensive, gives us a lot of bang for the buck' but isn't free and doesn't happen unless people get active.

"Volunteer petitioners, handouts ("The Libertarian Party Represents You" is fairly useful), cash and postage stamps are crucial," he explained. Anyone interested in helping David do this important work may call him at 836-6326.

# Letter: Bloxham drug policy threatens the movement

Letter-to-the-editor:

Roger Bloxham could not have done more to undermine the drug legalization movement in Orange County if he were a DEA agent than he did by publicly calling for the legalization of drugs for sale to children (FOC May '92).

Before, when our detractors expressed concern about juvenile drug use, we could say that we are calling for legalization for adults. This position is gaining support and has a real chance of turning back the tide of state encroachment into personal lives. Now, thanks to Bloxham, libertarians can and will be attacked for openly advocating legalization of drugs for children, a completely indefensible position that undermines our credibility immeasurably.

Judge Gray is clearly not a libertarian. It is important to keep his stand in favor of legalization, as courageous as it is, in perspective. But I cannot stand behind any call to legalize recreational drugs for minors. To do so is at best irresponsible, at worst suicidal.




