We're going public !

Sacramento Libertarians will be on TV Channel 63 starting Oct. 18 and every Thursday from then on. It's a half hour show aching at 8:30 pm. The first two shows were taped on Oct. 9th at 6:00 pm. at the Coloma Center- 46th and "T" St. with the "3R's"; Raming Rufer, and Roberts, with an eleven person production crew of Libertarians.

We are signing a 13 week contract with the TV station for a weekly show, however we will use the studio only twice a month and will produce two 30 minute shows at each session.

The name of the show was debated and settled by a close (16-1) vote at the last meeting. "Libertarians in Bondage", lost out to "The Libertarian Conspiracy." This title will be on the scroll and in the newspaper. Eventually most of the people in the 170,000 households that get the cable will be intrigued into watching us. Our show will be presented three times each week, once in the evening, afternoon and morning.

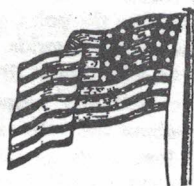
TALENT WANTED

Elections

It's almost over now. Except for the shouting and voting. To Libertarians, "Victory" is winning 2% of the statewide vote total for any one candidate. The counting part, is yet to come. That will tell the crucial tale. There is optimism that the obvious dissatisfaction with the entrenched legislative incumbents which will almost certainly result in a term limitation, will also carry us along in its sweep and accomplish our 2% goal. This will make further efforts so much easier for us as a party.

Libertarians can take time to pat ourselves on the back. What we lack in numbers and explicit credits is reflected in the power and quality of issues and ideas that other political efforts can only plagiarize. They grant us the satisfaction of winning by losing. The Republicrats must guiltily concede the Libertarian origin of their "issues" and retreat in the traditional manner of the "me too" Republicans before the onslaught of the Democrats. They, in turn have fallen back from the shopworn slogans of collectivism which in turn has dramatically collapsed in its "show case" of eastern Europe for the entire globe to witness.

In America the various breeds of collectivists have never placed a candidate in office, yet all the planks of their platforms are statutory realities now. They too, won by losing. Failing to learn from their example could render our "Victories" to the Pyrrhic status of winning battles while losing the war.

Like any successful enterprise we must remain "pro-active, and market our "product" to an expanding market that finds it increasingly useful. While our goals may be "market share" (voters) and "profit" (Liberty) our method of competition is the pursuit of reputation: offering a value to our "customers" that is nobly reflected in the Libertarian pledge. The intransigent adherence to that Ideal is—and will be the key to our success.

The strategies And tactics we can aggressively employ present a kaleidoscope of opportunities.

Why must we tolerate "debtors prisons" for taxation bankruptcy while dis-allowing it in the private sector? Why not institute "Taxruptcy"?

What about the "Homesteading of the as yet undefined property rights—Utility and Transportation Corridors—government "surplus" lands, accessible Habitat and Environmental preserves—vertical air space for view preservation, fishing rights—etc. etc. etc.? Such issues could inflame the entrepreneurial drives of a population now plunging to poverty from Americas self induced "Industrieicide".

Are such things "property of the people", (control by special monopolistic interest groups) or is it a proper "custodial" function of government that the Homestead idea represents?

Is Victimless Crime, (punish or kill them for their own good), a sign of benevolence; or camouflaged malevolence?

A guaranteed drop in crime statistics of (verifiable ratio) a low percentage rate from a Libertarian Administration? That's more plausible than "holes" in the ozone layers peril.

The never before seen fact of Americas rise from "Developing 3rd World Nation" to that of "Greatest" in the scant historical years between the Civil and 1st World Wars Should scare the wits out of collectivist politicians when we advocate true "Free Enterprise" Zones.

Are employees "Second Class" citizens that should remain content with exclusion from taxation and benefit privileges granted to corporate entities—don't they market Their product (brains-effort) like anyone else? The "Freeloader" syndrome displayed by Republicrats is fuel to heap on the fires of shame of those who derive their benefits from the initiation of the use of physical force.

I won't belabor the point.

We have the worlds greatest product to sell Liberty. SELL we must. To dutifully respond by bitching about the evils raised by political lust, is to retreat in the battle for the rights of individuals.

LIBERTARIAN PARTY VOTER RECOMMENDATIONS

Please take this slate sheet to your polling place to assist you in voting for Libertarian positions on the ballot measures and to help you identify the Libertarian candidates.

Statewide Ballot Propositions:

- 124 No. Libertarian Ted Brown wrote the arguments against this measure which would authorize local hospital districts to acquire stock in corporations engaging in health care related business.
- 125 No. Libertarian John Vernon wrote the arguments against this measure which would allow the diversion of gas tax money for the acquisition of rolling stock for public mass transit systems.
- 126 No. This proposition would impose a heavy tax on alcoholic beverages; revenues to go into the general fund.
- 127 Yes. This measure allows a tax exemption for earthquake safety improvements.
- 128 No. Requires stricter regulation of pesticides and a phase-out of cancer-causing agents. Creates office of "Environmental Advocate". \$40 million for environmental research. \$300 million in bonds for ancient redwoods and forest projects. While the Libertarian party supports protection of our environment, the establishment of another bureaucracy is not the right approach.
- 129 No. This \$740 million bond issue would perpetuate the war on drugs.
- 130 No. This \$742 million bond issue would allow the state government to acquire more ancient forests, further increasing the 50% of land now controlled by government in California.
- 131 No. While this measure is said to limit terms of office, all it really does is limit *consecutive* terms. For instance, it would allow members of the Assembly to serve twelve years, take a two year break, and serve twelve more years. We suggest you support Proposition 140 instead.
- 132 No. Makes the use of gill or trammel nets for fishing purposes illegal after 1994.
- 133 No. Would increase the state sales tax another half cent to fight the war on drugs. More anti-drug hysteria.
- 134 No. You thought you were seeing double? Another proposal to increase taxes on alcoholic beverages by an estimated \$830 million a year.
- 135 No. Steps up the inspection of foods and vegetables and expends more money on pesticide research.
- 136 Yes. This proposal to require a two-thirds vote for the passage of special tax increases was placed on the ballot by the Gann and Jarvis groups.
- 137 Yes. Also placed on the ballot by Jarvis and Gann, this initiative would require changes in initiative or referendum processes to be approved by the voters.
- 138 No. A \$300 million bond issue to acquire more timberlands.
- 139 No. Allows putting state prison inmates to work for private business to pay their upkeep and victim restitution damages.
- 140 Yes! Also known as "Operation New Broom", this initiative sponsored by L. A. County Supervisor Pete Schabarum, Lew Uhler of the National Tax Limitation Committee, and Libertarian Mike Ford of the Marin United Taxpayers Association, would limit members of the Assembly to three two-year terms, and all other state office holders to two four year terms. It would also reduce the amount of money spent running the offices of Assemblymen by at least \$60 million a year. Eliminates the special pension plan of the Assembly and places them on Social Security.
- 141 Yes. Applies Proposition 65 toxic reporting requirements to governmental agencies.
- 142-151 No. Afterthought bond issues; Libertarians John Vernon, Ted Brown and Bill McCord wrote arguments against five of these ten bond issues. We urge a NO vote on all of them.

BOOK REVIEW

*Cutting Back
City Hall*

Author: Robert W. Poole Jr.

The founder of the Libertarian oriented monthly magazine, Reason as well as the Reason Foundation, has written (1980) what should be, in this writers opinion, "The Manual" of Libertarian grass roots activism. In a calm, lucid and thorough style he has outlined in sixteen chapters and 224 pages, the issues most readily available to Libertarians that bring the message of individual liberty and awareness of effective actions to a confused public eager for solutions. Mr. Poole has succeeded admirably in translating the abstract notions of the Libertarian ethic into empiric and pragmatic, workaday political solutions.

There is little about "demonstrations", precinct "grunt" work, or confrontational situations described in this book; just workable, logical, options. What's more, it is full of - wonder of wonders - examples - of concrete applications tried and in use elsewhere! This is powerful stuff when presented to a skeptical public or hostile politico's.

Mr. Poole doesn't miss much. The more recent proliferation of the revived "mercantilism", and guild socialism that goes under the misnomer of "Urban Redevelopment" perhaps, but that would entail another book probably and the steps advocated in his book would highlight and nullify most of Urban Redevelopments evils.

Police, the Court System, Traffic, Public Works, Parks and Recreation, Zoning, Permits, Bldg Codes, and more come under his scrutiny. Even the public school system. Without esoteric theory, he illuminates the methods to employ in bringing about the organization(s) that nurture change.

Grass Roots activism without this book is like a horseless cowboy or hunting with an empty gun. Read it- and feel your brain ferment in the process!

Freedom and Fun In Argentina?

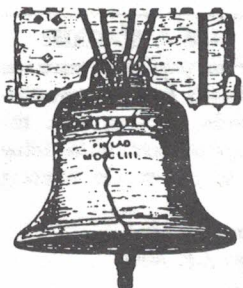

SAGA of CHUCK BOWER

Mark one up for our side. Remember the articles about Chuck Bower being arrested for jury tampering? When the judge and Chuck met again in court on Sept. 6th, Bower was found not guilty, furthermore, the judge stated that this case had been a clear violation of Mr. Bowers first amendment rights. He now intends to file a suit against the county for violating his constitutional rights. When I spoke to Mr. Bower he asked an interesting question. "Who - besides the judge, can file contempt charges?" In this case, it was the District Attorney of Amador County.

I called the D.A. office in Tehama County to inquire about this. They referred me to the Red Bluff Justice Court. I was informed that the D.A. could file contempt charges at the judges request, or at his own discretion. Comment: I am not sure what to think about this. Any input from our readers as to the pros and cons of the D.A. having this authority?

BAY AREA TOLL ROAD

The trend towards privatization has been picking up steam and supporters over the last decade. As the detrimental effects of government run services are felt more and more, people are seeking responsive ways of providing basic services. An old concept has been updated and presented to the Bay Area motoring public and that is, the toll road.

An international consortium headed by Parsons Municipal Services Inc. and including Australian and French banks has proposed the first major privately owned and built freeway in California.

The \$1.2 billion road would be 85 miles long, running from Vacaville to Livermore. The six lane road would be intended as an I-80 by-pass, to take commuters from the South Bay around the aging and clogged freeway to a connecting point for Sacramento bound or Redding bound traffic. Construction would begin in mid-1992 and be completed within five years.

Parsons, from Pasadena, is the engineering firm doing the relocation work for the collapsed Cypress section of the Nimitz Freeway, and also is handling a 30 mile toll road development in Denver. Another French partner of the consortium is the owner and operator of over 500 miles of toll roads in France.

Although no toll amount has been suggested yet, Alameda and Contra Costa county officials said the support the concept while some smaller communities in the roads path oppose it. Serious study by Cal-Trans has begun but will, of course, take some time. We'll keep you posted.
