## Introduction from the Chair

I write to introduce myself to you as the new State Chair of the Libertarian Party of Colorado. Let me skip the rhetoric. While I intend to make myself available to you, I will control the times, places, and degree to which I will be available to you. I do this not because I am an arrogant snob, but because my primary responsibility is to see to it that the new Board members know the "what, how, and when" of doing their jobs. I cannot do that job if my day is spent servicing unsolicited interrupts (yes, I'm another one of those computer geeks).

Getting the LPCO to grow to what we all want it to be is going to take a lot of work. The new Board will not be arguing political issues, making judgments about who is Libertarian or who is not, nor will it be devising strategies for "getting back at those nasty Republicans." We will be building structure and organization.

Structure is the design of an organization without the specific individuals. It identifies and isolates specific functions of an organization such that they can be performed by different people independent of each to the degree possible. A structure becomes an organization when individuals are assigned to the specific roles defined by the structure. While a structure can last a very long time, an organization changes constantly as the individuals involved change. Structure helps organizations succeed because each individual in the organization:

- 1) Understands exactly their individual responsibilities;
- 2) Knows exactly what to expect from the organization;
- 3) Is provided the authority necessary to fulfill their responsibilities;
- 4) Knows where to go for help, training, mentoring, assistance, etc;
- 5) Knows what specific organizational resources are available to them;
- 6) Knows that it is not a disgrace to send up the red flag if they become overwhelmed.

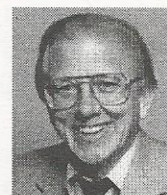
## Presidential Forum at the Convention

The 2003 LPCO convention opened Saturday, April 5 with a presidential forum. Seeking the party's nomination for presidential candidate were **Gary Nolan and Michael Badnarik**.

**Nolan** hosted "Nolan at Night," a nationally syndicated show with the Radio America Network. He plans to run on a platform to lower taxes, protect civil liberties and to limit our interventionist foreign policy. Nolan proposes that, if elected, he would dramatically reduce federal spending and personal income taxes in his first four years so that the combined tax burden does not exceed 25 percent for any taxpayer, in contrast to the current tax rate of almost 50 percent for the average American family. He said that the War on Terror has turned into a war on the individual civil liberties of the American people and that these tactics have no place in a free society. Therefore, he calls for the full restoration of civil liberties as a key component of enhancing national security. Regarding U.S. foreign policy, Nolan believes that we should no longer act as the armed social worker or global cop. He proposes an immediate reduction of our foreign initiatives.

**Badnarik** has programmed computers for a stealth bomber simulator and a nuclear power plant. He works as a computer consultant and teaches classes about the Constitution.

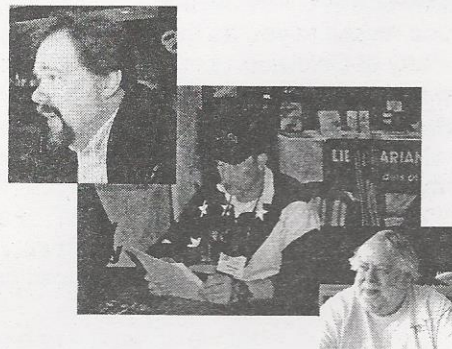
### Help Wanted:

### The New State Board at the Convention:

"Working Together to Imagine a Better America" was the theme of this year's state Libertarian convention, and working together is the theme of the new Board elected on Sunday. In what may be a first in the history of the Colorado Libertarian Party, an entire slate of candidates, the "Dream Team," ran a unified campaign to win election to the nine LPCO Board positions. The candidates emphasized the need for teamwork to reinvigorate the LPCO.

At the Sunday business meeting, six of the nine "Dream Team" candidates were elected to the Board.



For the position of Information Director, slate candidate Samantha Kelly lost to Boulder LP chair Bo Shaffer. In the contested race for Fundraising Director, former LPCO Chair Michele Poague defeated slate candidate Dana Wagenhoffer. For Media Director, slate candidate Jeffrey Oliver lost to Desiree Hickson, 2002 Libertarian candidate for Lieutenant Governor. Oliver subsequently ran for and won the position of Treasurer.

The composition of the new Board is listed at the bottom of the first page of this issue.

In addition, veteran LP activist David Bryant, who has served nine years on the Board in various capacities, will serve as senior advisor to the new Board. Cory Hanzlick is the webmaster for the new LPCO website. Our ranks of volunteers on many committees is growing with each day.

New State Chair Norm Olsen stresses the need for an activist Board focused on results. See the listing of Board member's goals elsewhere in this issue for specifics.

He spoke of the need to educate people about their Constitutional rights. He also pointed out that a right is something that you have the authority to do without asking for permission, while a privilege is something that a higher authority allows you to do. The Constitution, he added, is supplemented by the Bill of Rights, not a "Bill of Privileges." Badnarik emphasizes three issues in his platform: guns, schools, and drugs. He opposes the state assertion that, in order to own or carry a gun, he is required to fill out paperwork and supply photos and fingerprints to exercise a *right*, and that all gun laws are unconstitutional. Concerning schools, he notes that there is no Constitutional basis for granting the federal government the authority to control public schools, and that the entire Department of Education is therefore unconstitutional. Badnarik said the "War on Drugs" has propagated such civil rights violations as "asset forfeiture" and has succeeded only in raising the price of drugs and creating a profit incentive for violence and gang warfare. By decriminalizing drugs, he added, the illicit profit motive will be removed and our streets will be safer.

## What Does HB03-1142 Really Mean

Under Colorado legislative rules, a representative gets to introduce up to five bills in each legislative session. Once introduced, the title of the bill cannot be changed and the content of the bill must remain true to the title. In the event a representative realizes after introduction that a bill is bad news and needs to be completely overhauled, the representative does not withdraw the old bill and submit a new one. That would use up one of her/his five bills. The procedure is to amend the original bill by "Striking everything below the title" and replace it with the new stuff. Thus, the term a "Strike below" amendment has a special connotation in the legislative process. It essentially means, that this is an entirely new bill, which replaces the old. Only the title remains intact.

As passed and signed into law, HB03 1142 is just such a bill. At its first official hearing in committee, a "Strike below" amendment was introduced and passed to completely replace the original contents of the bill. Thus, the original draconian content was replaced by language which is distasteful to us, but doesn't put us out of business. Several of us who were intimately involved with the fight against HB03-1142 have opinions as to why the original draconian bill was dumped, but these are all theories. If you are interested in developing your own theory, contact representative Bill Crane; the sponsor of the bill.

Before HB03-1142, the process a minor party used to select its candidates was up to the minor party. While Colorado law set broad guidelines as to what the minor party Bylaws could and should do, the party's Bylaws specified how a nominees were selected. As Libertarians, our Bylaws provided for: 1) nomination by local affiliates which was ratified by the convention, 2) nomination by the convention itself, and 3) nomination by a vacancy committee (e.g. the Board of Directors) after the convention. As a result, after the convention, the Board of Directors could, by majority vote, nominate candidates and place them on the ballot.

HB03-1142 now specifies how minor parties will nominate their candidates. Minor parties will hold Assemblies for the purpose of nominating candidates not less than 65 days prior to the primary date (first Tuesday in August). At that Assembly, the party would nominate all of its candidates. Candidates can no longer be nominated after the close of the Assembly (other to fill a legitimate vacancy). The law also requires that all candidates seeking a specific nomination who receive 30% or more of the Assembly vote would be placed on the primary ballot. Yes, if HB03-1142 had been in effect for Election 2002,

we would have had a statewide primary and our nominees for Governor and US Senate would have been determined in that manner.

So, the major affect of HB03-1142 on the Libertarian Party is that we will simply need to have all of our candidate recruiting completed before the Assembly. At the Assembly, we would nominate our candidates as we have in the past. We would not be able to nominate additional candidates after the Assembly. (We could still fill a vacancy caused by withdrawal.)

The above represents the major difference between now and then as I see it. However, there are several quirks in the law which we need to be mindful of.

First, any voter registered as a Libertarian (long enough to qualify) may petition his/her way on to the primary ballot. The number of signatures varies, 1,000 would be all that is needed for governor. Some believe (as I do) that this could be used to sabotage a legitimate Libertarian candidate. Remember, at a primary election, any voter who is registered as unaffiliated can declare an affiliation and vote in the primary of any party. It wouldn't take too many "unaffiliated" voters to give the primary victory to an "unLibertarian" candidate who would then end up on the ballot with the Libertarian label. The "unLibertarian" could also withdraw at an carefully selected time, leaving us without any presence at all on the ballot.

Second, it is not clear as to when this law will take affect. It is my position that the 2004 election cycle has already started. It started on December 6, 2002; the 31st day after the last election day. I suggest that it is illegal and improper to change the rules of an election after the election cycle has started. Thus, I believe this new law cannot take affect until the 2006 election cycle starts on December 3, 2004. This is the opinion of a computer programmer; I wouldn't bet any money on it.

Third, the law is vague as to how many votes are to or can be taken at an Assembly. For example, if we have a contested nomination and the first vote goes 60/40, does that mean we're done? Does that mean the candidate who received 40% has earned the right to a primary election? Or can Assembly take another vote and see if the party can avoid a primary?

HB03-1142 as passed is not the minor party killer it started out to be. The "Strike below" amendment took out all the nonsense about having a party caucus in a precinct in which the party does not have even a single registered voter; a physical impossibility. What really bothers me, however, is that it is essentially a law by which the political party in power (the Republicans in this case) dictates how a political party out of power (all minor parties in this case) will choose their candidates. I thought they only did that in Cuba.

To actively support legislative action that repeals prohibitions, while developing our own legislation, and finding co-sponsorship in the current state house and senate.

Michele Poague:

As *Fundraising Director*, I have three primary goals. I would like to get at least three letters out to the membership. In the process, I hope to rebuild our Donors list. There are dozens of people who would like to be involved and who would like to contribute, but we need to re-establish contact with them. Second, I plan to offer incentives to local affiliates who can raise money for their own projects. These new incentives might include such prizes as trips to Disneyland or resorts in Mexico. Third, I would like to find and work with the person who wants to replace me at the end of my term in 2004, in order to maintain continuity following next year's convention.

Steve Gallant:

As *Publications Director*, my goals are the publication of a quarterly Liberty and the revitalization of the LPCO website. Our newsletter and website will inform current members, attract new members, support campaigns, and raise funds. The Liberty will chart our progress, document our successes, target our obstacles, and provide information for upcoming events. The website, developed by Cory Hanzlick, will provide essential state and affiliate party information as well as a frequently updated calendar.

Michael T. McKinzie:

As *Campaign Director*, I believe we need to do more than get names on the ballot. With your help, I will assist the Outreach Director in building local structure and organization that will attract qualified candidates with libertarian philosophies to be our candidates in local elections. We will do this by providing them with: a) ballot access; b) an established base of volunteers; c) a fund raising base; d) campaign finance reporting; e) public relations staff; f) event scheduling support; g) a brand name that they will be proud to affiliate with; and h) national affiliation.

Rand Fanshier:

As *Outreach Director*, I have a vision: A vision of the LPCO doing a great job to find, support and keep activists like myself and my team members, and to one day replace the jaded and cynical, worn-out politicians we've become accustomed to, with spirited, loving, champions of freedom. Wherever there is even one activist in a region, I will be there to help and support the growth of that local affiliate. I will facilitate organization and cooperation between the different groups in the state. I will support our candidates and push for our new campaign strategy.

Desiree Hickson:

As *Media Director*, my man goal is to make sure that the public, knows exactly where the LP and the LPCO stands on legislative and Constitutional issues that effect all of us, for better or worse. This includes increasing press coverage and expanding our notoriety, for the better. Getting more published or televised interviews and quotations from press releases used more consistently, especially as they relate to legislation or constitutional matters being addressed in state and/or local government.

Norm Olsen, *Chair*:

Given your support, as Chair, it is my task to insure that the others on the Board: a) know what it is they are supposed to do; b) know when it is supposed to be done; c) know how to get it done; and d) who to count on for help and support. Our Board is dynamic, energetic, knowledgeable, and experienced. But we will accomplish little without your support. Our success will depend on how well I do my primary job: Gaining your support for our activities. Can I count on you?
