#### 'Deceit Is Central to the Gun Control Movement'

The CU Campus Libertarians hosted a March 21 public lecture on civil arms. Bruce Tiemann criticized the intellectually dishonest arguments employed by gun restriction activists, while Ari Armstrong argued the anti-gun crusade arises from political interests, quasi-religious fervor, and skewed media coverage.

Tiemann told the crowd, "It was what appeared to be the demonization of guns and gun owners that actually got me involved in this subject, and the more I looked, the more I found dishonesty coming from the gun control camp. The level of deceit ranges from misuse of a single word all the way through the commission of scientific-looking, and widely cited, studies which are based on logical fallacies, and everything in between."

#### **Election Season Is Just Around the Corner!**

For voters, the next statewide election is a long way off. For candidates, the election cycle has already begun. As a Libertarian activist, I hope all of you consider yourselves to be potential candidates.

There are certain qualifications required of candidates for political office. Some of these can be bureaucratically painful to meet if the candidate waits too long to deal with the issue. The information contained in this article pertains mostly to state political offices. Check with your county clerk for the specific candidate qualifications for a given county office.

An individual qualified to vote in a specific election is an elector. An elector is a citizen of the United States, 18 years of age on or before election day, who has lived in the district of her registration for at least 30 days, and is registered to vote with the County Clerk. (Voter registrations for individuals who have not voted in any election over a period of eight years are automatically purged.)

Moving into a new county, or even a new voter precinct, and failing to re-register with the (possibly new) County Clerk will invalidate your voter registration and status as an elector.

To be a candidate, you must first be a qualified elector; that is, meet all of the above as a bare minimum. The Constitution of the State of Colorado adds additional qualifications for most offices; and the Libertarian Party of Colorado has some requirements that must be met before it will nominate you and place your name on the ballot.

The specific qualification that causes the most trouble is that you must have been a "registered" member of the Libertarian Party of Colorado for at least one year on the day that you are nominated. Two things are of note here.

First, you need not be a dues-paying member of the party to be a candidate. Being an active dues-paying member will certainly improve your chances of being nominated by the party, but it is not a legal requirement for being a candidate.

Not being a dues-paying member will not legally preclude the party from nominating you. Being registered with the County Clerk as a Libertarian is, however, a specific legal requirement. Thus, you could be a dues-paying member and contribute a million dollars a year to the party, but if the records maintained by the County Clerk in your county do not show you as affiliated with the Libertarian party, the party cannot legally nominate you.

Second, the important date here is the date upon which you are nominated by the party, not the day of the election. The last day that the party can officially nominate you and still get you on the ballot is the 120th day before the day of the election. So, this means that the state election records, as maintained by your local County Clerk, must show you registered as a Libertarian at least 16 months before the actual day of the election in which you desire to run.

This requirement is problematic as the County Clerk's records are often incorrect, especially if you have moved since you last filed a registration form. Normally, we don't care as long as we can vote. When becoming a candidate, however, it is crucial that the County Clerk's records are correct, especially with regard to party affiliation.

So, as a project for the month of May, I ask all Libertarians to call or visit their County Clerk's Office of Elections, and verify that your name, address, and party affiliation are correctly recorded. Further, should you move to a new county between now and the next state-wide election (November 2002), be sure to verify that the new County Clerk has a correct record of your new address, when you moved, your party affiliation, and the last date at which you declared your party affiliation. That is, it is important that the records showing how long you have been registered as a Libertarian are accurately transferred to the new county.

### **Howell Shreds Anti-Gun Law at Hearing**

Carla Howell won a record 308,860 votes in her year 2000 "small government is beautiful" Libertarian campaign for U.S. Senate against Ted Kennedy. A business consultant with an MBA from Babson College, Howell has worked in the private sector for 25 years in engineering, marketing, and management in the fields of high tech and health care. She is considering

a run for governor of Massachusetts in 2002. Howell will attend the Colorado Libertarian Convention in May (see pages 4-5 for details).

On April 3, Howell presented the following remarks to the Massachusetts House Committee on Public Safety.

This is anti-gun law Chapter 180. And here's where it belongs. [Howell shreds Chapter 180 of the Acts of 1998 before the Committee and 231 attendees, many of whom were there to testify for or against anti-gun laws.]

Today, the Committee on Public Safety is here to hear bills that will reform old, flawed laws or add new, flawed laws to the Massachusetts General Laws.

Where are the bills to repeal harmful laws? Where are the bills to remove ineffective laws? Where are the bills to eliminate legislative blunders of the past?

Our State Legislators use too many pens, and not enough erasers.

As Henry David Thoreau said, "Our lives are frittered away in needless detail. Simplify. Simplify."

Our freedoms are shredded by needless legislative detail. We must Simplify. Simplify.

I could speak on behalf of Senate Bill 1244. I support 1244. As reforms go, it is better than most. It mitigates the damage done by earlier Anti-Gun Laws.

Yet Senate Bill 1244 does not go far enough. Not nearly far enough.

We must repeal all Massachusetts General Laws that prevent honest and responsible adults from owning or possessing, selling or buying firearms.

Why?

State legislators and law enforcement officials rarely, if ever, put their legislation to a scientific test. What are the verifiable consequences of the law? Does the law make things better? Or does it make things

worse? Does the law move us closer to its objective? Or does it take us further away?

1. Anti-Gun Laws do not work. They do not accomplish their objectives. They intimidate and instill fear in the honest and innocent. They hinder and stop good people from defending themselves. They cause

good and decent people to live in fear. But criminals have little difficulty in acquiring illegal weapons. Anti-Gun Laws give criminals the advantage. And peace of mind.

2. Anti-Gun Laws often make things worse for the very people they're intended to help. Waiting periods give stalkers time to terrorize. Complex and difficult laws stand between good people and self-defense. Discretionary laws guarantee that all citizens are equal, but some are more equal than others.

**3.** Anti-Gun Laws create new problems. They feed an obscenely profitable black market in firearms. Run by criminals. Anti-Gun Laws turn a harmless mistake or oversight by an honest gun owner into a felony. They clog our courts with needless cases, while criminals remain armed and dangerous.

**4. Anti-Gun Laws are wasteful and costly.** Honest gun owners are forced to pay special taxes and fees. Anti-Gun Laws treat responsible gun owners like ex-convicts on parole.

5. Anti-Gun Laws divert money and attention from positive and productive activities. Every hour that law enforcement officials spend on licenses forms, permits and other red tape is an hour they cannot spend pursuing and apprehending violent criminals.

This Committee has before it new laws and reforms to old laws.

But where are the bills to Repeal? Where are the bills to Simplify?

As a first step toward streamlining the Massachusetts General Laws, I propose that we immediately repeal Chapter 180 of the Acts of 1998. I propose we remove it. Eliminate it. Erase it.

I propose we shred this Anti-Gun, Anti-Safety legislation. Shredding Chapter 180 is a bold first step toward greater public safety and responsible gun ownership. Thank you.





#### Innocent Victim Heeded Jefferson's Advice

Sheriff Masters presented the following speech to the Pro Second Amendment Committee in Grand Junction, March 10, 2001. Masters is the highest ranking Libertarian official in Colorado and the nation's only Libertarian sheriff. His web page is at http:libertybill.net. The Sheriff will attend the state LP convention in May.

I am really proud to be an American. We don't say that often enough today.

I thought of this when I was watching the news last week and they were interviewing one of the former directors of the CIA. They were talking about the FBI agent who was a spy for the Russians for 15 years. The

reporter was questioning the director about how we could prevent such an incident in the future—should they use polygraphs on all the agents, better background investigations, and different investigative techniques? And the director had an interesting response. He stated the best defense against these kinds of spies is to have spies in the foreign service of our enemy's government. In that way, foreigners who are spying for the United States could tell us when our adversaries have spies in our government.

He went on to say that American traitors, like this FBI agent, who spy on our country usually do so for money and seldom do it for philosophical reasons, whereas the foreigners that volunteer to spy for

the US on their governments usually do so out of a philosophical belief that the principles the United States represents are superior to those of the government of their homeland.

He then stated, and this is the important part, "Thomas Jefferson is still our best recruiter." At times tonight, I am going to bore you with some Jefferson.

"A strong body makes a strong mind. As to the species of exercises I advise the gun. While this gives moderate exercises to the body it gives boldness, enterprise and independence to the mind. Let your gun, therefore, be the constant companion of your walks." (Thomas Jefferson)

Zeke Hernandez's family are proud Americans. They have a small ranch along the Rio Grande bordering

Mexico, near the Texas town of Redford, population 100. The land there is poor, dry, mostly overgrown desert foliage and weeds. Zeke is a sophomore at the local high school, probably not going to Harvard, but known as a nice boy and well liked by his classmates.

Zeke likes to raise goats on his father's ranch. He enjoys the responsibility, like many his age, of caring for the animals. Every day, after school, he takes the goats out of their pens and herds them on the ranch, allowing them to forage on the scrub desert plants that only a goat would enjoy.

Years ago, Zeke was given an antique .22 caliber rifle by his grandfather. Now, when herding his goats, he always takes the little .22 with him to do some plinking and fend off the coyotes or wild dogs that come up to prey upon the goats.


But on this day, Zeke didn't see four US Marines assigned to "Joint Task Force Six" drug interdiction team. The plinking Zeke and his goats stumble into the camouflaged Marines' ambush formation. The Marines, doing nothing more than what they are trained to do, without warning, shoot and kill Zeke, thereby eliminating an armed threat to their mission of policing United States soil.

Donald Scott, age 62, was a wealthy man. He lived on a beautiful 250-acre ranch in California, which bordered a federal park. The feds wanted to buy his ranch to include in the park, but Mr. Scott was not interested in selling. Federal agents flew over the house and claimed they saw marijuana growing on the property. They obtained a search warrant for the ranch.

In the early morning hours of the next day, a pounding on the door to their home awakened Mr. Scott and his wife Frances. When Mrs. Scott attempted to open the door, a group of narcotics task force deputies burst into the house with guns in their hands. Mrs. Scott was pushed forcefully to the ground, a gun aimed at her head. She pleaded, "Please don't shoot me!" Hearing his wife's pleas, Mr. Scott armed himself with a revolver and ran out of his bedroom, only to be shot and killed instantly by the raiding officers. No marijuana plants or drugs of any kind were found on the Scott property.

Sixty-nine year old Ralph Garrison of New Mexico was awakened before sunrise one morning after hearing someone trying to break into the rental house next door that he owned. Knowing his tenants were out of town, he went outside to investigate. He saw a

group of armed men on his property wearing dark clothing and black masks. He returned to his house and called 911. According to the reporters who listened to those 911 tapes, Mr. Garrison's voice is filled with "fear and panic."

Garrison then armed himself with a pistol and a cell phone and went to his back door to wait for the police to arrive. Three members of a police SWAT team who were busy breaking down the door of Mr. Garrison's unoccupied rental house immediately shot 12 rounds from their AR-15 assault rifles into Mr. Garrison as he stood in his own doorway. He was killed instantly.

Police in Texas were using a paid informant to buy \$30 worth of drugs. The informant claimed he had purchased drugs at Annie Rae Dixon's house. The police raided the home, shot, and killed the 84 year old bedridden Mrs. Dixon. No illegal drugs were found in her home.

Ismael Mena from Mexico, father of nine, came to the United States legally for work to support his family. He worked night shift at the Coca-Cola bottling plant. He was in his bedroom sleeping during the day, when the Denver police department SWAT team raided his apartment after obtaining a "no knock" search warrant for drugs. Mr. Mena, awakened by the black-clothed officers breaking down his door, armed himself with a .22 caliber pistol. Officers stormed into his bedroom and ordered him to drop the pistol. He started to drop the pistol; then, according to the SWAT team, he questioned, "Polica?" He was immediately shot in the head and chest, at which point, according to the officers, he reached for the gun again and in fact discharged the gun, but was shot six more times and killed. No illegal drugs were found in Mena's home.

Investigation revealed the police raided the wrong house. The narcotics officer in charge of the case, according to district attorney Dave Thomas, made false statements, knowing they were false, in order to obtain the search warrant. The officer was charged with three felonies, including perjury. However, he was allowed to plead guilty to a misdemeanor so he could retain his job as a police officer in Denver. He was recently given nine months of back pay, almost \$40,000, and reinstated as a police officer for the city of Denver.

Regarding the controversy over the officer's reinstatement, Denver mayor Wellington Webb stated, "Mr. Mena would still be alive today if he just didn't have a gun."

Now, I have 30 or so more cases I could continue to bore you with. I could talk about 11-year-old Alberto Sulpuveda, unarmed, lying face down on the floor of his bedroom as ordered by a SWAT team, shot in the back and killed with a 12-gauge.

I am talking about kids, old ladies, completely innocent people, shot and killed not by gangs, not by robbers or drug dealers, schoolyard shooters or kids playing with guns, but by those sworn to protect our lives.

One police bureaucrat stated these shootings were "unintentional but not mistakes."

And then we have the gall, to put it politely, to tell you we need a law to force you to put trigger locks on your guns.

There is a reason why we are allowing these shootings to happen. We are in a war, a war on drugs. And during a time of war, innocent people get in the way sometimes. People's rights have to be placed on the back burner.

It is interesting to me that most of us concerned about the erosion of the Second Amendment have all heard of Ruby Ridge and Waco, but because it was a "drug raid" we calmly accept the deaths of ranchers, businessmen, old ladies, children and even innocent goatherders.

When asked by his significant other what he was doing, he said that he was taking a political quiz.



#### **Outreach Booth Draws New Members**

The COLP Outreach Booth celebrates its first birthday! It's hard to believe, but the COLP has had a constant presence at the Denver metro gun shows for more than a year now. In January 2000, we set up a table at the Tanner hunting and fishing show in Adams county. Because of the positive response, we went back to the February show. After that show, we announced our success, and asked for your help to raise funds to attend the show on a regular basis.

As a result of your support, we built a first rate booth which many of you have seen either at one of the shows or at last year's LP convention. The response that we received from those attending the show was so overwhelmingly positive that we attended the Crossroads of the West show later that month. We have been doing both of these shows on a monthly basis ever since.



As election season drew near, we began to set up the booth at the smaller county shows in Loveland, Fort Collins, Brighton, and Longmont. Because of this expanded presence, we were once again forced to turn to you, the membership for financial help, and again, many of you came through, and we were able to maintain our presence at these shows.

We felt that because of the looming threat of Amendment 22, we would be very popular (and we were right), and we would be able to benefit by showing sportsmen and gun owners that they are not alone as they stand up for their rights.

To date, we are averaging 9.5 new Libertarian voter registrations, 1.75 new dues-paying members, and 35 requests for more information. We hit an all time high last month at the Crossroads show with 16 new Libertarian voter registrations, 5 new dues-paying memberships, and 55 requests for more information!

Gun owners are beginning to realize that only the Libertarian party will protect their rights. We were at 18 such shows in 2000, and 5 so far in 2001.

But gun owners are not the only people whose rights are being encroached upon. The next two groups who have their heads on the proverbial chopping block are computer users and private party "Rave" attendees. The first group faces threats of internet taxation and

censorship, while the second group faces government threats of being shut down. (Some states have already restricted bottled water and phosphorescent light sticks at private parties—calling them "drug paraphernalia!")

As a result, we at the COLP outreach team know that we need to begin taking our message of liberty to these people. As you read this, a tri-fold brochure titled "Your right to 'Rave" is in the final phase of editing. We have also begun work on a tri-fold brochure discussing the LP's views against internet censorship

and taxation. It is our goal to present these new brochures at the outreach booth at computer shows and raves by the end of the summer.

But we once again are forced to ask for your help. Despite the great successes over the past year, these shows cost us money each and every show. As we gear up to expand into other venues, we're going to have our backs against the wall financially.

We do not want to abandon our successes at the gun shows, but we know that we need to expand to other venues, and so we are asking, once again, for your help.

Our team of volunteers has been growing, and we will continue our string of success, but we can only do so with your help. Will you send in a donation to help us expand the message of liberty?

Even a small donation will make a world of difference. In fact, while it costs us on average \$150 to set up a single show, we have been expanding our selection of 'for donation' items, so the net cost of a show is now less than \$40.

### Minorities Hurt by 'Smart' Growth

Independence Institute Release: Survey Finds 95% of Colorado Legislators Own Homes as they Vote to Limit Housing for Others

On April 6 Jon Caldara revealed the results of an Independence Institute survey showing that 68% of Colorado's general population own homes while the Colorado Legislature boasts a whopping 95% ownership rate.

In a press conference held Friday morning at the State Capitol, the Independence Institute president said the legislature is being pressured to approve "smart growth" measures which would have the combined effect of driving up home prices statewide and increasing the value of the legislators' home investments.

"The Independence Institute thought it would be interesting to find out how many legislators already own their own homes, because these individuals would be rewarded with increased home values by voting for growth controls, Caldara told the reporters, adding that minorities such as blacks and Hispanics will be hurt the most.

One such black American, Gene Berry, was on hand to

say that home buying is already tough enough for struggling minority families. Berry told the press that he had been trying to qualify for a home loan for six months so that he, his wife and their two children could fulfill the American Dream of owing their own home. He said he was afraid the "smart growth" measures being considered by the legislature could eliminate his ability to qualify.

Although Coloradans in general own homes by 68%, according to recent U.S. Census Bureau figures, black families only own homes by 46% and Hispanic families by 45%. Seventy percent of white families own their homes.

"It's much easier to vote to limit housing choice and opportunities for others when you already own your own home," Caldara chided the legislators.

Those that argue that "smart growth" policies do not raise home prices have not looked at the documented figures from cities that are already limiting growth, such as Portland and Boulder, Caldara said.

"Basically," Caldara pointed out, "it's a group of white guys with homes who are voting to deny homes to Colorado's working families."

#### **Montrose Snuffs Out Property Rights**

The Western Slope Libertarian Party fought valiantly. Unfortunately, a Montrose law passed that prohibits business owners from allowing smoking on their private property. Lane Mills, WSLP Media Coordinator, said, "I guess six weeks just wasn't long

enough to overcome the two years of lies the anti-rights folks had as an advantage. It was a good day to die. We will regroup and decide what to do next. We lost the election by 299 votes; we had a 66% turnout—the largest in Montrose mail-in ballot history. Our spirits are temporarily down, but we are not finished with this issue."

#### **Gun Control Kills**

#### Fort Morgan Trip Nets Coverage

For example, getting the federal government out of schools, where it should never have intervened, since education is delegated to the states, letting business work without the heavy hand of government regulations or preserving the right to bear arms."

#### **Privatize Health Care**

#### Libertarians Offer a Third Voice in Politics

The inability of conservatives to understand or allow people to engage in personal freedom and liberty is counterbalanced by the inability of liberals to understand economics and property rights. The nation suffers repeatedly in the conflicts.

Case in point: The California power fiasco. It was a Republican governor and the California Assembly bowing to leftist environmentalist activists that resulted in the re-regulation of the power industry and then called it de-regulation. The results are now in.

It is the same environmentalist faction that will lobby against oil drilling in the Arctic National Wildlife Refuge (ANWR) in contradiction of the facts. The ANWR is 19.5 million acres. The maximum area the oil companies intend to disturb and develop for drilling rigs and infrastructure is less than 10,000 acres. That is just a bit over 0.05 percent of the area of the ANWR. One-half of one-tenth of 1 percent! This is possible using modern drilling techniques.

If liberals successfully defeat opening up new oil and gas reserves and halt the building of power plants, they will be the first ones to cry foul when energy prices to the consumer rise. That is how silly they are.

People die or are profiled, harassed, searched or simply unnecessarily detained with regularity from errors made in warrants, no-knock searches, and traffic stops. The increasing militarization of the police and complicity of the courts for this insanity has effectively repealed the First, Fourth, Fifth, Ninth, 10th and 14th amendments to the U.S. Constitution.

The war on alcohol could not be won in the '20s and the drug war will never be won now. At least government had the decency, prior to enforcing prohibition in the '20s, to pass a constitutional amendment to declare "war" on the citizens. Conservatives will continue to insist the drug war can be won against history and against our rights. That is how silly they are.

There are myriad issues from abortion to growth, to social programs, to property rights, to the environment and so on, *ad nauseam*. Pick any conflict between conservatives and liberals and you will see a clash where some freedom or liberty is being compromised or lost. Worse yet, they both make government bigger and take more away from everyone in taxes carrying out their successively failing programs. Government will grow no slower in the next four years than it did in the last four. It will just grow differently.

For State Senate and State House of Representatives, there is a qualification that you must be a resident of the district you will represent for one year prior to the day you are elected. Note that the specific date is the

day you are elected, not the day you begin serving. Election day in 2002 will be November 5. Thus, if you move on or after November 5, 2001, and you end up moving into a new district, you will not be able to be a candidate.

Of course, moving to a new address in the same district does not affect your qualification for candidacy. Since this is the year of redistricting, however, moving may have some interesting side

effects. This is, of course, one of the reasons why, by law, redistricting has to be completed by a certain date.

The Fair Campaign Practices Act, a Colorado statute, requires that all candidates adhere to the requirements of the law. Among these are requirements that you file declarations with the Secretary of State as to the individuals and companies with whom you have significant financial dealings. That is, file a list of all individuals and companies you might be inclined to treat favorably due to financial considerations.

You will not need to disclose the amount of money involved, only the names of the persons or entities involved. An obnoxious intrusion into your privacy to be sure. But it is a requirement of the law, and potential candidates need to know that they will be required to supply this information. Also note that while this information is not actually published, it is considered public information and the Secretary of State will make it available for inspection to anyone who requests it.

Finally, the Libertarian Party of Colorado will require that you indicate your agreement to the basic principles of the Libertarian Party by signing a statement to that effect.

I realize that for many of you, being a candidate is the last thing on your mind. However, being a "line holder" candidate requires virtually no effort on your part and can significantly help the party, and the cause of liberty, grow. Please take a few moments to review this information and do what you can to maintain your viability as a potential candidate. This is very important for the future of the party and, more importantly, the future of liberty for all of us and our children.
