#### OFF & RUNNING...

For those of you who haven't already heard, on March 22 the U.S. Supreme Court ruled in favor of minor parties in the Salera vs Tucker suit, allowing the LPP and other minor parties in Pennsylvania until August 21 to file petitions. We immediately began planing for what will be the first major political endeavor by Pennsylvania libertarians, as well as one of the most ambitious petition drives in the country. Petitions are being printed this week, and we should be ready to start action state-wide by April 17.

A lot of work has already gone into this: Frank Bubb of Swarthmore has researched the election code, prepared instructions for circulators, and travelled to Harrisburg to tie up loose ends with the Election Commission. Olga Chauncey prepared an extensive mailing list which was used for our initial convention and petition-drive mailing. Bill Lewis has spent a considerable amount of time helping with all aspects of the petition drive, as well as working on the upcoming state convention, producing the newsletter, and managing the treasury. And twenty-seven people have helped by letting us put their names on the petition as Presidential Electors.

So what can you do? By now, you should have received our letter explaining what needs to be done. To expand on that: 1. Petitioning. We are organizing petitioning groups in several parts of the state to begin work as soon as possible. (You must be a registered voter to circulate petitions.) If you can't or won't register, we can also use volunteers for telephoning, delivering petitions (the mails can't be trusted), working on mailings that will be going out from time to time, and helping with the reams of correspondence that something of this magnitude creates. And, if anyone knows a sympathetic notary who would notarize 500-600 petitions for a nominal fee, we could save a bundle of money. 2. Contributing money. In order to reach our goal, we are going to have to hire full-time workers for part of the summer. But before we can proceed with that, we must pay a filing fee (\$50), notary fees, and printing and postage expenses for more letters soliciting help and money. So if you haven't contributed because you didn't know where the money would be going, you need a new excuse. . 3. Providing contacts. You can do this by sending us the names of anyone you know who might be interested in helping with any of the above. Or, start organizing a group of friends to help you petition-just make sure that everyone follows the instructions that will be provided to petitioners.

The response so far has been very good—we've received offers of help as well as contributions from people we don't even know—with your help, we'll be able to contact more of these "closet libertarians" across the state. If you haven't already done so, fill out the form that you received with the convention flyer, and return it today, so we can make ballot status for Roger and Dave a reality in Pennsylvania.

## pa MacBride for president committee formed

Pennsylvania is the latest state to form a MacBridefor-President Committee at the state level. Frank Bubb, 97 Darthouth Avenue, Swarthmore, will head the PA Committee. Campaign contributions and offers of assistance can be directed to him.
