Marshall Gets 22% of the Vote

Finishing better than any Illinois Libertarian has done to date in a non-local race, Dr. Robert Marshall received 22% of the vote in a two-way Congressional race, a valiant effort against the entrenched, arrogant, and powerful incumbent, Dan Rostenkowski. In the suburban precincts, Marshall received 35% of the vote. The Libertarian Party of Illinois is now an official party in the Eighth Congressional District. Dr. Marshall has expressed satisfaction with the campaign and the outcome.

Some of us in the campaign thought we had a real chance on winning. In fact, our own unscientific exit-polling showed us ahead in the race. However, in the end, the strength of the Chicago Democratic Machine proved to be too much to go up against. On the day of the election, there were at least one thousand Democrats working the district, compared to little more than a handful for Marshall.

Putting together a campaign in four-months time is not enough time to organize an winner. But now that we have ballot status in the district, the time

to act and build effectively for the race two years hence is now. We have a sufficient data base to organize from. Libertarians in the district can start now to form alliances, coalitions, friendships, and contacts with the various community, church, and single-issue groups by getting involved locally and promoting libertarian ideas and the Libertarian name so that the name won't be so foreign to so many in the voting booth next time around.

We should also start a voter registration drive in the district. There are many people so upset with the status quo that they don't even bother registering to vote. These people

are our natural constituency. Less than 35% of the possible voters voted in the November's election nationally; we need to contact and coalesce with these non-voters and convince them that the Libertarian difference is a real difference and thus worth supporting.

Organizationally, let's copy from the success of the Democratic Party. The Democrats operate at the precinct level. We need precinct captains who will identify the Libertarian voters in the precinct, making sure that their

needs are met (without violating libertarian principles). Identify local problems and present libertarian solutions to those problems in letters-to-the editor in local newspapers, signed, "Joe Freedom, Precinct Captain, Libertarian Party, 35th precinct." Senior citizens in this district are especially dissatisfied with Rostenkowski's performance. Also, rising property taxes threaten their life savings. Maybe Libertarians could accompany some of these people to the Cook County Board of Tax Appeals and help them get their property taxes reduced. This is an example of how we can help citizens fight government and

promote Libertarian principles.

If we start now, we can build a viable organization that can win in November '92. Rostenkowski will probably retire (and take his campaign-fund millions with him). The race will be wide open and available to the best organized.

I would like to thank all Libertarians (too numerous to list) who contributed time and/or money to the campaign. Your help was invaluable. A special thanks goes to Paul Salander who spent the greater part of the last week of the campaign distributing literature.

FIJA Update

The Fully Informed Jury Amendment Committee held its first national convention on the weekend of November 10th in St. Louis. 50 people attended. Don Doig, coordinator of FIJA, reports that the speeches were very informative and inspirational. Lobbying activities are under way and activists in Georgia and Louisiana report that prospects look good for the FIJA movement in those states.

Press coverage has been excellent, informs Doig. Recently, *The Washington Times* did a cover story on the movement. *Insight Magazine* carried a feature story. *Soldier of Fortune*, and *Easy Rider* also ran stories on the informed-jury movement. Ron Paul covered the issue on his "At Issue" series and "Crossfire" has expressed interest in doing a show on a FIJA theme.

"60 Minutes" has expressed an interest in covering the "Span" case. This is an atrocity that happened in Phoenix, in April of '88 where two U.S. Marshals attacked a 74-year-old man, Bill Span, his 72-year-old wife Virginia, and their children Jerry and Darlene. Then the marshals pressed charges against the family for assault. Bill Span died two months after the incident. A jury found the Spans guilty even though many on the jury regretted the verdict but felt they had no other choice but to convict because of the jury instructions. The Span children spoke at the convention.

Libertarian Candidate for President

Forces Run-Off in Poland

Libertarian Presidential hopeful Stanislav Tyminski has taken second place garnering 23% of the vote in Poland's first Presidential election forcing a run-off between Lech Walesa and himself. Tyminski holds a citizenship with both Poland and Canada. He is the leader of the Libertarian Party in Canada.

The news media seems surprised that Tyminski did so well, but to libertarians worldwide, and here in Illinois, it is no surprise at all.

"Tyminski represents a new wave in politics worldwide, a politics that focuses on individual freedom and limited government. For those disenfranchised by politics as usual, Libertarianism represents a fresh approach. We see this political avalanche happening here in Illinois as well as throughout the world," stated Sue Walton, State Chair of the Libertarian Party of Illinois.

Indeed, it is not hard to figure out that a country economically destroyed by socialism would now turn to the economics of the free market, the economics espoused by the Libertarian Party, to achieve prosperity.

To date, Tyminski, to the extent that he is portrayed at all by the news media, has been slandered as an eccentric "megalomaniac", a carpetbagger trying to buy the election. The fact of the matter is that Tyminski is a successful businessman who wrote a book called, Sacred Dogs, which sold out immediately upon its release in Poland. The book became so popular that candidates for President of Poland were seeking Tyminski's endorsement. Upon arriving to Poland, Tyminski was persuaded by supporters to run for President himself. They gathered enough signatures to get him on the ballot, and in a short time, Tyminski has achieved national stardom because of his uncompromising view on freedom.

This rising popularity of the libertarian philosophy is catching on worldwide. Norway has elected 23 libertarians to its parliament. For the first time, Peru has three Libertarians in its legislature. In South Africa, libertarian authors Frances Kendall and Leon Louw provide the only rational, peaceful method of reform in that country with their proposed "Swiss style" canton system of government outlined in their book, After Apartheid, The Solution to South Africa. The "Solution" continues to gather more support in South Africa.

Here in the United States, Libertarians doubled their election total this past election. In Texas, the Libertarian gubernatorial candidate held the balance of power with 3.3% of the vote. New Hampshire's Libertarian candidate for

Glenn Olofson, Libertarian candidate for the Third Legislative District in Illinos received four percent of the vote in the November election. Operating from limited resources, Glenn nearly received the required votes to obtain permanent ballot status for the party. Glenn has laid a good foundation for future campaigns in this district.

Tax Freedom Act Proposed

The Tax Freedom Act provides a statewide property tax rollback and cap at 1988 levels for all real estate, 60% voter approval for any increase in property taxes or other local taxes and user fees, and mandates property taxes be paid on election day, twice a year. The Tax Freedom Act eliminates tax increases caused by reassessments and multipliers. Also, you will not get a tax increase if you improve your property. New property will pay taxes comparable to similar property. New property tax revenue will cut taxes for residents. The sponsor of the bill is State Representative Ralph Caparelli, Democrat of Chicago in the 13 district. State Representative James De Leo, Democrat, 16th district in Chicago, is sponsoring the Tax Accountability Amendment. Contact your state representative to cosponsor both of these bills.

Governor received 5.5% of the vote, establishing the Libertarian Party of New Hampshire as an official political party that will hold a primary election with the Republicans and Democrats in 1992. Over 100 Libertarians now hold office throughout the United States. The Libertarian Party membership continues to mushroom in growth.

Buying a Libertarian Country

A couple libertarians in the Chicago area are making the ultimate proposal to those unsatisfied with the progress of libertarian reforms in this country. Buy a libertarian country. This idea is being circulated among libertarians in a 32-page booklet that evaluates present trends in the world, and suggests buying and starting a libertarian country as the solution.

The authors suggest buying a portion of an existing country that has a low-density population offering them a price they can't refuse, in effect, buying not only the land but sovereignty as well. Payments to the host country would occur over a 20-year period establishing an incentive not to intervene in the fledgling new income-producing capitalist country. During this time period, the new country would build a defense system capable of repelling attacks from other countries. A constitution would be formed based on libertarian principles and could only be changed by a unanimous vote of the property owners. Prospective purchasers must believe in libertarian principles in order to buy land. The authors estimate that 150 million dollars for twenty years will be needed to be raised in order to purchase the land. Units would be sold in one-acre lots and buyers could purchase multiple lots. Ownership but not citizenship would be transferable. The authors suggest that Guyana, South America, is the best example of where this project could work. Once established, this libertarian country would be the shining example for the world to follow.

Creating a Good Public Image

It goes without saying that libertarians, in propagating their ideas, must choose a strategy which will most likely result in a conversion by their listeners. If libertarians offend others or if they present their ideas in a way that others cannot comprehend, the message will not have the desired effect.

With regard to strategy, libertarians are of two types: "reversalists" and forwardists". A reversalist is a libertarian who attempts to propagate his libertarian message by contending that in past decades Americans were freer than they are now. The freedom of Americans has gradually been taken from them by evil-minded politicians and bureaucrats. Americans must rise up and take back what is rightfully theirs. Reversalists point out that the founding fathers designed a Constitution mandating limited government and that the U.S. has departed from this greatly. Franklin D. Roosevelt is their favorite villain. Reversalists maintain that we must "go back" or "return" to our supposedly much freer past; developments of the past several decades must be reversed.

A forwardist maintains that, regardless of what occurred in the past, a tremendous amount of human potential can be unleashed in the future if only the government would get out of the way. The standard of living will rise and the people will be happier if they are not hindered by government restrictions. The 21st Century is approaching rapidly. It will be a century of growth and freedom. Restrictions on human activity based on faulty reasoning and ignorance of economics should be repealed. The international marketplace which benefits all humankind can only function properly in an atmosphere of freedom. Failed experiments in coercive social engineering should give way to a spontaneous order. People must look forward to a bright future.

In my opinion, it is not wise for libertarians to adopt a reversalist attitude. Reversalists are so preoccupied with the supposedly golden days of old that people are liable to think that libertarians harbor a classically conservative attitude—ā stubborn, crotchety inability to accept the coming of change over time. Conservatives are viewed as pessimists and killjoys,

hostile to progress. Also, most Americans would question the idea that the old days were so free and wonderful. They remember the restrictions on speech and sexual expression that existed back then. Even in the economic realm, monopoly and protectionism are by no means new. Americans are liable to mistakenly believe that libertarians advocate returning either to the "sweatshops" of the industrial period, by no means an attractive proposition, or to an 1800s-style agricultural economy, a perhaps romantic but hopelessly outmoded way of organizing human affairs. Our opponents will state that the idea of limited government is a quaint relic from the past, inapplicable to modern conditions. Or they will claim that libertarians are wealthy people who are upset at their loss of relative status now that working people, too, get to enjoy a high standard of living.

A forwardist, rather than continuously ranting about the past betrayal of American principles by the supposedly diabolical Franklin Roosevelt and others, figures that it is counter-productive to rehash old grievances and that we must therefore look to the future. People must get the idea that libertarians look to the 21st, not the 19th Century. We are interested in high tech, not low. Government programs must not be abolished so much as grown out of. We must shed them like a snake sheds its skin. It is our opponents who must be painted as killjoys, hostile to progress. It is their ideology which must be portrayed as a relic of the past and which holds us back. There is a natural tendency to view forwardists as optimists, as progressives. This is the public image we should create and uphold.

Libertarians should refrain from talking about the "golden days of old." Rather, images should be conjured up about the "golden days of the future." It is this image which will appeal to—and have any relevance for—youth—and any rational oldster as well. It is this image which will lead us to victory.

Ed note: Sorry Dave, for my instant rebuttal, but I can't resist... There are two types of people in this world, those that organize people into two categories and those that do not.

The Matching Funds Question

As the Presidential nominating season approaches, there is renewed talk for the taking of federal matching funds in the Presidential campaign. Proponents argue that the process of taking matching funds is no more than recovering stolen tax money. The argument is thus justified on moral grounds. My argument against taking matching funds is a practical one.

Let's face it. Most political campaigns do not delve deeply into the issues. Politicians create impressions. Most voters are too busy, too disgusted, or too lazy to really size up campaigns in a rational, measured manner. The simple beauty in not taking matching funds is that this is the one issue that "Joe six-pack" can readily understand. "Libertarians talk about restoring limited government, and eliminating subsidies, and by-God, they mean it. They won't accept federal matching funds even though it would help their campaign. They indeed are the party of principle."

On the other hand, if Joe sees that the Libertarian Party accepts federal matching funds, then he perceives that Libertarians are all talk but no action. "They talk about getting government out of the lives of the American people, yet when it comes to their share of pork, they gladly gorge themselves. They are hypocrites."

Yes, I know Libertarians can rationalize the acceptance of matching funds. And the argument has some validity, although I believe the more principled, courageous stand would be just to stop paying the taxes in the first place. But Joe will not understand. Joe will reject us as just another hypocritical political party who could care less about principle.

There is an ethic for policemen that they should never be seen in a compromising position of receiving money from someone else while on duty, even if the transaction is perfectly lawful, lest someone else construe that they are taking a payoff. They are to appear to be beyond reproach. The same should be true of a Party of principle. If we don't appear in such a manner, then the next time we rail against farm subsidies, our arguments will ring hollow. The next time we blast corporate giveaways, our standing will subside. The next time we argue to reduce welfare, our believability reduces likewise.

One can run for office in one of the major parties and espouse libertarian principles. What sets off the Libertarian from other candidates is the principled Party he or she represents. Let's not lose this valuable asset. A good reputation is easily torn; the repair—tedious, long, and what remains is still a scar.

Marrou for President

Andre Marrou began the Libertarian for President campaign on November 7th.

Andre is an ideologically solid Libertarian and an eloquent spokesman for the cause of freedom. He has 14 years of successful political experience, from petitioning and staffing state-fair booths to winning election to and serving as a Libertarian state legislator.

As LP's Vice Presidential candidate in '88, Andre raised his own campaign funds and was our first candidate to campaign in all 50 states. He generated more than 4,000 prospects for the national party and helped state parties recruit members.

In '88, he co-founded *Project 51 In '92*, a political action committee committed to Libertarian ballot status in all 50 states and the District of Columbia. Since then, he has lobbied in five states to reduce ballot-access restrictions and has raised over \$25,000 for key Libertarian Party campaigns. After winning a lawsuit in North Carolina, Project 51 In '92 is managing the '92 LPNC ballot drive now and expects to win ballot status by July 4, 1991 (45,000 signatures). Because of this kind of early work, LP is now on or will have easy access to the ballot in 28 states. We have never before been in such good shape two years before an election.

A political realist, Andre intends to claim federal matching funds for his nominating campaign and use every cent of the reclaimed tax dollars stolen from Libertarians for TV advertising.

Think about it... If you're not on TV, you don't exist for the American electorate.

Think about it... In 1988 Bush and Dukakis each received \$46 million for their election campaigns. And that was after they and all the other nomination seekers received matching funds for their nomination campaigns. A goodly chunk of that money was our tax dollars.
