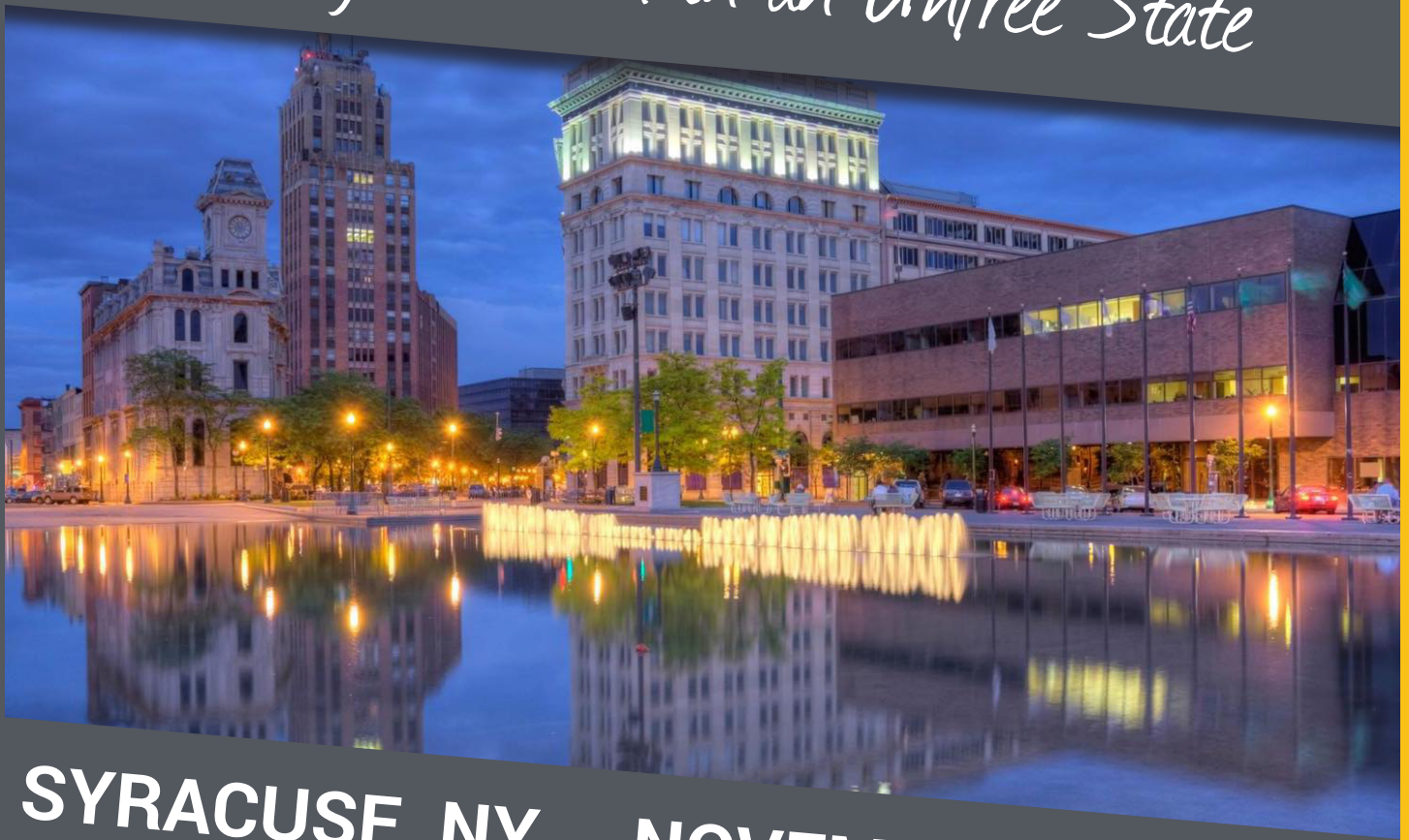

LETTER FROM THE CHAIR

Dear Freedom Summit Attendees:

Thank you for coming to Syracuse this weekend to support Liberty!

Since the Libertarian Party was founded 50 years ago, we have seen a steady erosion of Liberty at the national level: the establishment of the federal Department of Education and Vulcanization of government-run indoctrination camps; the logarithmic growth of the military-industrial complex and its projection of force and power across the globe; and the expansion of the surveillance state through the Patriot Act, its secret FISA court and warrantless wire-taps. Federal spending and debt levels have continued their unsustainable trend at the cost of our nation's strength and prosperity, making goods cost more and our paychecks worth less.

For those of us who have stayed here, living here in New York is far worse. In the nearly two years since the pandemic began, we have seen the summary destruction of minor political parties by Part ZZZ of the 2020 pandemic budget; the abdication of power by our legislature to an omnipotent executive; the senseless destruction of lives and businesses by Governor Cuomo's endless and ruinous executive orders; the reckless murder of thousands of nursing home staff and residents by Governor Cuomo's policies and his administration's subsequent cover-up; vaccine mandates for government and healthcare workers who worked tirelessly and unvaccinated through the pandemic; mask mandates for our school age children; the transfer of "green" power project siting authority from localities to the state; employer liability for airborne viral and bacterial infections; the 20% year-to-year increase in the state budget the continued exodus of businesses and residents to more Liberty-friendly locales...the list goes on.

And yet, I am more hopeful than ever about Liberty's prospects.

Since the end of 2018, and despite the State Board of Elections' attempts to drive people away from us, the Libertarian Party of New York's rolls have increased to over 20,000 enrollees. People have opened their eyes to a political system and tyrannical government that does not serve them. Groups across the state and nation have organized to stand up to tyranny in all its forms. Our biggest challenge, as I see it, is engagement of rank-and-file Libertarians.

With the help of technology and social media, the party is truly doing more to spread the Liberty message than it ever has before. By my estimate, the core work of the LPNY is done by under one hundred individuals. Simply put, we need to harness the time, money, and talent of our 20,000 Liberty-minded brothers and sisters and accomplish even more together. Time can be spent passing petitions and canvassing for our candidates, or joining a committee where their talents such as writing, proofreading, or organizing can be put to work. Obviously, the party's outreach and legal battles cost money, but imagine if each Libertarian in New York pledged a dollar a month to support our efforts: the possibilities would literally become limitless versus what we have today.

The bottom line is, we need your help to galvanize the Liberty Movement here in New York.

SPEAKERS



Spike Cohen

Spike Cohen is a successful business owner, Libertarian activist, and media figure. As the 2020 Libertarian Party candidate for Vice President, coming in third place in the 2020 election, Spike traveled across the nation by plane and bus and met tens of thousands of Americans to share the message of Liberty with them. Spike started a web design company as a teenager in 1998. In 2017, he retired from web design to focus on Libertarian messaging, entertainment, and activism. This culminated with him becoming the co-owner of Muddied Waters Media, the co-host of *The Muddied Waters of Freedom*, and the host of *My Fellow Americans*. Spike is a tireless advocate for freedom with a commitment to help grow the movement at the grassroots level, training Libertarian Party candidates and activists in positive and principled messaging to explain high concept libertarian ideas to everyday Americans, and working towards the Libertarian Party's goal of "a world set free in our lifetime." Since the 2020 election, Spike has become a regular guest on cable news networks, nationally syndicated radio, international media outlets, and podcasts across the globe.

Larry Sharpe

Larry Sharpe's mission is to help people find happiness through community and purpose, often by overcoming bad policy decisions in government. He ran for Governor of New York in 2018 and garnered about 100,000 votes—more than any previous Libertarian candidate. His ability to connect with voters across the spectrum enabled the Libertarian Party to achieve automatic ballot access for the first time in state history. Since his campaign, Larry Sharpe has toured every county of New York multiple times. He was instrumental in a lawsuit that opened up entertainment venues across the state. Larry Sharpe is a husband, father, Marine, entrepreneur, teacher, and political activist.



Scott Horton

Scott Horton is director of the Libertarian Institute, editorial director of Antiwar.com, host of Antiwar Radio on Pacifica, 90.7 FM KPFK in Los Angeles, California, and podcasts the *Scott Horton Show* from ScottHorton.org. He's the author of the 2021 book, *Enough Already: Time to End the War on Terrorism*, the 2017 book, *Fool's Errand: Time to End the War in Afghanistan*, and editor of the 2019 book, *The Great Ron Paul: The Scott Horton Show Interviews 2004–2019*. He's conducted more than 5,500 interviews since 2003.

SPEAKERS



Caryn Ann Harlos

Caryn Ann Harlos became a Libertarian in 2014 during a fortuitous visit to LP.org while reading the Party's Platform and its Statement of Principles. Since that time, she has risen to prominence through a nearly endless stream of exuberance and work ethic. Amongst other positions, she has served as the Communications Director and Secretary for the Libertarian Party of Colorado, Region 1 Representative for the Libertarian National Committee (representing nine western states), Libertarian Party Historical Preservation Committee Chair, Chair of the National Platform Committee for the 2018 and 2020 conventions (and interim Chair for the 2022 convention). Her particular interest is in Party history and its Statement of Principles and has been a featured speaker on those topics across the country.

In 2018, she was elected as the Party Secretary on a platform of transparency, accountability, and accessibility, and was wrongfully (in her opinion) suspended in 2021 in retaliation for calling out corruption and lack of backbone in the Libertarian Party leadership to face down the COVID regime. She is appealing that suspension. Additionally, Caryn Ann is the hostess of the educational YouTube channels the Cult of RONR and Pink Flame of Liberty. Dan Fishman



A well-respected and long-time leader in the liberty movement, Dan Fishman most recently served as the Executive Director of the Libertarian Party before taking on the title and role with People for Liberty. During his tenure, the party benefited from an over 50% increase in Membership from August 2019 through January of 2021. He deftly pivoted the organization during the coronavirus pandemic to lead the first-ever online Presidential Nominating convention in May of 2020 as well as the online portion of the LNC's hybrid convention in July of 2021. With a keen eye towards making the party more accessible to more people, he also led the charge to launch innovative programs including LPTV, Member Welcome Hangout, and the affiliate referral program. Today, he hopes to further broaden the reach of the liberty message and movement by creating a welcoming, diverse, and inclusive culture with People for Liberty that offers open arms and support to those seeking a world set free in our lifetime.

Diagnosed with Osteogenesis Imperfecta, Type II, he has beaten projected life expectancies, survived thousands of skeletal fractures, as well as the barriers, both physical and bureaucratic, that millions of Americans with disabilities face. He did it all while helping his family run their small farm in Sidney, New York. Tom's active involvement ranges from directly assisting peers to being the Vice President of a non-profit cooperative. He has been a member of the Mount Upton Lions Club, has volunteered for the Women's Auxiliary to support our local Fire Department, and is currently a board member of the Catskill Center For Independence.

Helping the community is his passion. Tom believes that communities, not state or federal governments, can provide the best assistance for those in need. As a grateful recipient of a crowdfunded wheelchair, he gives any time he can back to those who need help: from peer counseling, to volunteer work, to helping individuals meet their own needs. Tom is deeply immersed in the challenges facing the communities of Senate District 52, including protecting 2nd amendment rights, support for small businesses dismantled by coronavirus shutdown, and the plight of farming communities. For all who feel that they are battling alone, Tom will fight with you. He is ready to be the advocate who knows the Southern Tier and will fight to keep its best interests at the heart of all his work.

Eric Cordova

Eric Cordova has been an executive board member of the Libertarian Party of Queens County (LPQC) since 2018. In that time, he has served as the Director of Recruiting and Public Relations from 2018 to 2020 and is currently the Vice Chair. In that time, LPQC has increased its paid membership by 400% and has grown its social media and email outreach to one of the largest in the state. He has also recruited and worked on multiple campaigns within Queens and has helped coordinate events for the campaigns of Jo Jorgensen, Stacey Prussman, and Larry Sharpe.

Debra Altman

Debra Altman is a born-and-raised New York City Libertarian with a double MBA focused in I/O Psychology and HR management/Organizational Behavior. She is a homeowner, a mother of a special-needs child, and has worked in the family court system.

Debra ran for a citywide education council position in 2019 in District 75, a unique district for children with IEPs in NYC that spans all five boroughs. She was the first registered libertarian to win an election in NYC history. For two years, Debra fought alongside her fellow council members to advocate for 27,000 special-needs children during the pandemic. She wrote and passed two groundbreaking resolutions that protected the rights and choices in schools regarding masks, testing, and remote education options. A third resolution regarding reinstating summer services was enacted before being passed.

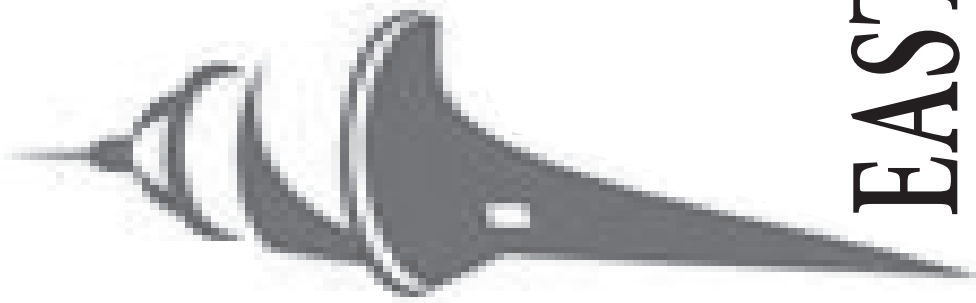
She was unanimously voted as Council Treasurer both years and allotted \$15,000 of the remaining budget to go towards libraries in NYC family shelters. She completed her term in 2021 and left a standing impression on parents to never give up advocating for their children in public school.

Jame VanDewalker

As lifelong residents of Allegany County, Jame and her husband purchased their home in 2012 and settled in the Town of Allen with their three sons. Disenchanted with the public school system after being told that the school would not be able to assist their child until he began to fail, combined with the dissatisfaction of content taught, they took on the task of homeschooling. Jame, her husband, and their sons now operate their own business while Jame works part-time at another local small business.



Jame's career in politics started in 2014. She was appointed as Town Clerk for the Town of Allen. She finds the office of Town Clerk to be such a rewarding position to hold, and she truly enjoys her job and the opportunity it gives her to spread the message of Liberty! In 2019 she was re-elected as a Libertarian, the first and only for Allegany County. She has recently become a member of the Libertarian Party of New York State Committee representing Judicial District 8, as well as the County Contact for Allegany County and is working to establish an affiliate for Allegany County in the near future.
