The meeting was called to order by Chair Mark Axinn at 20:09. The minutes of the previous State Committee meeting of February 12, 2012 were approved upon waived reading.

Chair Mark Axinn issued a Chair's report.

Vice-Chair Audrey Capozzi issued a report on activity at the LNC.

Treasurer Gary Triestman issued a Treasurer's report.

County Organization representatives issued reports for Hudson Valley, Greater Rochester, Manhattan, Staten Island, Nassau, and Suffolk.

Motion to authorize payment of up to \$200 to Mark Axinn for expenses related to mailing notice of the Annual Convention to the membership passed by voice vote without debate.

Motion by Chris Edes to authorize payment of up to \$25 for expenses related to mailing to LPNY members in Otsego, Chenango, and Broome Counties for formation of a new County Organization covering those counties passed by voice vote without debate.

The following proposed amendment to the Bylaws by Max Kessler was debated and failed by voice vote.

#### Current:

Article VI: State Committee

A The State Committee shall consist of the State Chairperson, the two Vice-Chairpersons, Treasurer, Secretary, five (5) committee persons-at-Large, a representative from and elected by each chartered County Organization, and the Immediate Past Chair.

Article VI: State Committee

A Committee Membership

1 The State Committee shall consist of the State Chairperson, the two Vice-Chairpersons, Treasurer, Secretary, five (5) committee persons-at-Large, a representative from and elected by each chartered County Organization, and the Immediate Past Chair. 2 The position of Immediate Past Chair shall expire after one (1) year, unless a new Chairperson shall be elected.

The following proposed amendment to the Bylaws by Blay Tarnoff was debated and passed by voice vote.

In Article VI, section A, add "The Immediate Past Chair is the person, if any, who ceased to be the Chairperson at the end of the last Annual Convention."

The following proposed amendment to the Bylaws by Blay Tarnoff was debated and failed by voice vote.

In Article VI, section A, strike out "and the Immediate Past Chair" and the last sentence and insert "and" before "a representative".

The following proposed amendment to the Bylaws by Blay Tarnoff was debated and passed by voice vote.

In Article VI, section F, strike out "except that the State Chairperson shall vote only to resolve a tie" and insert "The presiding officer at any Convention or meeting of the State Committee may vote only when the vote is by ballot or his vote would affect the result."

The following proposed amendment to the Bylaws by Blay Tarnoff was debated and passed by voice vote.

In Article V, section F, strike out "officers and Committee persons-at-large" and insert "officers, Committee persons-at-large and delegates" and strike out "of" before "good standing" and insert "in".

The following proposed amendment to the Bylaws by Blay Tarnoff was debated and passed by voice vote.

In Article III, section A, subsection 2, last sentence, insert "remove or" before "replace" and insert "County" before "Chairperson" and in the previous sentence, capitalize the first letter in "county".

The following proposed amendment to the Bylaws by Blay Tarnoff was debated and passed by voice vote.
