# "OHIO LIBERTARIAN OF THE YEAR" AWARD

At the 1978 convention of the Libertarian Party of Chic, an award will be presented to the LPO member in each county, region, and in the state, who has done the most to further the activities of the LPO during the year. This plan, recently adopted by the LPO Executive Committee, will award points to all members for various activities. A complete list of rules and point awards is given on Page 3.

The awards will be given to those members who accumulate the most points during the year beginning April 16, 1977. Anyone wishing to participate should send news of all activities in which he participates to Bob Lehman.

## LPO ESTABLISHES FILM AND TAPE LIBRARY

At the last ExeCom meeting it was decided to establish a film and audiotape lending library for use by LPO members. The first proposed film acquisition is THE INCREDIBLE BREAD MACHINE TV SPECIAL (55 min., 16mm, color) @ \$400.00. ExeCom voted to furnish \$100 toward its purchase, with the remainder to be financed through individual contributions. \$61.50 has already been raised in this manner. advisor to The Smiler; Dr. Rogge is with FEE.)

This film is perhaps the most effective educational tool yet developed for promoting free market economics and is suitable for showing at all sorts of meetings and events. We hope to acquire it in time for a screening at the state convention in June, so contributions in any amount are actively encouraged. The tape library will consist of audio-tapes of interest to libertarians donated by LPO members. The librarian will furnish all donors with receipts

for their tapes, so that they can be recalled at any time. Contributions by Jim Higgins and Bob Lehman have already gotten this program off to an excellent start.



#### Qualifications

The usual discussions of nuclear energy focus on the safety (or lack thereof) of nuclear power plants. At last there is a book which, in its author's words, "...never tries to make the point that nuclear power is safe; the point it makes is that it is far safer than any other form of large-scale energy conversion yet invented."

The Health Hazards of NOT Going Nuclear Prof. Petr Beckmann

\$5.95 softbound, \$10.95 hardbound. Postpaid from Golem Press, Box 1342, Boulder, Colorado 80302. 190 pages.

Dr. Beckmann is a professor of electrical engineering at the University of Colorado. He was born in Prague, Czechoslovakia. Perhaps this is why his book is riddled with examples of government interference in the power industry and free-market arguments that advocate increased reliance upon nuclear power.

The book is intended for the layman but even a student of physics can learn much. From the Browns Ferry fire to breeder reactor waste disposal, it's all there. Nuclear power is even compared to the much-touted solar energy and found superior on all counts.

A recent Ford-Foundation report on nuclear safety has served to reinforce, for the most part, Dr. Beckmann's book which predates the report by almost a year.

The last chapter should be of particular interest to Libertarians. It discusses, in very Libertarian terms, why nuclear power is the political and media issue that it is in this country. Must reading.

# \*\*\* Dangerous precedent

The jailing of Lawy Flynt on trumped-up charges of organized crime is not only unjust, it is obscene. Apparently it is a crime in Ohio to peacefully engage in free trade with others, even with their consent. If persons are employed records kept, offices maintained in the commission of this "crime," that makes it an "organized crime."

Was any person who bought Hustler magazine defrauded? Was anyone forced against his will to view its pages? If so, let that person step forward and press charges against Larry Flynt. If not, then Larry Flynt has not violated anyone's rights and does not deserve to lose his right to liberty.

There are private, woluntary ac-

tions that people could take against Flynt, such as refusing to deal with enyone who sells or buys Hustler, thus curtailing demand and making it less profitable for Flynt to remain in the smut business. But for people to gang up and pass laws against a man simply because they don't like his product sets à dangerous precedent in this country. Once we accept the premise that society (through its agent, the state) may initiate the use of force against peaceful citizens inorder to accomplish some "worthy" goal, then we're not very far from the total extermination of individual rights, such as we've seen in Nazi Germany and Soviet Russia.

#### LPO OPPOSES FLYNT CONVICTION

At its most recent meeting February 20, the LPO Executive Committee adopted a resolution condemning the persecution of publisher Larry Flynt; Resolved, that the conviction of Larry Flynt on charges of publishing pornography is a gross perversion of justice; that this action is inconsistent with freedom of the press and of individual choice; and that this conviction should be immediately reversed and further prosecution of pornography should be halted immediately.

See Bob Lehman's letter, reprinted in this issue, for a libertarian view of this repression.

The Execom also adopted resolutions opposing government intervention in energy, endorsing the repeal of helmet laws, and supporting the School Home Rule Amendment. The petition drive is now under way to get this amendment on the ballot in November. Copies of the petition are enclosed with this Newsletter (while they last). You are urged to take this petition to PTA's, school board meetings, and to neighbors.
