

CALL TO CONVENTION STATE AND LOCAL TO MEET

THE JEFFERSONIAN ACTIVIST

One of the most effective and efficient uses of a libertarian's time is to write letters to the editors of your local papers.. It allows you to reach an audience of people who are tuned into local politics and community activities. If you are a regular writer and are published frequently you will get noticed. There are several things you can do to increase the likelihood of getting published.

1. Keep your letter brief and to the point. Editors are pressed for space and time. Keep your letters under 250 words. Less is better. Some of the most effective letters are under 100 words. You may be in love with your own words or ideas but do not assume anyone else is. Say it in plain English, avoid jargon or wonk speak.

2. Start out with a positive statement. Nothing turns editors or readers off like grouch. A statement that says: "I agree with Mr. Smith on this point..." or "the concern displayed in the article is valid but, I disagree with the solution" is likely not to draw immediate resistance and encourages the reader to want more.

3. Reference a recent article, editorial opinion or letter. For example, in the beginning paragraph: "I agree with John Smith ("Politicians Get Goofy," Aug. 15, 1997)..."

4. Suscribe to the paper you write to and...

5. Avoid extreme statements. Dire warnings of conspiracies, defining your opponent as demonic, and black helicopters are a sure way to be dismissed as on the fringe. A better way is to acknowledge the other sides concerns as valid but tell them you have a better way to fix the problem.

6. Include authoritative data and statistics. One of the most effective tactics is to use your opponent's own statistics or facts against them.

7. Avoid being snide, arrogant, or cute. It may be more fun to be nasty but it is totally ineffective.

8. Leave them with a call to action. Don't just inform, call on your readers to do something.

9. Write often. You probably won't succeed immediately but in time you get known for being an expert on certain subjects.

LETTERS TO THE EDITOR

Dear Editor,

My first choice in the recent election was Charles Collins; I switched to Harry Browne. Ideology is what prevented me from making the Libertarians my first choice. I am a pragmatist, not an ideologue. I am not going to march blindly over the cliff. I will try something and then wait and see whether it works before taking the next step. For example, I would eliminate the programs of the hopelessly corrupt and tyrannical federal government but I would keep or expand local programs, as a fall back in case of disaster. I view ideology as a form of blindness, a quest for a simple one-sixe-fits-all solution. Ideology desensitizes us. I saw this at the "Save The Constitution" rally on Labor Day. The Libertarians had most of the signs and much of the spirit, but when they walked around the mall displaying the signs, some the Libertarians acted silly or belligerent, indifferent to the people they were trying to reach. The theory made them right and everyone else wrong, or so they believed, outside observers would be more likely to conclude that the theory merely made them immature, self righteous and naive.

Pragmatism would cure this insularity. A pragmatist needs to hear what other people thing, because people provide feedback. People are more likely to vote for a party that is interested in what they think. There is a desperate need for such a party, a party which foments dialogue, but unites the people. The existing parties foment faction and division...the government grows ever stronger while the people remain helpless. Truth is a process. it entails dialogue, openness, adaptability, humanity. Libertarians have ideology, but they do not yet have truth. I wish Libertarians could be less rigid, less fearful, and more inclined to be what a party needs to be today, a way of inquiry, a way of life.

Many people can support you initially but, you sem to oppose all government, even Constitutional, limited, self government. You are trying to tell people that they have no right to govern themselves. Why go so far out on limb? So long as I you limit yourself to obvious, immediate, current problems, I can agree with you. Government is indeed bad, in theory, but the anarchy of capitalism run amok is also bad, and it's impossible, a priori, to say which is worse.

It is time for the rest of you to look as well.

Re: Land Monopoly. There is no debate. John Locke did not have a proviso on land property rights that each person has the right to equal land of equal value. He was very clear on this subject in the Second Treatise on Civil Government. In section 50 he states, "it is plain that the consent of men have agreed to a disproportionate and unequal possession of the earth..." in discussing land rights in a state of nature, Locke contended that a person had the right to the amount of land to which he could claim title with his labor. He did not say equal land of equal value but that might mistakenly be

implied from some of his writing. The most direct influence of a concept of equal land of equal value came from the feudal or manorial system of land ownership and use, which was undergoing severe changes during Locke's time and causing significant social changes. In the manorial system, the lord owned the land which was commonly divided into three fields...there were commons used for pasture and the villeins had the right to use of these for their own livestock. The reason for the division of the land into several different fields with many strips in each field was to inusre that each villein had access to the production of equal land of equal value. Beginning in the 14th c. and peaking in Locke's time, land owners engaged in a policy called enclosure in which they enclosed the fields, generally to turn them into pasutre to profit from the wool trade. ..the population of villeins, ...became the very poor of English cities of the 17th c. As a final comment, please note that Jefferson referred to life, liberty and the pursuit of happiness rather than to Locke's more traditional formulation of life liberty and property. One might suspect that the American revolutionaries didn't want to get too far out on a limb to asserting the right to property, especially of the Tories who remained loyal to England and whose title to land came from royal decree. TERM LIMITS

HOUSE JOINT RESOLUTION NO. 178. RESOLVED by the House of Delegates, the Senate concurring, a majority of the member selected to each house agreeing. That the following amendment to the Constitution of Virginia be..., ARTICLE IV LEGISLATURE Section 4. Qualifications of senators and delegates. Any person may be elected to the Senate who, at the time of the election, is twenty-one years of age, is a resident of the senatorial district which he is seeking to represent, and is qualified to vote for members of the General Assembly. Any person may be elected to the House of Delegates who, at the time of the election, is twenty-one years of age, is a resident of the house district which he is seeking to represent, and is qualified to vote for members of the General Assembly. A senator or delegate who moves his residence from the district for which he is elected shall thereby vacate his office. No person shall be eligible to be elected to more than three consecutive terms in the Senate. No person shall be eligible to be elected to more than six consecutive terms in the House of Delegates. Service for a partial term shall not preclude service for the following twelve years. These limits shall apply to terms of service in the General Assemblybeginning on or after the commencement of the 1996 Regular Session of the General Assembly. No person holding a salaried office under the govemment of the Commonwealth, and no judge of any court, attorney for the Commonwealth, sheriff, treasurer, assessor of taxes, commissioner of the revenue, collector of taxes, or clerk of any court shall be a member of either house of the General Assembly during his continuance in office; and his qualification as a member shall vacate any such office held by him. No person holding any office or post of profit or emolument underthe United States government, or who is in the employment of such government, shall be eligible to either house. This bill restricts a person from seeking more than one office at a time.

HOUSE JOINT RESOLUTION NO. 156. Proposing an amendment to Section 1 of Article V of the Constitution of Virginia, relatingto executive power and the Governor's term of office. Patrons-- Purkey, Bryant, Crouch, Fisher, Hamilton, Landes, McDonnell, Wagner and Wardrup; Senator Quayle-Referred to Committee on Rules ARTICLE V EXECUTIVE Section 1. Executive power; Governor's term of office. The chief executive power of the Commonwealth shall be vested in a Governor. He shall hold office for a term commencing upon his inauguration on the Saturday after the second Wednesday in January, next succeeding his election, and ending in the fourth year thereafter immediately upon the inauguration of his successor. No person shall be eligible to be elected more than two times to the same office for the term next succeeding that for which he was elected of Governor, and the Governor shall be ineligible to any other office during his term of service.

HB2003, House: Referred to Committee on Finance Delegate Vince Callahan has introduced a bill to reduce petitioning requirements for independent and third-party can-didates. This is a good bill! Write to your legislators in support.HB 2003 Reduces the number of required signatures for statewide office candidate petitions from onehalf of one percent to one-tenth of one percent of the number of registered voters in the Commonwealth. The approximate number of signaturesis reduced from 16,000 to 3,200. The bill reduces the number required for congressional district candidates in a like manner from approximately 1,500to 300. The bill deletes requirements that the person circulating the petition mustbe a registered voter entitled to vote for the candidate and that the circulator's signature on each page of the petition must be notarized. Note: both HB 1959 and HB 1621 would also prohibit medical research in these areas! HB1781 & SB1184 Two forms of seeds and stems - again. This bill would increase the number of marijuana charges resulting in felonies, even in minor cases. HB 1628 - Establishes a presumption of intoxication while driving for anyone with any detectable residue in their blood for any illegal substance. Very Bad for marijuana users who have such traces weeks after any ingestion at all! No studies have established levels of THC that indicate intoxication. Help stop this bill. SB 704 Increases many misdemeanor drug charges to felonies and mandates up to ten times longer jail terms for them. Voice your support for these 2 good bills: SB 776 While not perfect - we congratulate Senator Kenneth Stolle on his understanding of the complex issues of rehabilitation vs. imprisonment. This bill expands the first offender law that allows for treatment rather that jail even in some felony cases. HJR 656 A Joint Resolution for study of commercial Hemp in Virginia!Don't delay, this will be a very short session; so call right away and let your voice be heard.

Mr. Mason notes that the House of Delegates has already voted 86-13 to repeal the medicinal use of marijuana.

ANTI-PRICE GOUGING

This bill, sponsored by a CONSERVATIVE REPUBLICAN State Senator (Ken Stolle, a candidate for Attorney General this year), calls on the STATE to SET PRICES-for a wide range of products in the aftermath of a natural disaser. This bill should be defeated. Please all your legislators and tell them is a stupid bill that deserves no furher consideration. THE VIRGINIA GENERAL ASSEMBLY IS NOT EMPOWERED TO REPEAL THE LAWS OF SUPPLY AND DEMAND Patrons-- Stolle and Schrock-Referred to the Committee on General Laws--CHAPTER 17.8. VIRGINIA POST-DISASTER ANTI-PRICE GOUGING ACT. Essentially, the act allows the state to control prices in emergencies, and defines what and when. Definitions. As used in this

chapter: "Average retail price" means the average price at which similar merchandisese, services, or shelter were being sold or rented in the emergency area during the thirty days immediately preceding the declaration of an emergency. "Consumer goods" means any article, product, merchandise, or commodity of any kind which is customarily produced or distributed for sale or rent forconsumption or use by individuals, including, but not limited to, human or animal food, water, ice, clothing, lumber, hardware, chainsaws, generators, hom improvement materials, medical supplies, flashlights, batteries, candles, blankets, and diapers."Emergency" means any occurence, or threat thereof, whether accidental, natural, or man made, in war or in peace, which results or may result in substantial injury or harm to the population or substantial damage or loss ofpropertv."

WRITE-IN CANDIDATES

The General Assembly is considering a bill that would allow write-ins for President and Vice President. Although we've been hardworking (and fortunate) enough to have the LP candidates on the ballot here for the last 3 elections, this is a bill we should support. SENATE BILL NO. 667 Voting by paper ballot; voting for presidential electors; write-in votes. The qualified voter shall take the official paper ballot and enter the voting booth. After entering the voting booth, the qualified voter shall mark immediately preceding th ename of each candidate for whom he wishes to vote a check (/cm) or a cross (X or +) or a line (-=) in the square provided for such purpose, leaving unmarked the square preceding the name of each candidate for whom he does not wish to vote. Any ballot marked so that the intent of the voter is clear shall be counted. The qualified voter at a presidential election shall mark the square preceding the names and party designation for his choice of candidates for President and Vice-President. His ballot so marked shall be counted as if he had marked squares preceding the names ofthe individual electors affiliated with his choice for President and Vice-President. The qualified voter at a presidential election may cast a write-in vote for President and Vice-President as provided in subsections C and D of this section. At all elections except primary and presidential elections it shall be lawful for any voter to vote for any person other than the listed candidates for the office by writing or hand printing the person's name on the official ballot.

MARRIAGE

SENATE BILL NO. 694 Patrons—Reasor, Couric, Edwards, Howell and Whipple; Delegate: Brickley Referred to the Committee for Courts of Justice-Every person who is empowered to issue a marriage license shall, at the time of issuance thereof, distribute to the applicants for the license, birth control information, information concrning genetic disorders, information concerning acquired immunodeficiency syndrome and the available tests to determine the presence or absence of the disease and, a list of family planning clinics located in the county or city of the issuing office and information on the criminal laws of the Commonwealth proscribing physical or sexual abuse of a spouse or other family member. Such lists and information shall be furnished by the Virginia State Department of Health.

DEBT LIMIT

SENATE JOINT RESOLUTION NO. 115AMENDMENT IN THE NATURE OF A SUBSTITUTE. This bill, well on its way to being approved by this year's General Assembly, would amend the Virginia Constitution to limit the debt of cities and counties to 10 percent of the assessed value of creal estate within the cityor county. Of course, a debt limit of 0% would be better, but this is an encouraging development! (Proposed by the Senate Committee on Privileges and Electionson October 23, 1996)

GUN CONTROL

Delegate David Albo (R-Springfield) is trying to diminish our right to keepand bear arms ... this time taking away the right to a concealed carry permit to anyone ever arrested on a drug offense -- EVEN IF FOUND NOT GUILTY! Write to your legislators and urge them to opose HB 454.HB 454 Concealed handgun permit. Summary: Concealed handgun permit. Provides that a person who has been the subject of an adjudication on any drug possession or distribution charge within three years prior to his application for a concealed

handgun permit is ineligible whetheror not he is found guilty, provided the court finds that the facts of the case were sufficient for a finding of guilt.

Pro-Gun Bills

The best defense is a strong offense.HB 2662 -- Del. Jay Katzen's Bill on Concealed Carry Reform & Repeal Local Gun Control Laws. Concealed Carry Reform. Eliminates the restriction on carrying concealed in restaurants Recognizes permits issued by other states Extends duration of permit from 2 to 5 years. Reduces the cost of permit renewals from \$50 to \$25. Removes Social Security Number from the permit. Authorizes the clerk of the court to sign the permit. Repeals local gun control laws. HB 2896 -- Del. Jay Katzen's Bill to Repeal One-Gun-A-Month. Puts an end to Wilder's handgun rationing scheme.

Anti-Gun Bills

Mandatory Fingerprinting (HB 1566, HB 2336, SB 641, SB 944, et al) Creates centralized, federal gun owner registration by sending your fingerprints to the FBI. The Filegate scandal has shown that the FBI can't be trusted to maintain your privacy. Criminals don't apply for permits. Washington, D.C. is a prime example. Increases cost for permit applications. Restrictions on carrying concealed in County buildings (HB 1946, HB 2302, SB 763, SB 978, et al) Applies only to Fairfax County (counties with an executive form of government). Not based upon any demonstrated need or problem. Needlessly restricts law-abiding permit holders' access to government facilities. Implies permit holders are criminals or are more likely to commit criminal acts.

HB 1951. This bill could provide an insurmountable hurdle for the LP to retain official party status once it is achieved -- requiring 15 percent ofregistered voters to be registered with a party for that party to retain party status. The bill requires the State Board of Elections, in January 1998, to notify all registered

voters of the new party registration law and send them a return

card to indicate their party affiliation or independent status. Voters may change their party affiliation or independent status by written notice at any time except the 28 days before an election when the registration records are closed. The state party chairman must notify the State Board by January 31 of each year whether the party will close its primaries and permit only registered party members to participate or whether it will open its primary to party members and independent voters. Further, the bill adds a requirement that primary candidate petitions must be signed by voters registered as members of the party conducting the primary, sets the required number of petition signatures at one percent of the number of voters registered as members of the party in the election district where the primary is being held, and allows an official political party to retain that status so long as at least 15 percent of the Commonwealth's registered voters are registered as members of that party. Referred to Committee on Privileges and Elections.

1972 NOVEMBER: 1. John Hospers runs for US President (Tonie Nathan for VP) against Gerald Ford and Jimmy Carter. Does not win, but for the first time in history a woman receives a vote from the US Electoral college -- from Virginia elector Roger Lea MacBride. MacBride casts his vote for the Libertarian ticket. Ticket makes ballot in two states.

1976 NOVEMBER: 1. Roger MacBride runs for US President (David Bergland for VP). Does not win, makes ballot in most states, including Virginia.

1980 NOVEMBER: 1. Edward A. Clark runs for US President (David Koch for VP) against Tom Anderson, Jimmy Carter, and Ronald Reagan. Does not win; gathers close to a million votes around the country. Makes ballot in all 50 states & DC.

1991 JANUARY: 1. Rick Sincere of Arlington ran a credible campaign for the Virginia House in a special election, once again gamering a respectable percentage.

1991 NOVEMBER: 1. Paul Gagnon runs for Fairfax Board of Supervisors. Gagnon get 15% in a three way race -- a tremendous improvement over our vote percentage in the congressional campaign only a year earlier. 2. Rick Sincere runs for Arlington Treasurer. 3. Mike Ward runs for Arlington Board of Supervisors.

Proportional Voting Systems

Propsed Resolution for consideration by the LPVA convention: We strongly urge adoption of proportional voting systems in Virginia and the United States for fairer and more complete representation of the people in democratically elected bodies.

The U.S. is among the few democracies of the world that retain a Single Member Plurality (SMP) voting system. We divide legislatures into single member districts; voters have only one vote to cast, and only the candidate receiving the most votes in each district wins. Under such a system, the game for all candidates becomes one of trying to be all things to all voters and offending the fewest people possible. Voters are boxed into voting for the lesser of two evils.

The emerging democracies of this world chosen proportional representation. There are three types: party list voting (voting for parties and candidates within parties), additional member system (combines SMP elections with party list voting to fill out a legislature), and preference voting (candidates run in multi-member districts and voters state preferences for the candidates by marking their choices "1," "2," "3," etc. voting for as few, or as many candidates as they like). Winners are chosen by a process of transfers of excess votes from winning candidates to voters' next favorite candidate and transfers of all votes from losing candidates to voters' next favorite candidate until all open seats are filled. A candidate can get elected to public office by appealing to only a minority of voters, and not be forced to either be in the mainstream or be unelectable!

I have heard several objections that proportional voting (PV) violates libertarian principles. First, there are the understandable concerns about democracy. A libertarian society will come about in one of two ways: either armed revolt or democracy. The former will not happen in the United States. Many libertarians need to get over their ambivalent views about democracy and embrace the process.

Democracy, in of itself, does not violate libertarian principles and a more

representative democracy certainly would not. There is nothing wrong with working for something that is neutral with respect to our principles. but would help the LP practically. Others fear that PV will help the Left to gain power. The Left supports proportional voting because they realize they are an excluded political minority, while some LP members think the LP can win sometime soon in the current winner-take-all system. After the experience of the past 25 years for the LP, and the past 125 years of American history, the proposition is dubious. I think the LP would be the primary beneficiary of PV and only a very small minority of Americans would embrace the Left.

There is an important role for the LP in American politics. For years I have heard certain people say that the LP is never going to succeed without explaining why this was destined to be the case. The primary reason why the LP's success has been limited is our voting system. SMP voting is largely responsible for the sad state of the American democracy: ever decreasing voter turnout and a choice between the lesser of two evils. Americans have said that they want to see more viable choices on the ballot. The only way to get that is with proportional voting. It is the only way political minorites are going to become electable, and it is time to recognize that for now, Libertarians are a political minority.

The conflict has been exciting, agitating, all-absorbing, and for the time being, putting all other tumults to silence. It must do this or it does nothing. If there is no struggle there is no progress. Those who profess to favor freedom and yet deprecate agitation, are men who want crops without plowing up 🕏 🕏 the ground, they want rain without thunder and lightning. They want the ocean A without the awful roar of its many wa-

This struggle may be a moral one, or it may be a physical one, and it may be both moral and physical, but it must be a struggle. Power concedes nothing without a demand. It never did and it never will.
