

Rampant taxes abridge our economic rights

r. Martin Anderson, senior fellow of the Hoover Institution and former presidential adviser, has always argued that we need some kind of constitutional protection of our economic rights, which he sets forth in a pamphlet, "An Economic Bill of Rights." The presi-

dent has seen the argument and is apparently ready to lend it the power and prestige of the White House.

While the framers of our Constitution produced the world's most perfect set of rules to promote a free society, they were remiss in not guaranteeing our The economic freedoms.

Constitution's language is quite clear in the protection against government violation of precious liberties like speech, religion, assembly, trial by jury and others enunciated in the Bill of Rights. The phraseology of the Bill of Rights says it all: "Congress shall make no law ... prohibiting ... abridging ... infringing" these precious rights.

Nothing in the Constitution gives similar protection to our economic liberties. The document leaves it up to Congress. Congress can take 20, 40, or 70 percent of our earnings. It's up for grabs. Congress and state legislators, acting in

the interests of powerful lobby groups, can control all our pocketbook rights. So it's high time we had some kind of constitutional guarantee of our economic rights.

In a bicentennial speech on July 3 at the Jefferson Memorial, President Reagan said, "Over the past 40 years, however, the growth of government has left our citizens with less control over their economic lives. What America needs now is an Economic Bill of Rights that guarantees four fundamental freedoms: the freedom to work; the freedom to enjoy the fruits of one's labor; the freedom to own and control one's property; the freedom to participate in a free market."

In my book the president earns an "A" in identifying the four freedoms we need to have protected. But he rates only a "C-minus" for his proposed initiatives to secure those freedoms. Reagan proposes to secure economic freedoms by establishing a Commission on Privatization, reconstituting the Task Force on Regulatory Relief, and pushing welfare reform. The only thing saving his proposed initiatives for securing our economic rights from an "F" are those calling for a line-item veto and Balanced Budget-Spending Limitation Amendment.

A Balanced Budget-Spending Limitation Amendment would place a ceiling on the amount of our earnings Congress could take. The 1982 version of this amendment, worked out by the National Tax Limitation Committee (NTLC), which passed the Senate only to be defeated in the House, contained a clause saying: "Total outlays in any fiscal year shall not increase by a percentage greater than the percentage increase in nominal gross national product in the last calendar year prior to the beginning of said fiscal year." The NTLC blue ribbon committee, of which I was a member, sought an amendment to hold the line on government spending at the 1982 level which could only be exceeded by the president's Nativity Scenes declaring a national emergency with two-thirds of both Houses of Congress concurring, or it could be exceeded with a three-fourths vote in

Obviously, Congress does not want a limit on what they can spend. It appears we'll have to go the Article V route and have two-thirds of the state legislatures call for reconvening the constitutional convention for the narrow purpose of enacting a Balanced Budget-Spending Limitation Amendment. Thirty-two states have already done so; we only need two more. If the president starts a national campaign to reconvene the constitutional convention, you'll know the White House is serious about economic freedom.

'Robin Hood style' tax hurts efficiency

TORONTO — (CP) — The spirit of Robin Hood was evoked by an economist yesterday and shown to be an impediment to progress.

Arthur Laffer, economics professor at University of Southern California, said over-taxing people's income robs them of the incentive to work.

Applying the mythical Robin Hood theory of taking from the rich to give to the poor, Laffer said an employer or high-wage earner learns quickly that it "doesn't pay to get ripped off.'

"How long would it take you to learn not to travel through Nottingham forest when you knew you'd be robbed?" he asked delegates to a conference sponsored by the Ontario Economic Council.

"In the long run, the Robin Hood concept makes the poor worse off.

There is nothing left to give them. Raising taxes excessively at the higher level makes it worse at the lower level."

Laffer, also a partner in the Boston consulting firm of H. C. Wainwright and Co., said reducing the tax base would lead to more employment, less welfare dependence and less tax evasion.

When taxes were cut in the U.S. several years ago, spending as a share of the gross national product increased by 2.5 per cent.

Laffer said he supports the theory of making interest rates on mortgage payments tax deductible, a concept also proposed by Opposition Leader Joe Clark.

However, he would not specify how such a policy might be applied in more than 300 delegates it is unfair to attack inflation at the wage level without offering workers some benefits in the form of tax incentives.

Three of them — Stellazine, Serenace and Disipal — are, according to a medical expert, "used only in the treatment of severe psychiatric illness."

As much as two litres each of Stellazine and Serenace are used each week to control the 50 each prisoners on the wing's No. landing.

A drug not listed-but which is, according to information, in regular use—is Largactil, another ultra-strong tranquilliser.

It has been administered in British prisons since 1958 as an alternative to the straitjacket.

One former Brixton officer said: "Up to four litres of Largactil are used every week on that landing.

"A normal dose would be 50 milligrammes . . . but I know of one prisoner who was kept on his knees just about permanently by 300 milligramme doses given three times a day.'

Another constitutional convention would take away individual rights

Could our Bill of Rights make it through committee today? Let's

Several months ago Reason magazine ran an article which asked the question, "Did the Constitution betray the Revolution?"

I suppose my belief that it did stems, in part, from being of the genes of the clan whose leader "smelt a rat" and prepared to meet the framers head on. Patrick Henry, with his co-adjutor George Mason, spoke for two weeks in June 1788 — in opposition to the "Philadelphia Document," not primarily because of what it didn't have (a full bill of rights), but because Section 9, Article 1, addressing the individual's rights in the "new scheme" was very incomplete.

The new scheme, then, was not meant just to deal with the states leaving their constitutions to preserve the sacred rights of individuals but its powers would encompass the national individual. By this implication, the rights not enumerated would be rights not owned.

Mason and Henry would have none of it. Richard Henry Lee was not in the Richmond assembly but worked to preserve the hard-won liberty in a series of articles (Letters of the Federal Farmer").

Thomas Jefferson, who was in Paris at the time, indicated why the Federalists had to satisfy the leader of the opposition: "He was the idol of the country beyond any man who ever lived," — and without the then huge state of Virginia, the union wouldn't stand. The rest is

The Bill of Rights, as promised by the Federalists at the ratifying convention, would preserve the revolution.

This absence, in light of what we see today, is why I have selected three statements that show the purity of the principles involved and why we must not allow them to touch the Bill of Rights:

- 1. Liberty of the Press (Chief Justice John Marshall): "The genius of the Constitution, and the opinion of the people of the United States, cannot be overruled by those who administer the government. Among those principles deemed sacred in America, among those sacred rights considered as forming the bulwark of their liberty, which the government contemplates with awful reverence and would approach only with the most cautious circumspection, there is no one of which the importance is more deeply impressed on the public mind than the liberty of the press. That this liberty is often carried to excess; that it has sometimes degenerated into licentiousness, is seen and lamented, but the remedy has not yet been discovered."
- 2. Freedom for and from Religion (President James Madison): "If the public homage of a people can ever be worthy the favorable regard of the Holy and Omniscient Being to whom it is addressed, it must be that in which those who join in it are guided only by their free choice, by the impulse of their hearts and the dictates of their consciences; and such a spectacle must be interesting to all Christian nations as proving that religion, that gift of heaven for the good of men, freed from all coercive edicts, from that unhallowed connection with the powers of this world which corrupts religion into an instrument of an usurper of the policy of the state, and making no appeal but to reason, to the heart and to the conscience, can spread its benign influence everywhere and can attract to the divine altar those freewil offerings of humble supplication, thanksgiving, and praise which alone can be acceptable to Him whom no hypocrisy can deceive and no forced sacrifices propitiate."

Irving Brant's comment from his book "The Bill of Rights":

"If it is meaningful that the author of the First Amendment, as president, willingly or unwillingly proclaimed days of prayer and thanksgiving, it is tenfold more significant that the wording destroys the claims that are based upon the fact that he proclaimed them. Where, in the words quoted from his proclamation, is there even microscopic room for the official prayer that the state of New York required to be recited every day in every schoolroom?"

3. Second Amendment: "A well regulated militia, being necessary to the security of a free state, the right of the people to keep and bear arms shall not be infringed.'

Knowing that this ability of the people to defend themselves put force into and respect for the other rights of the people - into the minds of all who would operate in the public arena - Patrick Henry declared in the Ratifying Convention:

"Liberty, the greatest of all earthly blessings — give us that is a book about the precious jewel, and you may take everything else! Guard with jealous Satanic I. R. S. attention the public liberty. Suspect everyone who approaches that jewel. Unfortunately, nothing will preserve it but downright force. For lots of hard to Whenever you give up that force, you are inevitably ruined."



Unload the Federal White Elephant

By Walter E. Williams

Columnist Jack Anderson warns, "It's time someone blew the whistle on a Reagan administration scheme that could lead to one of the biggest land grabs by greedy private interests in the nation's Now that's a highly emotional statement coming from one of the nation's leading columnists, but what is its analytical worth? Anderson probably wants you to be concerned about land being taken away from you. Let's put some light on this issue.

Forty-two percent of all the land in the United States is owned by some level of government: state, local or federal. The amount owned by the federal government is approximately one-third of all the land in the U.S. — 744 million acres, according to Dr. M. Bruce Johnson, research director of the Pacific Institute for Public Policy Research, and president of the Western Economic Association. Secretary of Interior James Watt has proposed selling some federally owned lands - not all of it, just some of it. As you might have guessed, numerous environmental and conservationist groups, ranging from the Audubon Society to the Sierra Club, have come out against the proposed sale. They say that the land belongs to the people of the United States.

Well, I'm one of the people of the United States; does any of that federal land belong to me? All evidence that I have in my possession says, "No!" How do I know that? It just comes from a simple test that I use to determine whether I own something: Can I sell it? I only own what I can sell. I own things like my shirt, my car, my house. I do not own federal land in Utah.

ASIDE FROM the issue of who federally owned land belongs to, there's the issue of how federal control leads to gross land mismanagement. Private ownership of resources, includingland, forces the owner to accountability standards, he must use the resource in a way that yields the highest return, i.e., profits. Government bureaucrats, on the other hand, have no such accountability standards; they can mismanage with virtual impunity. What do they have to lose?

Professors John Baden and Richard Stroup in their book. "Bureaucracy vs Mismanagement," and Professor Gary D. Libecap in his book, "Locking Up The Range," detail government mismanagement of public lands. One case is the Forest Service's logging of vast areas int he Rockies. The value of the wood is far less than the cost of extracting it. The government can ignore this fact and destroy the environment becuase it is not disciplined by profits. It does not have to compare benefits with costs.

Environmentalists aren't the only people who support large scale federal land ownership. Cattlemen find such an arrangement in their interest, too. If you are a rancher, you can, for a feee, let your cattle graze on government land next to your ranch. The annual rent that you pay to the Bureau of Land Management is well below what it would be on the market, so much so that, if your land is next to the federal land, it sells for a much higher price.

Many cattlemen would much rather deal with politicians than the market for use-rights to grazing land. It's a great arrangement. Total receipts from grazing fees to the government were \$24.9 million in 1981. Outlays by government for the grazing program were \$41.6 million. Who paid this difference? You and I, of course. We paid the ranchers to use federal lands. You would have thought they'd show their gratitude by lowering beef prices.

The best thing we can do is to support Secretary James Watt in his effort to unload this federal white elephant. Without question, federally owned land should be sold to the highest bidder. The only lands that should remain under federal control are those parcels which can further legitimate federal functions, such as national defense. Private citizens can do a better job of putting our remaining land resources to their most productive use.

There is, at the main campus of the University of Wisconsin in Madison, a mile-long strip which is one of the most beautiful spots in the midwest. > There is, up in the northwestern resort-crescent of Michigan, the campus of Northwestern Michigan College. It sprawls in Traverse City, near the shore of Grand Traverse Bay, and it looks like a misplaced redwood grove: The grounds are filled with tall slim trees whose branches don't begin until most of the way up and the pretty north coast of California is the first thing visitors are reminded of when they see the spot. Inside, things are less pretty, for there, five days a week, people are being taught that the lives of citizens are properly toys of the state, that whatever something a "majority" tells something called a "government" to do is fine, as an expression of something called "majority rule" or "democracy".

> There is, in a busily productive downtown area, the dramatic tower/campus of the University of Pittsburgh. The view of the city and its exploding suburbs and the Allegheny and the Monongahela and the Ohio they form----the view of all that from one of the campus/tower's higher floors, especially at night, is spectacularly beautiful---just as what goes on inside that tower is spectacularly ugly---as, for instance, when matriculators at the school are informed that good sense demands that the American people be disarmed, for their government will protect them against foreign aggression, and of course they'll never need to be protected against their government.

There is, down at the eastern edge of the delta-realm of Mississippi, the quaintly beautiful Faulknerian campus of the University of Mississippi----Ole Miss. Its atmosphere of magnolias and whippoorwills and jasmine and mockingbirds and warm summer-the-year-around nights is indescribably pretty----just as what's happening inside the campus buildings is indescribably ugly(the suggestion that southern universities have escaped the dementia of the rest of American academia is the sheerest mythology --- they have simply come along more slowly; but virtually all of them have now "arrived"). That ugliness is shown when the young Mississippians(few outsiders attend) are told that the murderer, the rapist, the assaulter, the thief, if not responsible for his or her own actions, is a victim of society, and is therefore someone who merits assistance, not punishment.

There is, off in the hill country of New Hampshire, the classicly New Englandish campus of Dartmouth, at the village of Hanover. Inside is where young Americans are indoctrinated to think that a free economic system is inherently vicious and unproductive and inequitable, that a socialist system is inevitably just and productive and fair, and that therefore the former must be replaced by the latter everywhere on the face of the earth.

There is, on the campus of Michigan State University, in East Lansing, the great carillon tower which features the chime-concertoes for which it is famous as well as as a splendid view of a pretty campus, one with lawns which rise and fall in gently rolling hills and valleys and countless shady nooks where studying is almost fun. That such indescribably pretty places should be the source of such indescribably ugly proslavery thoughts is ----indescribably sad.



SAN FRANCISCO - The Lyndon La Rouche-sponsored AIDS Initiative has returned to California after having been voted down at the polls last year 71% to

With only minor changes in its wording, the initiative classifies AIDS as a contagious disease, making its victims subject to legislation which pertains to diseases such as smallpox and malaria. People with AIDS (PWAs) or Aids-Related Complex (PWARCs) would be reported to the State Department of Health Services, and the state would have the power to quarantine PWAs and PWARCs.

In a statement made about the proposal last year, Khrusho Gandhi, chairman of La Rouche's Prevent AIDS Now Initiative Committee (PANIC), said the proposal would also empower the State Health Department to order mandatory testing for anyone suspected of having AIDS. (San Francisco Chronicle.






Dear Reader:

We can't offer you copies of reviews as the book is just out and has not been yet reviewed; even the copyright is still in process. We will give you a small sample, not at all typical:





Rowlee case stalled as lawyers battle

Two lawyers defending New York Patriot E. Kevan Rowlee lashed out at each other Tuesday in federal court, and the result was another postponement of Rowlee's taxevasion conspiracy trial.

Attorney Jersey M. Green of Denver, Colo., who was hired by Rowlee 10 days ago, revealed Tuesday that Rowlee's court-appointed attorney, John Rinaldi of Fayetteville, owes the Internal Revenue Service nearly \$70,000 in back taxes.

Rinaldi's deb creates the appearance of a conflict of interest, Green charged, be-cause Rinaldi was subject to pressure from the government agency that Rowlee is battling.

"The fact of Mr. Rinaldi's tax troubles with the Internal Revenue Service creates a conflict of interest in that here he is expected to take an aggressive stance against a government agency which can choose how vigorously to seek

collection of an assessement he owes the agency," Green said.

An angry Rinaldi reorted that Green is nothing but a hired gun from the West taking shots at his reputation.

"It really bothers me when he makes those insinuations and inferences that I'm in collusion with the IRS," Rinaldi said. He said the government has never attempted to

use his debt to influence how he represented Rowlee. "I've never done anything that in any way jeopardized Mr. Rowlee's right to a fair trial," Rinaldi said.

U.S. District Judge Neal P. McCurn denied Green's motion for a hearing to determine if the IRS and U.S. Justice Department tried to deprive Rowlee of his Sixth Amendment right to effective counsel.

"Frankly, I don't see one (a conflict)," McCurn said.

Green got into a spat with McCurn as well during the hour-long court hearing Tues-

Green asked McCurn to withdraw from hearing Rowlee's trial, claiming that the judge permitted Rinaldi to continue representing Rowlee despite having access to information about the IRS tax lien against Rinaldi.

McCurn said he was unaware of the lien until Green filed his motion.

"You don't expect me to go through every file and every document," McCurn said sharply. "Do they do that in Colorado?"

"No, but they do recuse themselves to preserve the public's confidence," Green shot back.

McCurn said he was not going to withdraw.

In asking for another postponement of Rowlee's trial, which was scheduled to begin Nov. 12, Green asserted Rinaldi has done virtually nothing to prepare Rowlee's defense.

Rinaldi countered that Rowlee has not cooperated in that effort and has made it clear he didn't want him to be his lawyer.

Despite protests from Assistant U.S. Attorney Craig A. Benedict, McCurn agreed to postpone the trial until Dec. 3 to give Green more time to prepare a defense.

Rowlee, 47, of Fulton, and the New York Patriots, an organization he founded, were indicted in December of mail fraud and conspiracy stemming from their alleged efforts to thwart the IRS.

Rowlee has not filed a federal income tax return since 1977, the indictment charges, and has filed false W-4 forms and urged other conspirators to follow suit.

If he is convicted on all counts, Rowlee could be sentenced to up to 212 years in prison.

Rowlee told reporters after Tuesday's hearing that he is looking forward to his trial.

"The court knew from day one I wasn't satisfied with Mr. Rinaldi because of his lack of experience in this area," he






own troops killed by doing everything wrong; they must NOT be given a command as an officer.





Now I realize that not everything is getting worse. If something you like is getting better, let it, or offer to help.


