Former LPSM Chair wins reelection!

Kate O'Brien retains seat on Rancho Simi Rec & Parks Board

n an amazing comparision to the Florida Presidential recount efforts, former LPSM Chair Kate O'Brien successfully held her seat on the Rancho Simi (California) Recreation and Parks District Board after her nearest contender abandoned his recount effort on the seventh day of hand recounting. O'Brien initially took the third and final board spot by a razor-thin margin—just 3 votes out of over 95,000 cast—when all votes were finally tallied on November 28.

O'Brien's opponent, Jim Dantona, Jr. called for a hand recount after the announcement. This hand-recount cost his campaign \$1,200 per day (after he had already outspent O'Brien more than \$20,000 to \$0 before election day), until he was forced to abandon his efforts on day seven. Many libertarian volunteers were on hand in the Elections Office during that time to observe the recount efforts.

This victory is the closest non-partisan race for a California Libertarian in recent memory and is yet another feather in the cap of the LPC's Operation Breakthrough. Congratulations, Kate!

ovember's meeting was mostly social, but we also reviewed some of the election campaigns just concluded and discussed some ideas and upcoming events that need planning.

Recap of Jack's campaign

Jack talked about various candidate round tables, TV broadcasts, and press interviews he was able to take advantage of. He posited that it may be fair to take credit for the narrow defeat of Measure B (the county crime lab remodeling bond), since he used some of his appearances to speak out against the need for a bond for this purpose. (The San Francisco Chronicle also noted the LPSM's usual opposition to bond financing.)

Introductions

Hospital board candidate Melisse Lusin

introduced us to her baby daughter, and noted that this was her last race for the foreseeable future, but her husband, Brian Holtz, said he'd be willing to run!

Bob's discussion topics

Bob raised a number of ideas for discussion. We declined to take any local position on Florida's ballot mess (1Y-4N-3A). We talked some about the mechanics of state and local initiatives. Most people present were interested in the problem of increasing our voter registration. Bob expressed the goal as getting voters to ask themselves "Why am I registered as a member of my present party?"—observing that many philosophical libertarians are registered in another party because their parents registered that way before them. The result of the discussion was that Bob organized a committee to pro-

mote LP voter registration, to meet later and discuss the subject further.

Open county offices

Bob volunteered to keep track of open offices in the county. Linden volunteered to keep tabs on the election calendar.

Chair: Presides at all business meetings, sets meeting agenda and ensures all officer positions are filled.

Vice-Chair: Assistant to the Chair and performs those duties in the chair's absence.

Secretary: Records the votes of the central committee and the Executive Committee. Provides meeting notes to the Newsletter Chair for inclusion in the newsletter.

Treasurer: Manages party funds under the supervision of the Executive Committee. Compiles monthly Treasurer's reports and keeps financial records.

Membership Chair: Responsible for activities to maintain and increase Party and central committee membership.

Public Relations Chair: Responsible for the dissemination of information about the Party to the media and the public.

Newsletter Chair/Editor: Publishes the monthly newsletter with pertinent information about Party activity and the results of any central/Executive committee votes.

Campaigns Chair: Responsible for coordinating candidate recruitment, training and support for candidates originating in San Mateo County.

Activities Chair: Responsible for coordinating activities intended to involve, motivate, and inspire members.

Database Chair: Maintains the database of members, prospective members and newsletter subscribers. •
