#### **County Party in San Mateo Daily Journal**

April 12 — In an op-ed entitled "Yes, Virginia, there is a choice", author John McDowell quotes county party Vice Chair Kevin Duewel: "In a left-leaning county like San Mateo, the Libertarian Party is a much more strategic vehicle than the Republican Party for advocates of limited government and individual liberty."

#### **State Party Convention**

March 30 — Delegates from across the state attended the Libertarian Party of California State Convention in Visalia, California. County Secretary Tom Lippman participated in the Platform Committee meeting, which proposed a slate of amendments to the state platform. County Vice Chair Kevin Duewel was elected as an at-large member to the state executive committee. Michael Stogner was endorsed by the Libertarian Party of California in his race for supervisor.

#### **State Senator Leland Yee Running Guns**

March 26 — Leland Yee was arrested by the FBI for public corruption and gunrunning charges. Yee was a renown proponent of gun control, stating that no individuals in the state of California should "own assault weapons ... no debate, no discussion." Yee is accused of dealing firearms and illegally importing firearms from the Philippines.
