NLP INITIAL PROGRAM DRAFTED

Steve Givot is circulating a draft copy of the proposed Libertarian Party program to national convention delegates and alternates. It will be presented at the National Convention in Philadelphia. The National Committee voted overwhelmingly to recommend adoption by the delegates in Philadelphia.

The draft Program planks present both long-term and interim short-term steps to move toward the LP objectives. The issues are ten of the most news-covered as required by the Bylaws.

The Preamble to the document is as follows:

- The Libertarian Party wants all Americans to be able to plan their own futures. Libertarians believe that individuals, families, associations, and businesses have the right and the ability to deal with their own problems by working with other people in a peaceful and honest way. We reject the idea that the aggressive use of force, whether by criminals or government, is either a moral or practical means for achieving positive ends.

Libertarians seek a world in which voluntary cooperation replaces force in human relationships. Toward that end, we offer the following ten-point Program.

(the following points are excerpts. ed)

Defending Americans in America

1. Notify our allies that they must plan for their own defense needs and take responsibility for paying for them. Provide allies with a timetable for the return of

American military personnel to America in order to defend America.

2. Negotiate arms reduction treaties which do not compromise our national defense.

3. Adopt a policy that Americans who travel abroad and companies which invest abroad do so at their own risk and are subject to the laws and customs of other countries while abroad. The United States will no longer use gunboat diplomacy on their behalf at taxpayers' expense.

4. Reject the "Reagan Doctrine," which engages the United States around the globe and risks the security of all Americans by increasing the possibility that the U.S. will become embroiled in a foreign civil war.

Federal Spending Must Be Cut

1. Place the federal budget under a "cap" at current levels. Any increase in spending on any project must be accompanied by an equal or greater reduction in other spending.

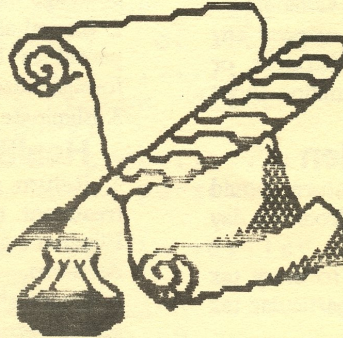
2. Phase out spending on aid to foreign governments and international organizations such as

the World Bank and the International Monetary Fund.

3. Phase out federal subsidies to all businesses such as the tobacco industry, the maritime industry, agriculture, or the military-industrial complex.

4. End federal subsidy programs to state and local governments. These programs merely take taxes out of the community and then send the money back, minus the amounts consumed by the government bureaucrats who administer them.

5. End all federally mandated programs forced on individuals, organizations, and businesses.

Choice in Education

1. Allow parents to send their children to the teacher and school of their choice by implementing a voucher system.
2. Eliminate the U.S. Department of Education, which spends billions on administration and educates no one.
3. Institute tax credits for any person or company which pays for the education of any student, or any number of students, at any school, public or private.
4. Remove restrictions which limit such private educational choices as home schooling.

Free Trade and Neutrality

1. The United States should return to its historical foreign policy of free trade and neutrality.
2. The United States government should repeal all laws which hamper trade with people in other countries.
3. The United States government should repeal all laws which restrict the right of Americans to travel to other countries.

Aids

1. Remove all impediments to research or testing regarding AIDS.
2. Allow any person who has AIDS or carries the virus to try any treatment or medicine, regardless of whether that treatment or medicine meets any other government regulations.
3. Federal Communications Commission and Postal Service regulations currently prevent people from getting information they need about AIDS research, treatment, and prevention. These regulations should be eliminated.
4. Public schools and universities should suspend any regulations which prevent teachers, administrators, or student newspapers from distributing information about AIDS research, treatment, or prevention.

Taxes: The Cruellest Burden

1. Neither Congress nor any state legislature should create any new tax or increase any tax rate from this day forward.
2. A "sunset" provision should be added to every tax statute. Such a provision would end the particular tax after two years unless it is re-enacted.
3. The U.S. Constitution and the state constitutions should be amended to provide for a binding initiative process where the voters can repeal any tax by majority vote.

4. Tax money should no longer subsidize any government service which can possibly be provided in the private sector.

Pollution is Trespassing

1. Clearly establish the legal right of individuals or groups to claim that pollution of their body, their property, the water on or under it, and the air above it is a trespass. This would include adoption of a broad definition of property rights to include air and water.
2. End all regulatory attempts to define an acceptable level of pollution or pollutants. Setting such standards has the effect of legally sanctioning that amount of pollution, even when it might be reduced below that level. It also deprives citizens of the right to successfully claim damages from lesser levels of pollution.

Solving the Drug Problem

1. Decriminalize the possession of marijuana, cocaine, heroin, and other controlled substances for personal use. Alaska and the Netherlands have already done this for marijuana and experienced no problems. The British have done this for heroin with similar results.
2. Hold people who commit crimes or cause accidents while under the influence of any drug (including alcohol) fully liable for their actions.
3. Repeal all laws and regulations which impede the establishment of private drug programs.

Immigration

1. Amend all welfare and benefit programs to exclude coverage and service for anyone who is not a U.S. citizen.
2. Repeal all laws and regulations which require a work permit or other form of government approval for a foreign citizen to work in the United States.
3. Eliminate all immigration quotas.

Health Care and Health Costs

1. Return decision making regarding medication and treatment to patients and health care professionals. Eliminate government interference in these important decisions.
2. Return all medical research to the private sector where scarce resource can be focussed on life-saving results rather than bureaucracy.
3. End government medical insurance and subsidy programs. Return these functions to private insurance companies and charitable organizations.

The Economics of Force vs. Consumer Choice-- The Education Dilemma

The dearth of education quality in this state has been the focal point of the latest political infighting. The politics of tax, spend, and divide the spoils is now in high gear. Politicians know no other means of solving problems than by this method, the economics of force. There is a better way to solve problems. When will they ever learn?

Governor Thompson proposes a 40% state income tax increase. House Speaker Michael Madigan opposes. Richie Daley gets elected. Michael Madigan proposes a 20% increase for two years-- a "temporary" tax. Yea, just like the unwanted relative "just staying the weekend." Thompson opposes.

"Downstate" doesn't want to "give" a disproportionate share to Chicago. Chicago just wants its "fair share". DuPage County complains that under the Madigan plan, they will receive only 33% of the tax instead of 37%.

The trouble with the economics of force is that there is no "fair share". This problem is inherent in a system where politicians decide how to divide a finite amount of spoils. No one is ever happy with the result, and the pie that they cut from is an ever-shrinking one. This is the economy of the command system, a socialist system, the system that is bringing the communist world to its knees.

Compare that system with one that is consumer oriented. A consumer earns his own money through productive effort. He spends his money on goods and services that he chooses. When trading, both the buyer and seller benefit from the trade, or it wouldn't happen in the first place. The resultant economic pie is an ever-expanding one. This is the system that made America the envy of the world, a system which is now under attack by the cancerous growth of the economics of force, the economics of politicians like Thompson and Madigan.

"But," you say, "the state income tax increase will help fund education, a worthy cause indeed." Over the past twenty years, spending on public

education has gone up 351% adjusted for inflation. Virtually every one agrees that the quality of education has gone down. Forty-five per cent of the people in this country are functional illiterates. At the birth of this nation, the literacy rate was 92%, reading was a national past-time, and a public education system was nearly non-existent.

Throwing more money to the government education system is not the answer to encourage better quality education for our young people. That "solution" has been tried and has failed miserably.

It is high time to give choice a chance. We, as consumers, have a choice as to where we live, where we work, where we recreate. To the extent that choice is unencumbered by regulations and taxation, this system of choice works well. Why do politicians and apparently so many consumers themselves opt not to choose a system of choice when it comes to so important an issue as educating their children? Why do they choose instead the economics of the barbarian, fighting over the spoils of the latest kill from an overly hunted jungle where the supply of game is being depleted rapidly?

I believe part of the answer is that we have always done it this way. When things are going well, no one wants to rock the boat. But by not reacting to the storms of educational crises, our boat has become swamped. It is time to bail out.

Give choice a chance. What does choice in education mean? It means consumers choosing where their children go to school-- not burdened by paying double if the option is private (This especially benefits the poor-- the more well-heeled can afford to pay twice). It means the establishing of a wider variety of schools that are better equipped to meet the individual needs of individual students and parents. It means the elevation of good teachers and good schools, and the elimination of bad teachers and bad schools. It means that parasitic administrative and union bureaucrats will have to go out and try to find an honest job. It means the savings of millions if not billions of dollars which can be spent or invested by consumers in other areas to increase the quality of life. And it means saying "No" to the proposed state income tax increase.

Choice is the mode by which free men live. And it works. All I am saying, is give choice a chance...

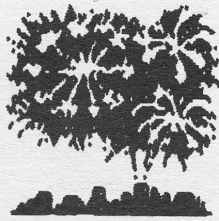

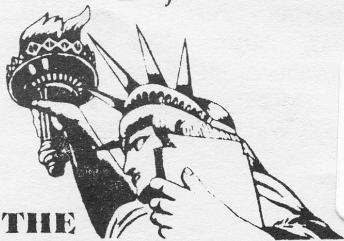
