Chair Andrew Kolstee called the meeting to order at 6:42 p.m.

Speaking of Candidates Seeking Endorsement:

Raven Mason Thompson (R): Running for Jamestown City Council Ward 2.

Will face Tony Dolce in June primary. Motivated by family tragedy, too many sirens, lack of opportunity for some residents. Choice and truth obstructed by laws. Against City Annex of Falconer Substation property. City Council needs to do more than just vote. Zoning infringement on individual rights. Goals: Better neighbors, respect rights of individuals and municipalities. Safety and Education. Focus on homes and families before downtown development.

Problems of Local Government: Intimidating, lacks transparency and accountability. Need to encourage more participation.

Dan Heitzenrater (R): Running for Ellicott Town Council (incumbent)

Interest in LP. Overlap of R and L values.

Played a role in reducing a proposed increase of town tax from \$0.20/k to \$0.05/k

Goal: Stay engaged with residents and other area leaders. Keep town on an efficient track.

Problems of Local Government: Members should look at local government as service versus a job. Too many "rubber stamps". Good people who are critical thinkers need to run for office and put the time in.

Dave Wilfong (R): Running for Mayor of Jamestown

Will face Andrew Liuzzo in June Primary. Currently serving as District 11 County Legislature

City is operating with a deficit and leans too hard on receipt of state funds.

Has worked as bipartisan at County Legislature

County has lowered taxes the last 5 years but overall increases are due to town budgets.

Discussion of cracking down on drug dealers in the city.

Some current council members lack leadership qualities and communication skills.

More involvement of council members in community relations.

Chris Schaffer (D): Running for District 3 County Legislature

Currently serving as Board Member for Town of Pomfret

Decided to step up and get involved in local government instead of complaining

Led town Zoning Law Reform. State designation as "clean community". Kept taxes under cap. Town

Board a mix of political parties. Voted for 1984 LP presidential candidate. Like the LP.

Problem of Local Government: Meetings are transparent but residents aren't engaged. Possibly intimidated by too many layers of government overall. Push harder for consolidation.

Rudy Mueller (D): Running for Busti Town Supervisor

Currently serving as Town Board Member. Former County Legislature

Voted to cut health insurance for County Legislatures.

Tried to prevent redistricting of county.

Voted against tax cap.

Would repeal pay increase for supervisor if elected.

Problems of Local Government: Transparency issues. Infighting between town and village. Need more consolidation of facilities and services. Herbicide conflict-> town steamrolled village.

## Kevin O'Connell (D): Running for District 6 County Legislature (incumbent)

Used the term "part-time politician". Encourages bi-partisan spirit at both town and county level.

All government needs to work toward shrinking the overall footprint of government through downsizing and consolidation.

Problems of Local Government: A big county in which the information flow at the county legislature level is good but breaks down at the town level. Lack of interest in local government. Negative overall perception of government.
