#### Insurance Co. Pays for Patients Pot



In one of the first instances of an insurer paying for losses of medical marijuana, 215NOW! Hero Robert DeArkland received a claim check in the amount of \$6,500 from Bostonbased CGU Insurance Company -- the letter from DeArkland's psychiatrist. maximum \$500 per plant allowable under the shrubbery clause of DeArk- DeArkland was charged with cultivatland's policy.

Law enforcement seized 13 marijuana plants from DeArkland's home in an October 1, 1998, raid along with grow lights, fertilizer, \$424 in cash, 1.5 grams of dried marijuana, and a

This week began very well. A co-worker announced he had changed his voter registration to Libertarian. A conservative Christian, Mick was more likely to tease me about my political beliefs then enter into serious discussion. We knew that we agreed that taxes were too high and that his Republican views did not match mine on personal freedoms.

Mick decided to re-register because the Republicans in office have disappointed him repeatedly. Rather than lower taxes as they promised, the Republican Congress has consistently voted to raise taxes. Mick and others like him are sending a message to the GOP that the average taxpaying Republican would rather switch parties than go on supporting liars and donothings.

The week ended on a sour note. A fax to my office outlined a piece of legislation just passed that restricted the right of certain retailers to determine their stores' inventory of nontaxable goods.

Assemblymen Floyd and Villaraigosa introduced a bill to restrict large retailers or mass merchandisers from carrying more than 10% of their inven-

ing marijuana and possession of marijuana for sale, but the charges were dropped due to insufficient evidence.

This June, when sheriff's deputies returned DeArkland's property and plants, he discovered that the plants were dead. DeArkland filed a claim of loss with CGU, who processed the claim after DeArkland proved he had received a physician's recommendation to grow the marijuana.

The only other similar known case occurred in Seattle, where earlier this year State Farm Insurance paid \$3,500 to a man who was arrested after he reported his medical marijuana stolen.

#### In a landmark ruling for medical marijuana

patients a federal appeals court ruled Monday 9/13 that medical marijuana centers may be allowed to distribute cannabis if they can prove that the drug is needed to protect patients against imminent medical harm.

In a 3-0 decision, the U.S. Court of Appeals for the 9th Circuit ordered U.S. District Court Judge Charles Breyer to review his October 1998 injunction, which shut the Oakland Cannabis Buyers' Cooperative (OCBC) for violating federal drug laws. Breyer's decision to shut the OCBC came at the request of the Clinton administration. The Appeals Court felt Breyer should not have granted the request without regard for the sick people served by the OCBC.

tories as food and drug items, all nontaxable goods. Both the State Senate and the Assembly passed the bill the second week of September. This bill covers new construction and is not retroactive. Organized labor and supermarket chains pushed this legislation. The arguments in favor of the bill included the nonsense that small grocers were being put out of business by the warehouse stores. These are the same small stores that use the mass merchandisers as distributors.

Our legislators believe they can violate our right to contract with whomever and under whatever terms we choose. The bill is really not surprising when we consider all the local restrictions on building and the business assessment districts which exist in each of the cities and both counties here in the East Bay. Also consider all that Congress and "big business" have done to restrict competition. But, it was shocking to read the quote attributed to Assemblyman Floyd (no relation to our past editor, Terry) in the Los Angels Times article: "...before these bastards (Costco) take over the whole country." Costco, which does not advertise, took out a full-page ad in most of the newspapers around the state. They are asking their customers to write to Governor Davis asking him to veto the bill when it reaches his desk. I am taking Costco's request one step further. I have cut up my Safeway card and I am returning it to their headquarters in Pleasanton with a letter of explanation. I am telling Safeway that I will not shop in their stores because of their support of restrictions on competition and free trade. I am explaining to them that it will cost me more to shop in the independent local grocery store but I will be spending all my grocery dollars there and at Costco's food department. I am copying the letter to Governor Davis, Assemblyman Floyd, Lucky's, the local union offices for grocery store clerks and to Costco. I am hopping mad and I am not going to take these restrictions on my freedoms any more. I hope you will join me in supporting local independent stores as well as the mass merchandisers.

This sort of legislation is most hurtful to the economy as a whole. The ripple effect cuts jobs and capital that keeps our economy strong. Speaking out on free market issues is a valuable part of the libertarian political agenda. Not only do we educate the public regarding the marketplace, but we show up the Republicans who only give lip service to the concept of free markets. Toward liberty,

# Volunteers rebuilding church at Waco compound site

WACO, Texas (AP) A **libertarian** talk show host and volunteers used shovels and pickaxes over the weekend to begin rebuilding a church at the site of the Branch Davidians' compound fire six years ago.

A fire during the 1993 government raid leveled the compound, killing leader David Koresh and about 80 followers. Austin talk show host Alex Jones, 25, said Sunday he wants to rebuild the church as a memorial and to increase publicity about the FBI's possible role in the fire.

"This is about saying the witch hunt of 1993 is over," Jones said as he and about 60 people who accompanied him to the fenced-off hillside began digging foundations for a 38-by-40 frame church.

The deadly fire April 19, 1993, ended a 51-day standoff between Koresh and the federal Bureau of Alcohol, Tobacco and Firearms and FBI.

Jones said he chose now to build a memorial and church because of a recent admission by the FBI that agents had fired potentially incendiary tear gas canisters at the compound the day it burned, despite years of statements to the contrary. Attorney General Janet Reno earlier this month appointed a special counsel to investigate.

Government officials maintain that Branch Davidians, and not federal agents, set the fatal fire.

A wrongful death suit filed against the government by relatives of those who died is scheduled to go to trial next month. "It's all about public opinion. We know that now is the perfect time, that's why we're doing it," Jones said.

The project is expected to take two to three months.

Koresh follower Clive Doyle, who survived the 1993 fire, said Sunday he has been leading 12 to 20 people in Bible studies near Waco and likely will lead services at the new church.

Koresh's stepfather, Roy Haldeman, 71, a retired carpenter who had lived at the compound, said that he felt good about the project. Stoically looking over the workers, he said the project's significance was "too deep" to explain.
