ILLINOIS ON THE BALLOT!

ONLY FOUR MORE STATES TO GO

After almost a year and countless hours of petitioning by dozens of volunteers, the Libertarian Party has finally won a spot on the November 4 ballot in Illinois. Illinois LP Secretary Dan Hansen and Green for Senate Coordinator Mike Hepple travelled to the State Board of Elections offices in Springfield August 4 to turn in the 15-inch, 1,894 page book containing about 37,000 signatures.

The petitions placed the names of Ed Clark, David Koch, Bruce Green, and U of I Trustee candidates William Mitchell, James McCawley and Richard Rasmussen on the ballot under the Libertarian Party label. Petitions filed separately that day also placed candidates for State Representative Jim Peron, Celeste Webb and William Hall on the ticket.

After the five-day challenge period had lapsed, a call to Cal Hudson of the State Board confirmed that the Libertarian Party candidates had been placed on the ballot.

In all Illinois counties with the exception of Cook, DuPage and Lake, the LP will appear third from last on the ballot,

ahead of the Citizens Party and Independent presidential candidate John Anderson. A lotter held earlier this year has already placed the Libertarian Party in first position on the ballot for both the Presidential and general party ballots. Lotteries will be conducted in upcoming weeks to determine ballot position in Cook and DuPage

According to Region 11 NatCom Representative Leslie Graves, as of August 23 only four states remain before the Libertarian Party will have attained ballot status in all fifty states. To date, the LP will appear on the ballots of all states with the exception of New York, Wyoming, Virginia and New Hampshire. Ballot status has also been won in the District of Columbia and Guam.

Graves reported that ballot drives in Virginia and New Hampshire were within a few hundred signatures of being completed, and that New York libertarians had begun their drive August 5 and would finish September 14.

Illinois LP Opens New Headquarters in Chicago

The Libertarian Party of Illinois has a new home in Chicago. On July 15 the new Libertarian Campaign Headquarters was opened in a storefront at 2577 North Lincoln on Chicago's North Side.

According to Dan Hansen who has been managing the office, the new location has generated a phenomenal volume of inquiries, some seven or eight times the number that came in weekly before the opening. "We've been getting in eight to twelve phone calls on an average day," Hansen said. "The Headquarters are located in an ideal area. There is a very youthful, independent character to the neighborhood, and there is a heavy flow of both pedestrian and auto traffic on Lincoln,

making us very visible. Both phones are kept in pretty constant use, and our literature display outside has been drawing a lot of attention."

There was a Grand Opening celebration at the office the evening of July 31 at which presidential candidate Ed Clark, as well as Senate candidate Bruce Green and 13th Dist. State Rep candidate Jim Peron spoke. headquarters was also the site of an interview with a reporter from the Lerner Booster newspaper and the subject of a WGN-Channel 9 news feature which resulted from a filming session at HQ August 21.

TOM VERKULES... SERAPPING WITH THE IRS

An interview by Dan Hansen

On Thursday, June 14, 1980, veteran libertarian activist Tom Verkuilen was convicted of failing to file Federal income tax returns, and was sentenced on July 23 to nine months imprisonment in the Chicago Metropolitan Corrections Center plus two years probation. Subsequent action by the Federal Deposit Insurance Corporation resulted in his dismissal from a position at the Sears Bank & Trust Co. and his being banned from employment in the banking industry until his sentence is completed.

On August 16 I interviewed Verkuilen for the ILLINOIS LIBERTARIAN.

DRH: What first caused you to consider refusing to file your income tax returns?

Verkuilen: I should clarify that, in my belief, I never refused to file an income tax return; I did file a return every year, on time, and answered every question, but with the word "none", or invoking the Fifth Amendment protection against self-incrimination, which the courts have said I can do.

DRH: What first made you decide to file in that unusual manner?

Verkuilen: Back in '74 when I returned from the Peace Corps, I began to investigate my rights as a taxpayer, and one of the things I learned is that a taxpayer has the protection of the Fifth Amendment if he wishes to claim it. If you look at the fine print at the bottom of Form 1040, it says that you swear under penalty of perjury that what you have said above is true. Once you have given that information to the IRS, and you are wrong, it can be used against you. Supreme Court has said that a taxpayer has the right against self-incrimination -- and other rights -- but they must be exercised at the time you file your Form 1040. So, I decided that if I wanted to assert all my rights, knowing how the IRS operates -- and it's been notorious for years for stomping on taxpayers -- I decided I should file that way right from the beginning. If you seek the Fifth Amendment protection later, it's too late.

DRH: But what was the key motivating factor that caused you to file in this manner?

Verkuilen: I can't name any one sudden revelation that told me "Quick, file a Fifth Amendment return." Like many libertarians, I've learned a lot from the experiences of the war in Vietnam, as far a foreign policy goes, and the experience of Watergate. The illegal uses of the IRS by the Nixon Administration -- the "hit list" -- to get political opponents is an example. Many people today are proud of being on that list, such as Jane Fonda and Paul Newman, to name two.

When I went into the Peace Corps, it was the weekend of the Watergate break-in, and I came back the week Nixon resigned, so I saw this whole process developing from over-seas.

DRH: What was your first contact with the IRS after filing the Fifth Amendment return?

Verkuilen: A few weeks after I filed my first return in this manner -- back in 1975 -- I received a form letter back from the IRS saying, in effect, "the return you filed is not in compliance with the law; a blank return is enclosed for your convenience; fill it out or else you will be suject to penalties." When I got that letter, I went back

and investigated the law again and decided that I was right, that this was just a form letter and did not address anything specific concerning my return. It was a very general type of letter that could have covered anything from a blank return to a mathematical error.

Aside from that letter, the first time I heard from the IRS was when I was called in in 1977 for an audit of my 1975 tax return. The investigation was conducted in a very sneaky manner. For example, the investigator would begin by shooting the breeze about the weather, and then would ask, "Are you trying to hide your income?" So I had to be on the ball about which questions I would answer, and would claim the Fifth Amendment protection at the appropriate times. Again, he would start talking about baseball or some such thing and then ask, "Well, how much money did you really make?" This went on for some time, and he finally went to see his supervisor who decided that there was nothing further they could do at that time. I was informed that I could be subject to

civil as well as criminal penalties, but I decided that he was just bluffing and stood

my ground.

Then when the interview was finally over and we were, I thought, just talking casually he dropped the question, "Are you a libertarian?" The question caught me completely off quard, and I said "Yes."

DRH: What do you think caused the IRS to single you out for this kind of treatment, considering that they go after relatively few people who do not report their full incomes?

Verkuilen: I think in the IRS view, I was waving a red flag in their faces. They can't accept, it seems, valid constitutional objections -- not necessarily to the income tax -- merely to the raising of the Fifth Amendment. If you talk to any attorney or CPA who has dealt with the IRS, they will say, "The courts say, "A, B, and C," and the IRS begs to differ." It will continue to maintain its position and bluff taxpayers with that.

DRH: What do you think caused the IRS to go beyond the audit and actually decide to prosecute you?

Verkuilen: The one year I was audited for, the '75 return, never resulted in prosecution; I was prosecuted for the '76 and '77 returns which were sent in in the same way. In 1978 I was sent a Notice of Deficiency and given 90 days to file a petition in Tax Court regarding the '75 return, but that case is still pending and hasn't even come to a hearing yet. The strange thing about this is that in the Notice of Deficiency, the IRS claimed that I owed them \$707, but the calculations on their own work sheet showed that they owed me a refund of \$15 to \$20. So their motives for going after me were somewhat obscure, and while "harassment" may be too strong a word, they were certainly wasting their time and mine. If they owed me a refund, why not just sent it to me?

The first time I heard that I had been charged -- by Prosecutor's Information -- was April 7, 1980. I had taken Friday, April 4th off and gone camping with my brother. When I came back to work on Monday, my boss said, "Did you know your name was in the paper Friday? You were indicted by the IRS." So it was actually in the papers three or four days before I even heard about it. And there were people who thought I had taken off for Bermuda to play golf with Robert Vesco. It wasn't until a few days later that I got a notice in the mail to appear in court for the arraignment.

This whole process was very interesting because according to an IRS manual on handling so-called "tax protesters," it is urged that the subject of investigation be given an interview with the District Counsel of the IRS before they recommend prosecution. It's, in a sense, a warning to the individual to give him a last chance to change his mind. I never had such an interview.

DRH: Any other interesting anecdotes that came out of this experience?

Verkuilen: Once when I was in the shower, the door buzzer sounded. Not about to have my shower interrupted, I ignored it, expecting whoever it was to come back later. A few minutes later as I was getting out of the shower, there was a loud banging on the door. I put on my bath robe and opened the door to find two IRS agents standing there. This was about 8:30 in the evening. Again, I'd had no warning; they hadn't even had the courtesy to call to see if I'd be in. I let them cool their heels in the hall for a few minutes while I got dressed, and then let them in. They read me a statement similar to the Miranda warning advising me of my right against self-incrimination, which made me wish later that I'd asked the question: "Just when did I get this right? Was it at the time of the investigation or when I filed my return?"

They told me that I was the subject of a criminal investigation for failure to file, at which point I interjected that I had filed. They told me, "Well, we don't consider it a filing." When I offered to show them the legal information I had, they turned it down, saying that they were only there to give me a warning.

DRH: What opinion did the people you worked with and for have of you and your activities?

Verkuilen: Both my superiors who knew me, and the employees who worked for me may have found it difficult to understand why I was doing what I was, but they certainly knew that I was no crook; I had worked with them for years and there was no question about my honesty. They are still my friends, and I am grateful to them for standing by me, both before and after the trial.

DRH: An article which was published in the Chicago Sun-Times on June 15, shortly after you were convicted, noted that "[e]vidence revealed Verkuilen is a member of the Libertarian Party, which supports the view that taxation is theft by the government." Did that come from the defense or the prosecution, and what part did it play in the trial?

Verkuilen: That was very nicely put in the newspaper; it sounded like: "Aha! We've discovered the truth about this guy!" The evidence was actually introduced by our side to support our belief that one of the reasons the IRS came after me was that I was a Libertarian. We attempted to show that selective prosecution had taken place by doing a statistical demonstration that of 700,000 people a year that the IRS knows of -- by name, address and social security number -- who have failed to file, only about 7,000 failure to file prosecutions are filed, so right there the odds are a thousand to one. It's even more unusual for them to prosecute someone for failure to file who $\underline{\hat{h}as}$ sent in a return. At least I was making a good faith effort to comply with the law, as the courts had said I could. So the evidence we introduced was that they had selected me out for prosecution, possibly because of my political views.

Q. What is the point of all this work? A. Simple. It's working.

That's right, it is working. For those who petitioned, didn't you notice that more people had at least heard of us? Some were even excited about signing! Quite unlike 1976 or even 1978, wasn't it? To those who staffed fair booths in the dismal July weather, was it just your imagination that people were actually interested in us? To headqaurters staffers, did you know that we now get more phone calls in one day than we received all month in 1978?

None of this is because of our imaginations. Here are a few "notes" which, considered sperate from each other seem to be of little or limited importance. But, when you put them together, the pattern of progress is clear.

Take the Green campaign, for example, I've been involved in both the 1978 and 1980 campaigns. It has three times the number of donors it did in 1978. (It is still broke, of course, but with three times as much potential support.) Bruce just completed a three day swing through downstate's major cities. In 1978, coverage of his talks and news conferences was good by libertarian standards. Only a few people turned down requests for interviews and at least one reporter covered news conferences. Only a few interviwers treated us as "novelties." This time, there was television coverage of each of three news conferences, plus radio and print coverage. No one turned down an interview and all interviews were issueoriented, not "aren't these cute people" personality pieces.

Even the League of Women Voters is starting to take us seriously, along with organizations like the Independent Vpters of Illinois. Bruce will be addressing the League at a candidate luncheon on October 22. The I.V.I. invited him to speak at their endorgement session. Despite the general liberal approach of the group, he was listened to attentively and asked serious questions about issues. They unanimously rated him as candid, credible and qualified for the office. (They didn't endorse him, but rate each candidate on these points by voice vote.)

Bill Mitchell was also invited to appear before I.V.I. a few weeks ago. Although he didn't get their endorsement, once again he was treated respectfully and taken seriously. The fact that he was asked indicates a new awareness on the part of political groups throughout the state.

Another news outlet, the Lerner Booster, solicited an interview from Jim Peron and Dan Hansen about Jim's race. The story, which appeared August 23 in the Sunday edition, ran 25 column inches with a four inch photo. Treatment again was serious because the paper realizes that Jim might just win or at least hold the margin between the other candidates.

Take a look at the national scene. Ed Clark appeared, alone, on Issues and Answers. For those of you who remember the 1976 race, Roger MacBride was included with Lyndon LaRouche and several other "fringe" candidates in what appeared to be a three ring circus. Clark will probably appear on Meet the Press, the three ring circus in 1976, alone. This, despite the equal time provision imposed by the F.C.C. which deters coverage of "minor" parties. The stations are willing to take the risk, because viewers are interested in Clark's campaign. He is newsworthy.

Another important note: WGN, in their local story, interviewed people randomly in front of the Water Tower in Chicago. They were shocked that most people had heard of the Libertarian Party and/or Ed Clark, probably due to the television ads the Clark campaign has been running. They knew who we are, that we exist, but haven't formed an opinion of us yet.

The next step is to form a positive impression of the ideas we hold. This applies to both ourselves and to the general public. Our candidates more than ever are stressing the positive side of freedom, showing that it puts money back in people's pockets and frees up legal constraints on their lifestyles and keeps us out of war. Yes, we are against many things, but we must stress the positive solutions we have to offer and not dwell on how government has hurt us. People support causes they believe in, they vote for things, not against them. They want solutions, not mere complaining.

And we must be positive in our thinking about the LP. It isn't a closet organization of people who have revolted against goverment with little chance of victory. It is a growing group of individulas committed to realistic, practical solutions based on maximum individual rights.

And it's working.

was it that caused that agency to get involved?

Verkuilen: I had told the bank that I didn't want to cause them any embarrassment and that if they wanted me to resign, I would. They took that under advisement, but once the storm blew over, I went right on working. had been working there for five years, and in spite of what they may have regarded as a mistake or an unduly extreme position on my part, they did not dismiss me. But they wanted to clarify the situation to make sure that they did not have to dismiss me, so they went to the Federal Deposit Insurance Corporporation for an answer. The FDIC told them, broadly interpreting a regulation concerning dishonesty, theft, and self-dealing, that they had to dismiss me. Again, this regulation covers dishonesty and theft, not failure to file an income tax return.

DRH: You were sentenced on July 23 to nine months in prison plus two years probation. Do you consider that stiff or lenient?

Verkuilen: Let me answer that question comparatively with other sentences I've seen over the past few months. At the time my indictment was printed in the newspaper, a number of other people were indicted at the same time. One of these people received one year's probation; this woman had not filed any returns at all for five years, allegedly owed the government \$19,000, and yet the judge apologized to her for the fact that the IRS had sought criminal failure to file penalties instead of simply bringing a civil suit to seek the money owed. In fact, the judge said that if he'd had more courage, he would have reversed her guilty plea. Also, Attorney General Scott, who was charged with tax evasion, a felony (I was charged with a misdemeanor), received a sentence of a year and a day. According to Federal parole standards, a sentence of longer than a year is eligible for parole after one-third of the sentence has been served, in Scott's case, four months. The same standards are not applied to sentences of under a year; there would be no possibility of parole in my case. So Scott could be out in four months, while I would have to stay in for nine. This is a high elected public official. So in that light, nine months did seem unduly harsh.

We had asked for probation, and failing that, for work-release. In fact, the probation officer who had done the pre-sentence investigation had been in favor of a period

of work-release.

To elaborate upon the libertarian philosophy in court, we called Paul Stout as a witness. Paul is a long-time, veteran libertarian who ran for Congress in, I believe, 1972. This was where the mention of the Libertarian Party's opposition to taxation in the SunTimes came from.

DRH: Why do you think the jury convicted you? Verkuilen: It was interesting as the trial went along that it began to look like a 15round bout where at times we were winning, and at times the opposition was winning. But the clincher seemingly came when the judge instructed the jury on how they were to reach their verdict. When that point of the trial arrived, the judge threw his own instruction -- not proposed by the prosecution, and certainly not by the defense -- which said that if I had legitimate income, I had to declare it and could not take the Fifth, but if I had any illegitimate income I could. And since the prosecution had introduced evidence that I had legitimate income from my employment at Sears Bank -- which we didn't deny -the jury virtually had to convict me.

DRH: Apparently even after you were convicted, the Sears Bank where you worked decided that you were a good employee and decided that they would keep you on, and it wasn't until the FDIC stepped in that you lost your job. What CONTINUED NEXT MONTH.....


