Chairman's Report

As per our Bylaws Article II, Section 1, the duties of the Chairman are as follows:

The Chair shall be the Chief Executive Officer of the Party, holding the powers of administration pertaining to the ordinary business affairs of the Party and such other powers as may be delegated by the Board of Directors, as well as overseeing leadership training and succession planning at all levels within the Party. Unless otherwise specified in the Party's Bylaws, Special Rules of Order, or resolutions of the Board, the Chair is responsible for appointing the chairs of all committees. The Chair shall call the Convention as specified in the Party Constitution. The Chair, or their designee, including other Board members acting within their designated job duties at the direction of the Chair, shall be the person who shall communicate on behalf of the Party.

I was elected chairman in April of 2019 and as chairman I've tried to do my best representing the values of the libertarian party of Colorado, protecting members rights and the principles of the parties constitution and statement of principles. I have always believed that the spirit of the law rather than the letter of the law is what is important.

Between 2019 and 2020 we have had some turnover in the party leadership, but I am pleased to say that we have had a full board for most of the time I've been chairman. Some left for personal reasons, some were asked to resign because of violations or to allow for someone else to take over the position when they couldn't fulfill the duties required do to work or family responsibilities.

2020 has been an "interesting" year to say the least.

We had the governor issue draconian orders that changed the way we do business, those orders were supposed to be temporary, but, several months later we are still subject to unconstitutional mandates and restrictions on our rights to assemble and on our right to redress of grievances.

During my tenure thus far, I have visited every affiliate in the state and I have worked closely with Steve Galant on helping development groups get started. Denver County and Jefferson county development groups became full-on affiliates. Chaffee, and Elbert county started development groups and have strong leaders, who, in spite of the measurements by the government, continue to organize.

We had an online convention in April where we elected our candidates and placed nearly 60 candidates on the ballot. We had a contested senate race that ended up in a primary. It's good to have contested races as it shows me that people are willing to participate. We also elected our delegates to national convention. We had a full delegation in Orlando and we made history.

I started a petition to the governor to stop infringing on our rights and to let people decide for themselves as to what is best for themselves. I testified in favor of repealing the red flags bill.

I would like to thank the people who have stepped up to help get the eballot working and who have recruited candidates. If I missed any names it was not done on purpose.

Assist the Chairman. Since assuming office of Vice Chair in April 2019, have attended several county monthly meetings across metro corridor, concluded work with the Style Committee on current bylaws, actively recruited and personally met with candidates/potential candidates for partisan elections in 2020, participated in several phone banking, fundraising, and newsletter preparation events, and attended several Libertarian National Committee (LNC) related events including the Frontier Summit, LNC Quarterly Meeting in Sparks, Nevada, trainings on using the virtual convention set up, and as national convention delegate to the 2020 National Convention.

Continuity Binders. Binders were completed by all officers by February of 2020.

Organization of Regions. Prior to COVID-19 Pandemic related restrictions on public gatherings, new interest in forming affiliates began in Adams, Weld, and Elbert counties. Elbert county began their initial meetings, with established Affiliates expressing interest in reaching out to neighboring counties that did not yet have their own affiliates.

Treasurer, 24 August 2020

As per our Bylaws Article II, Section 9, the duties of the Treasurer are as follows:

The Treasurer shall be responsible for maintaining accurate records of all income and expenses associated with the operation of the Party and shall present a summary of all income and expenses incurred at the regular meeting of the Board. The income and expense summary may be limited to activity since the last regular meeting of the Board. The Treasurer shall also prepare budgets for the other board members or assist them in preparing their own budgets.

As of 24 August 2020, PayPal balance was \$166.58.

As of 24 August 2020, BBVA balance was \$29,196.70.

As of 24 August 2020, Stripe balance was \$424.29

As of 24 August 2020, FEC account balance was \$110.00

As of 24 August 2020, AVAILABLE FUNDS (reserved funds excluded) was \$17,800.28.

Available funds have increased \$4612.92 since last annual report.

Any anticipated large future expenses (> \$1,000 annually), whether one-time or instalment, I propose to budget in the same manner as with NationBuilder, where I reserve funds monthly into a specific sub-account. For clarity for me and subsequent treasurers, the standard reserve of \$1,500 has been placed in a sub-account. Starting April 2018 state convention funding is being reserved on a monthly basis.

2020 annual subscription donations to PayPal, Stripe & Compass Bank: \$3882.08, a decrease of \$2,169.32.

2020 state un-convention registrations: \$6,560.00. Note that these are new donations and do not include the previously donated registrations from our canceled convention in Glenwood Springs that have been credited toward attendance at the un-convention.

I request that any Board member who receives cash or check from a donor please email me with the date received, check number, amount, and name & address of the donor. If the check is \$100 or more, then I also need the donor's occupation and employer. Please refer to the postscript in Treasurer's Report July 2016 for a list of TRACER-accepted occupation names. We can't accept cash donations over \$100. We can't accept contributions from corporations or from foreign nationals. The party can accept anonymous donations less than \$20 but if anonymous donations are collected by someone not authorized to accept funds for LPCO (not a board member) then that someone is considered a conduit and the collected aggregate is counted against their personal contribution limit and the funds conveyed to LPCO can't include more than \$100 in cash.

Campaigns Director Annual Report – 2020

DUTIES AND POWERS BY Art II Sec 4 “The Campaigns Director shall identify political races and coordinate candidate and issue development. The Campaigns Director shall be responsible for, and coordinate, all political campaigns of the Party.”

Campaigns is a principal reason for the existence of the Libertarian Party. LP Colorado needs qualified candidates to maximize liberty and minimize government interference into our daily lives. If you know of qualified individuals that might be willing to run for and serve in public office please introduce them to someone on the Campaigns team so that we can help get them lined up for a run for office.

Even with the challenges of COVID-19, the Libertarian Party of Colorado nominated approximately 56 candidates to federal, state, and local races. The most recent candidacies include two individuals who successfully gained ballot access by petition signature.

The focus of Campaigns through November will be to assist the candidates who have made it onto the November ballot. This includes the August 2020 candidate training sessions, connecting candidates with media, assistance with media surveys and websites.

After November, Campaigns will pivot onto recruiting qualified candidates for 2022 federal, state, and local campaigns. At the same time Campaigns will begin working on infrastructure for the 2022 campaign season.

Legislative Director Town Hall Report

The Legislative Director shall be responsible for monitoring activity in the State Legislature, communicating with that body, developing legislation or issue-oriented committees (including the appointment of any committee chairs), and working with other organizations on areas of mutual concern.

The previous Legislative Director, Michael Stapelton, did an admirable job engaging the Colorado Legislature over the last year, reviewing bills, speaking in Committees and advocating for Libertarian Principles through the chaotic legislative session. Unfortunately, Mr. Stapelton resigned in July of this year.

A new Legislative Director and former Gubernatorial candidate, Matthew Hess, was appointed at the July board meeting.

Guidance on current ballot measures for the general election have been posted in the Facebook group and will be updated if new measures are added to the ballot.

Five tools for managing legislative bills, committee hearings, votes, legislative scoring, and a team of reviewers were examined and one was selected based on the ability to meet the full scope of needs of the legislative director and the cost of the tools available. The annual cost was proposed to the board and passed.

The Legislative Director has drafted and proposed a resolution for the LNC to adopt opposing the National Vote Compact.

The Legislative Director is now involved in the process for helping to form the Colorado Blue Book and has begun providing information and feedback to the Colorado Legislative Council.

The direction forward is to create a legislative review team capable of reviewing legislation and scoring based on Libertarian Principles as well as coordinating testifying in committees on bills and providing activist information for personal engagement.

Libertarian Party of Colorado Un-Convention 2020

INTRODUCTION

Hello Libertarian Party of Colorado, my name is Joshua Lallement, I have been the Communications Director since April/May. I think I have met most of LPCO members but for those who don't know me. I have been a member of the party and steadily becoming more involved since February of 2016. I am also the communications director for Arapahoe County.

GOALS

1. **Maximize Social Media:** LNC Secretary Caryn Ann Harlos graciously did a social media training on Saturday Aug. 15 with a lot of great practices that my volunteers Mason J. I also set-up a Facebook messenger group of all the administrators, editors and moderators to better coordinate and know who's on the page and I am now recruiting a volunteer to help out with Instagram and possibly twitter which I have been able to start being active on the last two weeks.
2. **Regular Press Releases:** Work on putting out regular pieces out to the press especially the local papers, tv and shows. To that end making sure our media contact list is up to date especially with the denverpost that has a big turn over.
3. **Engage Members:** To help get to the ends of goals one and two, I want to welcome all members of the Libertarian Party of Colorado to help. If you have any thoughts and or ideas on press releases, stories that need attention and memo's for social media. I encourage you to send them. Unconvention

We have about 72,000 records – 35,000 registered libertarians and 37,000 contacts including former libertarians we've gotten from other sources like outreach booths. The latest update includes the ability to email any number of selected records. It was limited to 50 or the entire list.
