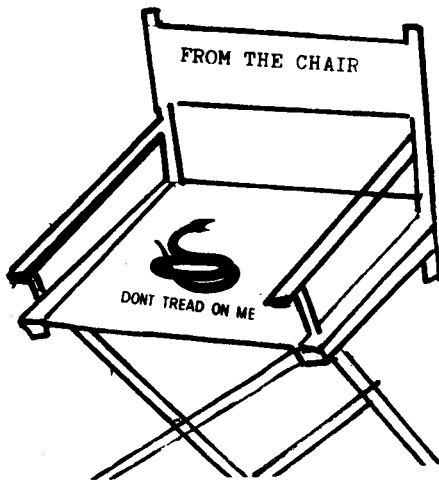

Another important item (for those who are not life or life sustaining members), to be voted upon is a proposal to: 1. change from a 12 month membership to a calendar year membership prorated by quarters for new and existing members. 2. Increase the annual dues for all categories of membership as follows:

CHILDREN'S RIGHTS

Children, as human beings, possess human rights. But as immature human beings, who by nature are incapable of functioning with the full responsibility and autonomy of adults, children possess rights to liberty which are less complete than those of adults. However, the rights children should possess include:

1. The right to place the burden of proof on whomever seeks to restrict the child's liberty in any legal determination of the child's right to assume partial or full responsibility for his actions.
2. The right to petition for recognition of adult status upon satisfaction of objective criteria evolved under common law.
3. The right to the full protection of the law against physical abuse.
4. The right to own and dispose of property which they have earned or which has been given to them.

Further rights associated with children include:

1. The right of parents to legally establish that their child is an adult and that their legal obligations to that child should be terminated.
2. Concerned adults should have the right to sue parents on behalf of the child for clear negligence and abuse of parental obligation or to petition for a change of legal guardianship.

ABORTION

We recognize the rights of all individuals to decide for themselves their own goals and activities—to exercise sole dominion over their own lives. We, therefore, oppose any regulations pertaining to birth control and sterilization. However, any separation of mother and fetus must presume the fetus' right to life. We advocate legalization of all procedures where the fetus has a reasonable chance of survival with due care being given to assure it, and such procedures should be construed as the birth of a child rather than the abortion of a fetus. In such cases, all laws relating to parent-child relationships should apply. At present, induction of labor, for example, might be reasonably safe for a fetus of seven months development. As technology improves, the "age" of a fetus where it would be reasonably safe to undergo a separation procedure would decrease to as early an "age" as the mother would wish to have such a procedure. Therefore, there is no conflict between the rights of the mother to control her own body and the rights of the unborn fetus.

FREEDOM WORKS

DISCRIMINATION:

No individual's rights should be denied or abridged by the laws of the United States or of any State or locality on account of sex, race, color, creed, age, national origin, marital status, or sexual preference. We condemn bigotry as irrational and repugnant. Nonetheless, we oppose any governmental attempts to regulate private discrimination, including discrimination in employment, housing, and the use of privately-owned "public" accommodations. The right to trade includes the right not to trade for any reason whatsoever.

DOMESTIC POLICY

Since each person has the right to offer his goods and services to others on the free market, and government interference can only harm such free activity, we oppose all intervention by government into the area of economics. The only proper role of government in the economic realm is to protect property rights, adjudicate contractual disputes, and provide a legal framework in which voluntary trade is not restricted. All efforts by government—local, state, or national—to redistribute wealth or to control or manage trade are inconsistent with a free society.

MONEY

We call for the repeal of all legal tender laws and reaffirm the right to private ownership of, and contracts for, gold. We favor the abolition of government fiat money and compulsory governmental units of account. We favor the use of a free market commodity standard, such as gold coins denominated by units of weight.

WELFARE

Government welfare programs violate individual rights since money or other property is coercively taken from some to give to others. The need of one person is not a claim on another, and we therefore urge an end to government welfare programs. Without the present, oppressive burdens of taxation, we believe that human benevolence would be adequate to meet the needs of those who cannot support themselves. We also believe that ending government interference in the economy would greatly decrease poverty and the need for welfare. Therefore we advocate:

1. An end to participation by the State of New Jersey in the food stamp program.
2. The gradual reduction and eventual end to New Jersey programs of aid to families with dependent children, aid to the blind, aid to the aged, and aid to the disabled.
3. The gradual institution of user fees for all medical programs, state hospitals, and other state-provided health services—such as Medicaid—until such programs are eliminated.
4. An end to tax-funded job training, re-training, and manpower development programs.
5. An end to tax-supported day care centers.

GOVERNMENT-MONOPOLIES

Government-operated or supported monopolies, such as the Postal Service abridge individual rights to free trade and should be abolished. We call for repeal of all laws which establish or support monopolies. As an interim measure, we call for immediate repeal of all laws which prohibit competition with government monopolies. As private business assumes the functions now provided so ineffectively by government, federal business holdings would be turned over to the private sector to reduce government debt or be otherwise used to yield the highest dollar return.

LICENSING LAWS

We advocate the repeal of all compulsory licensing laws, whether for the purpose of raising revenue or for the purpose of controlling any profession, trade, or other activity. No individual should be legally penalized for not possessing certification, and no consumer should be legally restrained from hiring non-certified individuals. "Certification of Competency" can only be provided by the free market, possibly in the form of adherence to voluntary professional standards or bonding by those organizations or individuals who would accept financial responsibility for the actions of the party; eg. malpractice insurance companies, who, in their own best interest, would determine the competency of a particular physician before certification, bonding, or insuring that physician.

CONSUMER PROTECTION

We advocate the use of civil litigation to combat product mislabeling, false advertising, and default of contract. The right to produce, purchase, and sell products and services must not be restricted by law, and indeed such restrictions are unnecessary. It should not be forgotten that, in a free market situation, consumers would be further protected because:

- *A good name is an asset to a business, and it can best be maintained by fair and honest dealing.
- *The use of certificates, guarantees and warranties issued by manufactureres and suppliers of goods and services are a protection to the consumer.
- *Both professional and nonprofessional people can voluntarily form associations for the specific purpose of maintaining high standards both in work and behavior.
- *Privately owned consumer protection organizations producing journals and magazines to advise consumers would proliferate in a free market.

Therefore, we endorse and advocate:

1. The elimination of all government consumer affairs bureaus or departments.
2. The repeal of all laws regulating the production, transportation, sale possession, advertising, quality, safety, or use of any product or service.
3. The repeal of all laws and regulations establishing quality standards for any product or service.

POLLUTION

The pollution of air and water violates the rights of individuals to their lives and property. Physical harm to health or property by pollution is as real as harm due to assault or theft and must be dealt with through objective legal property rights to air and water. Current government measures concerned with pollution often bypass court proceedings without concern for restitution to the victims of pollution or the rights of the accused polluters. Governments themselves being major contributors to pollution, they should be legally responsible for their waste products.

We call for the abolition of the Environmental Protection Agency and the return of all questions of violations of the rights to life and property to the jurisdiction of the civil courts.

EMPLOYMENT

We recognize the right of individuals to seek employment and of employers to voluntarily employ anyone of their own choosing so long as they do not forcibly interfere with the rights of others. Therefore, we support the repeal of all laws which impede the ability of a person to find employment such as minimum wage laws, so-called protective legislation for women and children, equal opportunity legislation, and restrictions on private day care centers. We call for the repeal of all laws requiring government licensing, including, but not limited to, doctors, lawyers, teachers, and tradesmen.

UNIONS AND COLLECTIVE BARGAINING

We support the right of individuals to voluntarily establish, associate in, or not associate in labor unions. An employer has the right to recognize, or refuse to recognize, a union as the collective bargaining agent of some or all of his employers. Therefore, we oppose all right to work laws, since this they prohibit employers from making certain contracts with unions. Notwithstanding this right, an employer and an employee are bound by prior contractual agreements.

Government should not prohibit unions from organizing secondary boycotts or engaging in any other activity if in so doing they do not violate individual rights or existing contractual agreements. We oppose government interference in contract negotiations, such as compulsory arbitration or imposing an obligation to negotiate. We call for the repeal of all laws and regulations interfering with employer-employee relationships such as: the Wagner Act, the Taft-Hartley Act, and the Occupational Safety and Health act.

ENERGY

In energy, as in so many areas, government is the problem. It regulates and restricts production, distribution, and sale; calls for special record keeping and information reporting, files and threatens to file law suits for antitrust and environmental actions, and heavily taxes the profits of energy suppliers, all of which greatly increase the costs and therefore increases the prices necessary to bring an adequate return on investment. Government artificially holds down the selling price which increases the consumer demand for energy and decreases the supply by making marginal ventures unattractive. Government tampering in the field of energy must end. We advocate:

1. An end to all government control of energy pricing, allocation, and production such as that imposed by the Federal Power Commission, the Federal Energy Administration, and the New Jersey Public Utilities Commission, thereby to protect the rights of buyers and sellers to trade voluntarily among themselves.
2. Immediate decontrol of the prices of oil, petroleum products, and natural gas.
3. An end to government subsidies for energy research, development, and operation, and abolition of the federal Energy Resources and Development Administration.
4. Repeal of the federal "Price-Anderson Act" which limits liability for nuclear accidents.
5. Privatization of the atomic energy industry and the sale, lease, or use to return the highest dollar amount of all government-owned energy production facilities such as: coal fields the Naval oil resources, offshore oil drilling sites, shale-oil deposits, and geothermal sources.
6. Repeal of the "Emergency Energy Fair Practices Act of 1974" which controls the distribution and sale of energy and fuel in emergencies.

We oppose:

1. All proposed restriction in the field of energy such as: S680 (which would provide for allocation of natural and synthetic gas), S22 (which would prohibit construction of off-shore oil port apparatus and attendant pipeline and storage facilities), and S1494- the Nuclear Reassessment Act (which would impose a moratorium on the new construction of nuclear fission power plants for 4 years).
2. Establishment of any new energy regulatory bodies through proposed laws such as: S495- the "Department of Energy Act," A1525- the Energy Facilities Planning Act of 1974 and A1296- the "Power Authority Act."
3. Government imposed rationing or prorating of energy products.
4. Speed limits imposed for the purpose of increasing mileage per gallon of fuel.
5. Tariffs, quotas, and excise taxes on imported and domestic fuels and automobiles.
6. Proposals of government to force breakup of oil companies.

TRANSPORTATION

Individual and mass transit and freight transportation have become major problem areas which are properly solvable only through voluntary action in the free market. Government interference has been characterized by monopolistic restriction and gross inefficiency. We advocate:

1. Immediate repeal of all laws restricting transit competition such as those granting taxicab and bus monopolies and those prohibiting private jitney services.
2. An immediate end to tax financing of mass transit projects.
3. An end to government regulation of private transit organizations and the prohibition of government favors to them such as subsidies and access to powers of eminent domain.
4. "Best economic use" of public road, airport, bridge, tunnel, and waterway systems either through sale, lease, or use to return the highest dollar amount.
5. Termination of Amtrak/Conrail and the return of America's railroad system to private ownership without government regulations or subsidies.
6. Dissolution of government agencies concerned with transit such as the Interstate Commerce Commission, the Federal Aviation Administration, and the Civil Aeronautics Board.
7. Deregulation of the trucking industry and elimination of fee schedules.

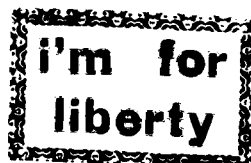
We oppose:

1. legislation which requires special equipment such as: seat belt laws, proposed air-bag laws, S268-which would require all cars made after Jan. 1, 1978 to have a rear window defogger or defroster, and A264-which would require every motor vehicle to be equipped with a hand operated fire extinguisher and portable warning devices.
2. Interference by the government in the field of transportation such as: A992 which would prohibit competition with subsidized motor bus operations A1388-which would authorize the State to acquire all bus carriers in the state. A2066- the "Bulk Commodities Transportation Act," and laws requiring motorcycle riders to wear helmets.

SUBSIDIES, TARIFFS, AND QUOTAS

In order to achieve a free economy in which government victimizes no one for the benefit of anyone else, we oppose all government subsidies. Relief from taxation should not be considered a subsidy.

Like subsidies, tariffs and quotas serve to give special treatment to favored interests at the expense of other individuals. We, therefore, support abolition of all tariffs and quotas as well as the Tariff Commission and the Customs Court.



CONSERVATION

The desire to conserve natural resources is not a valid excuse for the violations of individual rights, and we therefore oppose such violations. We believe that property owners may do with their property as they please. We oppose tax-supported conservation; conservatin should be the choice of the owners of the property. We advocate:

1. That methods be devised for the gradual transference to private ownership of all currently unowned property including waterways and airspace.
2. That conservationists buy areas or resources they wish to conserve.
3. That all laws relating to the conservation, regulation, and control of the use, development, sale, or production of resources (eg. land, minerals, and woodlands) be repealed.

FREE TRAVEL AND "ILLEGAL ALIENS"

We hold that rights are possessed by all human beings and not merely those who are recognized as citizens of a particular country. Although private property owners have the right to restrict others from trespassing on their property, government restrictions on the liberty of travel, residence, and employment such as immigration of human rights, and we call for their immediate abolition. We hold that all harassment of so-called "illegal aliens" by government should cease. We defend their rights to seek work, trade, and live within this country, just as we defend these rights when possessed by citizens.

AMNESTY AND PARDON

We advocate the unconditional exoneration of any individual lawfully convicted or accused of a "crime" that did not, in fact, constitute a violation of individual rights. As individual rights are restored by the repeal of current laws, persons convicted under such laws should be immediately pardoned.

BILL GEORGE DOES IT AGAIN.

The response to the cocktail party in honor of our Gubernatorial candidate, Dr. Frank Primich was fantastic in view of the fact that most of those who attended had less than a week's notice.

Bill George who got another party off the ground for us is to be commended. The crowd overflowing the cocktail lounge enjoyed the opportunity to rally informally amongst fellow Libertarians and guests.

At the end of the evening, when saying our good bys, Dr. Primich said, "thanks, its nice to know I'm not alone."

Keep it up gang and let Frank know that he can count on our support for the duration of his campaign.

Higher Taxes Feed Inflation

Whether there is a genuine taxpayers' revolt sweeping the land is open to debate, but there is no question that taxes are receiving much more attention than has been the case for many years.

Probably one of the greatest existing myths — resurrected periodically to bedevil the taxpayer — is the idea that government can control inflation by boosting taxes.

By taking money out of the hands of the consumer and the businessman, so the theory goes, the total money supply is lessened and the upward thrust on prices is reduced. That is true only if

the money taken out of circulation is not spent. It doesn't take much of a student of government to know the bureaucrats are very good at spending every tax dollar collected — and then some.

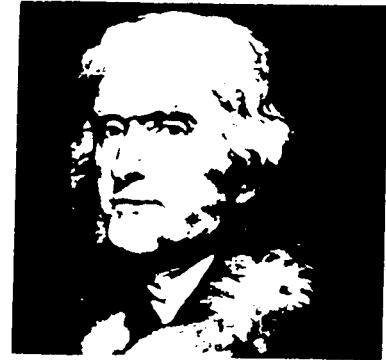
What is more, the spender of tax monies more often than not doesn't get full value for his dollar, as the individual who works for his money at least tries to do. So, instead of decreasing inflationary pressures, the taxing mechanism frequently becomes a device for feeding the fires of inflation.

This is one myth the tax earners are beginning to see through, even if the spenders are not.

GOP Gets Top Row

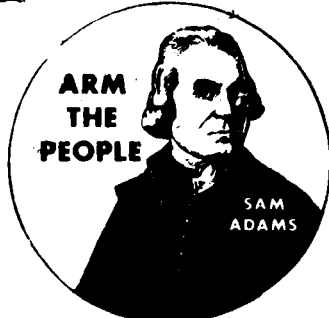

LEGALIZE FREEDOM

Primich Wins Support

EDITOR, PRESS: I am going to vote for Libertarian party candidate Frank Primich for governor.

I feel that Byrne and Bateman are philosophically identical candidates who differ only in personality and technique. Just look at the most important campaign issue this year, the question of state taxes and spending.

Byrne stands for big government and the unpopular income tax. Bateman, formerly an income tax supporter himself, now pushes for a 20 per cent increase in the state sales tax. (Figure it out for yourself — an increase in the sales tax from 5 cents to 6 cents on the dollar is a 20 per cent jump.) What is even worse, Bateman hasn't come up with a single legitimate proposal for cutting state spending.

On the other side, there is Primich. Primich calls for repeal of the state income tax, and massive cuts in state spending. The Libertarian candidate wants to abolish state regulatory agencies, and return government provided "services" to the free market. He also advocates the repeal of all victimless crime laws. In other words, Primich wants to shrink the size and power of the state government.

The Libertarian party, now the third largest political party in New Jersey, will be running 30 candidates for office statewide this year. I encourage everyone to support Dr. Primich and the other Libertarians.

LIBERTARIAN PARTY Statement of Principles

We, the members of the Libertarian Party, challenge the cult of the omnipotent state and defend the rights of the individual.

We hold that all individuals have the right to exercise sole dominion over their own lives, and have the right to live in whatever manner they choose, so long as they do not forcibly interfere with the equal right of others to live in whatever manner they choose.

Governments throughout history have regularly operated on the opposite principle, that the State has the right to dispose of the lives of individuals and the fruits of their labor. Even within the United States, all political parties other than our own grant to government the right to regulate the lives of individuals and seize the fruits of their labor without their consent.

We, on the contrary, deny the right of any government to do these things, and hold that where governments exist, they must not violate the rights of any individual: namely, (1) the right to life - accordingly, we support prohibition of the initiation of physical force against others; (2) the right to liberty of speech and action - accordingly we oppose all attempts by government to abridge the freedom of speech and press, as well as government censorship in any form; and (3) the right to property - accordingly we oppose all government interference with private property, such as confiscation, nationalization, and eminent domain, and support the prohibition of robbery, trespass, fraud, and misrepresentation.

Since governments, when instituted, must not violate individual rights, we oppose all interference by government in the areas of voluntary and contractual relations among individuals. People should not be forced to sacrifice their lives and property for the benefit of others. They should be left free by government to deal with one another as free traders; and the resultant economic system, the only one compatible with the protection of individual rights, is the free market.

Who is Frank Primich?

Frank Primich is a fifty five year old physician from North Bergen. He attended Weehawken High School and is a graduate of Columbia University and New York Medical College. Dr. Primich maintains his professional practice in West New York. As a staunch defender of private, voluntary institutions, Dr. Primich played a key role in the creation of Riverside General Hospital, a private facility built at no cost to the taxpayer. Since that time, Dr. Primich has remained active in the struggle to remove government from our lives. A candidate for Congress in 1976, Dr. Primich's experience as a public spokesman for freedom makes him uniquely qualified to be New Jersey's next Governor.

The Libertarian Party: "Only five years old, the Libertarian Party offers the best hope for our people to regain control of their government. The two major parties are committed to the 'Boss Rule' school of government. To one degree or another both parties are committed to gaining more power for themselves. People come last or never. Independents lack the statewide organization to become a lasting threat to the Big Government policies that are destroying our state. Members and supporters of the Libertarian Party disagree on many issues; however they share the common notion that we must reduce the size and cost of government at once if we are to remain a free people. Taxes: "The people of New Jersey neither wanted nor needed an income tax. The politicians wanted the tax to fatten their political bankroll. Since 1965 the cost of government in New Jersey has risen over 500%. The time has come for the people to elect a governor who will stop the "tax and spend" policies of the politicians. We must roll back senseless spending and cut taxes."

Education: "Our politicians deceitfully used innocent school children as an excuse for more taxes. The sad fact is that as the State Government has seized more control over local schools the quality of education has diminished. Loving parents are more concerned and better qualified to deal with education than a group of political appointees in Trenton. We must work toward decontrol of education. We must stop the senseless spending in the name of education that has only benefited special interest groups such as the NJEA. We must realize that you cannot legislate good education, therefore we must repeal the 'Thorough & Efficient' clause in our Constitution. Parents must be given maximum input in their children's schooling."

Jobs: "Restrictive laws and excessive taxation have created an army of unemployed in New Jersey. We must work at once to remove these restraints. We must make New Jersey a free market haven, committed to a free and healthy economy, to lure honest job-creating businesses into our state. We must tell those who would destroy our free economy by seeking government favor to go elsewhere."

Crime: "More and more each day our people are victims of violent acts against life and property. We must remove the police from areas of so-called victimless crime and free them to concentrate on real crime. You are not safer when the police close a movie theater. Law enforcement officials must concentrate on real crime: crime against life and property. We must repeal victimless crime laws and concentrate police efforts toward violent crime."

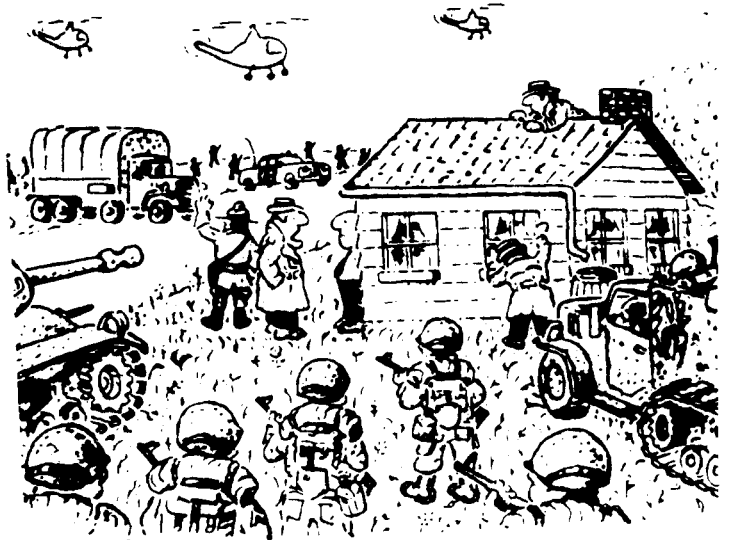

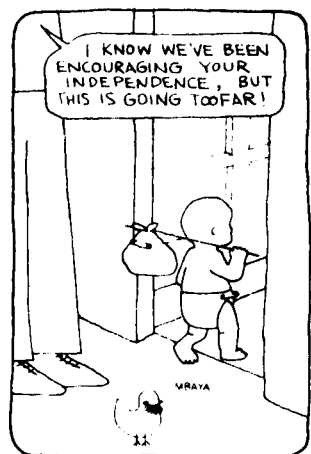

LIBERTARIAN PARTY
Statement of Principles

We, the members of the Libertarian Party, challenge the cult of the omnipotent state and defend the rights of the individual.

We hold that all individuals have the right to exercise sole dominion over their own lives, and have the right to live in whatever manner they choose, so long as they do not forcibly interfere with the equal right of others to live in whatever manner they choose.

Governments throughout history have regularly operated on the opposite principle, that the State has the right to dispose of the lives of individuals and the fruits of their labor. Even within the United States, all political parties other than our own grant to government the right to regulate the lives of individuals and seize the fruits of their labor without their consent.

We, on the contrary, deny the right of any government to do these things, and hold that where governments exist, they must not violate the rights of any individual; namely, (1) the right to life - accordingly we support prohibition of the initiation of physical force against others; (2) the right to liberty of speech and action - accordingly we oppose all attempts by government to abridge the freedom of speech and press, as well as government censorship in any form; and (3) the right to property - accordingly we oppose all government interference with private property, such as confiscation, nationalization, and eminent domain, and support the prohibition of robbery, trespass, fraud, and misrepresentation.

Since governments, when instituted, must not violate individual rights, we oppose all interference by government in the areas of voluntary and contractual relations among individuals. People should not be forced to sacrifice their lives and property for the benefit of others. They should be left free by government to deal with one another as free traders; and the resultant economic system, the only one compatible with the protection of individual rights, is the free market.

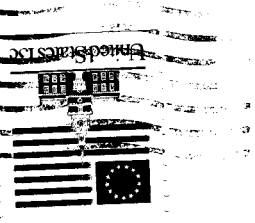
