The meeting was called to order at 7:00 p.m. by Anthony D'Orazio, 1st Vice-Chair in the absence of William Cody Anderson, Chair.

The Credentials and Nominations Report (Exhibit 1) indicated that there were 66 voting members at the time the meeting was called to order. 43 of 66 Members of the State Committee were present at the time of roll call; Matthew Morgan and Irwin Mark Weinblatt later entered the meeting.

The Agenda (Exhibit 2) was adopted without objection.

The Special Rules of Order (Exhibit 3) were adopted without objection.

Lora Newell issued a Treasurer's Report in writing (Exhibit 4).

Secretary Andrew Kolstee issued a Credentials and Nominations report (Exhibit 1). The following individuals were submitted to the Secretary to fill vacancies in the State Committee and accepted their nominations. Motion by Andrew Kolstee to adopt the following.

Adopt a matching funds program for supporting the development of unorganized counties. The State Committee shall match up to \$250 on all expenditures through December 31, 2022 for unorganized counties once they become a recognized County Affiliate. In order to qualify for matching funds, a county must meet the following requirements:

- 1. They must become a recognized County Affiliate before January 31, 2023.
- 2. Provide proof of obtaining an EIN.
- 3. Provide proof of opening a bank account by providing bank statements.
- 4. Provide proof of expenditures through receipts, bank statements, and/or online payment processing reports.

The State Committee shall make the final decision to disburse funds to qualified County Affiliates formed after January 9, 2022.

Public Engagement Committee Chair Anthony D'Orazio issued a report. Three press releases were distributed in December 2021. The party has a presence on Facebook, Twitter, and LinkedIn. Pietro Geraci asked about the possibility of a presence on TikTok.

Rules Committee Chair Paul Grindle issued a report. The next meeting is set for Wednesday, January 12, 2022.

Platform Committee Member Jeffrey Denecke issued a report in the absence of Chair Karyn Thompson and indicated that there was nothing to report.

2022 Libertarian National Convention Delegate Selection Committee Chair Lora Newell issued a report. An email to call for delegates is almost done. Voting on the delegate slate will be done at the State Committee meeting in February.

Motion by Jonathan Gunther to set the speaking time of candidates to fill vacancies on the State Committee to ninety (90) seconds was seconded by Angela Einwachter and passed without objection.

Special Rules of Order of the Libertarian Party of New York for the State Committee Meeting of January 9, 2022

As adopted by the State Committee on January 9, 2022.

Rule 1. **CREDENTIALS.** The Secretary, directly after the opening ceremonies of the business meeting, shall call the roll of the elected members of the State Committee.

Rule 2. **IDENTIFICATION OF VOTING MEMBERS.** To facilitate identification, seating, and voting, members and others shall be required to retain and display upon request the wristbands, voting cards, or other indicia issued by the organizers of the meeting upon registration. Division votes, whether simple or counted, shall be taken by members' standing and display of such voting member indicia. For meetings held by teleconference, voting members shall be identified within the platform or platforms used to conduct the meeting.

Rule 3. **DEBATE.**

- Rule 3.1. No member shall speak in debate on the same question a second time until every other member who wishes to speak had the opportunity to do so.
- Rule 3.2. No member shall speak in debate on the same question more than twice or longer than three (3) minutes in total without permission of the State Committee granted by a two-thirds vote without debate.
- Rule 4. **FILLING OF VACANCIES.** Vacancies on the State Committee shall be done in a manner as described in this Rule and in accordance with the Rules of the Libertarian Party. If there is no candidate to fill a vacancy for a particular district, the Chair may move to the next district or item on the agenda.

Rule 5. ADOPTION AND AMENDMENT OF PARTY RULES.

- Rule 5.1. All proposed amendments of the Party Rules must be submitted in accordance with this Rule and the Rules of the Libertarian Party.
- Rule 5.2. If discussion on an amendment has begun, any recognized speaker may also discuss alternative proposed amendments that deal with the same issues and may use that text to propose a substitution to the current amendment.
- Rule 5.3. If a member of the State Committee proposes more than one amendment, their subsequent proposals shall be taken up only after every other member's first proposed amendment has been considered.
- Rule 5.4. Debate on each amendment shall be limited to ten (10) minutes. Each speaker is limited to one (1) minute at a time. The Chair shall alternately recognize those speakers in favor of and opposed to the amendment.

Rule 6. CANDIDATE SPEECHES.

Rule 6.1. Candidates for Chair shall each be allowed five minutes to speak; candidates for all other Party offices shall each be allowed three (3) minutes to speak. Candidates to fill vacancies on the State Committee shall be allowed one minute to speak. Candidates may cede their time only to other members of the State Committee to speak on their behalf during their allotted time. Speeches will not be allowed for uncontested positions, in which candidates are only running against NOTA.

Rule 6.2. Candidates seeking endorsement for the highest public office shall each be allowed five minutes to speak; candidates seeking endorsement for all other public offices shall each be allowed three minutes to speak; candidates seeking endorsement for any public office shall also each be allowed one nominating speech and one seconding speech of one minute each.

Rule 7. **ENDORSEMENTS OF CANDIDATES.** Endorsements of candidates for public office shall be made in the same manner as elections for Party office, except that endorsements shall require a two-thirds (2/3) majority. Each office shall be filled with one election, even if that office has more than a single position to be filled. Each election shall consist of a series of ballots. In each ballot, voters may vote for as many candidates as there are positions for the office still open or "None of the Above". If None of the Above achieves a majority, a new election shall be held for the open positions still remaining and the candidates who were outpolled by None of the Above shall be ineligible; otherwise, those who achieve the requisite majority shall be recognized as elected, in order of their vote totals and in order of the length of term. The candidate receiving the fewest votes shall be eliminated from succeeding ballots. Ties shall be resolved by a separate ballot.

Rule 8. **PLATFORM.** When discussing the Platform, the previously adopted Platform shall be the base on which amendments, additions, or deletions shall be offered. Such changes to the Platform shall require a vote in accordance with the Rules of the Libertarian Party.

Rule 9. RESOLUTIONS.

Rule 9.1. A resolution offered by an individual member shall be submitted by the maker and the seconder – each of whom shall be a member of the State Committee – and shall be sent by email directly to the Secretary.

Rule 9.2. The Resolutions Subcommittee may convene during the main meeting to consider resolutions. Each member who offers a resolution shall be given an opportunity to explain it to the Resolutions Subcommittee if he so requests.

Rule 9.3. The Resolutions Subcommittee shall review all resolutions in the order they were submitted, and shall amend the text of each resolution to the satisfaction of the member that submitted the resolution, while satisfying formatting requirements, grammar, clarity, etc. The Resolutions Subcommittee shall present a report to the State Committee of all resolutions in the order they deem appropriate.



FUTURE OF COMMITTEE

An email was sent out to find more people to join the committee and seek candidates for Chair.

WEBSITE

PAGE UPDATES. The following pages have been updated since the last report: Cortland, Fulton, Leadership, Orleans, and Wayne.

E-MAILS LISTED. Several State Committee members and County leaders still only have a personal email address listed on the website, although it is recommended that we do not place personal emails on the website for security purposes. It is highly recommended that all state and county leaders get an LPNY email address.

HIDING E-MAILS? It is often recommended that emails be hidden. National does have a way to allow users to select where to send certain inquiries, suggestion the following. However, this runs into a situation of having so many email addresses due to all the County Affiliates, their officers, and County Contacts.

- Affiliates > affiliates@lpny.org
- Campaigns
- Volunteering
- Donating
- Feedback (main inbox)

A request to National was sent out to turn our contact lists into forms, in which individuals can be contacted, instead of showing their emails, for security purposes. In the request to National, they are unable to fulfill this request at this time.

PARTY RESOURCES PORTAL. This page is updated at least weekly.

EMAILS

CONSTANT CONTACT IMPORTS. On August 30, 2021, 9,159 contacts were imported from the CiviCRM database (19 new, 9,159 updated). Also, 6,396 contacts were imported from the National LP Database Dump for New York (33 new, 6,363 updated). On October 28, 2021, 6,186 contacts were imported (5 new, 6,181 updated). On January 1, 2022, 9,353 contacts were imported from the CiviCRM database (119 new, 9,234 updated).

CIVIMAIL. The IT Committee decided to test pilot CiviMail, which is the mass email platform recommended by National.

CIVICRM

RESUBSCRIBING AFTER UNSUBSCRIBING. National recommends using CiviMail and does not support Constant Contact. If an individual who had unsubscribed resubscribes via the LPNY website, they would not be imported into Constant Contact unless we manually reviewed all sign-ups, or the individual informed us that they unsubscribed and need to be sent an email to confirm that they want to be resubscribed.

DATA POLICY. Besides National's NDA, we need our own policy for granting access to the data.

CIVICRM TRAINING. Besides National's training, if LPNY County Affiliates want to use the CiviCRM, we need to be able to train them.

LPNY DISCORD

The LPNY Discord Server is up and running. As of January 9, 2022, 54 out of 66 State Committees (81.82%) are in the server. A policy document for Discord was drafted.

LPNY E-MAILS

GENERAL. It is recommended that all LPNY officials use an LPNY.org e-mail address. As of January 9, 2022, 40 out of 66 (60.61%) of all State Committee members have an LPNY e-mail address. Contact me if you want/need an LPNY.org e-mail address.

GUIDE. A guide for setting up @lpny.org emails has been drafted but is incomplete.

SECURITY CONCERNS. After conducting a security analysis, there are many issues with regard to conducting LPNY State Committee business through personal email addresses.

GRASSHOPPER

When calling the LPNY, the script is as follows: "Thank you for calling Libertarian Party of New York. If you know your party's extension, please enter it now or press 8 for the name directory. For Fundraising, press 1. For Elections and Campaigns, press 2. For Communication and Media Relations, press 3. For Chapter Development, press 4. For all other inquiries, press 0 and the next available representative will assist you." This should probably be updated at some point since affiliates are not called chapters anymore and perhaps individual titles should be in the recording.
