TAKING LIBERTIES

Time to write some letters, again! There are a quite a few initiatives now under consideration in the legislature in Richmond that libertarians should let their positions be known about:

HB 1676-Would eliminate localities' abilities to restrict mobile homes set up on private property. Currently, many localities are telling a lot of people to remove their mobile homes from their property and allow them only in government approved "parks". Tell them we are FOR passage of the bill.

- HB 1380-Provides for the seizure and forfeiture of any vehicle driven while driver intoxicated. In other words, if a friend of yours is using your car and gets stopped for drunken driving, you lose YOUR car. This one is yours courtesy of Del. Wm. T. Wilson of Covington. A-GAINST.
- HB 1631-This one, courtesy of Del. W.R. O'Brien, Jr. of Va. Beach, would make it illegal to serve a pitcher of beer to an individual drinking alone. AGAINST.
- HB 1496-This wonderful measure from the august mind of Del. Theodore V. Morrison of Newport News requires "that when 'retail establishments' won't or can't accept

'currency of any denomination' in payment for a purchase, the customer may take the merchandise anyway, provided he leaves his name address with the retailer. This means that if Del. Morrison purchased a 25 cent snack at a sidewalk kiosk and offered to pay for it with a \$100 bill, the little merchant would either have to change it or allow him to walk away with his snack without paying. Apparently it would be up to the kiosk operator to try to collect his quarter later." [Source: Richmond Times-Dispatch, January 28, 1985.] AGAINST.

HB 1720-From Del. S. Vance Wilkins Jr. of Amherst comes a gem that would

"regard as a litterer anyone whose name is on a magazine, envelope, 'or other papers or material' found on 'the highway, right-of-way, property adjacent to such highway or right-of way, or private property.' That person would be guilty of a misdemeanor. Such trash might have fallen from a refuse truck or it might have blown from a legal public dump, but it would be up to the accused...to prove that he did not improperly discard it himself. [Source: Times-Dispatch, Jan. 28, 1985.] AGAINST.

CANDIDATE REQUIREMENTS

In order to qualify as a candidate for the office of Governor, Lieutenant Governor, or Attorney General, a person must be: 1) Qualified to vote for and hold the office sought; 2) At least thirty years of age; 3) If a candidate for Gov. or Lt. Gov., must be a resident and registered voter of Virginia for at least five years immediately preceding the election: 4) If a candidate for Attorney General, a resident of Virginia admitted to the state bar at least five years prior to the elec-

Paperwork must be filed by 7:00 p.m. on 6/11/85. This includes: Financial Disclosure Form, Certificate of Candidate Qualifi-

others. I would strongly suggest to our readers that they contact the Division of Legislative Services [or Div. Legislative Information] and get: 1) a House Bills Calendar, 2) a Senate Bills Calendar, and 3) a 1985 Cumulative Index of Bills, Joint Resolutions, and Documents. Read through them carefully, for it has a brief description of each bill. Find the ones you want to find out more about, and get the D.L.S. or D.L.I. to send you a copy of each. Remember, these bills are playing with YOUR life. Ignoring what these paperpushers are doing will not make them go away! Let your legislator know you are watching him.

Various other bills which nibble away at freedoms include the seat belt crap, the 21-drinking age bills, a bill by Del. Stafford (R-Giles) that would kick out of state schools any students that have not registered with the Selective Service, and others too numerous to list. My fingers would become skeletons if I were to try typing them all up. Come to think of it, not just my fingers.

cation, Appointment of Campaign Treasurer, Declaration of Candidacy, and Petitions of Qualified Voters. The first goes to the Secretary of the Commonwealth, all the rest go to the State Board of Elections.

Incidentally, we now would need 12,653 valid signatures to get a candidate on the statewide ballot.

There are numerous other reports, etc, that need to be kept up to date by the candidate; so please call the State Board of Elections for complete info.

In order to qualify as a candidate for the House of Delegates, a person must be 1) Qualified to vote for and hold the office sought; 2) Twenty-one years of age by the time of the election; 3) A resident of the Commonwealth for one year immediately preceding the election; 4) a resident by the time of filing, of the House district to be represented.

No U.S. government employee is eligible to hold office.

Paperwork must be filed by 7:00 p.m., 6/11/85. Financial Disclosure Forms must be filed with the Clerk of the House of Delegates; Appointment of Campaign Treasurer gets filed with the Electoral Board of the county or city where the candidate resides; while Declaration of Candidacy and Petitions of Qualified Voters must be filed with the Clerk of the Circuit Court of the County or city where the candidate resides.

250 valid signatures of voters within the candidate's district are required for ballot status.

Please remember that there is additional paper-work that must be kept current during and after the campaign, so please call the State Board of Elections and request a candidate information packet for the office you seek.

TIDBITS

Public Schools Found Inadequate

Washington - A recent report by the Carnegie Institute found that American businesses are now spending \$100 billion per year to teach their employees.

The report stated that traditional schools from Kindergarten to college are producing workers that lack basic communication & problem-solving skills. [I think we could have told them that and saved them the money they spent on doing the study... ---Ed.]

According to the report, "employee training by large corporations now rivals four-year colleges in the number of adults taught and dollars spent" to do it. "Businesses now offer courses in everything from basic reading to high school chemistry to good management practices."

"It cited various estimates that corporations are spending at least \$40 billion a year - and as much as \$100 billion, if worker salaries paid during training are counted - teaching

nearly 8 million U.S. workers. By comparison, fouryear colleges spent about \$60 billion teaching 7.65 million people in 81-82, the latest figures available."

I think it's great to have a regularly issued newsletter again.

I would like to comment on Al Ander's "Tidewater Page" of last issue.

Al stated that he believes that the LPVA should run a full slate of candidates this year if possible, from Governor on down to House and local candidates. Even if it had to be a write-in campaign or as 'independents', I'm sure Virginia Libertarians would be delighted at the prospect.

More importantly, this is probably the boldest step we could take to proclaim the LP as a viable alternative, one that's here to stay, which will help us establish a basis for future Libertarian vote totals. I would be willing to bet that most political analysts, Larry Sabato included, would agree on this.

For the possible candidates, it would lend name recognition & a measure of legitimacy to future campaigns for House & local office. For those reluctant to drop a long-shot campaign for House this year, the aforementioned advantages would be theirs in Congressional races next year and state House/Senate

races the year after.

Let's remember the Illinois LP candidate for Congress who received the media support of four major conservative groups. Could we not hope for such a boost in Virginia? We will eventually have to convince Virginia voters that 'Libertarian' is not synonomous with 'liberal', but emphasises Liberty!

I beleive those who have been active politically, as I was in College, and who are familiar with nuts and bolts of necessary campaign procedures will agree that such a campaign is possible to mount. Running a statewide candidate can only help us even if he/she is only a figurehead candidate for Lt. Governor. Practical politics virtually demands it.

The Democrats may nominate one or more minority candidates this year; the Republicans may nominate one or more losers of previous elections, and probably some of their usual lack-luster figures.

Besides the better than usual opportunity for protest votes, we would benefit in increased publicity and media attention.

I invite feedback on this.

From the Chair

ANOTHER MODEST PROPOSAL

If crime is the hottest issue in this year's Virginia elections, then education is probably a close second.

The main reason that these two issues need to be addressed by libertarians loudly and often is that politicians are using the problems in prisons and schools as an excuse to gain public support for higher expenditures to "solve" these problems. Of course, few people realize that failure is endemic with the current system, so many are swept along to support bigger budgets and higher taxes.

The Robb administration came into office with a strong commitment to improve public education-with little imagination on how to do it. In the normal manner of bureaucrats. they have attempted to make an inefficient system more efficient by expanding it, which paradoxically makes it less efficient. The proposals are all for longer school days, longer school years, more pay for teachers, more teachers, more equipment, larger or fancier facilities, increased standardization of testing and curriculum, more studies, more bureaucracies. All of this flies in the face of the fact that learning is a totally individual process, which is usually stunted by the current factory system of schooling and its emphasis on conformity. Children have short attention spans, so longer school days will mean that much more wasted time for both student and teacher. It will also mean that much less time for homework, which can be the best learning time for the student. If the system isn't changed, then paying teachers more won't improve

Libertarians may realize that the only real solution to the education problem, among others, is to separate it completely from government. But the average Joe doesn't. We must

the results, either.

get people to question authority before we can convince them to rebel against it. A good attack strategy is for libertarians to ask people "if the government was doing such a great job of educating our kids (solving crime, poverty, whatever), would we even be talking about it?" Since the problem is being discussed, the government must not be doing the job. Then it will be much easier to get them to start thinking of alternatives to the status quo.

Let's dig up the facts, expose the fallacies that underlie public education, and advocate removing government barriers to private education; then later we will be in a position to realistically propose the phasing-out of the public-school system.
